EXECUTIVE SUMMARY

The purpose of this item is to designate a Councilmember as a second alternate to the North Front Range Metropolitan Planning Council.

STAFF RECOMMENDATION

Staff recommends adoption of the Resolution.

BACKGROUND / DISCUSSION

The North Front Range Metropolitan Planning Organization (NFRMPO) is an association of 15 local governments working together to improve regional transportation and air quality. Councilmember Tricia Canonico is the City's appointed representative to this organization, with Mayor Jeni Arndt as the alternate.

Due to scheduling conflicts, there are occasions where the City's appointed representative and alternate are unable to attend. Therefore, a second alternate is being designated.

The NFRMPO Articles of Association require the appointment of primary and alternate members be made in writing. This Resolution will appoint another Councilmember as an additional alternate to the NFRMPO.

RESOLUTION 2023-047 OF THE COUNCIL OF THE CITY OF FORT COLLINS APPOINTING A BACKUP ALTERNATE REPRESENTATIVE TO THE NORTH FRONT RANGE METROPOLITAN PLANNING COUNCIL

WHEREAS, by Resolution 2021-060 in May 2021, the City Council appointed Mayor Jeni Arndt to serve as representative and Councilmember Tricia Canonico to serve as alternate representative to the North Front Range Metropolitan Planning Council (hereafter as "MPO"); and

WHEREAS, by Resolution 2022-138 in December 2022, the Council modified the appointments for the MPO, naming Councilmember Canonico as the primary representative and Mayor Arndt as the alternate; and

WHEREAS, there may be one or more occasions on which these appointed representatives are unavailable to attend scheduled MPO meetings; and

WHEREAS, the City Council has determined that it is in the best interest of the City to be fully represented in MPO discussions and decisions in the event the appointed representatives are not available and appointing a second alternate representative will help ensure this.
