3. DISCUSSION

A. Town Plan - Discuss questions for town plan survey

- No additional questions were submitted by Planning Commission Board Members for the community survey since the last meeting.

- 29 - Planning Commission reviewed the South Hero Town Plan questions for town survey.
- 30 Discussion commenced regarding the survey questions used and expressed ideas that many of
- 31 the same questions could be used for Georgia's Town Plan survey.
- 32 - G. Drew expressed concerned with some of the questions regarding South Hero likes/dislikes
- 33 questions, as Town of Georgia doesn't have control over many of those topics. Though it would
- 34 be good to collect the surveys with these questions so the Town can look for patterns and
- 35 similarities.
- 36 - South Hero Town Plan took 18 months to complete and they used a consultant. Town of
- 37 Georgia should move forward to get quotes to building a new Town Plan. Waiting on
- 38 Selectboard decision to approve the Town Plan consultant fee.
- 39 - Discussion on how the survey will be distributed and advertised. Ideally the Town Plan
- 40 Survey would be available online, either on the Town of Georgia new website or run by Survey
- 41 Monkey or like services; as well as mailed on postcard to every resident. Copies would also be
- 42 made available at the Georgia Town Hall.
- 43 - Planning Commission discussed recent community input after the last DRB meeting. Town of
- 44 Georgia residents need to understand the Town Plan is what sets the DRB rules, Development
- 45 Regulations, Zoning, etc. The Town Plan will be a roadmap to what residents want the Town of
- 46 Georgia to look in the future, 10+ years forward.
- 47 - Town Plan should address the future facilities aspects, sewer & water, roads, sidewalks, etc.
- 48 How far can our well water stretch for community water service, or attracting new businesses?
- 49 All wells in the area will need to be tested and recorded if available for use in the SV. Does
- 50 Town of Georgia need the water supply in place first for investment into the community? Or
- 51 should development be approved first and then seek out water system later?
- 52 -Town of Georgia needs to plan for the future, small businesses that need water- cafe, salons,
- 53 etc. all need water in order to thrive. Georgia will need to catch up in 10+ years to include these
- 54 services for residents.
- 55 - Grant money possible for bike path rather than sidewalks. Asphalt instead of concrete
- 56 sidewalks.
- 57 - Planning Commission is in a holding pattern while waiting for Selectboard to approve funds.
- 58 However, time is running out to get the Town Plan completed to meet the deadline.

60 B. Development Regulations - discuss changes

- 61 - Current list of proposed changes for the Development Regulation will be collated and
- 62 distributed out to the Planning Commission for review and updating at the next meeting.
- 63 - Development Regulations need to be more tailored to what the Town of Georgia encounters
- 64 most often; as well as updating references to prior policies or regulations in place at the time of
- 65 the last update.
- 66 - Most important is to reformat the regulations so keywords or topics can be easily searched.
