3. DISCUSSION

A. Meeting with Michael Allen, ReGrowth to Review Town Plan Draft 2.0

- Butch and Tony McCracken started the discussion on the Town Plan and questioned the Zoning map and Regulations.
- The McCracken’s suggested changes to the zoning and development regulations to the South Village to increase full use of their property and to make development and growth in the South Village and Business districts of Georgia easier. Referred to the

Fairbanks property and the South Village regulations impairing the sale and development of the land.

- S. Brown explained the South Village will be examined when the Planning Commission updates the Development Regulations in the coming months.

M. Allen from ReGrowth joined the Planning Commission via Zoom at 6:48pm

- The Planning Commission examined the latest changes, additions and edits to the Town Plan Draft 2.0.
- Changes were made to timeline of Georgia history for sequential continuity.
- Conservation map will be updated for clarification.
- Several edits were made for clarifications purposes.
- K. Caspers will follow up with M. Allen with additional information to add to the Town Plan regarding schools, bussing and maps.
- D. Bergstrom joined the meeting at 8:40pm
- Maps within the draft document are designed to be shown in poster size (18 x 24 inches) so they are a little harder to view when shrunk down to fit the Town Plan.
- M. Allen went over the proposed schedule to complete the Town Plan, including distribution of draft materials, warning meetings, Planning Commission and Selectboard hosting ed meetings, and official copy sent to Northwest Regional Planning.

B. Zoning Map Discussion

- D. Bergstrom utilized the NEMRC Vermont Parcel Map of Georgia to reference the current town zoning districts.
- Discussion ensued over adding to the Industrial Zones and where that would make sense, adding another high-density growth zone and including some property currently located in the South Village.
- The Business district was examined to determine where business development was sensible and where farm and wetland areas could be preserved. Discussion over AR-1, AR-2 and AR-3 residential and farm zones, including minimum acre sizes and areas where those regulations could change.
- D. Bergstrom will incorporate discussed changes into a draft Town of Georgia zoning map for the Planning Commission to continue revision discussion.
