3. Discussion, consideration, and possible action on voting to ratify the increase in property taxes to be raised under the FY 2021-22 over what was raised in the FY 2020-21 Budget.

City Administrator Leamons presented the item to Council.

Motion made by Councilmember Conrad, Seconded by Mayor Pro Tem Joslin to ratify the \$.35959738 increase in property tax revenue raised under the FY 2021-22 Budget and set Public Hearing for September 7, 2021.

Vote 3/0 to approve. Voting Yea: Mayor Pro Tem Joslin, Councilmember Conrad, Councilmember Harris

4. Discussion, consideration, and possible action on amending the budget filed with the City Secretary and approving a resolution adopting the FY 2021-22 Budget.

City Administrator Leamons presented the item to Council.

Motion made by Councilmember Harris, Seconded by Mayor Pro Tem Joslin to approve FY2021-22 Budget to include the 2% COLA, and other revisions in the column labeled "REV +2%", and approve Resolution 2021-21 adopting the budget as amended.

Vote 3/0 to approve. Voting Yea: Mayor Pro Tem Joslin, Councilmember Conrad, Councilmember Harris

5. Discussion, consideration, and possible action on resolution adopting an amended FY 2020-21 Budget.

City Administrator Leamons presented the item to Council.

Motion made by Mayor Pro Tem Joslin, Seconded by Councilmember Harris to approve Resolution 2021-22 amending the FY 2020-21 Budget as presented.

Vote 3/0 to approve. Voting Yea: Mayor Pro Tem Joslin, Councilmember Conrad, Councilmember Harris

6. Discussion, consideration, and possible action regarding election equipment, election contract, and options for the City's future elections.

City Secretary Ritchie presented the item to Council.

Mayor Douglas updated Council on communications with the County regarding interlocal agreement negotiations. All negotiations have not been completed.

Council took No Action while waiting for additional information at a future meeting.

7. Discussion, consideration, and possible action on a resolution establishing a 380 Agreement Program.

City Administrator Leamons presented the item to Council.

Motion made by Councilmember Conrad, Seconded by Councilmember Harris to approve Resolution 2021-23 establishing a 380 Agreement Program as presented

8. Discussion, consideration, and possible action amending the City's Procedures for Placing an Item on the Agenda.

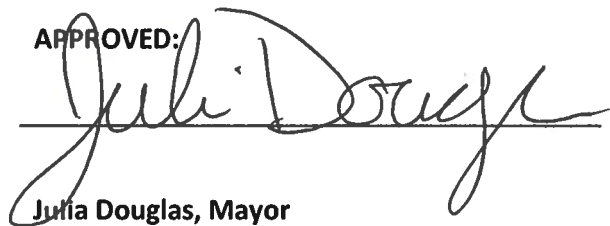

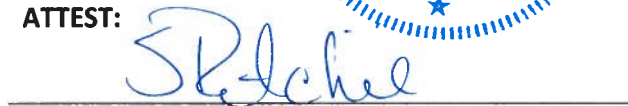
With no further business before the Council, Mayor Douglas adjourned the meetings at 7:13 pm.
