**6. Budget Work Session**

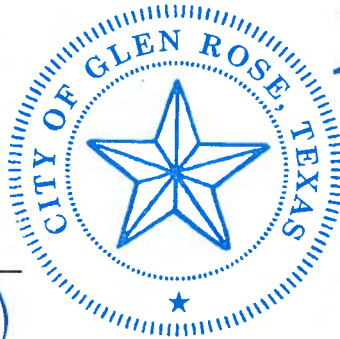
Wayne McKethan, Interim City Administrator, gave a high-level overview of the FY2023-2024 to Council. No action was taken.
