22. Discussion, consideration, and possible action on Jimmy Gosdin's request for approval of additional phases of his Squaw Creek Meadows Subdivision.

City Administrator Leamons presented the item to Council.

Gosdin representative, Tamara Valentine, addressed Council asking for approval of the remaining four phases of this subdivision.

Motion made by Councilmember Harris, Seconded by Mayor Pro-Tem Joslin to approve the additional phases requested by Mr. Gosdin subject to the same requirements stipulated as part of the original approval.

Motion made by Councilmember Harris, Seconded by Councilmember Conrad to authorize staff to use the BCBS renewal rate for health insurance and to approve the renewal rate for the dental, vision, life, and AD&D already in place.

Motion made by Councilmember Conrad, Seconded by Councilmember Harris to schedule a Public Hearing on the Proposed Fiscal Year 2021-2022 Budget at the August 24th meeting.

Vote was 3/0 to approve. Voting Yea: Mayor Pro-Tem Joslin, Councilmember Conrad, Councilmember Harris

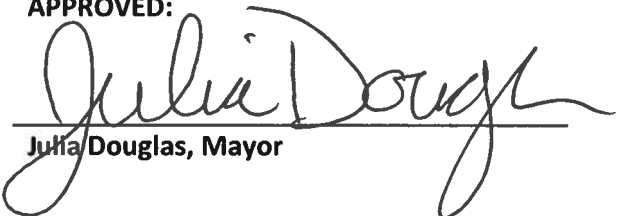
31. Mayor and Councilmember Reports (Councilmember Conrad)
