MOTION By TJ Walker, second by Richard Bruning, to approve Ordinance No. 2023.07.25.A adopting a speed limit of 20 miles per hour for school zones during the hours of 7:30 a.m. – 9:00 a.m. and 2:30 p.m. – 4:00 p.m. and changing the speed limit on Mary Lynn and Allen Drive to 25 miles per hour outside of those times. MOTION CARRIED with George Freas casting a dissenting vote.

Doug Martella, GoVirtualCFO, gave a presentation on his company's services.


- 5. Budget Work Session for FY2023-2024**

Discussion was held regarding the FY2023-2024 budget. Dennis Moore asked that the Council consider budgeting funding for a shuttle service during events. No action was taken.


