ITEMS REQUIRING PUBLIC HEARINGS

Public hearing regarding a request to Rezone for Property located at 311 E Elm St., also known as Acres 0.453, Tract F9-11 & 11-1, Abst A136, A136 MILAM CO SCH LD, TRACT F9-11 & 11-1, ACRES .4526, from R-1 (Single Family Residential District) to R-2m (Single and Two to Four Family Residential District and Multi-Building Residential District)
Mayor Boles opened the public hearing at 5:38 p.m.
Phillip David spoke in opposition to this rezone, stating that parking and traffic will be larger issues with the owner's ability to put multiple units on the lot.

Sheyenne Edwards spoke in favor of the development, stating that the lot has been vacant for a long time and would be a good fit for this location.

John Lenz spoke in favor of the six (6) lot development and that it would increase property tax revenue by \$20,000 in the tax year. He also stated that a development agreement could be put in place to ensure the City would be happy with the product.

BUDGET STATEMENT

In accordance with Texas Local Government Code Chapter 102, the proposed budget for the City of Glen Rose for Fiscal Year 2025-2026 has been filed with the City Secretary and is available for public inspection at City Hall and on the City's official website. The budget will raise \$35,789 more in total property tax revenue than last year's budget, which is a 4.09% increase from the FY 2024-2025 budget. The property tax revenue to be raised from new property added to the tax roll this year is \$23,040. A public hearing on the proposed FY 2025-2026 budget was held in accordance with Texas Local Government Code 102.006. Following the public hearing, the City Council took action to adopt the budget.
