The City Council of the City of Glen Rose met in a Regular Meeting on Tuesday, July 23, 2024, in the Glen Rose City Hall Council Chambers, 201 NE Vernon, Glen Rose, TX 76043, at 5:30 PM to consider the following items of business:

13. Discussion, consideration, and possible action regarding the contracted rate increase for Frontier Waste Solutions

Grant Gregg, Frontier Waste Solutions, presented the proposed rate increase to Council. Mr. Gregg explained that this increase is part of the City's contract with Frontier and is the first increase since the contract began on January 1, 2023. The increase will be 4.87%, resulting in an average increase of \$0.46 per month per residence.

MOTION by George Freas, second by Candace Scholz, to approve the contracted rate increase for Frontier Waste Solutions. MOTION CARRIED by unanimous vote.

14. Discussion, consideration, and possible action regarding awarding a bid for the 2024 Ground Storage Tank and Variable Frequency Drive Improvements Project

Chris Hay, eHT was in attendance to answer questions about the project. Bids were opened on July 11, 2024; three bids were received. Mr. Hay recommended that the project be awarded to TTE, LLC in the amount of \$1,211,170.
