The business to be brought before the meeting shall be limited to the following:

#### 1. Call Meeting to Order and Roll Call

The Mayor called the May 6, 2025, Special Called Meeting of the Mayor and Board of Aldermen to order. The Mayor presented the Notice of Regular Meeting of the Mayor and Board of Aldermen of the City of Gluckstadt, Mississippi acknowledged by all Aldermen. (Exhibit "A").

County School District and Germantown High School for reimbursement of pay compensation and retirement for the days staffed during the school year.
