The business to be brought before the meeting shall be limited to the following:

1. Call Meeting to Order and Roll Call

The Mayor called the August 9, 2023, Regular Meeting of the Mayor and Board of Aldermen to order. The Mayor presented the Notice of Regular Meeting of the Mayor and Board of Aldermen of the City of Gluckstadt, Mississippi acknowledged by all Aldermen. (Exhibit "A").

Motion made by Alderman Slay, Seconded by Alderman Powell.

The Mayor requested a motion to accept the lowest and best quote (Grainger) for expenditures related to the CESF COVID Grant, as requested by City EMA Director, Kerry Minninger, and Chief of Police, Wendell Watts. (Exhibit "T"). Motion made by Alderman Slay, Seconded by Alderwoman Bates.

Additionally, to discuss ongoing litigation, related to the City of Madison's Annexation, as well as the legal appeal of site plan denial by AutoZone and revisions to the July 11, 2023 meeting minutes, Seconded by Alderman Slay.

The Mayor declared the motion carried.

B) Litigation Matters: City of Madison Annexation

The board discussed the status of the City of Madison's Annexation filing and court deadlines.

C) Personnel Matters: Consideration of Candidate Qualifications Extension of Employment Offer for Purchasing and Fixed Assets Clerk

After discussion the candidate's qualifications at length and the need for the city to hire a full time Purchasing and Fixed Assets Clerk, the Mayor requested a motion to hire an individual for the position of Purchasing and Fixed Assets Clerk at a starting salary of \$38,000 + benefits. Alderman Slay then made a motion to extend an employment offer to an individual for Purchasing and Fixed Assets Clerk for the City of Gluckstadt, at a salary of \$38,000 annually, plus employment benefits such as health insurance, retirement and supplemental benefits offered by the city; employment with the city is contingent upon successful passage of all necessary background checks, such as criminal background, driving history, and drug screening. Seconded by Alderwoman Bates.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderman Slay, Alderwoman Bates.

The Mayor declared the motion carried.

D) Personnel Matters: Consideration of Candidate Qualifications Extension of Employment Offer for Public Works Director

After discussion the candidate's qualifications at length and the need for the city to hire a full time Public Works Director, the Mayor requested a motion to hire an individual for the position of Public Works Director at a starting salary of \$70,000 + benefits. Alderwoman Williams then made a motion to extend an employment offer to an individual for Public Works Director for the City of Gluckstadt, at a salary of \$70,000 annually, plus employment benefits such as health insurance, retirement and supplemental benefits offered by the city; employment with the city is contingent upon successful passage of all necessary background checks, such as criminal background, driving history, and drug screening. Seconded by Alderman Powell.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderman Slay, Alderwoman Bates.

The Mayor declared the motion carried.

E) Personnel Matters: Consideration of Candidate Qualifications Extension of Employment Offer for Crew Leader II, Public Works Department

After discussion the candidate's qualifications at length and the need for the city to hire a full time Public Works Crew Leader II, the Mayor requested a motion to hire an individual for the position of Public Works Crew Leader II at a starting salary of \$35,360 + benefits. Alderman Powel then made a motion to extend an employment offer to an individual for Public Works Director for the City of Gluckstadt, at a salary of \$35,360 annually, plus employment benefits such as health insurance, retirement and supplemental benefits offered by the city; employment with the city is contingent upon successful passage of all necessary background checks, such as criminal background, driving history, and drug screening. Seconded by Alderman Slay.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderman Slay, Alderwoman Bates.

The Mayor declared the motion carried.

Motion to leave Executive Session:

The Mayor then asked for a motion to leave Executive Session.

Within the Executive Session, Alderwoman Bates made a motion to leave Executive Session and re-enter open session, Seconded by Alderman Powell.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Bates, Alderman Slay.

The Mayor declared the motion carried and the board re-entered open session.

A public announcement was made that the Board had voted in Executive Session to extend employment offers to three individuals for the positions of Purchasing and Fixed Assets Clerk, Public Works Director, and Public Works Crew Leader. Additionally, the Board approved the revised July 11th, 2023 Regular Meeting minutes.

No further action was taken.

Adjourn

There being no further business before the Board of Aldermen, Alderman Powell made a motion to adjourn, Seconded by Alderman Slay.
