The Madison County Board of Supervisors and the City of Gluckstadt are submitting an application for roadway improvements to Weisenberger Road. Madison County will provide 100% of the costs for the Environmental Phases Services, Preliminary Engineering Services, Right-of-Way Acquisition Services and Utility Relocation Services for the project.
