- -Assist with Boswell site redevelopment.
- -Continue to support medical services.
- -Pursue initiatives that would support existing and new wood product industries.
- -Continue to diversify GREDA membership and include updates from local partners/organizations.
- -Engage young Entrepreneurs.
- -Airport reactivation.
- -Replenish GREDA capital funds.

- -Central School strategic plan.
- -Hwy 35 secondary effects.
- -Education MN North/Hwy 35 industry.
- -Blocks 20&21.
