**Motion made by Commissioner Learmont, Seconded by Council Representative MacGregor to elect Commissioner Stella Leone to the position of Human Rights Commission Vice Chair. Voting Yea: Commissioner Learmont, Commissioner Grossman, Council Representative MacGregor, Commissioner Pope-Sears, Commissioner Ducharme Voting Abstaining: Commissioner Leone. Motion Passed.**

PRESENTATION:

1. Itasca Pride

Karter Starling came to give an update to the HR Commission on what's coming up for Itasca Pride this year. They are in their last year of planting trees for the grant that they received. They would like volunteers to assist with the pancake breakfast again this year for the Itasca Pride celebration. It will be held on Sunday, June 14th from 10am to 5pm and the theme will be "Friends of Dorothy Beyond the Rainbow". He added that the volunteers could do prep-work with them the night before at their office at Central School. Commissioner Leone and Council Representative MacGregor said that they would volunteer to be pancake workers on Saturday, June 13th.

3. 2026 Workplan

Former City Councilmember Barb Sanderson joined the Human Rights Commission meeting this evening. She discussed Indigenous People's Day and spoke about how the Human Rights Commission was formed back in December of 2004 of which she was instrumental in its forming. The first IPDay was a big success in 2015 with a big pow-wow in the Kramer's parking lot and a thousand people attended.

She also discussed how a plaque gets passed around at the University of Madison, Wisconsin, which helps remind the citizens that their city is on native land. It would be nice to do something like that in Grand Rapids, or even something like a welcome sign in each storefront written in Ojibwe. Former City Councilmember Sanderson stated that in order to make a difference with Indigenous People's Day, the Tribe needs to be more involved, even if the Human Rights Commission decides to purchase a plaque like University of Madison does, to move around in the city.

A work group for Indigenous People's Day was set up to include Commissioners Leone,

Ducharme, Pope-Sears and Council Representative MacGregor. They will need to reach out to the Tribal members as soon as possible for Indigenous People's Day.

Announcement from Council Representative MacGregor that the Braver Angels for July will probably not be happening.

Also Commissioner Leone said that there are events coming up such as the 4 Directions Festival, ADA Pride Month in July and Dissolve the Divide, all can be added to the agenda in June.

4. Grand Rapids Area Human Rights Fund Draft-Community Foundation

Commissioner Learmont gave the Commission his latest draft for review and discussion. The Commission discussed how funds from the private sector can't co-mingle with the public sector and the importance of appointing an advisor. Commission Chair Miller will make an appointment to talk to the City Administrator and Mindy at the Community Foundation regarding where they are with this Draft.

5. Walk for Life-September

This item was tabled until the June agenda. The Commission may ask them to come and present their upcoming event.

7. City Council Updates

Council Representative MacGregor said that Commission Chair Blomquist's resignation was accepted by the City Council on April 27th, 2026.
