UPDATES

1. Commonwealth Development Project

- 30–40 unit apartment building planned for 400 block of 10th St SE.
- Application to Minnesota Housing Finance not approved this year.
- May resubmit next year awaiting confirmation.

2. King Lake Apartments

- HRA project proposal for 60+ new units on existing property.
- Includes land trust and family housing components.
- Application still pending; hopeful for funding.

3. Farm Co-op Redevelopment

- Grant submitted to IRRRB.
- Environmental planning underway: Response Action Plan and Construction Contingency Plan in progress.
- Additional submission required to MN Dept. of Agriculture for ag chemical removal.
- Identified chemicals: mainly fertilizers and crop products manageable issue.

4. Amazon Construction

- Construction ahead of schedule; foundation and slab work completed.
- Spring opening expected.
- Ribbon-cutting ceremony planned.

5. Library Area Construction

- Focused on parking lot and site prep.
- Material delays likely cause of slow progress (precast concrete pieces).

6. Highway 2 West Corridor

- Preferred design options presented to City Council (August 11).
- 5-year phased project led by MnDOT.
- Coordination continuing between EDA, MnDOT, and local businesses.
- Business concerns: access consolidation/removal.
