BACKGROUND:

The council directed staff to solicit for criminal prosecution services. Three proposals were received from Aaron Michels, Patrick Moren, and Todd Webb. The proposals and summary sheet are attached for review.

City staff are recommending entering into a five-year agreement with Aaron Michels for legal criminal prosecution which is attached for review.

II. GENERAL INFORMATION:

Since 1968, Moren attorneys have achieved results for clients in Roseau, Minnesota and throughout Northern Minnesota. We are a general practice law firm with extensive experience in many areas, including, but not limited to: municipal law, criminal law (prosecution), family law, estate planning, agriculture law, probate, real estate, civil litigation, and drainage law.

The primary contact for this proposal is Michelle Moren. As the current City of Roseau attorney and Acting Lake of the Woods County attorney, Michelle Moren's principal responsibilities from the criminal prosecution standpoint include review of officer reports, conferences with officers (in person and remote), assistance with search warrants (criminal and administrative), making charging decisions, drafting criminal complaints, prosecuting all levels of criminal offenses, court appearances, victim contact, negotiating plea bargains or trying cases, civil forfeitures, and all other aspects of criminal prosecution services.

Michelle Moren also provides prosecution services for the City of Baudette and is the City Attorney for the following small cities: Williams, Badger, Greenbush, Stephen, and Lake Bronson.

The Law Offices of Patrick D. Moren currently employs two licensed attorneys and will expand to three licensed attorneys when the law clerk passes the Minnesota Bar Examination. Pending bar passage, we will request that the City of Grand Rapids authorize William Woolever to work on criminal prosecution matters and to make court appearances as a supervised practitioner in accordance with the Minnesota Board of Law Examiners rules. Approval has been granted by both the City of Roseau and Lake of the Woods County.

At the Law Offices of Patrick D. Moren, Michelle Moren has over thirty years of experience practicing municipal law, criminal law and related fields. Michelle Moren started prosecuting for the City of Roseau in 1991. Thereafter, she was elected as the Roseau County Attorney and was in that role from 1995 to 2006, when she elected to go back into practice with her father. She has been a prosecutor since that time and has acted as the Lake of the Woods County Attorney three separate times with the most recent starting in August of 2023. Jacqueline Mosher has been learning the areas of municipal law and criminal law under the training of Michelle Moren. Jacqueline Mosher also has extensive knowledge of courtroom practice and procedure, as a former law clerk to the Honorable Donna K. Dixon, Judge of District Court. As a law clerk, William Woolever has been practicing under the supervised practice rules with Michelle Moren's guidance. William Woolever has appeared in court on a number of City of Roseau criminal prosecutions and has also drafted criminal complaints, reviewed reports for charging determinations, consulted with officers, prepared memorandums following contested criminal omnibuses, negotiated plea agreements, and has had communications with crime victims.

As stated, the primary office of the Law Offices of Patrick D. Moren is in Roseau, Minnesota at 309 3rd Street NW, with a small satellite office located in the North Loop of Minneapolis. Our

Two legal secretaries, Deb Strandlund and Kathleen Ross, ensure the office runs smoothly and efficiently. Ms. Strandlund's practice areas include criminal law, family law, and real estate. She has been employed by the law office for over thirty years. Ms. Ross' practice areas include probate, estate planning, and civil litigation. She has been employed by the law office for over twelve years. It is anticipated that if the Law Offices of Patrick D. Moren were awarded the city prosecutor attorney services, it would hire a part-time legal secretary/assistant to focus on providing services to the City of Grand Rapids unless the City currently has an employee for this position.

The Law Offices of Patrick D. Moren is a thriving, busy practice. Because of technology for remote work, our office is capable of being available for criminal proceedings when needed, both remote and in person (see below):

On February 3, 2025, the Minnesota Judicial Branch revised their Court Operations Policy and Procedure for Remote and In-person hearings, which provides that a majority of criminal matters will be heard remotely via Zoom. Itasca County provided a written deviation to the guidelines which requires that all hearings be held in person if a defendant is in custody. As that could be a daily occurrence, Michelle Moren had recent communications with Itasca County Court Administration to determine if in-custody detention hearings could be held via Zoom and the three sitting judges, through court administration, indicated their willingness to allow those types of hearings to be held remotely.

III. POLICE:

As the City of Roseau attorney, City of Baudette prosecutor, and Acting Lake of the Woods County attorney, the Law Offices of Patrick D. Moren is adept at working closely with law enforcement whether it be the Roseau Police Department, Roseau County Sheriff's Office, Lake of the Woods Sheriff's Office, Minnesota State Patrol, or Minnesota Department of Natural Resources. Our office is confident that it understands the needs and demands of the City of Grand Rapids Police Department.

A review of the Minnesota Bureau of Criminal Apprehension website reveals approximately 148 DWI investigations in the City of Grand Rapids from January 1, 2024, through February 17, 2025. A review of the Itasca County court schedule also reveals a high number of prosecution cases for the acting City Prosecutors.

With the number of cases cited and court proceedings, we estimate that approximately 20-25 hours per week will need to be dedicated to the City of Grand Rapids by the prosecuting attorney(s) also likely another 15-20 hours per week for support staff will be needed (unless provided) to complete necessary discovery disclosures, process reports, e-file necessary documents, file exhibits with MNDES, and provide statutorily required victim notices.

FEES:

The Law Offices of Patrick D. Moren proposes a yearly flat fee of \$115,000.00 if support staff is provided. If support staff is not provided, then the flat fee proposed would be \$145,000.00 with a salary of approximately \$30,000.00 allocated to part-time support staff. The flat fee would increase each year according to the city staff cost of living adjustment.

Retainer—we do not require a retainer from our municipal clients, instead additional
fees are added to our monthly billing statement.

Items proposed to be itemized and billed separately (list is not comprehensive):

- 1. Flash Drives: currently \$3.00 per flash drive.
- 2. CDs: currently \$7.50 per CD.
- 3. Copy Fees: currently 25¢ for black and white; 35¢ for color.
- 4. E-Charging Fee: to be determined with the cost divided among municipal prosecution clients.

- 5. Bureau of Criminal Apprehension's Criminal Justice Data Network Fee: to be determined with the cost divided among municipal prosecution clients.
- 6. Postage fees: at the current postage rate (will vary each month).

All itemized fees are subject to change. Mileage will not be billed.

II. Hourly Billing-

Hourly fees and costs the firm will charge for providing legal services to the City of Grand Rapids that fall outside the duties covered by the Retainer will be \$235.00 per attorney in accordance with our municipal rate for 2025. This municipal fee is subject to a yearly change. The Law Offices of Patrick D. Moren bills in fifteen (15) minute increments. If the City elects the flat fee, we request that we not be required to provide an itemized, incremental billing statement and would request that we provide instead a general monthly non-itemized statement; provided however if the City requests legal services outside of the scope of prosecution services, we will provide an itemized statement.

General Information:

I am interested in the Grand Rapids City Prosecuting Attorney position. My deep connection to Grand Rapids, and experience practicing law in Minnesota and throughout Alaska, make me the ideal fit for this position.

I grew up in Grand Rapids and graduated from Grand Rapids High School in 2000. I received my bachelor's degree from the University of Wisconsin - Stevens Point in 2004. After graduating from college, I worked as a wildland firefighter for the U.S. Forest Service in Deer River and then as a sports and outdoors writer for the Hibbing Daily Tribune, before attending the University of St. Thomas School of Law in Minneapolis. I graduated and was admitted to the Minnesota Bar in 2010 and performed a full-time internship at the Itasca County Attorney's Office during the summer of 2009. I worked as a judicial law clerk for Judge Gary J. Pagliaccetti in Virginia, Minnesota, for over a year, from March 2011 until April 2012, working at times for all three judges in Virginia, including Judge James B. Florey and Judge Terrence M. Aronson.

I moved to Alaska in 2012 and was a criminal prosecutor in Alaska from 2012 to 2016. I worked as an assistant district attorney in the Kotzebue District Attorney's Office for nearly three years, along with one other attorney. Our support staff consisted of one secretary and one paralegal. We prosecuted all the criminal cases that occur in the Northwest Arctic region of Alaska. My job consisted of managing my half of the Kotzebue criminal docket (we split nearly 1,000 cases per year alphabetically) in all stages of proceedings including charging decisions, arraignments, grand jury presentations, plea negotiations, motion work, and trials. My caseload consisted of everything from violation-level offenses to the most serious felonies. I have also served in the Palmer, Bethel, and Ketchikan District Attorney's Offices. I had the opportunity to return to Kotzebue in 2016 as the magistrate judge. In this position I was responsible for presiding over a wide variety of cases including minor offenses, misdemeanors in all stages, pre-indictment felonies, various civil matters, delinquency, child in need of aid (CINA), and protective orders. In my free time, I pursued the spectacular hunting, fishing, and trapping opportunities that Kotzebue offers. After leaving Kotzebue, I covered the Utqiagvik magistrate judge position remotely for three months. I was an Alaska magistrate judge for seven years.

In 2023, our family, including my wife and our three daughters, left Alaska to move back home to Grand Rapids. Since 2023, I have worked as a prosecutor again for the State of Alaska, now living in the Grand Rapids area and working remotely for the Utqiagvik District Attorney's Office. I have been a criminal prosecutor for five-plus years in total. For the past 13 years I have been practicing criminal law as a prosecutor, or on the bench, and have been in court, in person or remotely, on almost a daily basis. Grand Rapids has always been home. I am happy to be back home with my family, living - hunting, fishing, playing sports - and taking part in this community again. I care deeply about the safety of this community. Keeping Grand Rapids safe from crime is one of the most basic and important things we can do to maintain a high standard of living. I want to do my part.

Please accept this letter and attachments as my proposal for provision of prosecuting attorney services for the City of Grand Rapids. I would like a new challenge in my legal career and would appreciate the opportunity to provide long-term, quality prosecution services to my hometown.

I currently serve as Chief Assistant Itasca County Attorney – Criminal Division. I am a trial lawyer with over 30 years of experience prosecuting crimes ranging from misdemeanors to murder. I also supervise four attorneys and one staff working in our office and provide training to law enforcement officers.

The attachments include my resume and recommendation letters. It is my hope that this information serves to give you insights into the type of team member and prosecuting attorney I would be serving as Grand Rapids City Prosecutor.

Through my 25+ years of working as a prosecutor in Itasca County, I have also developed strong work relationships with the members of the Grand Rapids Police Department. I would encourage you to seek the input of Chief Morgan, Captain Ott, Captain Nelson, other officers, and department staff as to the virtues of my application. I would also encourage you to seek the input of Mr. Sterle, who has known me personally and professionally throughout much of my time living and working in our community.

Same as Mr. Dimich's circumstances throughout his long service as Grand Rapids City Prosecutor, I will not have a formal back-up plan in case of illness. I am aware that this lack of formality created no major disruptions in Mr. Dimich carrying out his duties. I would seek to make informal plans with Itasca County and/or other prosecutors who work in Itasca County for short-term coverage in the event I am unavailable. I would also seek continuances from the court in these circumstances.

Time appears to be of the essence as Mr. Shaffer's contract ended last month. In addition, Mr. Dimich's temporary remote work does not fulfill the essential functions of the position by not attending required in-person hearings such as jail court hearings, contested omnibus hearings, pre-trial settlement conferences, trials, and contested probation violation hearings.

It will not take long for defense attorneys and defendants to become aware of this issue and demand contested hearings and trials within time limits set by the Criminal Rules of Procedure. The time limit for an omnibus hearing is 42 days from their first court appearance. The time limit for a trial for a gross misdemeanor or a misdemeanor is 60 days from the demand and 10 days from the demand if the defendant is in custody for a misdemeanor. The time limit for a probation violation hearing is seven days if the defendant is in custody.

Compensation and office support/physical plant are the main areas of discussion from my perspective.

The total compensation for my current position in 2024 was \$189,931.82, which included a base compensation of \$138,226.06 + \$51,705.76 in benefits.

I spoke with Mr. Shaffer and reviewed his prosecution services contract with Grand Rapids. It was a five-year contract with "a flat fee of \$63,000 for the calendar year of 2025, \$64,890 for the calendar year of 2026, \$66,836 for the calendar year of 2027, \$68,841 for the calendar year of 2028 and \$70,907 for the calendar year of 2029." It is my understanding that the prosecution services contract with Grand Rapids has remained relatively unchanged for about 20 years.

I spoke with Mr. Borland and reviewed his prosecution services contract with Hibbing. The contract began in 2024 with annual renewals. Compensation includes \$100,000 per year, \$160 per hour for appeal work, and costs paid by City to access law enforcement and BCA records and programs.

My proposed contract terms regarding compensation seek to minimize the reduction in compensation and benefits as compared to my current position and to consider the current compensation disparity between Grand Rapids and Hibbing despite having almost identical case filings.

My proposed contract terms regarding office support/physical plant also seek to minimize the reduction in compensation and benefits as compared to my current position by utilizing existing City office support/physical plant.

My proposed contract terms also seek to provide stability and consistency in the delivery of prosecution services. The City enjoyed a long-term relationship with Mr. Dimich, who lived and worked in our community. The contract with Mr. Shaffer, a Duluth resident, was short-lived, and should serve as evidence for the City to consider in making future decisions to contract with an attorney with no strong ties to our community. My proposal provides for the same type of long-term relationship, as I have lived in Grand Rapids and worked as an Itasca County prosecutor for 25+ years.

My proposed terms include the following:

Duration: April 1, 2025 - December 31, 2031

\$90,000 (prorated for nine months) for the calendar year of 2025. \$96,000 for the calendar year of 2026, \$102,000 for the calendar year of 2027, \$108,000 for the calendar year of 2028, \$114,000 for the calendar year of 2029, \$120,000 for the calendar year of 2030, and 126,000 for the calendar year of 2031. Payments in monthly installments.

30-day notice of contract termination by City; 60-day notice of contract termination by Attorney

City to provide/pay for the following:

Office in City Hall or near City Hall and Courthouse that provides privacy for sensitive matters

and remote court hearings and resources for office support including but not limited to laptop computer, VPN, computer hardware/software, hardware/software support, multiple monitors, webcam, printer/scanner, cell phone and data plan with hotspot, headphones, space heater, office furnishings, postage, office supplies, and support from GRPD administrative/secretarial staff that including but not limited to case file management, preparation/filing of court documents, and processing discovery

Office/resources for office support/GRPD administrative/secretarial staff may be used for delivery of prosecution legal services to other jurisdictions if contracts occur between other jurisdictions and me.

Attorney malpractice insurance, attorney licensing, continuing legal education training including costs of travel, lodging and meals, and access to court/law enforcement records and programs and those associated with the court process including document service, discovery, and trial preparation.

Health/Dental/Vision/Life Insurance for my wife and I – same plan as City employees

Single Adult Pass, 2-person Cart Pass, Range Pass and Simulator Pass at Pokegama Golf Course.

I have no conflicts of interest in serving as Grand Rapids City Prosecutor.

I will be on vacation from February 26, 2025 – March 3, 2025.

I look forward to further discussion with City officials.

Mr. Webb has been my supervisor at the Itasca County Attorney's Office (ICAO) since I started my career as a criminal prosecutor in May of 2022. I entered this position with approximately six months of experience as a practicing attorney, and with almost no criminal experience. I am now a felony prosecutor.
