A discussion ensued on the funding of a downtown organization, location of office space and the role of the executive director.

4. Consider the adoption of a resolution approving a Preliminary Development Agreement between GREDA and Commonwealth Real Estate Acquisitions, LLC

Commonwealth Real Estate Acquisitions, LLC has submitted a Letter of Intent for 1.8 acres located on SE 10th Street parcel 91-028-1208. The developer is proposing a 32 unit affordable housing apartment complex.
