2. Artists in Residence Follow-Up

The Commission reviewed and discussed the Artist's Feedback. Some of the discussion about the Artists in Residence that the Commission brought up were being open on weekends, security issues, the timeframe of the artists residency and the need for something for them to transition to after their residency. There will be new artists moving in this week.

The discussion continued as to the rental prices and possibly subsidizing a space for the artists in the building. City Administrator Tom Pagel said that to fix all of the concerns of the building would be approximately 7.8 million. He also said that he would listen to and entertain ideas for uses for Central School, but would have to look at the City's Downtown Comprehensive Plan.

3. NE Neighborhood Art Project

Discussion on the worksession with the artist Greg Mueller. MacRostie Program Manager Emily Carlson suggested that the worksession be rescheduled to August 6th, with a rain date of August 7th at the NE Neighborhood site. She asked the Commission to check their schedules and she'll check with the artist, and if he can't do August, we'll try for September.

Riverfest 2024

Commissioner Squadroni showed the ideas he gathered for art at Riverfest that he brought to the last Commission meeting. The Commission also pondered incorporating the photos of the Blandin Art with the goal in mind that this is for people at the festival to make art. Commissioners Squadroni and Fox will work on printing.

6. True North Salone-Central School Sculpture - Ashley

Ashley of the True North Salon back in April had an idea for the Central School grounds. It was discussed as to what the next step would be, possibly be folding it into the full renovation of Central School.
