### Police Community Advisory Board Meeting June 3, 2021 IRA Civic Center 4:30 – 6:00 pm

**3. Approval of the Minutes:** Motion made by Connolly, seconded by Butterfield, to approve minutes from April 6, 2021 with minor corrections. Passed unanimously.
