3. Welcome New & Returning Commissioners

The Welcomed and introduced themselves to new Commissioner Sara Slaubaugh. They also thanked the returning Commissioners who were re-appointed.

4. Riverfest 2024

Discussion revolved around the possible options for public art at next year's Riverfest. The Commission talked about last year's art featuring Tom Page, the feedback they received and that they could brainstorm to get some ideas for more visible, engaging or interactive art for this year.

UPDATES:

5. NW Neighborhood Art Project

Discussion of Agenda Items 5 & 6 combined. The NW Neighborhood Art Project started a couple of years ago as goal of the Commission's Master Plan to place art in each of four of the city quadrants. The art would not only be a neighborhood identity, but enhance the community. The NW Neighborhood Art Project Area has been put on hold. There is a possibility of improving the park so that the area has better exposure and is more inviting to the public.

City Administrator Tom Pagel met with the Blandin Foundation to discuss their planning assistance with the park's improvements and what economic impact it would make to the community. There will be a follow-up meeting with the Blandin Foundation to include both the Community Development Director Rob Mattei and the Director of Parks and Rec/Yanmar Arena, Dale Anderson. City Administrator Tom Pagel will ask Program Manager Emily Carlson from the MacRostie to send a letter to the three artists letting them know that everything is on hold and that the timeframe has been pushed into the future.

6. NW Park Design Timeline

7. Blanket Exercise

Commissioner Peterson discussed the Blanket Exercise. It would take approximately an hour and a half and consists of a Blessing, a Meal and the Exercise. The Commission would like to invite the Human Rights Commission and the City Council. The tentative date for the Blanket Exercise will be April 8th after the City Council meeting, scheduled at Yanmar Arena.

8. Band Map

The Pokegama Band Map is a map being researched by Karen Noyce of the inhabited lands of the area prior to the Pokegama Reservoir being created. When completed, the Arts & Culture Commission will continue to discuss how they can invest in and assist with the map's structure for public display.

9. Mayor's Art Award Review

The Mayor's Art Award is an award for businesses that support the arts. Out of four nominations from the Arts & Commission, the public chose the "Night Makers Market". They were awarded the newly created award, now the standard, of a blue pinecone with their name on it to display.

ANNOUNCEMENTS:

City Administrator Tom Pagel said that the Blandin Foundation is looking to move the mural on their building to another location.
