4. Resignation of Commissioner Anne-Marie Erickson
The resignation of Commissioner Anne-Marie Erickson was approved at the July 25, 2022 City Council Meeting.
5. Mayor's Art Award
The results were tallied for the Mayor's Art Award. They were based upon a total number of points for each nominee. Kathy Dodge came out very strong. The award will be given at Riverfest and because she is not here, it should go to Steve. Commission Chair Hedlund will have a conversation with Steve as to how to honor Kathy winning the award.
Motion made by Commissioner Gorman, Second by Commissioner Peterson to recommend that the Mayor's Art Award be given to Kathy Dodge. All in favor, motion passed.
6. Art Plan and Goal Setting
The first target for the Neighborhood Meetings was the Forest Lake area that is west of Highway 38, east of 17th Ave NW and north of 4th St NW. Commissioner Gorman to draft a letter and will follow up with examples of art around town. Commissioner Gorman will update the letter, will check on dates with City Councilor Connelly and follow up with Commissioner Zabinski. City Administrator Pagel to meet with Commission Chair Hedlund and Commissioner Gorman after this meeting to coordinate the meeting date and place.
7. KAXE Art Project
City Administrator Tom Pagel to check on the delivery status of the art project.
8. Duane Goodwin
 - Unveiling Event
The unveiling will be on Indigenous People's Day, October 10th, 2022 at 4pm, so the City Council can attend the pipe and drum ceremony. City Administrator and Commissioner Peterson will reach out, coordinate and assist with the planning and come back with a cost at the September meeting.
 - Interview: Leah Lemm
The Commission would like to see a proposal for the interview from either Leah Lemm or Scott, the reporter from Lakeland.
9. Portrait Artist at Riverfest
The Commission discussed the Riverfest Portrait Artist from last year and said that he was open to ideas for this year.
10. Chalk Drawing Vendor
There was no discussion, but one of the Commissioners asked about a face painter and the consensus was, no.
11. Added Agenda Item #11, Nightmaker's Market. Commissioner Gorman described that this is a group of vendors selling for non-profit. They request the use of various spaces around the area for an evening and the funds that they receive for their homemade goods go to a specific

charity chosen for that month, such as Great Tails Foster Care. They have held their event at Hotel Rapids and they do have a proposal with EDA to use a space.
