2025 COMMUNITY SURVEY RESULTS

In September of 2025, the City issued the following community survey questions. The purpose of the survey was to get community feedback on key city initiatives that the council will be address in the nearer future. The survey was hosted on the city's webpage with the public notified through Facebook posts and local media outlets.

1. Do you live within the city limits of Grand Rapids?



 Action Item – In order to assess the accuracy of the survey Chatgpt was asked the following: "What is the statistical accuracy of a survey with 364 responses out of a population of 11,300 people?. It calculated a Margin of Error (95% confidence) = +/-5.1%

COMMUNITY DEVELOPMENT

2. The City updated its comprehensive plan in 2020. This plan guides the planning commission and city council in how the city should devel op. Did you participate in the planning process?



• Action Item – The City will likely begin the process of updating its comprehensive plan in 2027. When this occurs, the City typically mails a survey, through the US Postal Service, to every property owner in the city. Regardless of this effort, people continue to not be aware of the process which legally binds the city council on future land use decisions. Between now and the update, the Community Development Department will research and develop a communication plan in an effort to educate more residents and property owners on the importance of participating in the comprehensive planning process.

3. How would you rate WALKABILITY in the downtown area on a scale of 1 (worst) to 10 (best)?






• Action Item – The community rated walkability in the downtown area as slightly above average. The biggest challenge as identified in past studies, is crossing TH 2 and TH 169, which carry up to 20k vehicles per day. MNDOT has recently completed a corridor study for both highways in the downtown area which will address pedestrian travel. The agency is focusing on securing funding for improvements before further design development occurs. This is anticipated to occur in the next two to three years.


4. How would you rate VARIETY OF RESTAURANTS in the downtown area on a scale of 1 (worst) to 10 (best)?






Action Item – The community feels that the variety of restaurants in the downtown area
is about average. This is after two higher end dining establishments have opened. With
the creation of the Downtown Business Marketing group, it is the goal to get more
visitors to the DBA which should encourage more restaurants to open.

 Action Item – The community feels that the variety of shopping in the downtown area is slightly below average. With the creation of the Downtown Business Marketing group, it is the goal to get more visitors to the DBA which should encourage a variety of more stores to open.

 Action Item – The community feels parking in the downtown is about average. The city has developed a plan for the reconstruction of a city parking lot between Pokegama Avenue North and 1st Avenue NE. 7. How would you rate DRIVABILITY in the downtown area on a scale of 1 (worst) to 10 (best)?






Action Item – The community rated drivability in the downtown area as average.
 MNDOT has recently completed a corridor study for both highways in the downtown
 area which will address drivability. Especially northbound traffic on Pokegama Avenue,
 from 2nd Street North through 4th Street North (TH 2). The agency is focusing on
 securing funding for improvements before further design development occurs. This is
 anticipated to occur in the next two to three years.

9. Please provide any suggestions for improvements that would increase the vitality of the downtown area.


Action Item - A complete listing of suggestions is located in Appendix A of this report.










are not aware of its existence.


22. In addition to the County's Emergency Alert System, would you like to see the city upgrade and expand its existing emergency siren syst em?




Action Item – Taking into account the survey margin of error, the public is likely split on

PUBLIC WORKS/ENGINEERING

 Action Item – A majority of the surveyors felt that Public Works removed snow in a timely manner. The Public Works Director and staff should continue to review their process and technique and make adjustments as necessary.

• Action Item – Similar to streets the Public Works Director and staff should continue to review their process and technique and make adjustments as necessary.

29. Currently, there are outdoor rinks in the NE, SE, and SW quadrants of the city. Do you agree that a rink in the NW quadrant of the city is needed?




Action Item – The respondents are split on the need for an additional rink in the NW

low cost opportunity presents itself.



40. Do you believe the City should make the investment to maintain the Central School?




• Action Item – Overwhelmingly the public wants the city to invest in Central School. City staff will continue to pursue non-city funding to assist in this project.
