GENERAL APPLICATION FOR REVIEW

- 1. Development Review Permit for outdoor furniture selection at the McKnight Center outdoor seating area, and master sign program amendment, and mural proposal (23PLN-24) Location: 111, 117, 129 and 151 W McKnight Way (APN: 029-350-07 & 09)
 - Recommendation: 1. That the Development Review Committee approve the outdoor furniture concept proposed for the outdoor spaces at the McKnight Crossing shopping center as presented, or as may be modified by the DRC, which includes the following actions: a. Determine the project Categorically Exempt pursuant to Section 15301, Class 1, of the California Environmental Quality Act (CEQA) and Guidelines, as detailed in the staff report; b. Adopt Findings of Fact for approval of the Development Review Permit as presented in the Staff Report; and, c. Approve the Development Review Permit in accordance with the Conditions of Approval, as presented in this Staff Report.
- 2. Development Review and Variance Request for the Sierra Guest Home Expansion for a total of 27 rooms, including two full apartment units, for Supportive Housing use consistent with state requirements. The Variance request is for encroachment of a rear addition into the 20-foot rear setback and exceeding the 50% lot coverage limit (23PLN-28) Location: 131 Glenwood Avenue (APN:035-270-035)

Recommendation: 1. That the Development Review Committee recommend that the Planning Commission approve the Development Review and Variance applications for the expansion of the Sierra Guest Home at 131 Glenwood Avenue as presented, or as modified by the Development Review Committee, which includes the following

actions: a. Determine the project Categorically Exempt pursuant to Section 15305, Class 1, of the California Environmental Quality Act (CEQA) and Guidelines, as detailed in the staff report; b. Adopt Findings of Fact for approval of the Development Review Permit as presented in the Staff Report; and, c. Approve the Development Review Permit for the expansion of the Sierra Guest Home in accordance with the Conditions of Approval, attached to the Staff Report. d. Approve the Variance request for encroachment of a rear addition into the 20- foot rear setback, and exceeding the 50% lot coverage limit.
