<u>Recommendation</u>: Approve the attached equipment inventory as well as the associated annual report, renew previously adopted ordinance #815 pursuant to requirements of AB-481

**Background Information:** On 04/26/2022, the City Council heard and adopted its first reading of Ordinance #815 related to the police military equipment use policy (attached), pursuant to the requirements of AB-481, in accordance with Government Code 7070 et al. This was done to ensure the City of Grass Valley and its police department were in compliance with the new legislative changes. Now that we are multiple years into the policy, part of maintaining compliance is an annual report to City Council, updating the military equipment and policy as necessary, making the information public, and holding a meeting to discuss the policy and equipment with members of the public. The goal of this report and action of the Council is to ensure full compliance and transparency with the legislative requirements.

#### Analysis/Discussion:

There have been no legislative changes to Government Code 7070, GVPD Policy 706, and/or City of Grass Valley Ordinance 815 since their adoption.

Government Code Section 7070 (c) defines "Military equipment". The attached Annual Inventory Report identifies equipment utilized by GVPD that matches those definitions. It also indicates the quantity of any equipment utilized during calendar year 2023, pursuant to the requirement of 7072(a). Additional information is included in the written report (attached).

The governing body shall only approve a military equipment use policy pursuant to this chapter if it determines all of the following:

(A) The military equipment is necessary because there is no reasonable alternative that can achieve the same objective of officer and civilian safety.

(B) The proposed military equipment use policy will safeguard the public's welfare, safety, civil rights, and civil liberties.

(C) If purchasing the equipment, the equipment is reasonably cost effective compared to available alternatives that can achieve the same objective of officer and civilian safety.

(D) Prior military equipment use complied with the military equipment use policy that was in effect at the time, or if prior uses did not comply with the accompanying military equipment use policy, corrective action has been taken to remedy nonconforming uses and ensure future compliance.

Staff has reviewed these safeguards and finds that all of them have been met to the best of the police department's knowledge, training, and experience.

The governing body (City Council) shall review any ordinance that it has adopted pursuant to this section approving the funding, acquisition, or use of military equipment at least annually and, vote on whether to renew the ordinance at a regular meeting. The governing body shall determine, based on the annual military equipment report submitted pursuant to Section 7072, whether each type of military equipment identified in that report has complied with the standards for approval set forth above. If the governing body determines that a type of military equipment identified in that annual military equipment report has not complied with the standards for approval, the governing body shall either disapprove a renewal of the authorization for that type of military equipment or require modifications to the military equipment use policy in a manner that will resolve the lack of compliance.

The police department believes that the military equipment used by, and in possession of, the police department, as well as the previously adopted policy and ordinance, complies with the standards of the law.

The police department will hold a public meeting no more than 30 days from the approval of this action item, where the general public may discuss and ask questions regarding the annual military equipment report and the law enforcement agency's funding, acquisition, or use of military equipment (Government Code 7072(b)). We will also post our annual report and associated documents to the police department webpage (Government Code 7072(a)).

Any item sought as documented on the attached Annual Inventory Report will be acquired utilizing departmental budgeted funds. In the case of UAS (drone) replacement, any request for acquisition in FY25/26 (calendar year 25) will come to the City council as an agendized item at a future meeting. Existing drone platforms are beyond their useful life, nearing end of life, or technology now exists for much more advanced platforms.

<u>Council Goals/Objectives</u>: The execution of this action attempts to achieve Strategic Goal #6 - Exceptional Public Safety

<u>Fiscal Impact</u>: Any costs will be budgeted in the police department budget, or made by special request if a need arises beyond acquisition requests included in this action.

#### ORDINANCE NO. 815

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GRASS VALLEY ADOPTING A POLICY FOR THE USE OF MILITARY EQUIPMENT BY THE GRASS VALLEY POLICE DEPARTMENT

WHEREAS, on September 30, 2021, Governor Gavin Newsom signed into law Assembly Bill 481, relating to the use of military equipment by law enforcement agencies;

WHEREAS, Assembly Bill No. 481 ("AB 481"), codified as Government Code sections 7070 through 7075, requires law enforcement agencies to obtain approval from their governing body before requesting, funding, acquiring, using, or collaborating in the use of military equipment, as defined in Government Code section 7070;

WHEREAS, any elected body that oversees a law enforcement agency with military equipment must adopt a military equipment use policy by ordinance at a regular meeting held pursuant to open meeting laws;

WHEREAS, the elected body must make specific findings before approving a military equipment use policy;

WHEREAS, the Grass Valley Police Department's proposed Military Equipment Use Policy (the "Policy") is attached hereto as Exhibit "A" and incorporated herein by this reference;

WHEREAS, a draft Policy was presented to before the City Council on March 22, 2022; and

WHEREAS, the Policy was published on the Grass Valley Police Department's internet website on March 23, 2022, more than 30 days before the Policy was considered at a public hearing before the City Council on April 26, 2022; and

WHEREAS, a public engagement meeting was held by the Police Department, open to the public, related to the Police Department's possession and use of military equipment on April 7, 2022; and

WHEREAS, the Policy meets the requirements of California Government Code section 7070, subdivision (d).

# NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GRASS VALLEY DOES HEREBY ORDAIN AS FOLLOWS:

## **SECTION I: DETERMINATIONS**

The City Council finds recitals above are true and correct and incorporates them herein. Based on the recitals and the information provided to the City Council at the public hearing on the Military Equipment Use Policy, the City Council finds as follows:

- 1. The military equipment identified in the Military Equipment Use Policy is necessary because there are no reasonable alternatives that can achieve the same objectives of officer and civilian safety.
- 2. The Military Equipment Use Policy will safeguard the public's welfare, safety, civil rights, and civil liberties.
- 3. The military equipment identified in the Military Equipment Use Policy is reasonably cost effective compared to available alternatives that can achieve the same objective of officer and civilian safety.
- 4. All prior military equipment use complied with the City's policies that were in effect at the time, or if prior uses did not comply with the accompanying Military Equipment Use Policy, corrective action has been taken to remedy nonconforming uses and ensure future compliance.

# SECTION II: IMPLEMENTATION

The City Council authorizes the Chief of Police to designate a Military Equipment Coordinator to implement the Policy.

#### SECTION III. SEVERABILITY.

If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this ordinance, or its application to any other person or circumstance. The City Council of the City of Grass Valley hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more other sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

# SECTION IV. PUBLICATION AND EFFECTIVE DATE

This ordinance shall be published in accordance with applicable provisions of law, by either:

publishing the entire ordinance once in a newspaper of general circulation, published in the City of Grass Valley, within fifteen (15) days after its passage and adoption, or

publishing the title or appropriate summary in a newspaper of general circulation, published in the City of Grass Valley, at least five (5) days prior to adoption, and a second time within fifteen (15) days after its passage and adoption with the names of those City Councilmembers voting for and against the ordinance. This Ordinance shall become effective thirty (30) days from and after the date of its passage.

#### **SECTION V. CEQA FINDINGS**

This ordinance is exempt from the California Environmental Quality Act ("CEQA") under 14 Cal. Code Regs. Section 15061(b)(3) because it can be seen with certainty that there is no possibility that its adoption will have a significant adverse effect on the environment and under Section 15378 because this ordinance is not a project because it involves administrative activities that will not result in direct or indirect physical changes in the environment.

# 706.1 PURPOSE AND SCOPE

The purpose of this policy is to provide guidelines for the approval, acquisition, and reporting requirements of military equipment (Government Code § 7070; Government Code § 7071; Government Code § 7072).

# 706.1.1 DEFINITIONS

Definitions related to this policy include (Government Code § 7070):

**Governing body** – The elected or appointed body that oversees the Department. (i.e. the Grass Valley City Council).

**Military equipment** – AB 481's definition of "military equipment" is not "equipment used by the military" or "equipment acquired from the military," but instead reaches 15 categories of equipment however acquired from whatever source:

- 1. Unmanned, remotely piloted, powered aerial or ground vehicles.
- 2. Mine-resistant ambush-protected (MRAP) vehicles or armored personnel carriers. However, police versions of standard consumer vehicles are specifically excluded from this subdivision.
- 3. High mobility multipurpose wheeled vehicles (HMMWV), commonly referred to as Humvees, two and one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached. However, unarmored all-terrain vehicles (ATVs) and motorized dirt bikes are specifically excluded from this subdivision.
- 4. Tracked armored vehicles that provide ballistic protection to their occupants and utilize a tracked system instead of wheels for forward motion.
- 5. Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units.
- 6. Weaponized aircraft, vessels, or vehicles of any kind.
- 7. Battering rams, slugs, and breaching apparatuses that are explosive in nature. However, items designed to remove a lock, such as bolt cutters, or a handheld ram designed to be operated by one person, are specifically excluded from this subdivision.
- 8. Firearms of 50 caliber or greater. However, standard issue shotguns are specifically excluded from this subdivision.
- 9. Ammunition of 50 caliber or greater. However, standard issue shotgun ammunition is specifically excluded from this subdivision.
- 10. Specialized firearms and ammunition of less than.50 caliber, including assault weapons as defined in Sections 30510 and 30515 of the Penal Code, with the exception of standard issue service weapons and ammunition of less than.50 caliber that are issued to officers, agents, or employees of a law enforcement agency or a state agency.

- 11. Any firearm or firearm accessory that is designed to launch explosive projectiles.
- 12. 'Flashbang' grenades and explosive breaching tools, 'tear gas,' and 'pepper balls,' excluding standard, service-issued handheld pepper spray.
- 13. Taser Shockwave, microwave weapons, water cannons, and the Long Range Acoustic Device(LRAD).
- 14. The following projectile launch platforms and their associated munitions: 40mm projectile launchers, 'bean bag,' rubber bullet, and specialty impact munition (SIM) weapons.
- 15. Any other equipment as determined by a governing body or a state agency to require additional oversight.

# 706.2 POLICY

It is the policy of the Grass Valley Police Department that members of this department comply with the provisions of Government Code § 7071 with respect to military equipment.

# 706.3 MILITARY EQUIPMENT COORDINATOR

The Chief of Police should designate a member of this department to act as the military equipment coordinator. The responsibilities of the military equipment coordinator include but are not limited to:

- (a) Acting as liaison to the governing body for matters related to the requirements of this policy.
- (b) Identifying department equipment that qualifies as military equipment in the current possession of the Department, or the equipment the Department intends to acquire that requires approval by the city council.
- (c) Conducting an inventory of all military equipment at least annually.
- (d) Collaborating with any allied agency that may use military equipment within the jurisdiction of Grass Valley Police Department (Government Code § 7071).
- (e) Preparing for, scheduling, and coordinating the annual community engagement meeting to include:
  - 1. Publicizing the details of the meeting.
  - 2. Preparing for public questions regarding the department's funding, acquisition, and use of equipment.
- (f) Preparing the annual military equipment report for submission to the Chief of Police and ensuring that the report is made available on the department website (Government Code § 7072).
- (g) Establishing the procedure for a person to register a complaint or concern, or how that person may submit a question about the use of a type of military equipment, and how the Department will respond in a timely manner.

# 706.4 MILITARY EQUIPMENT INVENTORY

The following constitutes a list of qualifying equipment for the Department:

# 706.5 APPROVAL

The Chief of Police or the authorized designee shall obtain approval from the city council by way of an ordinance adopting the military equipment policy. As part of the approval process, the Chief of Police or the authorized designee shall ensure the proposed military equipment policy is submitted to the city council and is available on the department website at least 30 days prior to any public hearing concerning the military equipment at issue (Government Code § 7071). The military equipment policy must be approved by the city council prior to engaging in any of the following (Government Code § 7071):

- (a) Requesting military equipment made available pursuant to 10 USC § 2576a.
- (b) Seeking funds for military equipment, including but not limited to applying for a grant, soliciting or accepting private, local, state, or federal funds, in-kind donations, or other donations or transfers.
- (c) Acquiring military equipment either permanently or temporarily, including by borrowing or leasing.
- (d) Collaborating with another law enforcement agency in the deployment or other use of military equipment within the jurisdiction of this department.
- (e) Using any new or existing military equipment for a purpose, in a manner, or by a person not previously approved by the city council.
- (f) Soliciting or responding to a proposal for, or entering into an agreement with, any other person or entity to seek funds for, apply to receive, acquire, use, or collaborate in the use of military equipment.
- (g) Acquiring military equipment through any means not provided above.

# 706.6 COORDINATION WITH OTHER JURISDICTIONS

Military equipment used by any member of this Department shall be approved for use and in accordance with this Department policy. Military equipment used by other jurisdictions that are providing mutual aid to this Department, or otherwise conducting law enforcement activities in this jurisdiction, shall comply with their respective military equipment use policies in performing such actions.

# 706.7 ANNUAL REPORT

Upon approval of a military equipment policy, the Chief of Police or the authorized designee shall submit a military equipment report to the city council for each type of military equipment approved within one year of approval, and annually thereafter for as long as the military equipment is available for use (Government Code § 7072).

The Chief of Police or the authorized designee shall also make each annual military equipment report publicly available on the department website for as long as the military equipment is available for use. The report shall include all information required by Government Code § 7072 for the preceding calendar year for each type of military equipment in department inventory.

# 706.8 COMMUNITY ENGAGEMENT

Within 30 days of submitting and publicly releasing the annual report, the Department shall hold at least one well-publicized and conveniently located community engagement meeting, at which the Department should discuss the report and respond to public questions regarding the funding, acquisition, or use of military equipment.

**Background Information:** The McCourtney Rd Active Transportation Project involves construction of a shared use path along the south side of McCourtney Rd from Allison Ranch Rd to Brighton St and along the west side of Brighton St approximately 800 feet to the north. Associated work includes drainage improvements, curb ramps, pavement replacement, resurfacing and striping, and roadside signage.

The street improvements associated with this project are exempt from environmental review pursuant to Section 15301 "Existing Facilities" of the CEQA Guidelines.

# **Background Information:**

On March 11, 2025, the City Council received a detailed report and presentation regarding the new LRA Fire Hazard Severity Zone maps prepared by the Office of the State Fire Marshal (OSFM). The City actively sought and incorporated public feedback through its website, emails, and in-person comments during the City Council meeting.

Ordinance 835 adopts the LRA Fire Hazard Severity Zone maps in alignment with requirements for local agencies and will be submitted to the Board of Forestry and Fire Protection.

This report outlines the requirements established under existing state law regarding the designation of fire hazard severity zones in LRA as mandated by OSFM.

According to Government Code Sections 51177 to 51179, the OSFM must prepare, and release recommended maps delineating fire hazard severity zones. Local agencies within the designated areas are obligated to follow specific procedures to ensure compliance and public involvement.

# **Requirements for Local Agencies**

Upon receiving the recommended maps, local agencies must undertake the following actions:

• Public Review and Comment (Within 30 Days)

Local agencies are required to make the recommended maps available for public review and comment within 30 days of receipt. This ensures that community members have an opportunity to engage with and provide feedback on the fire hazard severity designations.

Adoption of Recommended Maps (Within 120 Days)

Local agencies must adopt the recommended fire hazard severity map by local ordinance within 120 days. This process formalizes the designation and allows local governance to address fire safety measures appropriately.

• Submission of Documents (Within 30 Days of Adoption)

Following the adoption of the ordinance, local agencies must submit the ordinance and any other required documentation to the Board of Forestry and Fire Protection within 30 days. This step is essential for maintaining state oversight and ensuring compliance with fire safety regulations.

# Limitations on Fire Hazard Severity Designations

It is crucial to note that local agencies may only increase the level of fire hazard severity as identified by the OSFM. They are prohibited from decreasing the severity level in any designated area.

# **Criteria for Designation**

The OSFM categorizes areas into moderate, high, and very high fire hazard severity zones based on several factors, including:

- Fuel loading
- Slope
- Fire weather conditions
- Wind patterns identified as significant contributors to wildfire spread

The updated fire hazard severity zone mapping significantly expands the areas designated as high and very high fire hazard severity zones within the City compared to the 2008 mapping. Additionally, new areas have been identified and classified as high and moderate severity zones. These updates reflect changes in risk assessment due to factors such as evolving wildfire behavior, climate conditions, and urban growth.




# Local Responsibility Area Fire Hazard Severity Zones











# Very High Fire Hazard Severity Zones in LRA As Recommended by CAL FIRE






Government Code 51175-89 directs the California Department of Forestry and Fire Protection (CAL FIRE) to identify areas of very high fire hazard severity zones within Local Responsibility Areas (LRA). Mapping of the areas, referred to as Very High Fire Hazard Severity Zones (VHFHSZ), is based on data and models of, **potential** fuels over a 30-50 year time horizon and their associated expected fire behavior, and expected burn probabilities to quantify the likelihood and nature of vegetation fire exposure (including firebrands) to buildings. Details on the project and specific modeling methodology can be found at <a href="http://frap.cdf.ca.gov/projects/hazard/methods.htm">http://frap.cdf.ca.gov/projects/hazard/methods.htm</a>. Local Responsibility Area VHFHSZ maps were initially developed in the mid-1990s and are now being updated based on improved science, mapping techniques, and data.

In late 2005 to be effective in 2008, the California Building Commission adopted California Building Code Chapter 7A requiring new buildings in VH FHSZs to use ignition resistant construction methods and materials. These new codes include provisions to improve the ignition resistance of buildings, especially from firebrands. The updated very high fire hazard severity zones will be used by building officials for new building permits in LRA. The updated zones will also be used to identify property whose owners must comply with natural hazards disclosure requirements at time of property sale and 100 foot defensible space clearance. It is likely that the fire hazard severity zones will be used for updates to the safety element of general plans.

This specific map is based on a geographic information system dataset that depicts final CAL FIRE recommendations for Very High FHSZs within the local jurisdiction. The process of finalizing these boundaries involved an extensive local review process, the details of which are available at <a href="http://frap.cdf.ca.gov/projects/hazard/btnet/">http://frap.cdf.ca.gov/projects/hazard/btnet/</a> (click on "Continue as guest without logging in"). Local government has 120 days to designate, by ordinance, very high fire hazard severity zones within its jurisdiction after receiving the recommendation. Local government can add additional VHFHSZs. There is no requirement for local government to report their final action to CAL FIRE when the recommended zones are adopted. Consequently, users are directed to the appropriate local entity (county, city, fire department, or Fire Protection District) to determine the status of the local fire hazard severity zone ordinance.

This map was developed using data products such as parcel and city boundaries provided by local government agencies. In certain cases, this includes copyrighted geographic information. The maps are for display purposes only - questions and requests related to parcel or city boundary data should be directed to the appropriate local government entity.

# **Background Information:**

Hot Spot Smoke Shop, located at 440 Colfax Avenue, held a valid Tobacco Retail License (TRL) issued by the City of Grass Valley, which expired on February 11, 2025. The licensee failed to submit a timely and complete renewal application and was also found to be in violation of local and state tobacco laws during a compliance inspection. Based on these factors, the renewal of the license was denied on March 7<sup>th</sup>, 2025.

The business appealed the denial on March 12, 2025, and the matter was heard by a Hearing Officer pursuant to Grass Valley Municipal Code (GVMC) Section 5.56.140 on March 27<sup>th</sup>, 2025. The Hearing Officer issued a written decision denying the appeal on March 31, 2025.

On April 9<sup>th</sup>, 2025, the City Clerk received a timely request for City Council review under GVMC Section 5.56.160, along with the required appeal fee and the written appeal outlining the grounds for review. The matter has been scheduled for Council consideration within the required 30-day window.

# SUMMARY OF HEARING OFFICER'S DECISION:

The Hearing Officer made the following Findings of Fact:

1. Hot Spot Smoke Shop's TRL expired on February 11, 2025.

- 2. The renewal of the application and fees were due by January 11, 2025.
- 3. The application was received on February 24, 2025, over 40 days late—and was incomplete.
- 4. The required late fee was not included.
- 5. A February 25, 2025, compliance check revealed illegal flavored vape products stored behind the sales counter in violation of:
  - GVMC Section 5.56.030(A) & (B)
  - California Health and Safety Code Section 104559.5(b)(1)

# Conclusion:

The Hearing Officer concluded that the business failed to meet renewal deadlines and was actively violating tobacco laws, justifying the denial of the renewal. The appeal was denied, and the business was prohibited from continuing tobacco sales without a valid license.

# **APPELLANTS CLAIMS FOR REVIEW:**

In a written appeal submitted by Raja Singh on behalf of Hot Spot Smoke Shop, the following points were raised:

- 1. Licensing Deadline Confusion:
  - The appellant states they attempted to renew the license before February 11, 2025, but were told by a staff member that there was "about a month and a half" left on the license.
  - Based on this guidance, they returned later, but after the renewal deadline had passed.
  - They argue the late submission was unintentional and caused by miscommunication.

# 2. Unintentional Possession of Prohibited Products:

- The appellant states the flavored vape pens were purchased from a large wholesale distributor.
- They were unaware that the products violated local or state law.
- Upon learning of the violation, they immediately disposed of all noncompliant items.
- 3. Alleged Errors in the Hearing Officer's Decision:
  - The appellant asserts that the Hearing Officer did not fully consider the circumstances surrounding the late filing.

- They request leniency based on their corrective action and intent to comply with regulations in the future.
- 4. Request for Relief:
  - The appellant requests that the City Council either overturn or modify the decision and permit license renewal.
  - They assert that Hot Spot Smoke Shop is a responsible business committed to following all laws moving forward.

# COUNCIL'S OPTIONS UNDER GVMC 5.56.160:

Pursuant to GVMC Section 5.56.160(B) and (C), the City Council may:

- 1. **Deny the appeal** and uphold the Hearing Officer's decision.
- 2. Grant the appeal and order the renewal of the license.
- 3. Modify the terms and impose conditions on the license.
- 4. **Reject the findings** and conduct a de novo hearing, allowing full reconsideration with or without new evidence.

The Council's determination must be accompanied by findings of fact and conclusions of law. These may incorporate the Hearing Officer's findings by reference.

At the April 22<sup>nd</sup> meeting, the appellant, Hot Spot Smoke Shop, requested that the meeting be put on the May 13<sup>th</sup> meeting.

- Late and Incomplete Application: Your Grass Valley Tobacco Retail License expired on February 11, 2025. Per GVMC 5.56.080 (C), your application for renewal was due with fees paid by January 11, 2025. However, your renewal application was not submitted until February 24, 2025. Per GVMC 5.56.080 (C1) & (C2), late submissions incur a late fee of 50% of the initial licensing fee and a signed affidavit as required in section. The late fee and affidavit were not submitted with the late application. In addition, the late application was not signed by the Owner/Applicant.
- Observed Violations: On February 25, 2025, a GVPD Officer arrived at your location to complete a compliance check and finalize the issuance process. While in your store, he witnessed Hot Spot Smoke Shop actively offering for sale illegal tobacco products (flavored vape pens) from a duffle bag hidden behind the sales counter. This was a violation of:

  - GVMC 5.56.030 (B)
  - o California Health & Safety 104559.5(b)(1)

When confronted about the illegal activity, the employee lied, obstructed, and delayed the officer in an attempt to conceal the criminal behavior.

The City Council may choose to uphold, modify, or overturn the hearing officer's decision, and their determination shall be final.

# APPEAL HEARING OFFICER'S DECISION Hot Spot Smoke Shop – Tobacco Retail License Renewal with City of Grass Valley

Hearing Date: March 27, 2025, at 1 pm Date of Decision: March 31, 2025

# I. Introduction

This matter came before the Hearing Officer on appeal by Hot Spot Smoke Shop regarding the City of Grass Valley's denial of the renewal of its Tobacco Retail License (TRL). The appeal was heard pursuant to the City of Grass Valley Municipal Code and applicable state law.

# II. Findings of Fact

- 1. Hot Spot Smoke Shop's Tobacco Retail License expired on February 11, 2025.
- 2. The renewal application and required fees were due by January 11, 2025, in accordance with the City of Grass Valley Municipal Code.
- 3. The renewal application was not received by the City until February 24, 2025, more than 40 days past the deadline.
- 4. The application submitted was incomplete and did not include the required late fee.
- 5. On February 25, 2025, a compliance check conducted by a Grass Valley Police Officer at Hot Spot Smoke Shop found illegal tobacco products (flavored vape pens) being offered for sale, and hidden behind the sales counter in a bag, in violation of:
  - Grass Valley Municipal Code Section 5.56.030(A) & (B).
  - California Health and Safety Code Section 104559.5(b)(1).

# III. Analysis

The City of Grass Valley Municipal Code clearly outlines the requirements for submitting a timely and complete renewal application, along with the necessary fees, for a Tobacco Retail License renewal. Hot Spot Smoke Shop failed to comply with these requirements by not submitting the renewal application and fees as specified. Additionally, the applicant submitted a late and incomplete application without the required late fees. Furthermore, the discovery of illegal tobacco products during a compliance check constitutes a serious violation of both municipal and state law.

The attempted sale of prohibited tobacco products demonstrates a failure to comply with regulatory requirements and further justifies the denial of the license renewal. The City's licensing regulations are designed to protect public health and ensure responsible retail practices, which Hot Spot Smoke Shop failed to uphold.

# IV. Decision

Based on the above findings and analysis, the appeal of Hot Spot Smoke Shop is DENIED. The denial is upheld on the grounds that:

- 1. The renewal application was not submitted by the required deadline.
- 2. The application submitted was incomplete and did not include the required late fee.
- 3. The business was found in possession of and offering for sale illegal tobacco products, in violation of local and state law.

Accordingly, Hot Spot Smoke Shop's Tobacco Retail License shall remain expired and will not be renewed. The business is prohibited from selling tobacco products within the City of Grass Valley without a valid license.

# V. Conclusion

This decision is final unless an appeal is made pursuant to the City of Grass Valley's appeal procedures. The City reserves the right to take further enforcement action if additional violations are discovered.

I, Raja Singh, respectfully submit this written appeal and request for City Council review of the Hearing Officer's decision dated March 31, 2025, which upheld the denial of Hot Spot Smoke Shop's Tobacco Retail License renewal. Enclosed is a copy of the Hearing Officer's decision, along with the required appeal processing fee of \$432.00.

#### 1. Reasons for Appeal

1. Licensing Deadline Confusion

When I attempted to renew the license before its February 11, 2025 expiration, a staff member informed me that the store still had about a month and a half remaining on the current license. I was instructed to return later, closer to the expiration date. Unfortunately, by the time I returned, the filing deadline had already passed, leading to our renewal application being submitted late. Had we been informed accurately, we would have renewed on time and included all necessary fees.

2. Unintentional Possession of Illegal Products

Regarding the flavored vape pens discovered during the compliance check on February 25, 2025, we purchased these products from a large wholesale retailer and were unaware that they contained prohibited flavors. Once we became aware of their illegality, we immediately disposed of all remaining similar items. We sincerely regret this oversight and are committed to preventing such an incident in the future by carefully checking product labels and verifying compliance with all local and state regulations.

2. Alleged Errors in the Hearing Officer's Decision

- We believe the Hearing Officer's decision did not fully consider the staff member's guidance that contributed to our late filing. Our delay was not intentional; it was influenced by the misunderstanding that we had additional time before the license expired.
- While the presence of flavored vape pens is certainly a serious matter, we took swift corrective action by removing the products entirely upon learning of their prohibited status. We ask for leniency given our prompt compliance once informed.

# 3. Request for Relief

We respectfully request that the City Council overturn or modify the Hearing Officer's decision and allow us to renew our Tobacco Retailer's License. Hot Spot Smoke Shop has been a responsible business in Grass Valley, and we are committed to adhering to all regulations moving forward.

# 5.56.130 Appeals.

- A. An applicant for a tobacco retailer's license, or a licensee may file an appeal from the following:
  - 1. The denial of an initial application for, or application for renewal of, a tobacco retailer's license;
  - 2. The revocation or suspension of a tobacco retailer's license.
  - B. The appeal must be in writing on a form provided by the city, shall state the specific reasons for the appeal and the grounds asserted for relief, and be accompanied by a nonrefundable appeals processing fee set by city council resolution. The appeal shall be filed with the city clerk within ten calendar days of receipt of the notice providing the grounds for the appeal. The failure to file an appeal within the time or in the manner prescribed in this section, or to include the appeals processing fee, waives the right to appeal.
  - C. The appeals processing fee shall be set by resolution of the city council, as amended from time to time.

### 5.56.140 Hearing before hearing officer.

- A. Upon timely receipt of a written request for a hearing, the city clerk shall schedule a hearing which shall be held no later than thirty calendar days after receipt of the request for healing.
- B. The city clerk shall serve a notice of hearing on the licensee at least ten calendar days prior to the scheduled date of the hearing.
- C. The chief shall have the burden of proof during the hearing, and shall prove by a preponderance of the evidence that the violations leading to suspension or revocation, or denial of the application, exist.
- D. At the conclusion of the hearing, the hearing officer shall prepare a written decision which either grants or denies the appeal and contains findings of fact and conclusions of law. The written decision shall be filed with the city clerk not later than seven calendar days following the date on which the hearing is closed. The city clerk shall, within three days of the filing of such decision, serve the applicant or licensee with notice and copy of the written decision.
- E. The provisions of the California Administrative Procedure Act (Government Code § 11500 et seq.), and the formal rules of evidence do not apply at the hearing. Any and all evidence which the chief or hearing officer deems reliable, relevant and not unduly repetitious may be considered.

#### 5.56.150 Finality of determination.

- A. With respect to appeals from the denial of an initial application for a tobacco retailer's license, the hearing officer's decision is final upon service of the hearing officer's decision on the appellant.
- B. With respect to an appeal from the denial of a renewal of a tobacco retailer's license, or from the revocation or suspension of a tobacco retailer's license, the hearing officer's decision is final ten days after service of the hearing officer's decision on the appellant, unless city council review is requested either by the chief or appellant.

# 5.56.160 Request for review by city council.

- A. To request city council review of the hearing officer's decision, the applicant for a license, license holder, or chief shall file a written request with the city clerk within ten days following the date of service of the hearing officer's decision. The request for review shall state in detail the reasons for review and the error alleged in the hearing officer's decision, and include a copy of the hearing officer's decision attached to the request for review, and an appeals processing fee as set by city council resolution.
- B. Upon receipt of a request for review by city council, the city clerk shall schedule city council review not later than thirty calendar days following the date of filing of the notice of appeal. The city clerk shall provide notice of the time and date of the hearing to the appellant at least ten days in advance. The city council shall be authorized to deny the introduction of evidence and decide the matter after oral argument presented during the hearing, to admit supplementary evidence with respect to challenges or particular findings, or reject the findings and conclusions and conduct a de novo hearing. The determination by the city council granting or denying the appeal shall be final and shall be accompanied by findings of fact and conclusions of law, which may consist of an adoption by reference of those by the hearing officer.
- C. The city council is authorized to order the issuance or renewal of a license, may order the revocation of the license, suspend the license or order the license to remain in effect upon such terms and conditions as in the discretion of the city council are necessary and appropriate.

### **Background Information:**

AB 2561 was introduced to address the issue of job vacancies in local government, which adversely affects the delivery of public services and employee workload. AB 2561 requires public agencies to hold at least one public hearing per fiscal year to discuss vacancies and recruitment and retention efforts. This report discusses the City's legal obligations under the new law, which took effect on January 1, 2025. This report recommends the adoption of measures intended to ensure compliance with such legal obligations.

In compliance with the new legal obligations, the City of Grass Valley is required to do the following:

 <u>Public Hearing</u>: At least once each fiscal year, at a public hearing before the Grass Valley City Council, the City shall present information regarding the status of vacancies and recruitment and retention efforts (Gov. Code § 3502.3(a)(1)) and identify any necessary changes to policies, procedures, and recruitment activities that may lead to obstacles in the hiring process (Gov. Code § 3502.3(a)(3)). If the City of Grass Valley adopts an annual or multiyear budget during the fiscal year, this presentation must occur prior to the City of Grass Valley's adoption of the final budget for the City of Grass Valley (Gov. Code § 3502.3(a)(2).)

- 2. <u>Employee Organization Participation</u>: Allow the recognized employee organization for each bargaining unit at the City of Grass Valley to make presentations during the public hearing concerning vacancies and recruitment and retention efforts. (Gov. Code § 3502.3(b).)
- 3. <u>Additional Reporting for High Vacancy Rates</u>: If vacancies within a single bargaining unit meet or exceed 20% of authorized full-time positions in that bargaining unit, upon request of the recognized employee organization for that bargaining unit, the City of Grass Valley must provide additional information during the public hearing, including the following: (1) the total number of vacancies; (2) the number of applicants; (3) the average time to fill positions; and (4) opportunities to improve compensation and working conditions for employees in the bargaining unit. (Gov. Code § 3502.3(c).)

The Procedures for the Public Hearing on City of Grass Valley Vacancies and Recruitment and Retention Efforts ("Procedures"), attached hereto as Attachment 2, establish protocol for the City's public hearings on vacancies in order to ensure a fair, orderly, and efficient hearing process.

The Procedures set forth specific requirements concerning matters such as the provision of notice to recognized employee organizations regarding the public hearing and their right to make a presentation at the hearing, the length and order of the City of Grass Valley's and the employee organizations' presentations, and the standards of discourse during the public hearing.

### **RESOLUTION 2025-10**

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRASS VALLEY ADOPTING PROCEDURES FOR PUBLIC HEARINGS ON CITY OF GRASS VALLEY VACANCIES AND RECRUITMENT AND RETENTION EFFORTS.

WHEREAS, on January 1, 2025, Assembly Bill ("AB") 2561 (Gov. Code § 3502.3) went into effect requiring public agencies to hold at least one public hearing per fiscal year to report on the City's workforce vacancies, and recruitment and retention efforts; and

WHEREAS, AB 2561 requires the City of Grass Valley to present information regarding the status of vacancies and recruitment and retention efforts prior to the adoption of the final budget for the City of Grass Valley; and

WHEREAS, AB 2561 requires the City of Grass Valley to allow recognized employee organizations for each City bargaining unit to make presentations during the public hearing concerning vacancies and recruitment and retention efforts; and

WHEREAS, AB 2561 requires the City of Grass Valley, if requested, to provide additional information during the public hearing if vacancies within a single bargaining unit is 20% or more of the authorized full-time positions; and

WHEREAS, the City Council of City of Grass Valley desires to establish protocol and additional requirements for the City of Grass Valley's public hearings pursuant to AB 2561, including the provision of notice to recognized employee organizations regarding the public hearing, the recognized employee organizations' right to make a presentation at the hearing, the length and order of the presentations and the standards of discourse during the public hearing.

### NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GRASS VALLEY DOES RESOLVE AS FOLLOWS:

1. The City Council of the City of Grass Valley hereby adopts the Procedures for Public Hearings on City of Grass Valley Vacancies and Recruitment and Retention Efforts as set forth in Exhibit "A".

2. The Resolution is hereby adopted and becomes effective and in full force immediately upon adoption.

### CITY OF GRASS VALLEY PROCEDURES FOR AB 2561 PUBLIC HEARINGS

### **Introduction and Scope:**

Effective January 1, 2025, Government Code section 3502.3 requires the City of Grass Valley to present information on the status of vacancies at the City and the City's recruitment and retention efforts at a public hearing before City Council at least once per fiscal year.

Government Code section 3502.3 also requires the City of Grass Valley to identify during the public hearing any necessary changes to City policies, procedures, and recruitment activities that may contribute to obstacles in our hiring process.

At the public hearing, a recognized employee organization for a bargaining unit is entitled to make a presentation to the City Council addressing the status of vacancies and recruitment and retention efforts for positions within that bargaining unit.

The purpose of these procedures is to establish protocol for the City of Grass Valley's public hearings on vacancies in order to ensure a fair, orderly, and efficient hearing process.

The City reserves the right to schedule separate public hearings for different bargaining units, and is not limited to one public hearing to address all vacancies and recruitment and retention efforts within the City.

### **Notice Requirements:**

- 1. When the City schedules a City Council hearing pursuant to the obligations set forth under Government Code section 3502.3 ("AB 2561 Hearing" or "Hearing"), the City of Grass Valley will notify in writing each recognized employee organization ("Employee Organization") about which the Hearing is being held that the City Council will hold an AB 2561 Hearing (the City and Employee Organization may hereafter be referred to collectively as "Parties"). The notice will provide each Employee Organization the opportunity to identify any negotiable impacts/effects regarding the City's compliance with Government Code section 3502.3 and the City's policy.
- 2. The City of Grass Valley will notify in writing each Employee Organization of the date, time and place of the Hearing at least 10 calendar days in advance of the Hearing, if the Hearing is regarding a bargaining unit represented by that Employee Organization. In the notice, the City of Grass Valley will inquire whether the Employee Organization intends to make a presentation to the City Council at the Hearing. The City will request that, for planning purposes, the Employee Organization provide written notice to the Human Resources Department at least 5

calendar days in advance of the Hearing indicating whether the Employee Organization intends to make a presentation at the Hearing.

The notice will also include information about the amount of time that the City Council has allotted to the Employee Organization(s) for the Employee Organization(s) presentation at the Hearing.

- 3. In the event the vacancy rate for a City bargaining unit is at least 20% of the total number of authorized full-time positions in the bargaining unit, the Employee Organization that represents the bargaining unit may request that the City present "additional information" related to the vacancies as permitted by Government Code section 3502.3, subd. (c). The City will request that the Employee Organization submit its request for the City's presentation of such information to the Human Resources Department in writing at least 5 calendar days in advance of the Hearing. The "additional information" constitutes the following: (1) the total number of job vacancies within the bargaining unit; (2) the total number of applicants for vacant positions within the bargaining unit; (3) the average number of days to complete the hiring process from when a position is posted; and (4) opportunities to improve compensation and other working conditions.
- 4. The City will provide notice of the Hearing to the public in accordance with the Ralph M. Brown Act. (Gov. Code §§ 54950-54963.)
- 5. A staff report regarding vacancies and recruitment and retention efforts may be published as part of the agenda packet for the Hearing.
- 6. The City of Grass Valley and applicable Employee Organization(s) may agree to exchange presentation materials in advance of the Hearing.

### **Order of the Hearing:**

The Hearing will proceed in the following order:

- 1. <u>City of Grass Valley Presentation</u>: The City of Grass Valley will present to the City Council information pursuant to the City's obligations set forth under Government Code section 3502.3. The City's presentation will be limited to 10 minutes for each bargaining unit about which the AB 2561 Hearing is held. The City of Grass Valley may choose to 1) present data on all applicable bargaining unit(s) at once, after which consolidated presentation, the applicable Employee Organization(s) will present; or 2) to present data for each applicable bargaining unit individually followed by the corresponding Employee Organization presentation.
- 2. <u>Employee Organization Presentation</u>: Following the City's presentation, each applicable Employee Organization will have the opportunity to make a presentation for each of the applicable bargaining units that the Employee Organization represents. For each bargaining unit, the Employee Organization presentation will

be limited to 10 minutes and should not contain bargaining proposals to the City of Grass Valley on matters that have not been presented in bargaining.

- 3. <u>Governing Body Questions</u>: The City Council may ask questions of the City of Grass Valley and the Employee Organization presenter(s). The time spent for City Council questions and the Parties' responses to City Council questions will not be included in the Parties' 10 minute presentations.
- 4. <u>Final City of Grass Valley Comments</u>: Final City of Grass Valley comments will be limited to 3 minutes per bargaining unit and will take place following the Employee Organization presentation. The City may choose to 1) present final comments on all applicable bargaining unit(s) at once, after which consolidated presentation, the applicable Employee Organization(s) will present its final comments; or 2) to present final comments for each applicable bargaining unit individually followed by the corresponding Employee Organization final comments.
- 5. <u>Final Employee Organization Comments</u>: Following the City's final comments, each applicable Employee Organization will have the opportunity to make final comments for each of the applicable bargaining units that the Employee Organization represents. For each bargaining unit, the Employee Organization's final comments will be limited to 3 minutes per bargaining unit and should not contain bargaining proposals to the City of Grass Valley on matters that have not been presented in bargaining.
- 6. <u>Public Comment</u>: Public comment regarding the AB 2561 Hearing will be limited to 3 minutes per person and any other lawful restrictions on public comments that the City Council may impose.

### **Standards of Discourse:**

The City Council should recognize that engaging with diverse perspectives is vital for effective governance and a vibrant community. To ensure full expression of such diverse perspectives, the City Council should provide that participants follow the principles of respectful and civil discourse.

**Background Information:** Mill Street Plaza, a central pedestrian corridor in downtown Grass Valley, is due for maintenance to preserve its appearance and improve its durability. The proposed project involves cleaning, etching, and re-staining the concrete surface throughout the Plaza. This process is intended to refresh the aesthetic appeal of the area and enhance the longevity of the concrete by allowing for better penetration and adherence of the new stain.

The work will include scrubbing and etching the concrete surface to prepare it for application of a high-quality, penetrating stain in multiple colors and coats. This approach not only revitalizes the visual character of the Plaza but also contributes to long-term maintenance efficiency.

To ensure the quality and consistency of this specialized work, staff is recommending a sole source contract with The Concrete Doctor, a contractor with demonstrated experience and familiarity with the Mill Street Plaza project and performed the original staining. Pursuant to Municipal Code Section 3.08.140, the sole source procurement requires a four-fifths (4/5) vote of the City Council.

In order to minimize disruption to regularly scheduled community events, staff is proposing to schedule this work after the July 4th holiday. Coordination will be conducted with the Grass Valley Downtown Association to ensure that the project

avoids conflicts with the Thursday Markets and other programmed events and minimizes impacts on local businesses and visitors.

<u>Council Goals/Objectives</u>: This item executes portions of work tasks towards achieving/maintaining the Strategic Plan - High Performance Government & Quality Service and Productive and Efficient Workforce.

**Fiscal Impact:** There are contingency funds available in this year's budget to cover the cost of this project.

**Background Information:** On November 21, 2023, the City of Grass Valley issued a Request for Proposals (RFP) for Design-Build services for the Condon Park Skatepark Project. The RFP invited qualified firms to submit proposals for either a full replacement of the existing skatepark or a rehabilitation of the current facility with an expanded footprint, incorporating new features and amenities. Following a thorough evaluation, Grindline Skateparks, Inc. was ranked as the top firm, offering the best overall value and demonstrating a strong commitment to delivering a high-quality signature skatepark for the Grass Valley community.

On February 13, 2024, the City Council awarded a Design-Build contract to Grindline Skateparks, Inc. in the amount of \$1,500,000. During the initial phase of the project, Grindline Skateparks, Inc. conducted a site visit to evaluate the condition of the existing facility. Their assessment identified several significant issues, including extensive cracking, signs of potential settlement, and drainage concerns. Consequently, they concluded that the current skatepark conditions pose potential hazards and cannot be feasibly repaired. In recent roundtable discussions, Stakeholder groups including Nevada County Skate and Grass Valley Skatepark Coalition recognized these as valid issues.

From April through September 2024, the City and Grindline Skateparks, Inc. hosted a series of community meetings to gather public input and collaboratively shape the design. The new skatepark final conceptual design reflects the community's feedback and priorities and aims to create an inclusive, modern, and durable facility for users of all skill levels. At recent meetings, stakeholders agreed the proposed design was great,

but some community insisted on keeping the existing skatepark and building the new park adjacent. At the meeting staff will present the pros and cons with this concept and the designer's comments.

This item is informational only. Should the City Council wish to consider modifications to the contract or the skatepark design in the future, such changes will be brought forward for discussion at a future regularly scheduled City Council meeting.

<u>Council Goals/Objectives</u>: This item executes portions of work tasks towards achieving/maintaining the Strategic Plan - Parks and Recreation.

**Fiscal Impact:** The project is funded through a Prop 64 Health and Safety Grant in the amount of \$1,500,000.
