Background Information: The CFAA agreement is used for response to incidents within California which require large resource commitments. These deployments are most noticeable in the summer during wildland season when our fire engines and personnel are deployed throughout the State in support of other agencies. The CFAA is the negotiated reimbursement mechanism for local government fire agency responses through the California Fire Service and Rescue Emergency Mutual Aid System. The terms and conditions that outline the methods of reimbursement are recommended for developing business practices when responding under the Mutual Aid System. The updated Unit 1 side letter allows reimbursement to the City for the assignment of the EMS Supervisor or Fire Marshal when deployed to an incident. The inclusion of the EMS Coordinator and Fire Marshal brings them into alignment with Battalion Chiefs for deployment and reimbursement to the City.

# RESOLUTION OF THE CITY OF GRASS VALLEY IDENTIFYING THE TERMS AND CONDITIONS FOR THE FIRE DEPARTMENT RESPONSE AWAY FROM THEIR OFFICIAL DUTY STATION AND ASSIGNED TO AN EMERGENCY INCIDENT.

WHEREAS, the City of Grass Valley Fire Department is a public agency located in the County of Nevada, State of California

WH£REAS, it is the City of Grass Valley Fire Department desire to provide fair and legal payment to all its employees for time worked; and

WHERE.AS, the City of Grass Valley Fire Department has in its employee, fire department response personnel including: Fire Chief, Battalion Chief, Fire Captain, Fire Engineer, Firefighter, Fleet Supervisor (Mechanic), EMS Coordinator and Fire Marshal.

WHEREAS, the City of Grass Valley Fire Department will compensate its employees portal to portal while iin the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident, or pre-positioned for emergency response; and

WHEREAS, the City of Grass Valley Fire Department will compensate its employees overtime in accordance with their current Memorandum of Understanding while in the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident, or prepositioned for emergency response.

NOW, THEREFORE, BE IT RESOLVED by the Councill of the City of Grass Valley, that:

- 1. Personnel shall be compensated according to the Memorandum of Understanding (MOU), Personnel Rules and Regulations, and/or other directives that identifies personnel compensation in the workplace
- 2.. In the event a personnel classification does not have an assigned compensation rate, a "Base Rate" as set forth in an organizational policy, Administrative directive or similar document will compensate such personnel.
- 3. The City of Grass Valley Fire Department will maintain a current salary survey or acknowledgement of acceptance *of* the "base rate" on file with the California Governor's Office of Emergency Services, F!re Rescue Division
- 4. Personnel will be compensated (portal to portal) beginning at the time of dispatch to return of jurisdiction when equipment and personnel are in service and available for agency response.
- 5. Fire department response personnel include: Fire Chief, Battalion Chief, Fire Captain, Fire Engineer, Firefighter, Fleet Supervisor

(mechanic), EMS Coordinator and Fire Marshal.

The parties have met and conferred and have agreed upon the following revisions to the existing MOU to update the classifications eligible for work performed in accordance with interagency agreements.

#### **ARTICLE 6- SALARY** (Replacement Language)

- B. Overtime (Non-Exempt Employees)
  - 5. <u>Interagency Agreement Work.</u> The following Unit 1 Exempt and Non-exempt classifications will be eligible to receive compensation for Interagency Agreement Work:
    - Battalion Chief Non-exempt
    - EMS Coordinator Exempt\*
    - Fire Marshal Exempt\*

The employee will receive hourly compensation, including time and one-half (1/2) pay or other applicable premium pay, for work performed in accordance with interagency agreements. Example: If employee serves on an OES strike team or overhead assignment, and the City is reimbursed premium pay, employee will receive such premium pay for all hours outside their usual work period. Instances for such premium pay will be indicated on the time card for the appropriate period. Payment of such premium pay will not be construed as treatment of the applicable position as non-exempt under the Fair Labor Standards Act.

\* The EMS Coordinator and Fire Marshal are exempt, salaried positions and shall only be eligible for the OT/Premium pay when assigned to an interagency/CFAA/OES assignment.

<u>Discussion</u>: This action finalizes the annual levy process for the Loma Rica Ranch Landscaping and Lighting District for Fiscal Year 2025-26. The assessments fund ongoing maintenance and improvements as detailed in the Engineer's Reports, approved by the City Council on November 12, 2024, via Resolution No. 2024-76.

<u>Background Information</u>: Health and Safety Code Section 5473 allows the City to place delinquent sewer and/or water charges on the County property tax roll for collection, with a two-thirds vote of the City Council. This process is used when utility service cannot be discontinued as a means of collecting unpaid charges and follows the same procedures as property tax collection.

Nevada County participates in the Teeter Plan, a property tax distribution method in which the County pays the City the full amount of the delinquent charges up front and assumes responsibility for collecting from the property owner. This ensures timely revenue for the City even if the property owner delays or fails to pay their tax bill. The method has proven to be a reliable and effective tool for recovering unpaid utility charges.

All affected property owners were notified in accordance with state law. Initial notices were mailed on June 12, 2025, with follow-up letters sent on June 30, 2025. Any delinquent accounts paid before the final submittal to the County will be removed from the list.

As of July 31, 2025, the total amount of delinquent charges eligible for placement on the tax roll is \$155,246.89. This amount may be reduced if additional payments are received after the publication of this report and before the City Council meeting. An updated list of delinquent accounts will be provided to the Council in advance of the hearing.

# RESOLUTION REQUESTING THE NEVADA COUNTY BOARD OF SUPERVISORS TO AUTHORIZE THE COUNTY AUDITOR AND THE COUNTY TAX COLLECTOR TO LEVY AND COLLECT DELINQUENT SEWER AND/OR WATER SERVICE CHARGES AGAINST CERTAIN PROPERTIES WITHIN THE CITY OF GRASS VALLEY AND THE UNINCORPORATED TERRITORY OF NEVADA COUNTY

WHEREAS, the City of Grass Valley has issued bills to certain property owners for sewer and/or water charges in accordance with Chapters 13.04 and 13.12 of the Grass Valley Municipal Code; and

WHEREAS, the recipients of said sewer and/or water services have failed to remit payment for those charges; and

**WHEREAS**, California Health and Safety Code Section 5473 authorizes a city, by a two-thirds vote of its legislative body, to collect delinquent sewer and/or water charges on the county tax roll;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Grass Valley as follows:

- 1. The Nevada County Board of Supervisors is hereby requested to authorize the Nevada County Tax Collector to levy and collect the unpaid sewer and/or water charges, as listed in Exhibit "A", against the respective parcels and owners of record identified therein. Exhibit "A" is attached hereto and incorporated herein by this reference.
- 2. The charges listed in Exhibit "A" are more than 60 days delinquent as of July 31, 2025, and do not reflect any payments received after that date. Exhibit "A" is subject to revise any accounts that are paid in full prior to submission to the County.
- 3. The City Council acknowledges that the City will incur costs for this collection service, to be charged in accordance with the "Standard Form Tax Collection Services" agreement between the City of Grass Valley and the County of Nevada.
