Dear Mayor Hodge and members of the City Council,

The American Motorcyclist Association (AMA) is a not-for-profit organization, founded in 1924 and incorporated in Ohio, with more than 225,000 enthusiast members nationwide, more than 30,000 of whom reside in California. Our members are interested in any action that may affect their enjoyment and use of on and off highway motorcycles.

It has come to our attention that the current repairs to S. Auburn and Main Street include the planned elimination of existing dedicated motorcycle parking spots in favor of additional automobile spots. As a longtime resident of Placerville myself I know firsthand the popularity of motorcycles throughout the foothills, especially during the spring and summer months. Riders seek out the beauty and history of the gold country, and this proposed elimination of a few decided spots seems shortsighted and one we request you reconsider.

Often we find that areas that are inappropriate for automobile parking are restricted/made into no parking areas when they would in fact be appropriate for dedicated motorcycle spots. We would also encourage you work with local riders (I would be happy to help put you in contact with some) who could assist in this effort.

Dear Mayor Hodge, Vice Mayor Caravelli, and esteemed City Council Members,

My name is Mark Gold, co-owner of Gold Rush Cookie Company, across the street from City Hall, and I ride a motorcycle.

Learn why this is important

As I understand it, with the repairs to S. Auburn and Main Streets will be the elimination of dedicated motorcycle parking in favor of increasing automobile parking. As of this moment, I am only aware of a single space located in front of Mountain Day Spa at 110 E. Main. This elimination is presumably to make up for the losses of parking spots due to the closure of Mill Street as well as the addition of parklets along Main Street. As someone who drives a car, I can understand the need for additional parking spaces. However, as someone who recently started riding a motorcycle most every single day, it has become clear that eliminating dedicated motorcycle parking should be reconsidered.

#### Why Grass Valley Needs Dedicated Motorcycle Parking on Main Street

As downtown Grass Valley continues to thrive as a cultural and commercial hub, it's time to consider smart infrastructure solutions that benefit both residents and visitors. One simple yet high-impact improvement: **Do not remove the dedicated motorcycle parking along Main Street, and instead, increase it**.

Here's why this change makes sense-economically, practically, and aesthetically-for our town:

#### More Parking with Less Space

Motorcycles take up significantly less space than cars. On average, **3-4 motorcycles can fit in the space of a single car**, **specifically in spaces such as those that run parallel to Main Street**. By converting even one or two car-length spots along Main Street into dedicated motorcycle areas, or if that is not an option, then other areas that are not suitable for automobiles to park that could be repurposed for motorcycle parking. By increasing the amount of available motorcycle parking, Grass Valley can **dramatically increase total vehicle capacity**—a critical benefit during peak tourist seasons, festivals, and weekends when motorcycle traffic increases. We also know that there are a lot of motorcycle riders in Nevada County. One needs to look no further than the annual toy run as an example of that. And with the mild winter we had and relatively mild summer so far, motorcycle ridership is up.

#### 🚵 Support Local Businesses

Motorcyclists are mobile, loyal consumers who often plan their routes around convenient parking. I can tell you first-hand about this based on customers coming into my store. By providing visible, safe, and legal parking, Grass Valley becomes more attractive to riders passing through the Sierra Foothills—bringing increased foot traffic to our shops, cafes, and events. **More riders stopping = more dollars spent locally.** 

#### 傄 Prevent Damage and Theft

Motorcycles parked randomly are more vulnerable to being knocked over by cars or tampered with. A few **well-placed**, **well-marked spaces** along Main Street (with clear signage) show that the city supports motorcycle use and takes rider safety seriously. That's a small investment with big returns in goodwill and damage prevention.

## **P** Encourage Low-Impact Transportation

Motorcycles produce less congestion and lower emissions than cars. Encouraging two-wheel transportation helps Grass Valley meet **sustainability and traffic-reduction goals**—especially important in a compact, historic downtown where road space is limited.

#### 🔗 Celebrate Our Culture of Open Roads

Grass Valley sits at the gateway to some of Northern California's most scenic motorcycle routes including Hwy 49 and Hwy 20. Riders already come through town regularly. By creating visible, dedicated parking, we send a clear message: **you're welcome here**. This kind of rider-friendly infrastructure can turn Grass Valley into a must-stop destination.

#### In Summary:

Dedicated motorcycle parking on Main Street would:

- Increase total vehicle capacity without needing more space
- Boost business by attracting motorcycle tourism
- Protect motorcycles from damage
- Encourage environmentally friendly transport
- Celebrate the freedom and culture that define our region

I am happy to work with the Grass Valley City Council, the City Engineer Bjorn Jones, and others to help come up with suitable alternatives to completely eliminating motorcycle parking in downtown. Our two-wheeled community both near and far will appreciate the effort to accommodate them.

**Background Information:** The City of Grass Valley is exploring opportunities to improve forest health on City-owned properties through proactive vegetation management practices such as selective tree thinning, pruning, and brush clearing. These efforts are aimed at enhancing ecological resilience, and promoting long-term forest sustainability.

To support this work, the City intends to apply for funding through the California Forest Improvement Program (CFIP), a state-funded initiative administered by CAL FIRE. The purpose of CFIP is to encourage both private and public investment in the improved management of California's forestlands. The program promotes forest productivity, environmental stewardship, and economic benefits—while ensuring that forests remain healthy and resilient for future generations.

CFIP provides cost-share assistance to eligible landowners—including public agencies—for properties ranging from 20 to 5,000 acres.

Participation in the California Forest Improvement Program (CFIP) would enable the City to leverage state funding to implement high-priority forest health projects on City-owned lands. These efforts will enhance community safety, protect vital natural resources, and strengthen overall forest resiliency. The City is currently preparing to apply for funding to improve forest conditions on more than 240 acres of City-owned property, including open space near Loma Rica Ranch, Condon Park, the Wolf Creek

Trail corridor, and areas surrounding the City's Wastewater Treatment Plant and Corporation Yards.

As part of the CFIP, the City needs to designate a representative to act as authorized agent to conduct all necessary negotiations and to execute and submit all required documents—including, but not limited to, applications, contracts, amendments, payment requests, and compliance certifications with all applicable state and federal laws—for the successful completion of the CFIP project. Staff is recommend the City Manager be designated as the authorized agent for the CFIP for the City.

<u>Council Goals/Objectives</u>: The execution of this action attempts to achieve the following Strategic Goals - Community and Sense of Place.

**Fiscal Impact:** The areas identified for treatment were originally planned to be cleared using Measure B funds. However, if the City is awarded CFIP funding, a significant portion of those costs would be reimbursed by the State through the program. This would allow the City to preserve a substantial amount of Measure B funds for other potential projects and priorities.

**Background Information:** In June of 1997 the voters of the City of Grass Valley approved the Special Emergency Medical and Fire Response Tax (Measure A) to fund three additional firefighters. The voter approval contained a provision allowing for an annual inflation adjustment to the special tax based upon the CPI-All U.S. Cities for the prior calendar year, not to exceed 5%. That adjustment is necessary in order to maintain ongoing funding for the three firefighters. The CPI for the year ending December 2024 was 2.9%.

The 2025/2026 Special Emergency Medical and Fire Response Tax with the December 2024 CPI applied are as follows:

### RESOLUTION REQUESTING THE COUNTY AUDITOR TO PLACE THE CURRENT SPECIAL EMERGENCY MEDICAL AND FIRE RESPONSE TAX ON THE PROPERTY TAX ROLL FOR FISCAL YEAR 2024-2025

WHEREAS, on March 11, 1997, the City Council adopted Resolution No. 97-22, calling for a Special Municipal Election to be held in the City of Grass Valley on June 3, 1997 for the purpose of submitting to the qualified voters of the City the issue as to whether to impose a special emergency medical and fire response tax (Measure A); and

WHEREAS, a Special Election was held in the County of Nevada for the City of Grass Valley on the 3<sup>rd</sup> day of June 1997, in accordance with the provisions of the City Charter, California Elections Code, and other State Laws concerning election matters; and

WHEREAS, the County Clerk did conduct said election, canvass the returns and certify the Statement of Results of the Election on June 5, 1997; and

WHEREAS, Proposition 218 requires that all special taxes receive at least 66-2/3rds vote and Measure A, the Emergency Medical and Fire Response Tax passed with a 78.3% approval; and

WHEREAS, Measure A includes a provision for an automatic cost of living allowance not to exceed 5% per year; and

WHEREAS, the December 2024 cost of living allowance as determined by the CPI – All U.S. Cities Index showed a 2.9% annual increase; and

WHEREAS, the cost of living allowance increase is necessary to continue to fund the firefighters as provided for in the special emergency response tax; and

WHEREAS, the total CPI adjustment for FY 2025 – 2026 Measure A special tax is 2.9%.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Grass Valley, as follows:

**Background Information:** Health and Safety Code Section 5473 allows the City to place delinquent sewer and/or water charges on the County property tax roll for collection, with a two-thirds vote of the City Council. This process is used when utility service cannot be discontinued as a means of collecting unpaid charges and follows the same procedures as property tax collection.

Nevada County participates in the Teeter Plan, a property tax distribution method in which the County pays the City the full amount of the delinquent charges up front and assumes responsibility for collecting from the property owner. This ensures timely revenue for the City even if the property owner delays or fails to pay their tax bill. The method has proven to be a reliable and effective tool for recovering unpaid utility charges.

All affected property owners were notified in accordance with state law. Initial notices were mailed on June 12, 2025, with follow-up letters sent on June 30, 2025. Any delinquent accounts paid before the final submittal to the County will be removed from the list.

As of July 17, 2025, the total amount of delinquent charges eligible for placement on the tax roll is \$179,101.24. This amount may be reduced if additional payments are received after the publication of this report and before the City Council meeting. An updated list of delinquent accounts will be provided to the Council in advance of the hearing.

<u>Council Goals/Objectives</u>: This action supports Strategic Plan Goal #7 - Water and Wastewater Systems & Underground Infrastructure, by ensuring sustainable cost recovery for utility services.

- 3. The City Council acknowledges that the City will incur costs for this collection service, to be charged in accordance with the "Standard Form Tax Collection Services" agreement between the City of Grass Valley and the County of Nevada.

## **Background Information:**

The Cities of Grass Valley and Nevada City are jointly exploring the feasibility of developing a shared facility to support local CRV (California Redemption Value) buyback, composting, and clear plastic recycling operations. Currently, these services are centralized at the County-owned McCourtney Road Transfer Station (MRTS), operated by Waste Management (WM). Green waste and other organics from MRTS are hauled to composting facilities more than 36 miles away, and the existing CRV buyback center—also located on County property—is inconvenient for many local residents.

In response to growing interest in sustainable and community-based waste management solutions, both cities are considering localized alternatives that would:

- Reduce transportation costs and emissions by processing organic waste closer to the source and making finished compost available for community use;
- Expand public access to CRV buyback services, addressing service gaps caused by the closure of multiple centers in recent years;
- Support local, volunteer-led recycling efforts for items such as film plastic and food waste;

 Assess the potential for capturing and processing cannabis-related waste as a supplemental revenue stream.

To evaluate these opportunities, the Cities propose a high-level feasibility study that will examine applicable regulations, market demand, operational requirements, potential sites, and preliminary financial projections. The study will help determine whether the development of a shared facility is practical and beneficial.

The objective is to provide both Cities with clear direction on the viability of establishing a local facility for compost processing and CRV/recyclables drop-off. While not intended to produce final designs or cost estimates, the study will offer guidance on next steps and key considerations for moving forward with a project of this nature.

A copy of the proposal for the Feasibility Study is attached for City Council's review and information.

<u>Council Goals/Objectives</u>: The execution of this action attempts to achieve the following Strategic Goals - Community and Sense of Place.

**<u>Fiscal Impact</u>**: The total cost of the Feasibility Study is estimated at \$25,000, to be shared equally between the City of Grass Valley and the City of Nevada City. Sufficient funds are available in the General Fund Contingency and Measure B allocations to cover Grass Valley's share of the cost.

# **1. SCOPE OF WORK**

## Background

WM is the operator of Nevada County-owned McCourtney Road Transfer Station (MRTS), located at 14741 Wolf Mountain Rd., Grass Valley. From the MRTS, WM transports green waste and other organics to composting facilities that are, at a minimum, 36 miles away. WM also operates a buy-back center for CRV on County-owned land adjacent to MRTS.

# For the following reasons, the Cities are considering the development of alternative facilities for various waste streams:

- » The Cities have a preference for keeping organic waste within the community for processing and use of the finished organic waste product, as well has identifying a more economically beneficial solution.
- » Several buyback centers have closed in recent years, and the current location of the buy-back center is inconvenient for many residents of Nevada City and Grass Valley.
- » The local community has created grassroots processes for managing film plastic, food waste and other waste products, and the jurisdictions would like to support the community effort.
- » The region generates a notable amount of cannabis waste, and the Cities believe capturing this material could be a revenue stream that can help support localized efforts.

This proposed scope aims to fulfill a cooperative planning task for both Cities, who jointly are interested in understanding what services can be localized to their communities. It is anticipated that should this project move forward, Nevada City will serve as the contracting agency.

## **Scope of Work**

R3 is proposing to conduct an initial evaluation of the opportunity for the Cities to develop a local site for management of discreet material types. This feasibility analysis will be high-level such that it will help guide the jurisdictions on a potential course. This analysis will not result in final costs or an implementable technical protocol, but rather is intended to be an initial viability check towards aligning on a proper course forward to manage local waste.

## Task 1 Policy and Regulation Framework

- **1.** Research California Redemption Value (CRV) and the Bottle Bill by conducting research and compiling information about the current state of CRV and statewide status of buyback centers.
- **2.** Research general permitting requirements for compost handling facilities, with a particular focus on cannabis handling, and associated regulatory requirements.
- **3.** Research other agencies (JPAs, Cities, and Counties) that operate or contract to operate buyback centers and/or small to medium scale composting facilities throughout the State by conducting online research and phone calls.
- **4.** Establish communication with CalRecycle staff responsible for the Bottle Bill administration as well as local LEA staff to gather information and identify solutions.

### Task 2 Market Analysis

- **1.** Assess Buyback and composting facilities within a 60-mile radius of the McCourtney Road Transfer Station.
- 2. Conduct outreach with existing grassroots recycling groups, including film plastic group, to understand their processes, the material they collect, and their niche in the market.

- **3.** Document local buyback centers that have closed in the last ten years and gather data on gaps created by their absence.
- **4.** Research the generation of cannabis waste in the region and local handling procedures currently in place.
- **5.** Document tonnage trends of covered waste streams over the past few years to understand potential throughput.

### Task 3 Financial Analysis

- **1.** Research grant funding and other financial resources available for the development of buyback centers and composting facilities.
- **2.** Understand costs associated with existing processing of material per collection and processing agreements with WM.
- **3.** Develop preliminary proforma establishing planning level estimated expenses and revenues and project an approximate ROI.

### Task 4 General Siting Parameters

**1.** Develop guardrails for requirements for facility relative to zoning, space requirements, and accessibility based on anticipated volume and user type(s).

### Task 5 Benefit Analysis, Recommendations and Deliverable

- **1.** Based on gathered information and analysis, determine benefits and drawbacks associated with this type of project.
- **2.** Depending on the outcomes of the research, suggest alternatives (if viable) to the initial concept of the project.
- **3.** Develop a framework for next steps to further develop an implementable project, with greater emphasis on technical analysis and more detailed financial forecasting.
