**1. Call to Order**

#### **6. Greeley on the Go- City Transportation Master Plan**

Public Works Director Paul Trombino introduced this item and turned the presentation over to Allison Baxter, Transportation Planner. Planner Baxter presented as set forth in the presentation in the agenda packet.

As part of the presentation, a draft vision statement was provided for Council feedback. Discussion on the statement focused on the value of the word 'easy' in the statement, and examples of developing areas where that is not ideal.

There was consensus to accept the statement as presented.

The second item presented to the Council for feedback was the list of eight goal areas identified in the plan. Support for the inclusion of safety in particular was voiced. There was discussion around what is intended in each of the goal areas. There was consensus to accept the goals as presented.

At the conclusion of the item, Mayor Pro Tem Hall requested information on the status of the Hwy 34 interchanges. Director Trombino responded, indicating ongoing communication with the Colorado Department of Transportation (CDOT) and the wait for additional information on timing and next steps.
