**Committee Duties**: Promote and provide public awareness for programs, opportunities, initiatives of public, private, and charter schools, to recognize and promote the accomplishments of students, educators, and all schools located within the city; to also oversee and recommend up to ten (10) educational scholarship awards annually to eligible high school seniors, college, technical, or trade school students who reside in the city.
