The ZBAA granted a garage reduction for interior units only. Planner Leon presented the buffer plans and landscape plans. The applicant presented architectural elevation plans. The project would be compatible with neighboring residential plans. Planner Leon stated the ZBAA presented some conditions. Staff recommended approval of Resolution.
