F. Manager's Report

Winter Issues

Winter is here. Please be careful on snowy roads and remember that you cannot push your snow into the Town's right-of-way unless you have received permission from Town staff.

Pretty soon, we will begin seeing snowmobiles on our streets. If you plan on snowmobiling in Grand Lake, make sure that you are familiar with the rules and regulations. They can all be found in Chapter 7, Article 7- of the Town code.

Grand Passes

With ski season about to start, I want to remind the Trustees that the Town receives two Grand Passes for the use of employees and Trustees. If you are interested in using the passes, check with Caitrin to see if they are available.

Housing Progress

The affordable housing units at Portal Crossing are under construction. If you are interested in one of the units, please contact the Town's Community Development Director, Kim White, for more details. The CHFA study of the Mary Drive parcel is continuing with a traffic study. We should see plans in the beginning of 2023. Space to Create has been awarded \$3 million for its project, and it looks like additional funds will be coming soon. We anticipate that we will be breaking ground by the end of 2023. These three projects could bring an additional 50+ workforce units to our Town in the very near future.

Snow Plowing

Winter is in full force, and we will have plows out on our streets most days. Please be careful when driving around our workers and please keep an eye out for pedestrians.

As we plow, we will be creating berms across homeowner's driveways. There is no way for our public works drivers to avoid this. It is the responsibility of the individual homeowners to clear the berms if they need to in order to access their homes. The Town cannot clear individual driveways. If you are clearing your own snow, remember that you cannot store it in the Town right-of-way without specific permission.

Upcoming Events

The Rocky Mountain Repertory Theater will be holding its Home for the Holidays show on December 17 & 18 and its annual New Year's Eve show on December 31. The Grand Arts Council will be hosting its comedy show at the Community House on December 30. You will be blown away by the new lighting and sound system in the Community House. You can get tickets at grandartscouncil.com. The Town will be launching another spectacular fireworks show at 12:00 midnight on New Year's Eve (Dec. 31).

Ice Rink

Ice is forming on the lake and Town staff is keeping a close eye on it. As soon as the ice is thick enough, we will be opening the ice rink on the lake by the Town dock. Staff will be plowing and maintaining the ice with the Zamboni.
