A. Public Hearing- Resolution 04-2022 Consideration to Recommend a Special Use Permit (SUP) to Allow a Commercial Use on Property Located at Block 3, Lot 4-6, Town of Grand Lake.

There was no public comment. The applicant stated that she will not be removing any structures, but will be cleaning up the lot. She will build a ramp to protect the boardwalk when moving the truck across the boardwalk. There will be trash cans that will be emptied each night. The commission discussed the removal of the days of the week from the resolution in case the applicant wanted to extend the days or hours of operation.

Motion made by Commissioner Murray, Seconded by Commissioner Burke.

B. Public Hearing - Resolution 05-2022 Consideration of a Conditional Use Permit Application for a Business That Generates Income From The Use and Utilization of Animals, Located at Lots 15-16, Block 26, Town of Grand Lake

Planner White introduced the applicant and proposal stating that the applicant has requested a conditional use permit to use the property as a training facility and daycare for canines at the location

which currently has a conditional use permit for canine boarding. The commission stated that since the use is similar to the current use, that it meets the requirements of the conditional use permit.

Motion made by Commissioner MacSllarrow to recommend the Conditional Use Permit, Seconded by Commissioner Burke.

C. Public Hearing - Resolution 06-2022 To Consider the Construction of an Inland Boatslip at Subd. Shadow Point Lot 6, Also Known As 300 Lakeside Drive.

Planner White presented the application as stated in the packet and memo. The commission discussed the 7 findings of fact for the shoreline variance request and to find 5 items for the allowance of a retaining wall over 6'. The planner stated that this is a variance request and it is not the building permit. The Applicant, Chapdelaine's spoke about their permit request. They stated that they changed their design from a gabion basket to a concrete wall due to structural concerns with their home. They will be working with Roger Claeys to build the boat slip. They will be trucking the soil offsite. They will be using an aquadam to retain the sediment while they dig out the slip.

Public comment:

Sylvia Hites at 304 Lakeside Dr. stated that she thought it will be very nice to have.

Michael McDonald 217 Marina Dr. Said he was concerned about pouring concrete with water and our lake.
protect our water.

Scott Munn- asked why digging down 8 feet for a concrete wall is better than stair-stepping a 4' wide gabion basket for the foundation of the house? He stated that he did not see information on the application about how the water is being pumped out , where it is getting stored, how is it getting filtered. He said the applicant spoke about it, but he wants to see the plan in writing by an experienced contractor. Wants to know who will be writing up those plans. He asked how far the setback was from the house.

Mr. Chapdelaine stated that he is relying on Roger Claeys and Dave Z as the experts to tell him how this should be built. He stated that the setback for the gabion was making it dangerous for the house. He stated that the setback was "right there" indicating it was next to the house.

Commissioners: Chairman asked the Planner if the erosion control details come in at the variance level or at the building permit, staff stated that the erosion control would be at the building permit. Vice-chair MacSllarrow was concerned with the unknown environmental consequences with over-pouring concrete into the lake.

Motion made to approve the shoreline and retaining wall height variance by Commissioner Murray, Seconded by Commissioner Burke.

D. Art Space/ Space to Create - Conditional Use Permit Review

Planner White presented this item as stated in the packet. She stated that the commission could motion to request a public hearing, motion to recommend the CUP to the Board; at the Board meeting, the board can approve the CUP or request a public hearing. Due to the controversial nature of this application the commissioners motioned to recommend that the board of trustees hold a public hearing about the CUP, and if they chose not to have a public hearing, the item would come back to the planning commission for a public hearing before the board could vote on it. The commissioners need to discuss the factors which are economic effect, character on the neighborhood, and any other items that the commission deems necessary.

Commissioner Burke asked about the water protection area for the well on the corner of the lot proposed for Artspace. This setback has been considered on the site plans.

The applicant Will Law spoke about the project, stating that he is confident that they will be funded with an upcoming grant if they can get their application in in the next few days/weeks. In order to apply for the grant, that would pay for the majority of the project, they need to have a recommendation from the Town stating that the zoning would be approved. Commissioner Murray asked if the Town would be able to mandate occupant qualifications, such as veteran's, fire fighters, work force housing in addition to art space. The applicant stated that this will be in the development agreement with the Town to outline these objectives. They stated that the Town constituents would need to vote on the sale of the property. Commissioner Bishop asked who would manage the units. The applicant said that Artspace would be responsible, they self manage in most locations unless they find a local management group that provides adequate services for rent collection and maintenance, and compliance to affordable housing to the federal government and state of CO. Commissioner Bishop was concerned that the public was not being heard and wanted a public hearing before it went to the Board with a recommendation. Chairman Shockey asked about the number of units that are available, the 3 units that are on Hancock are non-live units that will be small galleries or studio spaces. They can be rented to people in the community or to the people who live in the building. The purpose of the spaces on Hancock was to wrap the commercial district from downtown, around the corner. Chairman Shockey asked if there was a transition or buffer was going to be in place to the west property line. Scott Munn of Munn Architecture stated that it will be addressed as the proposed design is developed. Vice-Chair MacSlarrow asked if there were any public hearings for this specific location. The applicant stated that it was heard at one board meeting meeting and was in the paper. The design will be shown to the public and there will be community meetings and multiple reviews, as this is just for the entitlements. Commissioner Burke said that since it coming up on the summer it will allow for more people to be involved and there should be a hearing at the planning commission level to get the new Board up to date on the project. There was much discussion about community engagement and suggested that a motion be made to require a hearing at the Board level. Vice Chair MacSlarrow asked that if the funding were available tomorrow would not having the zoning in place disqualify the application. The applicant stated that it was a threshold requirement to apply for the grant. DiAnn Butler spoke about the public outreach that has occurred for over the past three years.

Motion made by Commissioner Murray to recommend approval of the conditional use permit with the condition that a public hearing be held, if the Trustees chose not to hold a public hearing it reverts back to the planning commission to hold a public hearing. Seconded by Commissioner Bjorkman.

E. Rocky Mountain Repertory Theatre - Off-Broadway Housing- Sketch Plan

Planner White presented the item as was written in the packet. This meeting is to exchange information when they submit their development plan. The planner stated that applicant would like to combine the preliminary and final development plan because the development is substantially the same as the existing; that the property has an old lot line agreement recorded, but when the final plat is done, it will be recorded as a lot consolidation plat to be up-to-date with the current process for combining lots; two variances will be requested during the development plan which should be discussed if these will be feasible to be approved in the development plan. The 2 variances are: MC states a 20' space between buildings, but IBC states that 10' space is required, and they received feedback from the fire department that the spacing was ok; that the first 50' are supposed to be commercial and they are not currently and will not be in the future. Commissioner Burke stated that the units would be helpful to reduce pressure on the community to provide affordable units for the theater. Commissioner Murray said this a valuable asset to the Town. Commissioner Bishop noted that the modular units did not appear to be modular and looked nice.

Christopher Tagseth of Munn architecture presented the sketch plan by discussing the poor conditions of the existing structures. He stated that they would be improving the drainage by adding the storm drainage; the alley parking would be 2" of compacted gravel; leave the gravel driveway south of "Judy's house", and would be used for snow storage. Commissioner Bjorkman stated his only concern was that these houses are only used 3 or 4 months of the year. The RMRT are concerned that renting it out would affect their non-profit tax-exempt status.

The commissioners discussed whether or not the trees would be removed, and the applicant said that 4 trees will be affected. They asked about extending the boardwalk, and it was stated that it was a swale to the north and no boardwalk exists. The chairman asked if there could be gable roofs and the applicant stated that it was not in the plans currently. The commissioners discussed that the proposed use is essentially the same as existing. The commissioners said that they would be in favor of all of the items that were requested. The construction would begin in September after the RMRT theater staff left. The project would be built by May if everything stays on schedule. There was no motion because it is a sketch plan.

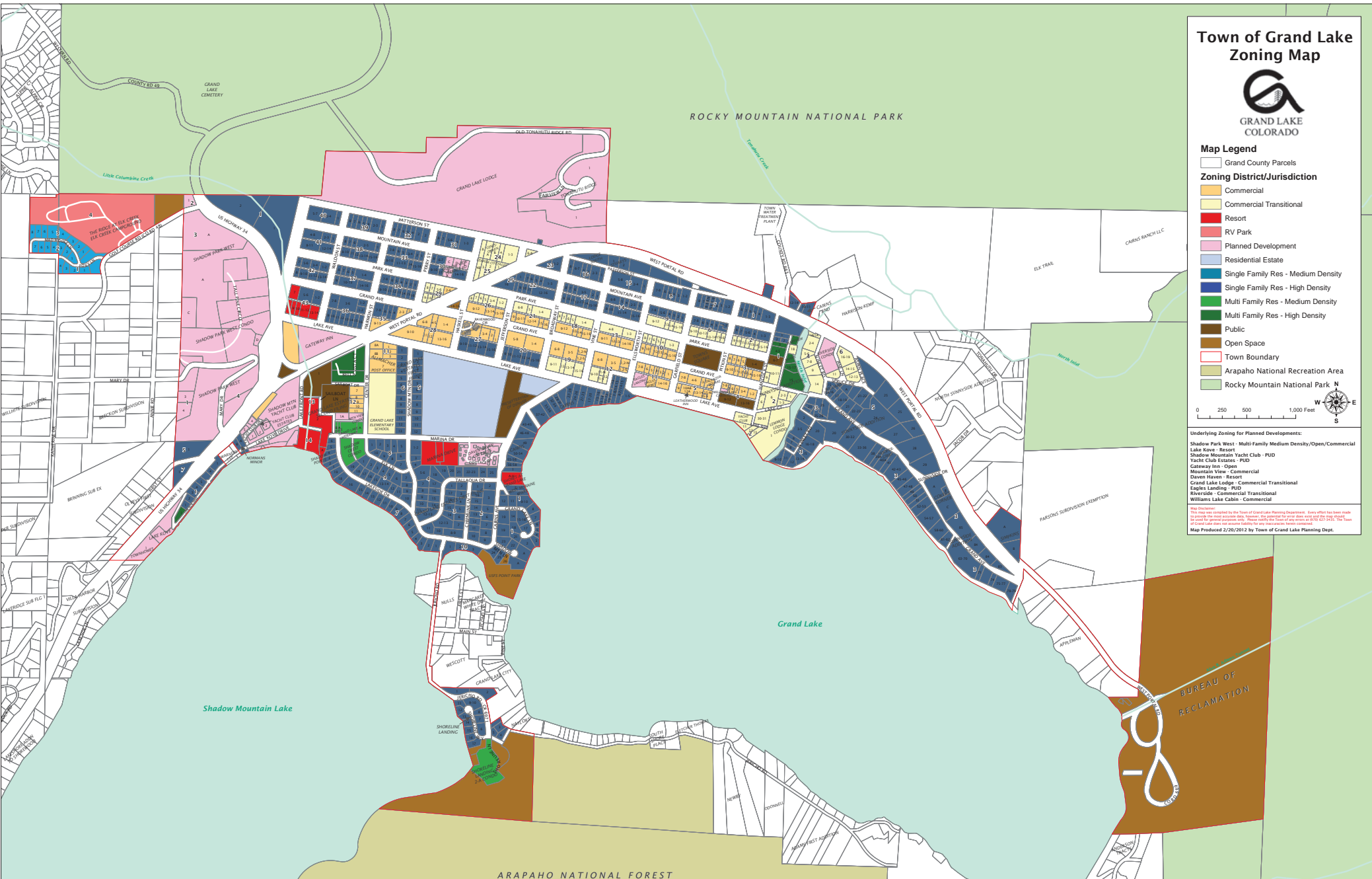

4. Nightly Rental Conditional Use Permits

Nightly Rental Conditional Use Permits depend on the zoning district which the proposed rental is located. In addition to other Town requirements, no person shall rent or advertise to rent a Single Family structure, dwelling, dwelling unit, or lock-off unit for nightly rental purposes, except in accordance with the provisions of this Article. Nightly Rental CUP applications and renewals will be exempt from the Conditional Use Permitting deposit but may be assessed other fees, as defined within the provisions of this Article.

(a) Nightly Rental Conditional Use Permits by Zone

1. The following shall apply only to the following districts: OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, and MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY.

(i) Town Action:

1. If Town Staff determines that the application satisfies the requirements of Section 12-2-31(B)4, all adjoining property owners or all owners within 100', whichever includes the largest number of properties, will be notified in writing by the Town of the applicants proposed use. All notified property owners will be given fifteen (15) days to object to the proposed use in writing.
2. If one (1) or more notified property owners object to the proposed use in writing, the application shall be treated as a conditional use as outlined in Section 12-2-31(B)3. The owner of the subject property shall be given a copy of all written complaints. In consideration of the proposed use, the Planning Commission may hold a Public Meeting to determine its recommendation to the Board of Trustees. The Board of Trustees may hold a Public Hearing on the proposed use to decide whether to approve, modify, or disapprove the Planning Commission's recommendation.
3. If zero notified property owners object to the proposed use, Town Staff shall issue the Nightly Rental License administratively.
4. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the owner has the option of purchasing a business license in lieu of the Nightly Rental License.



5. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

(ii) Renewal

1. If zero complaints have been filed in the previous 12 months, and the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License. For purposes of Section 12-2-31(B)4, a complaint must be either an official police citation or a letter signed by the complaining party.
 2. If one (1) or more complaints have been filed in the previous 12 months, the applicant must pay the appropriate application fee, as set by Resolution by the Town Board of Trustee and Nightly Rental License fee. The Town shall provide notice to all adjoining property owners or all owners within 100', whichever includes the largest number of properties, and the application shall be treated as a conditional use as outlined Section 12-2-31(B)4.
2. The following shall apply only to the following districts: COMMERCIAL TRANSITIONAL, COMMERCIAL, and RESORT DISTRICTS.

(i) Town Action:

1. If Town Staff determines that the application satisfies the requirements of Section 12-2-31(B)4, the Nightly Rental License will be issued.
2. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the owner has the option of purchasing a business license in lieu of the Nightly Rental License.
3. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

(ii) Renewal

1. If the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License.
3. The following shall apply only to the following districts: PD and PUD.
- (i) Planned Developments/Planned Unit Developments—Are considered one in the same; PD's that have no underlying zoning or are zoned PD



or PUD shall be governed under Section 12-2-31(B)4(a)1.

(b) Nightly Rental Conditional Use Permit Regulations - Nightly rentals of such units shall only be authorized if all of the following conditions are met:

1. Applicant must provide two copies of a site plan that displays conformance with the following criteria, the appropriate application fee for all units listed in 12-2-31(B)4(a)1, and the appropriate Nightly Rental License fee. No person shall rent or advertise for rent their structure, dwelling or dwelling unit unless a Nightly Rental License has been granted by Town Staff. A nightly Rental License must be obtained for each structure, dwelling, or dwelling unit. If an application is subsequently denied, the applicant shall be refunded the Nightly Rental License fee.
2. All fees, dues, debts to the Town of Grand Lake, and taxes must be current before a license will be issued.
3. The fee for a Nightly Rental License is set by Resolution. In instances when a license is issued for a period of time other than 12 months, the fee shall be prorated for the number of months in which it is being issued. Other than the first issued license to an owner of a unit for that unit, all Nightly Rentals shall be issued for 12 months, from January 1st to December 31st. The Nightly Rental License for a unit is transferable to a new owner of that unit upon completion of a complete and approved application.
4. No person shall be granted a Nightly Rental License unless a state sales tax number has been received to provide for the collection of state, local sales and lodging taxes. If the structure, dwelling, or dwelling unit is operated by a third party as defined in Section 12-2-31(B)4(b)5, the third party may use a pre-existing sales tax number for purposes of this paragraph.
5. At the time an application for a license is submitted, the licensee shall provide to Town Staff the name, address and telephone number of any current management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. It shall be the duty of the licensee to update such information throughout the term of the license so that Town Staff always has the correct and current information.
6. At the time of the application of the license the licensee shall provide to Town Staff the name, address and telephone number of a local contact person who is authorized by the licensee to receive communications from the Town concerning the nightly rental. The local contact person may be a management company, rental agent or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. The local contact person shall maintain a residence or permanent place of business within 15 minutes driving distance to the Town and must be available 24 hours per day, seven days per week, during periods in which the structure is being rented. The designated local contact person may be changed by the licensee from time to time throughout the term of the license. To effect such change, the licensee shall notify Town Staff of the change in writing in advance of the change and shall, at the same time, provide Town Staff with the name, address, and telephone number of the licensee's replacement contact person. Any replacement contact person shall meet the requirements of this subparagraph.



7. Site Plan Criteria:

- (i) Adequate parking shall be shown on the site plan, as outlined in Section 12-2-28. Parking requirements for nightly rentals shall be calculated from Group II. The motor vehicles of all occupants of the nightly rentals shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.
- (ii) There is a clearly-defined trash storage area and an adequate number of trash containers provided and the trash company hired for regular pick-up must be identified. The owner or property manager may use the Pay As You Throw (PAYT) trash program in lieu of hiring a trash company for regular pick-up.
- (iii) The Single Family Dwelling Unit to be used as a nightly rental shall provide on-site snow storage that is equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.
- (iv) The location of the Single Family Dwelling unit, Accessory Dwelling Unit, and all other buildings must be depicted and labeled accordingly. The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.
- (v) The applicant shall obtain HOA sign-off if the property resides within an HOA.

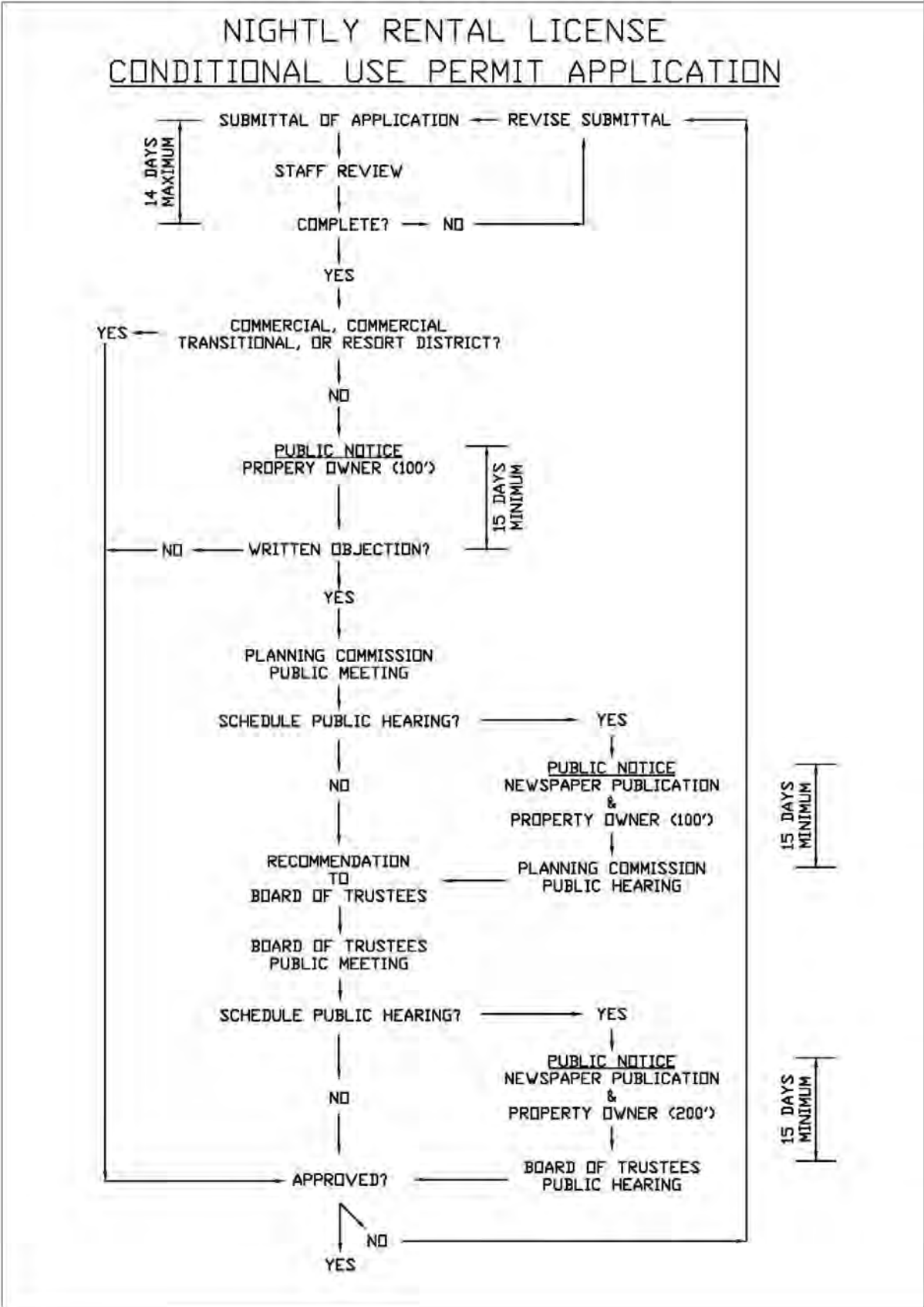

- (i) While occupying or visiting a nightly rental, no person shall make, cause or permit unreasonable noise to be emitted from the nightly rental that is in violation of 7-1-15 Disturbing the Peace or 7-1-16 Unnecessary Noise.
- (ii) At no time shall a nightly rental qualify for a sign permit. If more than one property is accessed by a shared driveway, written permission to access the drive must be obtained from each affected property owner.
- (iii) Compliance with the conditions set forth in Section 12-2-31(B)4(b) shall be the non-delegable responsibility of the owner of the nightly rental; and each owner of a nightly rental shall be strictly liable for complying with the conditions set forth in this Section or imposed by the Board of Trustees.
- (iv) Licensee to Receive Conditions. At the time of the issuance of a license, Town Staff shall provide the licensee with a copy of the special conditions set forth in Section 12-2-31(B)4(b) or imposed by the Board of Trustees.
- (v) Licensee to Post License and Conditions. The licensee shall post a copy of the license and the conditions set forth in Section 12-2-31(B)4(b) or imposed by the Board of Trustees in a conspicuous



location in the nightly rental. The license and the conditions shall remain continuously posted in the nightly rental throughout the term of the license.

- (vi) Licensee to Provide Management Company with Conditions. The licensee shall provide any management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental with a copy of the conditions set forth in Section 12-2-31(B)4(b) or imposed by the Board of Trustees.
- (c) Nightly Rental Conditional Use Permit Penalties
1. Any person found to be advertising a Nightly Rental without a license to rent that property will be notified by certified mail to cease and desist all advertisements. Upon receipt of that notice, the offending party shall have ten (10) days to remove the offending advertisement. After this grace period has ended, or upon a second or further violation, the offending party shall be determined to be in violation of this Ordinance and shall be ticketed for each offense.
 2. A violation of any part of Section 12-2-31(B)4 is punishable by a fine not to exceed Three Hundred Dollars (\$300.00) for each occurrence. Each day such violation persists or continues shall constitute a separate and distinct offense.
 3. The Town may also seek an injunction in addition to all other remedies and penalties provided for by local ordinance or available law.
 4. All these remedies shall be in addition to all other remedies and penalties provided for by local ordinance or available at law.

ORDINANCE NO.1- 2005.

AN ORDINANCE AMENDING CHAPTER TWELVE, ARTICLE TWO, ZONING REGULATIONS FOR OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY, COMMERCIAL TRANSITIONAL, COMMERCIAL, RESORT DISTRICTS, PLANNED DEVELOPMENTS/PLANNED UNIT DEVELOPMENTS WITHOUT UNDERLYING ZONING and SUPPLEMENTAL REGULATIONS.

WHEREAS, the Town Board of Trustees finds and determines that there have been numerous incidents where the nightly rental of residences has resulted in conditions that are extremely disturbing and disruptive to persons residing next to or in close proximity to the nightly rental; and,

WHEREAS, the Board of Trustees further finds and determines that the nightly rental of properties located in residential areas creates special problems for those persons who live near the nightly rentals including, but not limited to, ownership of nightly rentals by nonresident owners who often are not fully aware of how their property is being used on a day to day basis; overcrowding of the nightly rental; noise disturbances emanating from the nightly rental; insufficient parking to accommodate all of the persons who occupy the nightly rental; and inadequate disposal of trash generated from the use of the nightly rental; and,

WHEREAS, the Board of Trustees finds and determines that the practice of nightly rentals in districts in which residential uses are permitted creates an unfair disadvantage to businesses that provide this same service, since such businesses purchase a business license, collect sales tax and are assessed at a commercial property rate, and therefore find it difficult to remain competitive while still retaining a profit; and,

WHEREAS, the Town of Grand Lake Planning Commission appointed an ad hoc committee to make recommendations to the Planning Commission; and,

WHEREAS, the ad hoc committee's recommendations are reflected in this document; and,

WHEREAS, the Town of Grand Lake Planning Commission held a public meeting, following public notification, on December 7, 2005; and,

WHEREAS, the Board of Trustees held a public hearing, following public notification, on January 9, 2006; and,

WHEREAS, following the public hearing, the Board of Trustees agreed with the recommendation of the Planning Commission regarding the proposed amendments to the Zoning Regulations of the Town of Grand Lake Code; and,

WHEREAS, the Board of Trustees finds and determines that this Ordinance is timely in that current laws and Town regulations are insufficient to adequately address the aforementioned problems;

NOW THEREFORE BE IT ORDAINED BY THE TOWN OF GRAND LAKE BOARD OF TRUSTEES AS FOLLOWS:

1. In order to clarify the Board’s intent, Chapter 12, Article 2 shall be amended as follows:

12-2-6 **Nightly Rental -- A structure, dwelling or dwelling unit that is rented for periods of time of less than thirty (30) consecutive days. The term “Nightly rental” shall not include hotel, motel or bed and breakfast establishments**

12-2-8 (a)(6), (b)(9) **Nightly Rentals**

12-2-9 (a)(7), (b)(5) **Nightly Rentals**

12-2-10 (a)(6), (b)(5) **Nightly Rentals**

12-2-11 (a)(6), (b)(5) **Nightly Rentals**

12-2-12 (a)(6), (b)(5) **Nightly Rentals**

12-2-13 (a)(6), (b)(5) **Nightly Rentals**

12-2-14 (a)(6), (b)(5) **Nightly Rentals**

12-2-15 (a)(6), (b)(5) **Nightly Rentals**

12-2-17 (a)(14) **Nightly Rentals**

12-2-18 (a)(9) **Nightly Rentals**

12-2-21 (a)(7) **Nightly Rentals**

12-2-23 (j) **The following shall apply only to the following districts: OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, and MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY**

Nightly Rentals – In addition to other Town requirements, no person shall rent a structure, dwelling, dwelling unit, or lock-off unit for nightly rental purposes, except in accordance with the provisions of Section 12-2-23(j). 1. Applicant must provide two copies of a site plan that displays

conformance with the following criteria, an application fee of \$150, and a Nightly Rental License fee of \$400. A Nightly Rental License must be obtained for each structure, dwelling, or dwelling unit. If an application is subsequently denied, the applicant shall be refunded \$400.

2. Application can be made for a Nightly Rental License as early as June 1st for the subsequent year and the first Nightly Rental License for any applicant may be valid for a period of up to 19 months (June 1st of current year through December 31st of following year). In instances when a license is issued for a period of time other than 12 months, the fee shall be prorated for the number of months in which it is being issued. Other than the first issued license, all Nightly Rentals shall be valid for 12 months, from January 1st to December 31st.

3. No person shall be granted a Nightly Rental License unless a state sales tax number has been received to provide for the collection of state, local sales and lodging taxes. If the structure, dwelling, or dwelling unit is operated by a third party as defined in Section (j)(4), the third party may use a pre-existing sales tax number for purposes of this paragraph.

4. At the time an application for a license is submitted, the licensee shall provide to the Town Clerk the name, address and telephone number of any current management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. It shall be the duty of the licensee to update such information throughout the term of the license so that the Town Clerk always has the correct and current information.

5. At the time of the application of the license the licensee shall provide to the Town Clerk the name, address and telephone number of a local contact person who is authorized by the licensee to receive communications from the Town concerning the nightly rental. The local contact person may be a management company, rental agent or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. The local contact person shall maintain a residence or permanent place of business within 15 minutes driving distance to the Town and must be available 24 hours per day, seven days per week, during periods in which the structure is being rented. The designated local contact person may be changed by the licensee from time to time throughout the term of the license. To effect such change, the licensee shall notify the Town Clerk of the change in writing in advance of the change and shall, at the same time, provide the Town Clerk with the name, address and telephone number of the licensee's replacement contact person. Any replacement contact person shall meet the requirements of this subparagraph.

Site Plan Criteria:

6. Adequate parking shall be shown on the site plan, as outlined in Section 12-2-23(a). For purposes of Section 12-2-23(j), parking requirements for nightly rentals shall be calculated from Group III. The motor vehicles of all occupants of the nightly rentals shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.
7. There is a clearly-defined trash storage area and an adequate number of trash containers provided and the trash company hired for regular pick-up must be identified.
8. The dwelling to be used as a nightly rental shall provide on site snow storage that is equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.
9. The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.
10. The applicant shall obtain HOA sign-off if the property resides within an HOA.

Town Action:

11. If Town Staff determines that the application satisfies the requirements of Section 12-2-23(j), all adjoining property owners or all owners within 100', whichever includes the largest number of properties, will be notified in writing by the Town of the applicants proposed use. All notified property owners will be given fifteen (15) days to object to the proposed use in writing.
12. If one (1) or more notified property owners object to the proposed use in writing, the application shall be treated as a conditional use as outlined in Section 12-2-23(b). The owner of the subject property shall be given a copy of all written complaints. In consideration of the proposed use, the Planning Commission may hold a Public Meeting to determine its recommendation to the Board of Trustees. The Board of Trustees may hold a Public Hearing on the proposed use to decide whether to approve, modify, or disapprove the Planning Commission's recommendation.
13. If zero notified property owners object to the proposed use, Town Staff shall issue the Nightly Rental License administratively.

14. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the Nightly Rental License Fee shall only be \$165.

15. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

Additional Criteria:

16. While occupying or visiting a nightly rental, no person shall make, cause or permit unreasonable noise to be emitted from the nightly rental that is audible upon private premises in excess of the limits set forth in Sections 25-12-101 through 25-12-109, Colorado Revised Statutes.

17. At no time shall a nightly rental qualify for a sign permit. Signs for advertising shall not be permitted at nightly rentals except as outlined in Section 6-2-1(c), Town of Grand Lake Sign Code.

18. If more than one property is accessed by a shared driveway, written permission to access the drive must be obtained from each affected property owner.

19. Compliance with the conditions set forth in Section 12-2-23(j) shall be the non-delegable responsibility of the owner of the nightly rental; and each owner of a nightly rental shall be strictly liable for complying with the conditions set forth in this Section or imposed by the Board of Trustees.

20. Licensee to Receive Conditions. At the time of the issuance of a license, the Town Clerk shall provide the licensee with a copy of the special conditions set forth in Section 12-2-23(j) or imposed by the Board of Trustees.

24. If one (1) or more complaints have been filed in the previous 12 months, the applicant must pay an application fee of \$150 and a Nightly Rental License fee of \$400. The Town shall provide notice to all adjoining property owners or all owners within 100', whichever includes the largest number of properties, and the application shall be treated as a conditional use as outlined in paragraph twelve (12) of Section 12-2-23(j).

Penalties

25. Any person found to be advertising a Nightly Rental without a license to rent that property will be notified by certified mail to cease and desist all advertisements. Upon receipt of that notice, the offending party shall have 10 days to remove the offending advertisement. After this grace period has ended, or upon a second or further violation, the offending party shall be determined to be in violation of this Ordinance and shall be ticketed for each offense.

26. A violation of any part of this Article is punishable by a fine of up to \$300 for each occurrence. Each day of violation is a separate offense.

27. The Town may also seek an injunction in addition to all other remedies and penalties provided for by local ordinance or available law.

12-2-23 (l) The following shall apply only to the following districts: PD and PUD.

Planned Developments/Planned Unit Developments—Are considered one in the same; PD's that have no underlying zoning or are zoned PD or PUD shall be governed under Section 12-2-23 (j).

2. Except as specifically hereby amended, Chapter 12, Article 2 shall remain in full force and effect.

3. Repeal - Existing ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.

4. Validity - If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The Town of Grand Lake hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.





Section 12-2-17 Regulations for CT - Commercial Transitional District

The Regulations set forth in this Section, or set forth elsewhere in this Article, when referred to in this Section, are the District Regulations in the CT - Commercial Transitional District.

- a. Uses Permitted by Right
 - 1. Single Family Dwelling Units
 - 2. Neighborhood Businesses
 - 3. Day Nurseries or Child-Care Centers
 - 4. ~~Commercial Parking Lots and~~ **Private and Publicly-owned Parking Lots**
 - 5. Not-for-Profit Clubs and Service Organizations
 - 6. Hotels, Motels, Condo/Hotels and Lodges
 - 7. Group homes for the elderly **and indigent**, ~~limited to persons sixty years of age or older and further~~ limited to not more than eight persons per home.
 - 8. Multi-family attached rental units
 - 9. Bed and breakfast establishments
 - 10. Condominiums and Townhouses - Timeshare and interval estate units of more than sixteen shares per unit are required to have a central reservation facility on site.
 - 11. Mixed Residential with permitted Commercial Use within the same building or buildings on the lot.
 - 12. Rental, repair, wholesaling, and storage in conjunction with any of the above non-residential uses, provided all such activity is clearly incidental and accessory to said uses, and further provided all such activity is conducted within a building.
 - 13. Accessory buildings and uses normal and customary to the uses listed above.
 - 14. **Multi-family attached rental units, condominiums and townhouses are uses permitted by right except on the first story, as defined in**

this Chapter 12 Article 2. This regulation applies to projects for which a Building Permit has not been issued by the Grand County Building Department before the effective date of Ordinance 4-2004 and for projects which require the subdivision of the property and advancement to the Final Plat Review of the Grand Lake Planning Commission before the effective date of Ordinance 4-2004.

- b. Conditional Uses
 - 1. Commercial establishments of the following and like nature: antiques; small appliances; ~~art supplies; retail bakeries; cameras; candies; tobacoo;~~ furniture; gifts; hardware; sporting goods; stationery; and, variety shops;
 - 2. Service establishments of the following and like nature: ~~financial institutions; catering services; laundromats; medical clinics; insurance offices; real estate offices;~~ funeral parlors and mortuaries;
 - 3. Eating and drinking establishments; ~~when combined with hotels; motels, and condo/hotels;~~
 - 4. Public utilities;
 - 5. Water reservoirs, water storage tanks, water pumping stations, sewer lift stations and wireless towers.

- c. Building Height Limit - Except as provided in Section 12-2-23, the height regulations are as follows:
 - 1. No structure shall exceed thirty-five feet (35') in height.

- d. Area Regulations - Except as provided in Section 12-2-23, the area regulations are as follows:
 - 1. Minimum Floor Area - The minimum floor area for multi-family attached rental units, lodges, condominiums, townhouses, and condo/hotels is five hundred (500) square feet per each dwelling unit. The minimum floor area for hotels and motels is as is defined in the Definitions Section of this article. The minimum floor area for single family dwelling units is eight hundred (800) square feet.
 - 2. Minimum Lot Area - Five Thousand Square Feet (5,000 sq. ft.) except in the case of townhouses where the provisions of Section 12-6-20 (m) shall apply.

3. Minimum Lot Frontage - Fifty Feet (50') except in the case of townhouses where the provisions of Section 12-6-20 (m) shall apply.
4. Minimum Front Yard – Measured from the front property line, every principal or accessory building shall have a front yard of not less than Five Feet (5') ~~Twenty Five (25') Feet~~ for all structures. Section 12-2-26 (c) #4 and #5 does not apply.
5. Minimum Rear Yard - Measured from the rear property line, every principal or accessory building shall have a rear yard of not less than Twenty Feet (20') ~~Ten Feet (10')~~. Section 12-2-26 (c) #4 and #5 does not apply.
6. Minimum Side Yard - Measured from the side property lines, there shall be side yards of not less than Five Feet (5') ~~Ten Feet (10')~~ on each side of the lot. Section 12-2-26 (c) #4 and #5 applies only for a distance of Two and a Half Feet (2 ½') into the side yard setback.
7. Density - Density shall not exceed twenty (20) dwelling units per acre of gross land area.
8. Open Space - Open Space requirements will be governed by the setback requirements, ~~or in the case of Mixed Use developments by the Open Space schedule contained in Section 12-2-23 (G) of these Regulations, whichever is greater.~~

CONSIDERATION TO DIRECT THE TOWN MANAGER TO SEND A LETTER TO THE COUNTY REGARDING ENFORCEMENT OF SLASH BURNING RESTRICTIONS – Mayor Burke asked Town Manager Hale to present this matter to the Board. CONSIDERATION OF ORDINANCE NO. 1-2007, AN ORDINANCE AMENDING THE TOWN OF GRAND LAKE ORDINANCE NO. 12-2001 AND ORDINANCE NO. 21-2006 – Mayor Burke asked Town Code Enforcement Officer Korkowski to present this matter to the Board. Korkowski explained that while he was updating the ordinances onto the computer, he found the following typographical errors which need to be corrected by the Board of Trustees:

- 1.) Ordinance 12-2001 had a typographical error on the numbering of the Section that the Ordinance was creating. The Section listed was 7-2-10 and it should have read 7-2-11 as 7-2-10 already existed and dealt with an entirely different issue.
- 2.) Ordinance 21-2006 also had a typographical error on the numbering of a Subsection that the Ordinance was adding to an existing Code. The Subsection was listed incorrectly on the Attachment as 12-2-17 (a) (14) and it should have read 12-2-17 (a) (15). The attachment also should have listed Subsection 14 as “Nightly Rental” which had previously been added by a different Ordinance.

Based upon this information, staff is requesting that Ordinance 12-2001 and Ordinance 21-2006 be amended, and Ordinance 1-2007 be adopted.

**AN ORDINANCE AMENDING CHAPTER 12, ARTICLE 2,
ZONING REGULATIONS, OF THE CODE OF THE
TOWN OF GRAND LAKE**

WHEREAS, amendments to the Zoning Regulations of the Town of Grand Lake Code are permitted following public notice and public meetings; and,

WHEREAS, the Town of Grand Lake Planning Commission held a public meeting, following public notification, on May 2, 2007 and June 6, 2007; and,

WHEREAS, following the public meeting, the Planning Commission recommended approval of the proposed amendments to the Zoning Regulations of the Town of Grand Lake Code to the Board of Trustees; and,

WHEREAS, the Board of Trustees held a public hearing, following public notification, on April 9, 2007 and May 14, 2007 and June 11, 2007; and,

WHEREAS, following the public hearing, the Board of Trustees agreed with the recommendation of the Planning Commission regarding the proposed amendments to the Zoning Regulations of the Town of Grand Lake Code,

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GRAND LAKE THAT:

PART 1. Section 17 of Chapter 2 of Article 12 of the code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

~~15. Multi family attached rental units, condominiums and townhouses are uses permitted by right except on the first story, as defined in this Chapter 12 Article 2. This regulation applies to projects for which a Building Permit has not been issued by the Grand County Building Department before the effective date of Ordinance 4-2004 and for projects which require the subdivision of the property and advancement to the Final Plat Review of the Grand Lake Planning Commission before the effective date of Ordinance 4-2004.~~

15. Residential units herein defined as: Multi-family attached rental units, condominiums, townhouses and condo/hotels are uses permitted by right with the following restrictions:

- (A) The first story area measured from the frontage to 50' into the lot or structure shall be dedicated to commercial space.

- (B) If any portion of the area described in (A) is used for a hallway, elevator, stairwell access, fire escape access or mechanical appurtenances, a minimum of 30% of the second story of the structure must be dedicated to commercial space. This area shall be located on the frontage side of the structure.
- (C) The commercial space aspect of any structure must be constructed prior to or in conjunction with the residential units. A Certificate of Occupancy must be issued to the commercial space prior to or in conjunction with the residential units.
- (D) The commercial space aspect of any structure must be the same width or greater as the residential units constructed.
- (E) One stairwell will be allowed to be placed in the commercial space without having to comply with section (B) if the following conditions are met:
 - 1. The structure is located only on one 50' x 100' lot or less.
 - 2. There are four or fewer residential units constructed in the structure.
 - 3. The stairway is no larger than 5' in width.

PART 2. Section 18 of Chapter 2 of Article 12 of the code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

- 1. All uses provided for in the CT - Commercial Transitional District, except Single Family Residential. ~~Mixed Residential with permitted Commercial Use is a Use By Right provided not more than one half of the total square footage of the building or buildings on the lot are to be used for residential purposes. Minimum floor area requirements apply. Time-share restrictions for the CT District also apply to the C - Commercial District except Single-Family Residential. Multi-family attached rental units, condominiums and townhouses are uses permitted by right except on the first story, as defined in this Chapter 12 Article 2. This regulation applies to projects for which a Building Permit has not been issued by the Grand County Building Department before the effective date of Ordinance 4-2004 and for projects which require the subdivision of the property and advancement to the Final Plat Review of the Grand Lake Planning Commission before the effective date of Ordinance 4-2004.~~

- 10. Residential units herein defined as: Multi-family attached rental units, condominiums, townhouses and condo/hotels are uses permitted by right with the following restrictions:
 - (A) The first story area measured from the frontage to 50' into the lot or structure shall be dedicated to commercial space.

PART 3. Section 6 of Chapter 2 of Article 12 of the code of the Town of Grand Lake is hereby amended by adding the following definition:

Commercial Space – uses permitted by right in the Commercial District and the Commercial Transitional District excluding single family, multi-family attached rental units, condominiums, townhouses, condo/hotels and parking lots.

PART 4. Except as specifically amended herein, all other provisions of Chapter 12, Article 2 of the Grand Lake Town Code shall remain in full force and effect.

PART 5. If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or unconstitutionality of the remaining portions of this ordinance. The Town of Grand Lake hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared invalid or unconstitutional.





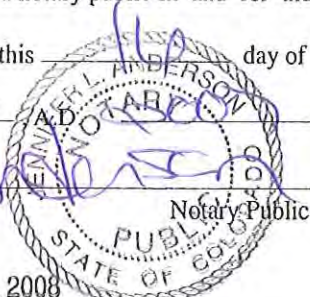

**AN ORDINANCE AMENDING CHAPTER 12, ARTICLE 2,
ZONING REGULATIONS, OF THE CODE OF THE
TOWN OF GRAND LAKE**

WHEREAS, amendments to the Zoning Regulations of the Town of Grand Lake Code are permitted following public notice and public meeting; and,

WHEREAS, the Town of Grand Lake Planning Commission held a public meeting, following public notification, on April 2nd, 2008; and

WHEREAS, following the public meeting, the Planning Commission recommended approval of the proposed amendments to the Zoning Regulations of the Town of Grand Lake Code to the Board of Trustees; and,

WHEREAS, the Board of Trustees held a public hearing, following public notification, on May 12th, 2008; and,

WHEREAS, following the public hearing, the Board of Trustees agreed with the recommendation of the Planning Commission regarding the proposed amendments to the Zoning Regulations of the Town of Grand Lake Code,

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GRAND LAKE THAT:

PART 1. Section 12-2-6, Definitions, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

Accessory Uses and Structures - A use naturally and normally incidental to a use by a right, and complying with all of the following conditions:

- f. Overnight camping on private residential property, by the owner or guest, for a period not exceeding seven (7) consecutive days.**

Boathouse - An accessory structure for sheltering boats and other aquatic equipment, with one boathouse that meets applicable design standards allowed per existing single family residence with lake frontage; to be used primarily for storage of equipment and not for human habitation. Recreation facilities such as courts and decks may be made a part of a boathouse structure, but no facilities such as lavatories, toilets, showers, sinks, cooking equipment (other than charcoal type cookers) and sleeping accommodations may be included.

Planning Commission - The Grand Lake Town Planning Commission.

Commercial Space – Uses permitted by right in the Commercial District and the Commercial Transitional District excluding single family, multi-family attached rental units, condominiums, townhouses, condo/hotels, and parking lots.

~~Modular **Factory Built** or Manufactured Home -- **Meets IBC** Any portable structure originally constructed to have no foundation other than facilities for placement or erection of the structure on site so designed or constructed to permit permanent occupancy as living quarters (Also see "Dwelling Unit").~~

Manufactured – Meets HUD Code; Any non-portable, wood-sided, pitched-roof structure, on a permanent foundation and meeting snow load requirements, which is equal to or greater than 24' wide by 36' long. If less than 24' by 36', only permitted in trailer parks.

Off-Street Parking Space - An off-street, hard-surfaced, dust-free space designed and intended to be occupied by a parked automobile which is up to one hundred eighty (180) square feet in area exclusive of maneuvering and roadway space.

For purposes of this Section, off-street parking shall be of two classifications, (1) Surface off-street parking; and (2) covered underground off-street parking. An off-street parking space shall consist of the following area requirements:

Development Plan Review Procedures and Submittal Requirements - The application for a Planned Development Overlay shall be subject to a three-faceted review process composed of the following: (1) a Sketch Plan Preapplication Conference; (2) a Preliminary General Development Plan; and (3) a Final Development Plan. These processes may be integrated with the Subdivision Process at the applicant's option. Applicants are strongly encouraged to have a Pre-Application conference with Town Staff prior to Sketch Plan submittal.

1. Sketch Plan Preapplication Conference - Prior to actual submission of the Preliminary General Development Plan Application, and prior to constructing any site improvements, each applicant shall confer with either the administrative staff of the Town or the Planning Commission at a regular meeting and other appropriate governmental departments and agencies in connection with the preparation of said application in order to obtain and exchange information. The general outlines of the proposal, evidenced schematically by sketch plans, are to be considered at this conference. Thereafter, Either staff or the Planning Commission may furnish the applicant with written comments regarding said conference, to inform and assist the applicant prior to the preparation of the Preliminary General Development Plan application. Any materials prepared by the applicant to be used in discussions with the Planning Commission are to be submitted, by noon, to the Town Clerk Town Staff twenty-one (21) fifteen (15) days in advance of the meeting date the discussion is to take place. Eleven (11) Three (3) copies of all materials, including a CD of all submitted drawings in PDF format, and required application deposit, set by resolution by the Town Board of Trustees, are need to be submitted. and five (5) extra copies of any sketch maps need to be included if the discussion is to be held with the Planning Commission.

2. Preliminary General Development Plan - The Preliminary General Development Plan application is intended to generate site plan information in the form of written statements and plans in order to provide adequate information for review by the Town and the general public. The completed application shall be known as the Preliminary General Development Plan.

A. Submission Requirements - The Preliminary General Development Plan shall embrace all properties which are to be included in the proposed development and shall be sufficiently detailed to allow for an effective review. All applications shall be accompanied by appropriate fees and submittal documents. The applicant shall submit one (1) complete copy of the Preliminary Plan documents, by noon, to Town Staff and pay the required fees within twenty-one (21) days prior to the Planning Commission meeting. Town staff will have fourteen (14) days to determine whether or not the application is complete. If an application is deemed incomplete, the application will not be presented to the Planning Commission. The applicant may resubmit, by noon, to Town Staff a complete application twenty-one

(21) days prior to the next regularly-scheduled Planning Commission meeting for determination of completion. Once determined complete, the applicant must submit an additional nineteen (19) copies, including a CD of all submitted drawings in PDF format, to town staff.

C. Site Plan(s) - A site plan and supporting maps and drawings shall be at a scale of one inch (1") equals fifty feet (50') or larger on sheets of twenty-four inches (24") by thirty-six inches (36") in size and shall include, at a minimum, the following information:

(3) Proposed lot lines and site designs by reference to permanent survey monuments (pins, as set by a professional surveyor).

(14) Any additional information as may be required by the Planning Commission or staff to evaluate the character and impact of the proposed Planned Development suggested during the at the time of Sketch Plan preapplication conference.

D. Approval Procedure

consideration of changes, the Planning Commission shall take formal action in writing, which either approves or disapproves the changes.

Plan; (2) any preliminary or final subdivision plats required if the construction of the development is planned to begin within one year; (3) any required dedication documentation and/or bonds; (4) any additional information as may be required by the Planning Commission or Board of Trustees necessary to evaluate the character and impact of the proposed Planned Development; (5) final engineering plans for public roads and utility systems and storm drainage control system; and (6) appropriate fees.

Issuance of Planned Development Overlay Designation - If the Planned Development Plan is granted final approval, the Board of Trustees shall, by Ordinance, adopt the approved PD Plan and authorize the rezoning of the subject property of PDD No. ____ . ~~the Town Clerk~~ Town Staff ~~or staff~~ shall cause the Official Zoning Map overlay sheet to be marked as per Section ~~12-2-24.3(4)~~ 12-2-7 of these Regulations. The PD Overlay shall incorporate the approved Development Plan and any conditions imposed by the Planning Commission and the Board of Trustees and shall set forth the period of time within which the development provided in the PD Plan shall be completed. The PD Overlay, together with the ordinance adopting the PD Plan and all accessory documents, shall be kept on file with ~~the Town Clerk~~ Town Staff as a matter of public record; and a copy of the PD Plan and Plan Map(s) shall be recorded in the records of the Grand County Clerk and Recorder. Upon filing and recording of the PD Plan(s), the terms and the provisions of the approved Plan incorporated therein shall govern and control the use and development of the property. Pending completion of the Planned Development within the time provided in the PD Plan, the provisions of the approved PD Plan shall not be modified, released or revoked by either the landowner or the Town except in the manner and in accordance with the procedures set forth in these Regulations.

6. Failure to Begin Development, or to Show Substantial Progress

B. The PDD Special Review will be undertaken by the Planning Commission to determine if the developer can verify to the Commission that the original assumptions and plans of the Planned Development are still appropriate. At this review, the development schedule shall be recommended to be formally amended. Proceedings of this Review shall be forwarded to the Town Board of Trustees for their review and approval of the amended development schedule. No development may proceed until these formal amendments and approvals are made.

D. After the Special Review has been undertaken and the Board of Trustees has found, determined, and declared that there is no realistic possibility that the PD can or will proceed as approved in the Final Development Plan, the Board of Trustees shall by resolution revoke the PD overlay. Said Revocation may trigger penalty provisions of the zoning ordinance due to non-conformance with the original base zoning.

g. Design Standards

3. Open Space

C. Mixed Use Planned Developments - Open space in a mixed use (must include residential in the mix) Planned Development shall, at a minimum, be provided and consistent with these Zoning Regulations, Section 12-2-26(g).

E. Administration and Maintenance - The following provisions shall govern the administration of the common improvements and open space in all Planned Unit Developments approved pursuant to these Regulations:

5. Lot Requirements

A. There shall be no minimum lot width, setbacks, or lot area requirements in a PD. Setbacks and lot widths shall be as required by the Planning Commission to provide adequate access and fire protection and to ensure proper ventilation, light, and air. The stream and lake setback requirements of these Zoning Regulations shall be adhered to the greatest degree possible as a priority item. Deviations from these water setbacks will be judged according to Section ~~12-2-26(f)~~ 12-2-29 of these Regulations.

12. Other Provisions and Standards - The PD Plan may include other provisions deemed necessary or desirable by the landowner for the efficient development and preservation of the Planned Development subject to the approval of the Planning Commission and the Board of Trustees. In addition, the Commission and Board of Trustees may, in review of each Planned Development, require that additional provisions be incorporated into the PD Plan or that conditions be imposed in the public interest to ensure that the Planned Development will be developed in accordance with good design standards and practices and can exist compatibly with the neighboring land uses and the community as a whole. Such requirements and conditions may include, but shall not necessarily be limited to any of the land use requirements or controls not mentioned in the previous sections which would otherwise be applicable by reason of the Zoning Ordinance, or modifications thereof, including without limitation requirements relating to building design, location and construction, minimum yards, setbacks, lot widths, building spacing and floor areas, and requirements regarding the

availability and provision of streets, roads, utilities and other public or quasi-public facilities. Any such requirements and conditions imposed by the Planning Commission or Board of Trustees shall be specifically set forth in the PD Plan, as finally approved, and in the Planned Development Special Permit issued for the development.

PART 20. Section 12-2-26, ~~Supplementary Regulations~~ **Regulations for Mixed Use Developments**, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

a. Mixed-Use Regulations for the CT, C and RST Districts

1. *Mixed-use developments in the above listed districts will be subject to the following supplementary regulations. These regulations are minimum requirements and will also apply to Planned Developments within these districts.*
2. *Multiple family dwellings may be constructed above commercial uses provided:*
 - A. *Access to dwelling units is not through commercial establishments.*
 - B. *Trash, service and loading areas shall be screened from view from the dwelling units and from street entrances to dwelling units.*
 - C. *Outdoor lighting associated with commercial uses within the structure, including lighting for parking, service and loading areas, shall be designed and located such that the direct source is not visible from any dwelling unit within nor shall there be any glare.*
 - D. *At least two (2) means of ingress and egress from each floor of dwelling units shall be provided and that all other regulations as may pertain to fire protection be met.*
3. *Mixed-Use projects shall conform to the following schedule of ~~open-space~~ **(Private) Open Space Land Area R**requirements:*

4. *In the C District, the developer shall submit a proposal for the **(Private)** Open Space Land Area Required for Mixed-Use projects according to one of the following alternatives.*
 - A. *The **(Private)** Open Space Land Area Required is to be provided on-site, in accordance with the definition of Open Space, as provided in Section 12-2-6, Definitions.*
 - B. *At the option of the Board of Trustees, the developer shall, in lieu of such provision of land, pay to the Town of Grand Lake in cash or terms acceptable to the Board of Trustees, an amount equal to the fair market value of the **(Private)** Open Space Land Area Required as determined by appraisal on the date of approval by the Board of Trustees. If the Town of Grand Lake and the developer fail to agree on the fair market value of the land, the fair market value shall be fixed and established by a qualified appraiser selected by the Town and the Developer.*
 - C. *At the option of the Board of Trustees, the developer shall convey to the Town of Grand Lake land dedicated for parks, playgrounds, schools, housing, or other public uses except streets and utility easements. Conveyance shall be by deed, preceded by or accompanied with a current Title Insurance Policy, Tax Certificate and Survey.*
 - D. *At the discretion of the Board of Trustees, the developer may provide a combination of (a.), (b.) and/or (c.) above to satisfy the **(Private)** Open Space Land Area Requirement.*

PART 21. Section 12-2-27, Planned Unit Development Supplemental Regulations for Setbacks, Height and Area, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

- a. *Additional Setback Regulations*
 1. *R.O.W. Buffers: Where an improvement (structure, parking lot, etc.) borders of State Highway 34 right-of-way, the Planning Commission may require a buffer strip of such an extent and type as may be practical with a minimum width of twenty (20) feet or other adequate protection against hazards and undesirable effects of the highway, such as a fence or landscape earthen berm installed by the developer. Snow storage areas are allowed in this setback.*

- b. *Additional Height and Area Regulations - The following additional height and area regulations shall apply to all zone districts as set forth in this Article.*
1. *Hospitals, institutions or schools, when permitted in a district, may exceed the maximum height regulations in the zone district in which they are located provided the maximum for the use under question is set by the Board of Adjustment but in no instance shall such use exceed Forty-Two Feet (42') in height.*
 2. *Chimneys, church steeples, cooling towers, elevator bulkheads, fire towers, monuments, stacks, stage towers or **theatre** scenery lofts, tanks, water towers, ornamental towers, spires, grain elevators, or necessary mechanical appurtenances may exceed the maximum height regulations of the zone district in which they are located provided the maximum height for the use under question is set by the Board of Adjustment, but in no instance shall such use exceed Sixty Feet (60') in height. Wireless telecommunications facilities may exceed the maximum height regulations of the zone district in which they are located provided the height is established by the Planning Commission during the Conditional Use review and they do not exceed a total height above the ground of One Hundred (100) feet.*
 3. *Unless authorized by the Board of Adjustment, no basement or cellar shall be occupied for residential purposes until the remainder of the building has been substantially completed.*
 4. *Open-lattice enclosed fire escapes, fireproof outside stairways, and balconies opening upon fire towers, and the ordinary projections of chimneys and flues and eaves into the front, side or rear yard may be permitted by the Building Inspector for a distance of not more than Three and One-Half Feet (3 1/2') and where the same are so placed as not to obstruct light and ventilation of adjacent buildings.*
 5. *An open un-enclosed porch or paved terrace may project into a front, side or rear yard for a distance not exceeding Five Feet (5'). An un-enclosed vestibule containing not more than Forty Square Feet (40 sq. ft.) may project into a front yard for a distance not to exceed Four Feet (4').*
 6. *For the purpose of the side yard regulations, a Two-Family Dwelling, or a Multiple Dwelling shall be considered as one building occupying One (1) Lot unless developed as a Planned Development.*
 7. *A structure presently encroaching into a setback shall **not** be allowed to make additions onto the structure within the boundary line measured from the lot line to the edge of the existing encroachment without seeking a variance from the Board of Adjustment.*

PART 22. Section 12-2-28, ~~Non-Conforming Uses and Structures~~ **Off-Street Parking Regulations**, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

No building shall be erected, enlarged to the extent of increasing the floor area by more than ten percent (10%), changed in use as defined in this Article 2, or rezoned (excluding Town initiated rezoning) unless there is either an off-street parking fee paid to the Town if allowed, or there is provided on the lot, space for parking and space for the loading and unloading of automobiles or trucks in accordance with the following standards and requirements:

2. *The method used to calculate the required number of off-street parking spaces shall be as follows:*

- A. *The total number of required parking spaces shall be calculated based on the table from Part 1. above. Any fraction shall be rounded up to the next whole number. In cases of mixed uses on one property, the requirements of each group shall be calculated and applied independently of the requirements of other groups. In cases of an existing building being enlarged so as to increase the floor area by more than ten percent (10%), changed in use as defined in this Article 2, or rezoned (excluding Town initiated rezoning), the total gross leasable area and/or number of bedrooms of the resultant building after enlargement, change in use, or rezoning (excluding Town initiated rezoning) shall be used to calculate the required number of off-street parking spaces to be provided.*
 - B. *Group I and Group II structures shall be required to supply one hundred percent of the resulting number on the property where the structure is located.*
 - C. *After allowing for the on-street parking credit, if eligible, group III structures shall be required to always supply the first eighty (80%) of the resulting number on the property where the structure is located. The remaining twenty (20%) may be either supplied on-site or may be satisfied through payment of the appropriate off-street parking fee.*
 - D. *After allowing for the on-street parking credit, if eligible, group IV and group V structures shall be required to satisfy seventy five (75%) percent of the resulting number of required off-street parking spaces. Fractions shall be rounded up to the next whole number. This may be satisfied by supplying any combination of on-site spaces and the appropriate off-street parking fee. Nothing in this part shall supersede the on-site utility requirement for structures built on property within the commercial district.*
3. *The off-street parking fee shall be ten thousand (\$10,000.00) dollars for each parking space. This fee may be amended from time to time by resolution adopted by the Board of Trustees. The parking fee shall be assigned to a particular lot or parcel, and may not thereafter be conveyed, assigned or transferred to any other property. The parking fee shall be paid in full concurrent with the Town's approval of a Building Permit Application, and is non-refundable.*
4. *All parking and loading areas shall be surfaced with asphalt or concrete in all zones except the Residential, open and Resort zones where parking areas may be surfaced with compacted gravel and treated to control fugitive dust. Underground or structured parking is encouraged.*

5. *Parking lot aisle lanes may vary from twenty-four (24) feet to twelve (12) feet depending upon the angle of parking with perpendicular parking requiring an aisle width of twenty-four (24) feet.*
6. *Convenient snow storage areas shall be provided for parking areas equivalent to one-third (1/3) of the total drive and parking area. Snow storage areas must not drain directly into any stream, creek, lake or ditchway (that drains to any stream, creek or lake) without first passing through some water quality control device such as grassed waterways, retention pond or the like. Parking areas may not double as snow storage areas and if snow removal from the site is contemplated, a plan of action is to be drawn up and submitted to the Planning Commission for review.*
7. *Parking structures shall be a minimum of ten (10) feet from public or private road right-of-ways. In the case of State Highway 34, the setback shall be twenty (20) feet from the ROW. No setback is required for at-grade parking lots.*
8. *All parking areas are to be adequately lighted for security reasons.*
9. *No parking is to be allowed on through public roads unless additional surface widths are provided for this purpose.*
10. *All parking lots (greater than thirty (30) spaces) and structures are to be provided with a minimum of two (2) accesses.*
11. *Before a Certificate of Occupancy (C.O.) is issued on any structure(s), all parking areas are, as a minimum, to be graveled. This requirement may be waived should weather conditions necessitate it. All improvements bonds, escrow funds, etc., are to be held by the Town until paving is complete.*
12. *Loading areas are to be designed to adequately accommodate both goods and people unloading at all residential and commercial buildings; the minimum loading area is ten (10) feet wide by twenty (20) feet long by sixteen (16) feet high.*
13. *Parking and loading areas are not to be used for the sale, repair, dismantling or storage of any vehicle or equipment. The sale of any materials, supplies, food or other goods is prohibited except by special permit from the Town.*
14. *Required parking spaces must be provided on the same property or use as the principal building or use in the Open and Residential zones. In the other zones, for multifamily developments up to thirty (30) percent of the parking shall be within two hundred (200) feet of the principal use provided that a minimum of one (1) space per unit is available on the site; and for Commercial, industrial and mixed use developments, may satisfy the off-street parking requirement by providing an off-site parking area. The off-site parking area shall be within one*

thousand feet (1000') of the principal use. The zoning for the parking area shall be the same as the principal use or a more intensive classification, except that in the C zone, land in the CT zone may be used as the off-site parking area. Parking areas shall be owned by the owner of the principal use for which parking space are being provided or said owners shall have a long term lease on the land. The off site parking area shall have a deed restriction placed upon the property prohibiting sale, lease, transfer or conveyance without the prior approval of the Town and limiting its use to solely a parking lot servicing the off-street parking requirements of the property containing the principal use. The deed restriction shall be of a content and form approved by the Town and shall be recorded with the Grand County Clerk and Recorder.

~~15. 14. Twenty five percent (25%) of the total number of parking space required for commercial, office, cultural, and civic uses in any district may be of a compact car size (8'X16'). These spaces shall be properly marked and grouped in the overall parking plan.~~

~~16. 15. On-Street Parking Credits in Determining Required Off-Street Parking Spaces.~~

- ~~A. *In determining the amount of off-street parking required, credit will be given for the available on-street parking adjacent and contiguous to any property subject to the provisions of this Section which adjoins a public right-of-way of eighty (80') feet or more.*~~
- ~~B. *The amount of off-street parking spaces required as determined elsewhere in this Section shall be reduced by the number of available on-street parking spaces on a one-to-one basis.*~~
- ~~C. **For qualifying lots, as described in (A), the amount of off-street parking will be calculated at 0.085 spaces per foot of frontage on a road that has available on-street credit.** It shall be the responsibility of the Building Code Administrator to determine the number of on-street parking spaces available in computing the credit.~~

~~17. 16. Accessible Parking - one designated accessible (handicapped) parking space shall be required as a part of the overall off-street parking requirements mandated under this Section for each twenty-five (25) off-street parking or fraction thereof. In all cases the accessible space shall be located in a manner close and convenient to the principal building main pedestrian ingress/egress.~~

PART 23. Section 12-2-29, Administration **Shoreland Regulations**, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

1. Stream and Lake Setbacks

B. *In order to help preserve the environmental quality of the water in the Grand Lake, a thirty (30) foot stream and lake setback from the mean identifiable high water mark shall be maintained for buildings, parking, snow storage areas and other improvements to a site. The setback applies to a stream, creek, river, irrigation ditch (dry or wet), lake, pond, wetland, or any other body of water.*

C. *When activities are proposed within the 30' setback, a variance may be requested by an Applicant. The Planning Commission shall review the request at a public meeting and make a recommendation to the Board of Adjustment, who shall make the final determination. Fifteen (15) days prior to the scheduled **Public Hearing** date, legal notice shall be placed in the local newspaper of general circulation advertising the time, date, and location of the public meeting. In addition, certified letters are to be mailed at least fifteen (15) days prior to the public meeting to all property owners within two hundred (200') feet of any portion of the property.*

The Board of Adjustment shall grant no variance from any provision of this regulation without first conducting a public hearing. The Board of Adjustment will hold a public hearing within 45 days from receiving a recommendation from the Planning Commission. Fifteen (15) days prior to the scheduled date, legal notice shall be placed in the local newspaper of general circulation advertising the time, date, and location of the public hearing. In addition, certified letters are to be mailed at least fifteen (15) days prior to the public meeting to all property owners within two hundred (200') feet of any portion of the property.

*During the public hearing the burden of the Applicant shall include but not be limited to, establishing that the activity conforms to one or more of the exceptions set in 12-3-5 (b) (A) through (E). A non-refundable fee, **set by resolution by the Board of Trustees**, ~~of \$270.00~~ is required for a variance request to the Stream and Lake Setbacks.*

1. *At a minimum, a variance request shall include the following information:*

- a. *A site map that includes locations of all streams, wetlands, floodplain boundaries, slope, topography, and other natural features, as determined by field survey.*
- b. *A description of the size, shape, soils, vegetation and other physical characteristics of the property.*

- c. *A detailed site plan that shows the locations of all existing and proposed disturbances, both inside and outside the setback. The exact area of buffer to be affected shall be accurately and clearly indicated.*
 - d. *Documentation of unusual hardship should the setback be maintained. (Refer to 12-3-5 (b) (A) through (E) for hardship criteria)*
 - e. *At least one alternative plan, which does not include a setback intrusion, or an explanation of why such a plan is not possible.*
 - f. *A calculation of the total area and length of the proposed intrusion.*
 - g. *An erosion and sedimentation control plan.*
 - h. *A stormwater control plan, if applicable.*
 - i. *Proposed mitigation, if any, for the intrusion.*
2. *The following factors will be considered in determining whether to issue a variance:*
- i. *The shape, size, topography, slope, soils, vegetation, and other physical characteristics of the property.*
 - ii. *The locations of all bodies of water on the property, including along property boundaries.*
 - iii. *The location and extent of the proposed setback intrusion.*
 - iv. *Whether alternative designs are possible which require less intrusion or no intrusion.*
 - v. *Sensitivity of the body of water and affected critical habitats.*
 - vi. *Intensity of land use adjacent to the body of water proposed to intrusion.*
 - vii. *Impact on floodplains and stream functions (a variance shall not be approved when the reduction would result in the setback being narrower than the floodplain)*
- D. *A setback of greater than 30 feet may be required if one of the following is present on the site:*
- 1. *Slope equals or exceeds thirty percent (30%);*
 - 2. *Highly erodable soils are present;*
 - 3. *The proposed use of the property presents a special hazard to water quality (e.g., storage or handling of hazardous or toxic materials).*
 - 4. *Floodplains or floodways*
 - 5. *Riparian vegetation within a designated habitat*
 - 6. *Wetlands are present*

The increased setback to be required in such cases shall be determined by the Board of Trustees upon recommendation of the Planning Commission.

In these cases, a setback of greater than thirty feet (30') may be required in order to protect the public health, safety and welfare.

Should this increased minimum setback, in combination with other setbacks outlined in the various zone districts, cause a previously platted lot or parcel to become unbuildable, the Planning Commission and Town Board of Trustees may allow encroachments into this or other setbacks in order to relieve the hardship without requiring a variance proceeding before the Board of Adjustment. The priority of encroachments allowed will be lot setbacks first and stream and lake setbacks second in order to relieve the hardship. Provisions for channeling runoff to retention areas will need to be provided in any drainage plans for the development.

D. Improvements that are exempted from these setback requirements are foot paths, bridges, irrigation structures, flood control devices, revegetation, landscaping, and boathouses, commercial marinas, boat rentals, boat repair and maintenance facilities and walkways and stairways less than four feet in width leading directly from the shoreline to the principal structure. The first five (5) feet of this setback shall be a non-disturbance zone, except in the cases of bridges, irrigation structures, flood control devices, boathouses, commercial marinas, boat rentals, boat repair and maintenance facilities and walkways and stairways less than four feet in width leading directly from the shoreline to the principal structure.

E. In addition to these required stream and lake setbacks, properties contiguous to any stream, creek, river, irrigation ditch, lake, pond, or wetland area, shall be required to abide by the Erosion and Sediment Control Regulations as then in effect for Grand County, for construction projects involving ground disturbance. This requirement applies to single family, multiple family, commercial, and all other construction involving ground disturbance.

~~h. Boathouse and Covered Boat Docks Construction~~

~~1. In Grand Lake, construction of boathouses and covered boat docks is a special use case and requires a public hearing before the issuance of a Building Permit. Boathouse construction and covered boat dock construction does not require a special use or conditional use permit, but any conditions placed on the construction of said boathouses and covered boat docks will constitute conditions for a Building Permit.~~

~~The public hearing will be held before the Planning Commission, and such factors as size, lake bed disturbance, surrounding property owners' concerns and other relevant factors will be considered. A nonrefundable processing fee of One Hundred (\$100.00) dollars shall be paid at the time the request for the hearing is requested by the applicant.~~

- ~~_____ The date of the hearing will be set by the Town Clerk and notice of said hearing will be placed in the newspaper of public record for the Town at least fourteen (14) days prior to the hearing. The Town shall notify by certified mail all property owners within two hundred (200) feet of the property boundary on which the boathouse or covered boat dock will be placed of the date of the hearing, fifteen (15) days in advance of the hearing.~~

- ~~_____ After taking evidence in relation to said boathouse or covered boat dock, the Planning Commission shall recommend approval, approval with conditions or denial of the Building Permit application to the Board of Trustees. The Planning Commission may recommend, based on site-specific conditions, approval of a design that exceeds specified parameters of the Boathouse and Boat Dock Design Standards and of applications for multi-family residences with lake frontage, lakefront properties without a residence, and commercial marinas. No recommendation shall be considered grounds for the recommended approval of subsequent applications. The Board shall act on the application at their next regularly scheduled meeting. Appeals to the Board of Trustees decision may be considered by the Zoning Board of Adjustment.~~

- 2. ~~_____ Uncovered boat docks are not subject to the provisions of this Section so long as the placement of said uncovered dock meets the provisions of this Section and so long as said uncovered dock does not extend more than thirty five (35') feet into the lake. Such docks shall be handled administratively through the issuance of a Building Permit.~~

- 3. ~~_____ Notwithstanding any other provisions contained in this section, property within the Town and which borders Shadow Mountain Lake is subject to the jurisdiction of the United States Government as regards the installation of boathouses, covered and uncovered boat docks into Shadow Mountain Lake. Said properties shall also be required to comply with the special use easement provisions contained herein for the construction of boathouses, and covered boat docks and all such structures, including uncovered boat docks, shall meet the side setback requirements of the zoning district.~~

- 4. ~~_____ Notwithstanding any other provision of this zoning code, freestanding uncovered docks, or docks attached to the sides of boathouses shall be allowed to encroach five (5') feet into the side setback requirements of the zoning district.~~

- 5. ~~_____ In addition to the Grand Lake Design Review Standards and any other applicable agency's regulations, all boathouses and covered boat docks shall comply with the following Design Standards unless a site-specific exception is allowed:~~
 - ~~_____ Height Limit: No structure shall exceed sixteen feet (16') from the mean water line to the highest point of the structure.~~

~~Width Limit: No structure shall exceed thirty feet (30') in width. This width excludes any uncovered dock or decking that is physically attached to the structure. Side setbacks must be satisfied.~~

~~Extension Beyond Shoreline: No structure may extend more than thirty five feet (35') beyond the natural shoreline, including any uncovered dock or decking that is physically attached to the structure. There may be site-specific cases where boathouses and covered boat docks may be dug into the shoreline, with approval of the applicable agency having jurisdiction, to preserve the natural character of the surrounding area.~~

2. Boathouse and Covered Boat Docks Construction

A. General - In Grand Lake, construction of boathouses and covered boat docks is a unique case and requires a public hearing before the issuance of a Building Permit. Boathouse construction and covered boat dock construction does not require a special use or conditional use permit, but any conditions placed on the construction of said boathouses and covered boat docks will constitute conditions for a Building Permit.

Uncovered boat docks are not subject to the provisions of this Section so long as the placement of said uncovered dock meets the provisions of this Section and so long as said uncovered dock does not extend more than thirty-five (35') feet into the lake. Such docks shall be handled administratively through the issuance of a Building Permit.

B. Boathouse and Boat Dock Design Standards

In addition to the Grand Lake Design Review Standards and any other applicable agency's regulations, all boathouses and covered boat docks shall comply with the following Design Standards unless a site-specific exception is allowed:

Height Limit: No structure shall exceed sixteen feet (16') from the mean water line to the highest point of the structure.

Width Limit: No structure shall exceed thirty feet (30') in width. This width excludes any uncovered dock or decking that is physically attached to the structure. Side setbacks must be satisfied.

Setbacks: All structures, including uncovered boat docks, shall meet the side setback requirements of the zoning district. Notwithstanding any other provision of this zoning code, freestanding uncovered docks, or docks attached to the sides of boathouses shall be allowed to encroach five (5') feet into the side setback requirements of the zoning district.

Extension Beyond Shoreline: No structure may extend more than thirty-five feet (35') beyond the natural shoreline, including any uncovered dock or decking that is physically attached to the structure. There may be site-specific cases where boathouses and covered boat docks may be dug into the shoreline, with approval of the applicable agency having jurisdiction, to preserve the natural character of the surrounding area.

Notwithstanding any other provisions contained in this section, property within the Town and which borders Shadow Mountain Lake is subject to the jurisdiction of the United States Government as regards the installation of boathouses, covered and uncovered boat docks into Shadow Mountain Lake.

C. Commercial Marinas

In Grand Lake, construction of Commercial Marinas are a unique case and requires a Public Hearing before the issuance of a building permit. To the extent possible, Commercial Marinas shall conform to the Boathouse and Boat Dock Design Standards. The Planning Commission may grant greater height, as well as a greater extension beyond the shoreline, given the commercial considerations.

D. Submission Requirements – Complete applications include a site plan and supplemental information. All proposals must adhere to Boathouse and Boat Dock Design Standards, as identified in the previous Section of this Article.

(1) Site Plan –The minimum site plan data required includes:

- a. Name of property owner and applicant
- b. Location of property: Legal Description and Street Address
- c. Lots and blocks numbered consecutively.
- d. Date of preparation, map scale, and north sign.
- e. High water line
- f. The existing topography of the site shall be shown.
- g. Abutting property lines
- h. Existing structure(s) – with labels
- i. Proposed structure(s) – with labels
 - 1. Dimensions of proposed structure(s) including height
 - 2. Setbacks from property lines
 - 3. Square footage of decks

(b) Supplemental Information – The following information does not have to be addressed on the site plan but must be included with building permit application. The minimum supplemental information required includes:

- a. Description of materials (including color samples) for siding, roof, window trim, decks, docks, railings, etc.
- b. Erosion and sediment control practices. Silt fencing or equivalent is required on any site adjacent to a body of water or on a steep hillside. Erosion control will be required to insure sedimentation does not leave the site. Town officials have the right to require erosion control on any site.
- c. Identify existing landscaping that will be disturbed. Identify landscaping material(s) to be placed on the site after construction.
- d. H.O.A. approval, if applicable.
- e. U.S. Forest Service approval if the proposed development is located on Shadow Mountain Lake.
- f.

E. Submission – One complete building permit application, including a site plan, supplemental information, and a nonrefundable processing fee, set by resolution by the Town Board of Trustees, must be received twenty-one (21) days prior to the next regularly-scheduled Planning Commission meeting. Staff will have fourteen (14) days to determine completeness. Upon determination of completeness, the applicant must submit an additional ten (10) copies, a CD of all drawings in PDF format, of supplemental information to Town Staff.

F. Review Process - The public hearing will be held before the Planning Commission, and such factors as size, lake bed disturbance, surrounding property owners' concerns and other relevant factors will be considered. The date of the hearing will be set by the Planning Commission and notice of said hearing will be placed in the newspaper of public record for the Town at least fifteen (15) days prior to the hearing. The Town shall notify by certified mail all property owners within two hundred (200) feet of the property boundary on which the boathouse or covered boat dock will be placed of the date of the hearing, fifteen (15) days in advance of the hearing.

After taking evidence in relation to said boathouse or covered boat dock, the Planning Commission shall recommend approval, approval with conditions or denial of the Building Permit application to the Board of Trustees. The Planning Commission may recommend, based on site-specific conditions, approval of a design that exceeds specified parameters of the Boathouse and Boat Dock Design Standards and of applications for multi-family residences with lake frontage, lakefront properties without a residence, and commercial marinas. No recommendation shall be considered grounds for the recommended approval of subsequent applications. The Board of Trustees shall act on the application at their next regularly scheduled meeting.

G. Appeals - Appeals to the Board of Trustees decision may be considered by the Zoning Board of Adjustment.

- 1) Applicants appealing the Board of Trustees denial of the boathouse/covered boat dock building permit application shall file with Town Staff a request for hearing. The form of the appeal shall be in the manner as is prescribed by Town Staff. All appeals shall be accompanied by a non-refundable processing fee set, by resolution, by the Town Board of Trustees. The matter shall be scheduled for the Zoning Board of Adjustment. At that meeting the Board shall determine if the denial is to be sustained or whether a public hearing shall be required. The sustaining of the appeal is a final decision.
- (2) If the Board determines a public hearing is appropriate, then at least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the public hearing. In addition, at least fifteen (15) days prior to the scheduled date, Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed indicating the time, date, and location of the public hearing.

H. Permit Approval -The applicant shall comply with all conditions, as are imposed by the Board, as a condition of issuance. One such condition, applicable to all boathouse and/or covered boat dock building permit applications, is Army Corps of Engineers approval.

A. Special Use Permits

1. *SUP General Information- The Special Use Permit (SUP) review process prescribed herein is intended to assure compatibility and harmony between the proposed special use with both the surrounding properties and the town at large. The Special Use Permit Process shall not be used for the purpose of granting the use of mobile homes for the purpose of temporary living quarters.*

2. **SUP Types**
Two types of SUPs may be awarded.

a. Commercial or Public Zone SUP: *The use of property for or by: ambulatory vendors; peddlers; vendors selling retail from a vehicle (except fixed route vendors); and/or persons carrying on a trade or business from a temporary*

structure. This type of permit permitted only within the commercial or public zone districts.

The Mayor, or the Mayor's designee, may exempt persons and events from the provisions of this Section if they are being sponsored by non-profit organizations and if such exemption is deemed to be in the best interest of the town.

b. General SUP: The use of property, in any zoning district, for a period of six months or less, which use is not listed as a use by right or a conditional use.

3. *Application and Required Information: At least twenty-one (21) days prior to the next regularly scheduled Planning Commission meeting, a SUP Application, supporting documentation, and a CD of all supporting documentation in PDF format, shall be submitted to Town Staff. **Town staff will have fourteen (14) days to determine whether or not the application is complete. Once determined complete, the request will be placed on the next regularly-scheduled Planning Commission meeting.** The application shall be supported by documents, maps, plans and other material containing the following information:*
- a. *Name and permanent address of applicant.*
 - b. *Name and address of property owner and the legal description, street address and other identifying data concerning the proposed Special Use site.*
 - c. *A description of the precise nature of the Special Use and a site plan showing its operating characteristics, including but not limited to: dimensions, and locations of specific activities, off-street parking, ingress and egress points, traffic circulation, utilities and drainage features, and measures proposed to make the use compatible with other properties in the vicinity.*
 - d. *A current and valid (if applicable):*
 - Colorado Sales Tax License,
 - Grand Lake Sales Tax License,
 - Grand Lake Business License, and
 - Grand Lake Peddlers and Transient Merchant License.
 - e. *Any other information deemed by Town Staff to be reasonably necessary to carry out the provisions and the fair administration of this Article.*
 - f. *An affidavit signed by the applicant stating that the information contained on the application is true and correct to the applicant's knowledge and further stating that knowing submission of false information shall be cause for the SUP to be immediately revoked without notice or hearing.*

g. *A non-refundable administrative processing fee, set by resolution by the Town Board of Trustees, of two hundred fifty (~~\$250.00~~) dollars. (See Resolution 11-2004)*

4. *Planning Commission Processing and Review Criteria*

a. *The Planning Commission shall review the SUP application and determine whether to deny the application or schedule a public hearing to receive testimony and comment of interested citizens, businesses, and adjoining property owners. In making this determination, the Commission shall consider the following factors:*

- (1) *Relationship of the proposed Special Use to the economic development objectives of the Town and the anticipated impact of the SUP on existing businesses.*
- (2) *Effect upon traffic, with particular reference to congestion, automotive and pedestrian safety and convenience, traffic flow and control, access, maneuverability, and (if applicable) snow removal from the streets and parking areas.*
- (3) *Effect upon the character of the area in which the proposed Special Use is to be located, including the scale and bulk of the proposed Special Use in relation to surrounding uses and neighborhood.*
- (4) *Such other factors and criteria as the Commission deems applicable to the proposed Special Use including but not limited to: proposed length of use; specific businesses, land owners or other interested parties to be notified; or proposed conditions of SUP issuance.*

b. *After consideration of these factors, the Commission shall vote either to deny the application or to schedule a public hearing. The applicant may appeal the Commission's decision to deny the SUP request to the Board of Trustees, in accordance with the procedure outlined in part (5) (A) below.*

c. *At least fifteen (15) days prior to the scheduled date, Town Clerk shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing. In addition, at least fifteen (15) days prior to the scheduled date, Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP public hearing.*

d. *At the public hearing, after receiving comment and testimony, the Commission shall make a recommendation to the Board of Trustees in the form of a resolution. Nothing in the Section shall preclude the Board of Trustees from tabling*

or continuing the public hearing to another time and place. If the resolution is to approve the request, it shall contain the following findings:

- (1) That the proposed location of the use is in accord with the purposes of this Chapter and the purposes of the district in which the SUP site is located.
- (2) That the proposed location of the Special Use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety, or welfare, nor will the proposed materially injurious nearby land uses, properties, or improvements.
- (3) That the proposed use will comply with all of the applicable provisions of the Code of Ordinances.
- (4) That the applicant shall comply with such terms and conditions as the Commission determines are necessary to carry out the letter and intent of the Special Use Permit process.

5. Board of Trustees Processing and Review Criteria

a. Appeal of Commission Denial:

- (1) Applicants appealing the Commission denial of the SUP application shall file with Town Staff a request for hearing. The form of the appeal shall be in the manner as is prescribed by Town Staff. All appeals shall be accompanied by a ~~two hundred (\$200.00) dollar~~ non-refundable processing fee, **set by resolution by the Town Board of Trustees.** The matter shall be scheduled for the next regular Board meeting. At that meeting the Board shall determine if the denial is to be sustained or whether a public hearing shall be required. The sustaining of the appeal is a final decision.
- (2) If the Board determines a public hearing is appropriate, then at least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing. In addition, at least fifteen (15) days prior to the scheduled date, Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP public hearing.

b. Recommendation of Approval or Conditional Approval:

- (1) Upon adoption and transmittal of the Commission's resolution, Town Staff shall set a date for a public hearing on the application before the Board of Trustees. At least fifteen (15) days prior to the scheduled date, Town Staff

shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing.

- (2) *Final action on the Special Use Permit is to be taken by the Board of Trustees at the public meeting; except that the Board may continue the public hearing to another time before taking final action.*

6. *Permit Issuance of Approval or Conditional Approval*

- a. *A Special Use Permit shall not grant variances. Variances shall be granted in accordance with the procedures prescribed in Section 12-2-28 32.*
- b. *The SUP shall be valid for a maximum period of twelve months unless a shorter period is authorized by the Board.*
- c. *The SUP applicant shall also be subject to all other procedures, permits and requirements of this and other applicable ordinances, regulations and agreements of the Town. In the event of any conflict between the provisions of a Special Use Permit and any other permit, requirement, or agreement, the more restrictive provision shall prevail.*
- d. *Authorization of a change or waiver in any condition previously imposed in the authorization of a special use shall be subject to the same procedures as a new special use.*
- e. *The SUP applicant shall comply with all such other conditions as are imposed by the Board as a condition of issuance.*
- f. *Failure to adhere to the General Conditions shall be cause for Town Staff to either suspend or revoke the SUP without notice or hearing.*

B. Conditional Use Permits

1. CUP General Information – Conditional Uses are those uses allowed in a district, in addition to the uses by right, where so authorized, when and if a Conditional Use Permit (CUP) is granted, in accordance with special procedures and requirements. The CUP review process herein is intended to assure compatibility and harmony between the proposed conditional use with both the surrounding properties and the town at large.

2. Processing and Review Criteria - Unless identified in Section 12-2-31 (B) #3b, requests for Conditional Use Permits will be processed and reviewed according to the following criteria:

- a. Procedure before the Planning Commission

The applicant may propose a Conditional Use Permit request by submitting, to Town Staff, written material outlining the proposed use. Written material must be accompanied by supporting documentation (including, but not limited to: maps, drawings, detailed photographs, product information, etc.). Application and supporting materials, including a CD of all drawings in PDF format, must be submitted at least twenty-one (21) ~~seven (7)~~ days prior to the next regular Planning Commission meeting. The Commission shall formulate a recommendation concerning the Conditional Use including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees. Within fourteen (14) days, staff will determine if the submitted application, and supplemental materials, are complete and schedule the Conditional Use Permit request for the next Planning Commission. The Planning Commission shall either:

1. Formulate a recommendation concerning the Conditional Use including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees.

2. Schedule a public hearing for a later date but no sooner than twenty-eight (28) days from receipt of the application. Notice of said hearing will be placed in the newspaper of public record for the Town at least fifteen (15) days prior to the hearing. The Town shall also notify, by certified mail, all property owners within two hundred (200) feet of the property boundary, fifteen (15) days in advance of the hearing.

After taking evidence in relation to said Condition Use application, the Planning Commission shall formulate a recommendation, including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees.

b. Procedure before the Board of Trustees

The Board of Trustees shall vote to approve, modify or disapprove the recommendation of the Planning Commission by resolution. The Board of Trustees may also request a public hearing. Should the Board of Trustees choose so, the process identified in Section # 12-2-30(a)2 prior to voting to approve, modify or disapprove the recommendation of the Planning Commission by resolution.

3. Types of Conditional Use Permits

a. Conditional Use Permits (CUPs), permitted uses allowed in a district, in addition to the uses by right, where so authorized, are designated by individual

zoning districts. Please refer to Sections 12-2-8 through 12-2-25 for individual zone listing.

- b. *Nightly Rental Conditional Use Permits depend on the zoning district which the proposed rental is located. In addition to other Town requirements, no person shall rent a structure, dwelling, dwelling unit, or lock-off unit for nightly rental purposes, except in accordance with the provisions of this Article ~~Section 12-2-26 (f)~~.*

1. Nightly Rental Conditional Use Permits by Zone

- A. *The following shall apply only to the following districts: OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, and MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY*

1. Town Action:

- a. *If Town Staff determines that the application satisfies the requirements of Section 12-2-26(j) 30B-3b #2, all adjoining property owners or all owners within 100', whichever includes the largest number of properties, will be notified in writing by the Town of the applicants proposed use. All notified property owners will be given fifteen (15) days to object to the proposed use in writing.*
- b. *If one (1) or more notified property owners object to the proposed use in writing, the application shall be treated as a conditional use as outlined in Section 12-2-26(b) 30B # 1 and 2. The owner of the subject property shall be given a copy of all written complaints. In consideration of the proposed use, the Planning Commission may hold a Public Meeting to determine its recommendation to the Board of Trustees. The Board of Trustees may hold a Public Hearing on the proposed use to decide whether to approve, modify, or disapprove the Planning Commission's recommendation.*
- c. *If zero notified property owners object to the proposed use, Town Staff shall issue the Nightly Rental License administratively.*
- d. *Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the Nightly Rental License Fee shall only be \$165.*

e. *Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.*

2. Renewal

a. *If zero complaints have been filed in the previous 12 months, and the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License. For purposes of Section 12-2--26(j) 30B-3b #2, a complaint must be either an official police citation or a letter signed by the complaining party.*

b. *If one (1) or more complaints have been filed in the previous 12 months, the applicant must pay an application fee of \$150 and a Nightly Rental License fee of \$400. The Town shall provide notice to all adjoining property owners or all owners within 100', whichever includes the largest number of properties, and the application shall be treated as a conditional use as outlined in paragraph twelve (12) of Section 12-2--26(j) 30B-3b #2.*

B. *The following shall apply only to the following districts: COMMERCIAL TRANSITIONAL, COMMERCIAL, and RESORT DISTRICTS*

1. Town Action:

a. *If Town Staff determines that the application satisfies the requirements of Section 12-2--26(k) 30B-3b #2, the Nightly Rental License will be issued.*

b. *Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the Nightly Rental License Fee shall only be \$165.*

c. *Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.*

2. Renewal

If the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License.

C. *The following shall apply only to the following districts: PD and PUD.*

Planned Developments/Planned Unit Developments—Are considered one in the same; PD's that have no underlying zoning or are zoned PD or PUD shall be governed under Section 12-2--26(+) 30B-3b #2.

2. Nightly Rental Conditional Use Permit Regulations

Nightly rentals of such units shall only be authorized if all of the following conditions are met:

1. *Applicant must provide two copies of a site plan that displays conformance with the following criteria, an application fee of \$150, for all units listed in 1A, above, and a Nightly Rental License fee of \$400. No person shall rent or advertise for rent their structure, dwelling or dwelling unit unless a Nightly Rental License has been granted by ~~the Town Clerk~~ Town Staff. A nightly Rental License must be obtained for each structure, dwelling, or dwelling unit. If an application is subsequently denied, the applicant shall be refunded \$400.*

- B. *Application can be made for a Nightly Rental License as early as June 1st for the subsequent year and the first Nightly Rental License for any applicant may be valid for a period of up to 19 months (June 1st of current year through December 31st of following year). In instances when a license is issued for a period of time other than 12 months, the fee shall be prorated for the number of months in which it is being issued. Other than the first issued license, all Nightly Rentals shall be valid for 12 months, from January 1st to December 31st.*

- C. *No person shall be granted a Nightly Rental License unless a state sales tax number has been received to provide for the collection of state, local sales and lodging taxes. If the structure, dwelling, or dwelling unit is operated by a third party as defined in Section ~~(A)(4)~~ 12-2-30B #2 (D), the third party may use a pre-existing sales tax number for purposes of this paragraph.*

- D. *At the time an application for a license is submitted, the licensee shall provide to ~~the Town Clerk~~ Town Staff the name, address and telephone number of any current management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. It shall be the duty of the licensee to update such information throughout the term of the license so that ~~the Town Clerk~~ Town Staff always has the correct and current information.*

- E. *At the time of the application of the license the licensee shall provide to ~~the Town Clerk- **Town Staff**~~ the name, address and telephone number of a local contact person who is authorized by the licensee to receive communications from the Town concerning the nightly rental. The local contact person may be a management company, rental agent or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. The local contact person shall maintain a residence or permanent place of business within 15 minutes driving distance to the Town and must be available 24 hours per day, seven days per week, during periods in which the structure is being rented. The designated local contact person may be changed by the licensee from time to time throughout the term of the license. To effect such change, the licensee shall notify ~~the Town Clerk- **Town Staff**~~ of the change in writing in advance of the change and shall, at the same time, provide ~~the Town Clerk- **Town Staff**~~ with the name, address and telephone number of the licensee's replacement contact person. Any replacement contact person shall meet the requirements of this subparagraph.*

Site Plan Criteria:

- F. *Adequate parking shall be shown on the site plan, as outlined in Section ~~12-2-26(a)~~ **12-2-28**. For purposes of Section ~~12-2-26(k)~~. Parking requirements for nightly rentals shall be calculated from Group III. The motor vehicles of all occupants of the nightly rentals shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.*
- G. *There is a clearly-defined trash storage area and an adequate number of trash containers provided and the trash company hired for regular pick-up must be identified.*
- H. *The dwelling to be used as a nightly rental shall provide on site snow storage that is equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.*
- I. *The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.*
- J. *The applicant shall obtain HOA sign-off if the property resides within an HOA.*

Additional Criteria:

- K. *While occupying or visiting a nightly rental, no person shall make, cause or permit unreasonable noise to be emitted from the nightly rental that is audible upon private premises in excess of the limits set forth in Sections 25-12-101 through 25-12-109, Colorado Revised Statutes.*
 - L. *At no time shall a nightly rental qualify for a sign permit. Signs for advertising shall not be permitted at nightly rentals except as outlined in Section 6-2-1(c), Town of Grand Lake Sign Code.*
 - M. *If more than one property is accessed by a shared driveway, written permission to access the drive must be obtained from each affected property owner.*
 - N. *Compliance with the conditions set forth in Section ~~12-2-26(k)~~ **12-2-30(B) # 3b** shall be the non-delegable responsibility of the owner of the nightly rental; and each owner of a nightly rental shall be strictly liable for complying with the conditions set forth in this Section or imposed by the Board of Trustees.*
 - O. *Licensee to Receive Conditions. At the time of the issuance of a license, ~~the Town Clerk~~ **Town Staff** shall provide the licensee with a copy of the special conditions set forth in Section ~~12-2-26(k)~~ **12-2-30(B) # 3b** or imposed by the Board of Trustees.*
 - P. *Licensee to Post License and Conditions. The licensee shall post a copy of the license and the conditions set forth in Section ~~12-2-26(k)~~ **12-2-30(B) # 3b** or imposed by the Board of Trustees in a conspicuous location in the nightly rental. The license and the conditions shall remain continuously posted in the nightly rental throughout the term of the license.*
 - Q. *Licensee to Provide Management Company with Conditions. The licensee shall provide any management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental with a copy of the conditions set forth in Section ~~12-2-26(k)~~ **12-2-30(B) # 3b** or imposed by the Board of Trustees.*
3. Nightly Rental Conditional Use Permit Penalties
- A. *Any person found to be advertising a Nightly Rental without a license to rent that property will be notified by certified mail to cease and desist all advertisements. Upon receipt of that notice, the offending party shall have ten (10) days to remove the offending advertisement. After this*

grace period has ended, or upon a second or further violation, the offending party shall be determined to be in violation of this Ordinance and shall be ticketed for each offense.

- B. A violation of any part of Section ~~12-2-26(k)~~ **12-2-30(B) # 3b** is punishable by a fine of up to \$300 for each occurrence. Each day such violation persists or continues shall constitute a separate and distinct offense.*
- C. The Town may also seek an injunction in addition to all other remedies and penalties provided for by local ordinance or available law.*
- D. All these remedies shall be in addition to all other remedies and penalties provided for by local ordinance or available at law.*

PART 26. Section ~~12-2-29~~ **12-2-32**, Non-Conforming Uses and Structures, of the code of the Town of Grand Lake, Colorado, is hereby amended to read as follows:

- i. Special Exceptions to Provisions on Expansion of Non-Conforming Uses

(1) The Board of Adjustment shall hold a public hearing within forty-five (45) days of receipt of application on all applications and appeals with the following special conditions required:

(A) A notice of said hearing shall be published once in the legal newspaper of the Town at least fifteen (15) days prior to the hearing date.

(B) A written notice of said hearing shall be mailed, by certified mail, to property owners within 200' at least fifteen (15) days prior to the hearing date to the owners of property adjacent to the property in question.

(C) Preparation of and payment for all notices shall be the responsibility of the Town Clerk. Supp. #10, 1983 See Ord. #7-1983 Adopted August 8, 1983

(2) Before any variance is granted, the Board of Adjustment shall include a written finding in its minutes as part of the record in each case, stating specifically the exceptional conditions, the practical difficulties or unnecessary hardships involved.

(3) In granting any variance, the Board of Adjustment may prescribe appropriate conditions and safeguards in conformity with these Regulations. Violation of such conditions and safeguards, when made a part of the terms under which the variance is granted, shall be deemed a violation of these Regulations.

(4) Unless otherwise stated in the Board of Adjustment minutes, all variance permits must be utilized within nine (9) months from the time such variance is granted by the Board, after which time, if the variance permit has not been utilized, it shall become null and void.

(5) The variance granted shall be so noted in the Town Official Records in the property file. Variances that are utilized shall be valid for the life of the building. If greater than fifty percent (50%) of the building is destroyed, the variance may not be transferred to the reconstructed building.

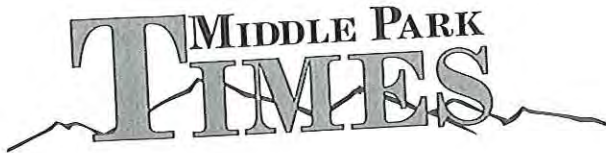

ORDINANCE NO. 33-2009

**AN ORDINANCE AMENDING THE TOWN OF GRAND LAKE MUNICIPAL CODE
CHAPTER 12, ARTICLE 2 ZONING REGULATIONS**

WHEREAS, the Town of Grand Lake Board of Trustees has the authority to adopt Ordinances; and

WHEREAS, the Town of Grand Lake Board of Trustees desires to have a cohesive and enforceable Municipal Code; and

WHEREAS, the Town Planning Commission held a Public Hearing on the matter on August 19, 2009, and took public testimony on the matter and forwarded a recommendation to the Town Board of Trustees; and

WHEREAS, the Town Board of Trustees held a Public Hearing on the matter on September 28, 2009, and took public testimony on the matter,

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GRAND LAKE, COLORADO THAT:

- 1. Section 6 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended by adding the following definitions to read as follows:

Accessory Dwelling Unit (ADU) – One additional dwelling unit within, and not legally subdivided from, the principal structure. The dwelling unit must be in a continuous enclosure. The entire dwelling unit must function as a unit without any permanent physical separation such as wall or floor with no means of connection.

Adult Arcade - Any commercial establishment to which the public is permitted or invited where, for any form of consideration, one or more still or motion picture projectors, slide projectors, or similar machines, or other image or virtual reality producing machines for viewing by persons are used regularly to show films, motion pictures, video cassettes, DVDs, slides, or other photographic, digital, or electronic reproductions describing, simulating, or depicting "specified sexual activities" or "specified anatomical areas."

Adult Cabaret – means a nightclub, bar, restaurant, concert hall, auditorium or other commercial establishment that features:

- A. Persons who appear nude or in a state of nudity or seminudity; or
- B. Live performances that are characterized by the exposure of “specified anatomical areas” or by the exhibition of “specified sexual activities.”

Adult Motel – means a hotel, motel or similar commercial establishment that offers accommodations to the public for any form of consideration and provides patrons with closed-circuit television transmission, films, motion pictures, video cassettes, slides, or other media productions, however produced, which are characterized by the depiction or description of "specified sexual activities" or "specified anatomical areas," and which commercial establishment has a sign visible from the public right-of-way which advertises the availability of this adult type of media production.

Adult Motion Picture Theatre – means a commercial establishment that is distinguished or characterized by the showing, for any form of consideration, of films, motion pictures, video cassettes, slides, or similar

photographic reproductions that have an "X" rating or that have an emphasis on depicting or describing "specified sexual activities" or "specified anatomical areas."

Adult Theatre – means a theater, concert hall, auditorium, or similar commercial establishment that, for any form of consideration, regularly features persons who appear in a state of nudity or live performances which are characterized by an emphasis on exposure of "specified anatomical areas" or by "specified sexual activities."

Bed and Breakfast - an owner-occupied single family residence with no more than ten guest rooms which provides overnight accommodations and breakfast, provided from a single kitchen on the premises, to registered Transient Guests. The use of a Bed and Breakfast in a single-family residence shall be considered an accessory use to the primary use.

Nudity or State of Nudity -

- a. The appearance of human bare buttock, anus, male genitals, female genitals, or the areola or nipple of the female breast; or
- b. A state of dress which fails opaquely and fully to cover human buttocks, anus, male or female genitals, pubic region, or areola or nipple of the female breast.

Seminude - A state of dress in which clothing covers no more than the genitals, pubic region, and areola of the female breasts, as well as portions of the body covered by supporting straps or devices, which supporting straps or devices are used to support or enable the wearing of such clothing.

Sexually Orientated Business (SOB) –

- 1. a business that has as one of its principal business purposes a substantial or significant portion (20% or more) of its stock and trade, books, magazines, other periodicals, videos, or DVDs on matter depicting, describing or relating to "specified sexual activities," or "specified anatomical areas", or
- 2. an establishment with a substantial or significant portion (20% or more) segment or section devoted to the rental, sale or display of materials, instruments, devices, or paraphernalia which are designed for use in connection with "specified sexual activities", or
- 3. "adult" arcades, cabarets, motels, motion picture theatres or theatres where:
 - a. persons appear in a state of nudity, or
 - b. there are live performances which are characterized by the exposure of "specified anatomical areas", by "specified sexual activities", or physical contact in the form of wrestling or tumbling between persons of the opposite sex or activities between male and female persons and/or persons of the same sex when one or more of the persons is in a state of nudity or semi-nude.

Specified Anatomical Areas - As used herein means and includes any of the following:

- a. Human genitals, pubic region, buttocks, anus or female breasts below a point immediately above the top of the areola, that are not completely and opaquely covered; or
- b. Human male genitals in a discernibly turgid state even if completely and opaquely covered.

Specified Sexual Activities - Includes any of the following:

- a. The fondling or other intentional touching of human genitals, pubic region, buttocks, anus or female breasts;
- b. Any sex act, whether actual or simulated, including, but not limited to, intercourse, oral copulation, or sodomy;
- c. Masturbation, whether actual or simulated;
- d. Human genitals in a state of sexual stimulation, arousal, or tumescence; or
- e. Excretory functions as part of or in connection with any of the activities set forth in subsections a through d of this definition.

Total Floor Area - The total number of square feet of floor space within the exterior walls of a building, not including space in cellars, carports or garages.

Transient Guest – a person who stays for a period not to exceed two (2) weeks.

(All other Subsections in this Section will remain the same.)

 - 4. Historic structures.

- b. Conditional Uses
 - 7. Sexually orientated businesses.

(All other Subsections in this Section will remain the same.)

13. Section 21 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

- a. Uses Permitted by Right
 - 5. Boat rentals, boat repair and maintenance facilities, lake tours, fishing equipment rentals and similar water-based recreational services.
 - 8. Historic structures.
- b. Conditional Uses
 - 1. Public, private and commercial marinas.
 - 6. Enterprises or businesses of the same nature or class as those listed above in Paragraph (a), "Uses Permitted by Right", which in the opinion of the Planning Commission, as evidenced by a Resolution of Record, is not more obnoxious or detrimental to the welfare of the area than those listed in said Paragraph (a).

(All other Subsections in this Section will remain the same.)

14. Section 23 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

- c. Conditional Uses
 - 5. Historic structures.

(All other Subsections in this Section will remain the same.)

15. Section 24 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

- b. Uses Permitted by Right
 - 17. Historic structures.

(All other Subsections in this Section will remain the same.)

16. Section 28 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

Section 12-2-28 - Parking Regulations

- a. All uses and structures of the date of adoption of this Section shall be deemed in compliance with the regulations set forth in this Section.
- b. Parking Requirements - No building shall be erected, enlarged to the extent of increasing the floor area by more than ten percent (10%), changed in use as defined in this Article 2, or rezoned (excluding Town initiated rezoning) unless there is either an approved parking plan in place or a parking fee paid to the Town if allowed, or there is provided on the lot, space for parking and space for the loading and unloading of automobiles or trucks in accordance with the following standards and requirements. *Nothing in this part shall supersede the on-site utility requirement for structures built on property within the commercial district.*

- 1. The criteria to calculate the required number of off-street parking spaces shall be as follows:

2. The method used to calculate the required number of parking spaces shall be as follows:
 - A. The total number of required parking spaces shall be calculated based on the table from Part 1. Any fraction shall be rounded up to the next whole number. In cases of mixed uses on one property, the requirements of each group shall be calculated and applied independently of the requirements of other groups. In cases of an existing building being enlarged so as to increase the floor area by more than ten percent (10%), changed in use as defined in this Article 2, or rezoned (excluding To

initiated rezoning), the total floor area and/or number of bedrooms of building after enlargement, change in use, or rezoning (excluding Town initiated rezoning) shall be used to calculate the required number of off-street parking spaces to be provided.

- B. Group I and Group II structures shall be required to supply one hundred percent of the resulting number on the property where the structure is located.
- C. After allowing for the on-street parking credit, if eligible, group IV and group VI structures shall be required to satisfy seventy five (75%) percent of the resulting number of required off-street parking spaces.

3. On-Street Parking Credits in Determining Required Parking Spaces.

- A. In determining the amount of off-street parking required, credit will be given for the available on-street parking adjacent and contiguous to any property subject to the provisions of this Section which adjoins a public right-of-way of eighty (80') feet or more in the Multiple-Family, Commercial, Commercial Transitional, Resort, Light Industrial, and General Industrial Districts.
- B. The amount of off-street parking spaces required as determined elsewhere in this Section shall be reduced by the number of available on-street parking spaces on a one-to-one basis.
- C. For qualifying lots, as described in (A), the amount of off-street parking will be calculated at 0.085 spaces per foot of frontage on a road that has available on-street credit.

4. The non-refundable off-street parking fee shall be ten thousand (\$10,000.00) dollars for each parking space. This fee may be amended from time to time by resolution adopted by the Board of Trustees. The parking fee shall be assigned to a particular lot or parcel, and may not thereafter be conveyed, assigned or transferred to any other property. The parking fee shall be paid in full concurrent with the Town's approval of a Building Permit Application, or a fee-in-lieu may be in equal and portioned payments over a five-year period. Portioned payments shall be assessed to the property tax statement of the subject parcel(s) and shall carry with the parcel(s) until the full payment has been made.

5. Parking spaces will be required to be located with a designated distance. Off-site parking spaces will be required to be owned by the same owner as the onsite parking spaces.

- A. Single Family Residential and Multiple Family Residential zones must have the required parking spaces be provided on the same property or use as the principal building or use.
- B. Commercial, industrial and mixed use developments may satisfy the commercial and industrial off-street parking requirement by providing an off-site parking area. The off-site parking area shall be within three (3) blocks of the principal use. Residential units in mixed used developments must have the required parking spaces on the same property or use as the principal building.
 - 1. The off site parking area shall have a deed restriction placed upon the property prohibiting sale, lease, transfer or conveyance without the prior approval of the Town and limiting its use to solely a parking lot servicing the off-street parking requirements of the property containing the principal use. The deed restriction shall be of a content and form approved by the Town and shall be recorded with the Grand County Clerk and Recorder.
 - 2. The zoning for off-site parking area shall be the same as the principal use or a more intensive classification, except that in the C zone, land in the CT zone may be used as the off-site parking area. Parking areas shall be owned by the owner of the principal use for which parking space are being provided.
 - 3. Upon Board of Trustees approval (based on recommendation by the Planning Commission) Commercial, industrial and mixed used developments may provide

on-street parking in areas where parking is under developed so requirements of distance and the design standards set forth herein are met.

6. Accessible Parking - one designated accessible (handicapped) parking space shall be required as a part of the overall off-street parking requirements mandated under this Section for each twenty-five (25) off-street parking or fraction thereof. In all cases the accessible space shall be located in a manner close and convenient to the principal building main pedestrian ingress/egress.

7. Loading/Unloading Areas

A. Loading/Unloading Areas may be a shared loading zone, located in the alleyway, for multiple-unit complexes provided it will adequately handle the commodities anticipated.

1. Changes in Structure (enlarged so as to increase the floor area by more than ten percent (10%) in any given two-year period) shall necessitate alley-access loading/unloading areas.

2. Changes in Use shall necessitate alley-access loading/unloading areas.

B. Loading areas are to be designed to adequately accommodate both goods and people unloading at all residential and commercial buildings; the minimum loading area is fourteen feet (14') wide by twenty feet (20') long by sixteen feet (16') high.

C. Parking and loading areas are not to be used for the sale, repair, dismantling or storage of any vehicle or equipment. The sale of any materials, supplies, food or other goods is prohibited in parking and loading areas except by special permit from the Town.

c. Parking Design Standards – The following requirements will apply to all projects that necessitate parking requirements as outlined in the previous section.

1. General Standards

A. No parking is to be allowed on through public roads unless additional surface widths are provided for this purpose. The minimum roadway width for on-street parking is eighty feet (80').

B. Convenient and accessible snow storage areas shall be provided for parking areas equivalent to one-third (1/3) of the total drive and parking areas.

1. Snow storage areas must not drain directly into any stream, creek, lake or ditchway (that drains to any stream, creek or lake) without first passing through some water quality control device such as grassed waterways, retention pond or the like.

2. Parking areas created to satisfy parking requirements may not double as required snow storage areas and if snow removal from the site is contemplated, a plan of action is to be drawn up and submitted to the Planning Commission for review.

C. All parking areas are to be paved with concrete or asphalt in the commercial, commercial transitional, and industrial districts. Concrete or asphalt may be required in the residential, open and resort districts if there is contiguous surfacing material.

1. Concrete surfacing material is highly encouraged.

2. All parking areas required to have asphalt must have a minimum compacted depth of four inches (4").

3. Residential, open and Resort zones where parking areas may be surfaced with compacted gravel (Class C) and treated to control fugitive dust.

a. All parking areas and stalls are to be defined with cribbing or similar material and surfaced with Class C gravel to a depth of two inches (2") as a minimum, if applicable.

D. Landscaping is required on the perimeters of parking areas to help screen them from public view.

1. Large parking areas are to be broken up with landscaped islands that provide a measure of aesthetics to the parking areas without seriously inhibiting snow plowing and storage; snow storage shall not reduce the required parking area.

E. Off-Site parking areas must have positive pedestrian accesses and connections to and from the principal use and/or structures which shall include mandatory or voluntary boardwalk, sidewalk and community greenways, if applicable.

2. Additional Parking Lot and Structure Standards

A. Parking lot aisle lanes may vary from twenty-four (24) feet to twelve (12) feet depending upon the angle of parking with perpendicular parking requiring an aisle width of twenty-four (24) feet.

B. All parking areas are to be adequately lighted for security reasons.

C. All parking lots (greater than thirty (30) spaces) and structures are to be provided with a minimum of two (2) accesses for the purpose of proper traffic ingress and egress traffic circulation.

D. Parking Lots on 50' X 100' lots shall conform to the following:

1. The surface off-street parking space width shall be measured at a perpendicular angle for all parking spaces. Angled parking will require individual parking blocks for each parking space.

2. Snow Storage will account for 1/3 of the total parking lot. This area shall be utilized for snow storage in the winter and may be placed directly on the paved surface.

a. Snow storage areas must not drain directly into any stream, creek, lake or ditchway (that drains to any stream, creek or lake) without first passing through some water quality control device such as grassed waterways, retention pond or the like.

3. Parking lot plans shall be engineered and submitted to the Town for review and approval. Parking lots shall provide for an adequate drainage system that will connect to the municipal waste water system or provide for Best Management Practices that allow for onsite drainage.

4. Lighting and signage plan will also be submitted to the Town for review and approval.

5. All other requirements of Section 12-2-28 will apply.

E. Parking structures shall be a minimum of ten (10) feet from public or private road right-of-ways. In the case of State Highway 34, the setback shall be twenty (20) feet from the ROW. No setback is required for at-grade parking lots.

F. Underground or structured parking is encouraged.

1. The creation of new parking lots will trigger the creation of mandatory boardwalks and greenbelts in those areas where they are required.

d. Variances to Parking Requirements and Standards

1. Variances to parking requirements and standards may be granted by the Board of Trustees, with recommendation from the Planning Commission. In order to grant approval of a variance, the Board shall find the following findings:

A. that the proposed parking plan requesting the variance has a mitigation plan in place for the requested variance; and

B. that the proposed parking plan requesting the variance has mitigated by providing enhanced pedestrian linkages between uses and structures with developed parking areas

C. that the proposed parking plan requesting the variance has demonstrated that the enhanced pedestrian linkages and developed parking areas will be for the public good to link community uses, promote and increase pedestrian traffic as well as not to pose a detriment to existing parking conditions in the Town; and

D. that the cost of the of the pedestrian linkages and developed parking areas are 30% or greater of the total parking fee; and

E. that the parking spaces that are being proposed to be provided will be a minimum of 65% of the total parking space requirement.

- 2. Application for a parking variance shall be at the time of submittal of an application for development which the requirements and standards are set forth in this Section.
 - A. The Town of Grand Lake shall not review requests of this nature unless the applicant (its constituents or members) are current with the Town and all Town enterprises for all fees, assessments, charges, taxes, or amount due of any type.

e. Acceptance of Parking Areas

- 1. Before a Certificate of Occupancy (C.O.) is issued on any structure(s), all parking areas are, as a minimum, to be graveled. A temporary waiver may be granted for a set period of time, should weather conditions necessitate. All improvements bonds, escrow funds, etc., are to be held by the Town until paving is complete.

17. Section 31 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

A. Special Use and Special Event Permits

- 1. Special Use and Special Event General Information - The Special Use Permit (SUP) and Special Event Permit review process prescribed herein is intended to assure compatibility and harmony between the proposed special use with both the surrounding properties and the town at large.
 - a. The Special Use and Special Event Permit Process shall not be used for the purpose of granting the use of mobile homes for the purpose of temporary living quarters.
 - b. The Special Use and Special Event permit process shall not be used for the rental and subsequent use of Town facilities in accordance with Town rental policies.
 - c. The Town of Grand Lake shall not review requests of this nature unless the applicant (its constituents or members) are current with the Town and all Town enterprises for all fees, assessments, charges, taxes, or amount due of any type.
- 2. Special Event Permit (SEP): The use of property in the Commercial, Commercial Transitional, or Public Zones or Town right of ways by a non-profit or governmental entity sponsored group for fund-raising efforts or to hold a public event.
 - a. The Mayor, or the Mayor's designee, may sign the SEP without referring the matter to the Board of Trustees if the SEP is deemed to be in the best interest of the Town with the following items being taken into consideration:
 - (1) The predominant use of the primary facility being used
 - (2) The proposed event and the event hours
 - (3) Neighborhood compatibility
 - (4) Effect of the proposed event on the community
 - (5) The Town's anticipated cost in Staff time and equipment use
 - (6) Duplication of services or sales items
 - (7) Permanent address of the non-profit organization or governmental entity
 - (8) First time event
 - b. The Mayor, or the Mayor's designee, will refer the matter to the Board of Trustees for approval if the event involves a Special Events Liquor Permit.
 - c. Special Event Permit Application and Required Information:
 - (1) Applications must be submitted at least thirty (30) days prior to the date(s) of the event.
 - (A) If the event involves a special events liquor permit, the SUP application must be made at least ninety (90) days prior to the date(s) of the event.
 - (B) Any significant changes to the application must be made at least thirty (30) days prior to the proposed use unless caused by an emergency, as determined by Town Staff
 - (2) The application for this type of SEP shall contain the following information, if applicable:
 - (A) Name and contact information of the sponsoring non-profit or governmental entity.
 - (B) Name and contact information of applicant.
 - (C) Name and phone number of the contact person for the event.

- (D) Proof of non-profit or governmental entity status.
 - (E) Name and address of property owner and the legal description, street address and other identifying data concerning the proposed Special Event site.
 - (F) Authorization by the property owner for the proposed use.
 - (G) A description of the precise nature of the Special Event.
 - (H) A site plan showing its operating characteristics, including, but not limited to: dimensions and locations of specific activities, itinerary for the event and clean-up, trash/dumpster locations, off-street parking, ingress and egress points, traffic circulation, utilities and drainage features, and measures proposed to make the use compatible with other properties in the vicinity.
 - (I) List of items or services being requested from the Town, such as sound system, extra trash containers, traffic control devices, street closures, marquee announcement, electricity, and timing of sprinkler systems.
 - (J) List of any signage requested including the type, size, and colors, the location of each sign, and the duration the sign will be displayed.
 - (K) A copy of the Special Events Liquor Permit application or permit.
 - (L) Copy of a current and valid
 - 1. Colorado Sales Tax License,
 - 2. Grand Lake Sales Tax License, and/or
 - 3. Grand Lake Business License
 - (M) Any other information deemed by Town Staff to be reasonably necessary to carry out the provisions and the fair administration of this Section.
 - (N) An affidavit signed by the applicant stating that the information contained on the application is true and correct to the applicant's knowledge and further stating that knowing submission of false information shall be cause for the SEP to be immediately revoked without notice or hearing.
 - (O) A damage deposit is required and is refundable after determination by Town Staff that no damage to Town Property occurred and no clean-up by Town Staff was necessary.
 - 1. The damage deposit shall be One Hundred Dollars (\$100.00).
 - (P) The applicant shall indemnify the Town of Grand Lake. Proposed events involving alcohol, livestock, or events that could cause harm to persons or property, or items of similar nature as determined by the Town.
3. General SUP: The use of property, in any zoning district, for a period of six months or less, which use is not listed as a use by right or a conditional use.
4. Application and Required Information for a General SUP:
- a. Applications must be submitted at least ninety (90) days prior to the date(s) of the proposed use.
 - (1) Any significant changes to the application must be made at least thirty (30) days prior to the proposed use unless caused by an emergency, as determined by Town Staff.
 - b. The SUP Application, supporting documentation, and a CD of all supporting documentation in PDF format, shall be submitted to Town Staff in accordance with the above listed schedule. Town staff will have fourteen (14) days to determine whether or not the application is complete. Once determined complete, the request will be placed on the next regularly-scheduled Planning Commission meeting. The application shall be supported by documents, maps, plans and other material containing the following information, if applicable:
 - (1) Name and permanent address of applicant.
 - (2) Name and address of property owner and the legal description, street address and other identifying data concerning the proposed Special Use site.
 - (3) Authorization by the property owner for the proposed use.
 - (4) A description of the precise nature of the Special Use and a site plan showing its operating characteristics, including but not limited to: dimensions and locations of specific activities, off-street parking, ingress and egress points, traffic circulation, utilities and drainage features, and measures proposed to make the use compatible with other properties in the vicinity.

- (5) Copy of a current and valid:
 - (A) Colorado Sales Tax License,
 - (B) Grand Lake Sales Tax License,
 - (C) Grand Lake Business License.
 - (6) Any other information deemed by Town Staff to be reasonably necessary to carry out the provisions and the fair administration of this Article.
 - (7) An affidavit signed by the applicant stating that the information contained on the application is true and correct to the applicant's knowledge and further stating that knowing submission of false information shall be cause for the SUP to be immediately revoked without notice or hearing.
 - (8) A non-refundable administrative processing fee set by resolution by the Town Board of Trustees.
5. Commission Processing and Review Criteria for a General SUP:
- a. The Planning Commission shall review the SUP application and determine whether to deny the application or schedule a public hearing to receive testimony and comment of interested citizens, businesses, and adjoining property owners. In making this determination, the Commission shall consider the following factors:
 - (1) Relationship of the proposed Special Use to the economic development objectives of the Town and the anticipated impact of the SUP on existing businesses.
 - (2) Effect upon traffic, with particular reference to congestion, automotive and pedestrian safety and convenience, traffic flow and control, access, maneuverability, and (if applicable) snow removal from the streets and parking areas.
 - (3) Effect upon the character of the area in which the proposed Special Use is to be located, including the scale and bulk of the proposed Special Use in relation to surrounding uses and neighborhood.
 - (4) Such other factors and criteria as the Commission deems applicable to the proposed Special Use including but not limited to: proposed length of use; specific businesses, land owners or other interested parties to be notified; or proposed conditions of SUP issuance.
 - b. The applicant may appeal the Commission's decision to deny the SUP request to the Board of Trustees, in accordance with the procedure outlined in part (7)(a) below.
 - c. At least fifteen (15) days prior to the scheduled date, the Town Clerk, or her designee, shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing, and Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP public hearing.
 - d. At the public hearing, after receiving comment and testimony, the Commission shall make a recommendation to the Board of Trustees in the form of a Resolution. Nothing in this Section shall preclude the Commission from tabling or continuing the public hearing to another time and place. If the Resolution is to approve the request, it shall contain the following findings:
 - (1) That the proposed location of the use is in accord with the purposes of this Chapter and the purposes of the district in which the SUP site is located.
 - (2) That the proposed location of the Special Use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety, or welfare, nor will the proposed use be materially injurious to nearby land uses, properties, or improvements.
 - (3) That the proposed use will comply with all of the applicable provisions of the Code of Ordinances.
 - (4) That the applicant shall comply with such terms and conditions as the Commission determines are necessary to carry out the letter and intent of the Special Use Permit process.
6. Board of Trustees Processing and Review Criteria for a General SUP:
- a. Appeal of Commission Denial:

- (1) Applicants appealing the Commission denial of the SUP application shall file with Town Staff a request for hearing. The form of the appeal shall be in the manner as is prescribed by Town Staff. All appeals shall be accompanied by a non-refundable processing fee, set by resolution by the Town Board of Trustees. The matter shall be scheduled for the next regular Board meeting. At that meeting the Board shall determine if the denial is to be sustained or whether a public hearing shall be required. The sustaining of the denial is a final decision.
- (2) If the Board determines a public hearing is appropriate, then at least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing, and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP public hearing.

b. Recommendation of Commission Approval or Conditional Approval:

- (1) Upon adoption and transmittal of the Commission's Resolution, Town Staff shall set a date for a public hearing on the application before the Board of Trustees. At least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP public hearing and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP public hearing.
- (2) Final action on the Special Use Permit is to be taken by the Board of Trustees at the public hearing; except that the Board may continue the public hearing to another time before taking final action.

7. Permit Issuance of Approval or Conditional Approval

- a. A Special Use Permit shall not grant variances. Variances shall be granted in accordance with the procedures prescribed in Section 12-2-32.
- b. The SUP shall be valid for a maximum period of six months unless a different time period is authorized by the Board.
- c. The SUP applicant shall also be subject to all other procedures, permits and requirements of this and other applicable Ordinances, regulations and agreements of the Town. In the event of any conflict between the provisions of a Special Use Permit and any other permit, requirement, or agreement, the more restrictive provision shall prevail.
- d. Authorization of a change or waiver in any condition previously imposed in the authorization of a special use shall be subject to the same procedures as a new special use.
- e. The SUP applicant shall comply with all such other conditions as are imposed by the Board as a condition of issuance.
- f. Failure to adhere to the General Conditions shall be cause for Town Staff to either suspend or revoke the SUP without notice or hearing.

B. Conditional Use Permits (CUP)

- 1. CUP General Information – Conditional Uses are those uses allowed in a district, in addition to the uses by right, where so authorized, when and if a Conditional Use Permit (CUP) is granted, in accordance with special procedures and requirements. The CUP review process herein is intended to assure compatibility and harmony between the proposed conditional use with both the surrounding properties and the town at large.
 - a. The Town of Grand Lake shall not review requests of this nature unless the applicant (its constituents or members) are current with the Town and all Town enterprises for all fees, assessments, charges, taxes, or amount due of any type.
- 2. Processing and Review Criteria - Unless identified in Section 12-2-31(B)3b, requests for Conditional Use Permits will be processed and reviewed according to the following criteria:
 - a. Procedure before the Planning Commission
 - (1) The applicant may propose a Conditional Use Permit request by submitting, to Town Staff, written material outlining the proposed use. Written material must be accompanied by

supporting documentation (including, but not limited to: maps, drawings, detail photographs, product information, etc.). Application and supporting materials, including a CD of all drawings in PDF format, must be submitted at least twenty-one (21) days prior to the next regular Planning Commission meeting. Within fourteen (14) days, staff will determine if the submitted application, and supplemental materials, are complete and schedule the Conditional Use Permit request for the next Planning Commission. The Planning Commission shall either:

- (A) Formulate a recommendation concerning the Conditional Use including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees, or
- (B) Schedule a public hearing for a later date but no sooner than twenty-eight (28) days from receipt of the application. At least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the CUP public hearing and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the CUP public hearing.
 - 1. After taking evidence in relation to said Condition Use application, the Planning Commission shall formulate a recommendation, including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees.

b. Procedure before the Board of Trustees

- (1) The Board of Trustees shall vote to approve, modify or disapprove the recommendation of the Planning Commission by resolution. The Board of Trustees may also request a public hearing. Should the Board of Trustees choose so, the process identified in Section # 12-2-31 (A)7 shall be followed prior to voting to approve, modify or disapprove the recommendation of the Planning Commission by Resolution.

c. Submittal of New Materials

- (1) The applicant may not submit additional materials to the Town Board of Trustees for review. Submittal of new materials shall constitute a new application, shall require deposits, and shall be reviewed by the Planning Commission prior to going before the Town Board of Trustees.

3. Types of Conditional Use Permits

a. Conditional Use Permits (CUPs) - permitted uses allowed in a district, in addition to the uses by right, where so authorized, are designated by individual zoning districts. Please refer to Sections 12-2-8 through 12-2-25 for individual zone listing.

b. Nightly Rental Conditional Use Permits depend on the zoning district which the proposed rental is located. In addition to other Town requirements, no person shall rent or advertise to rent a structure, dwelling, dwelling unit, or lock-off unit for nightly rental purposes, except in accordance with the provisions of this Article. Nightly Rental CUP applications and renewals will be exempt from the Conditional Use Permitting fee but may be assessed other fees, as defined within the provisions of this Article.

(1) Nightly Rental Conditional Use Permits by Zone

(A) The following shall apply only to the following districts: OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, and MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY.

1. Town Action:

- a. If Town Staff determines that the application satisfies the requirements of Section 12-2-31B(3)b(2), all adjoining property owners or all owners within 100', whichever includes the largest number of properties, will be notified in writing by

the Town of the applicants proposed use. All notified property owners given fifteen (15) days to object to the proposed use in writing.

- b. If one (1) or more notified property owners object to the proposed use in writing, the application shall be treated as a conditional use as outlined in Section 12-2-31B(1) and (2). The owner of the subject property shall be given a copy of all written complaints. In consideration of the proposed use, the Planning Commission may hold a Public Meeting to determine its recommendation to the Board of Trustees. The Board of Trustees may hold a Public Hearing on the proposed use to decide whether to approve, modify, or disapprove the Planning Commission's recommendation.
- c. If zero notified property owners object to the proposed use, Town Staff shall issue the Nightly Rental License administratively.
- d. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the Nightly Rental License Fee shall only be \$165.
- e. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

2. Renewal

- a. If zero complaints have been filed in the previous 12 months, and the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License. For purposes of Section 12-2-31B(3)b(2), a complaint must be either an official police citation or a letter signed by the complaining party.
- b. If one (1) or more complaints have been filed in the previous 12 months, the applicant must pay an application fee of \$150 and a Nightly Rental License fee of \$400. The Town shall provide notice to all adjoining property owners or all owners within 100', whichever includes the largest number of properties, and the application shall be treated as a conditional use as outlined Section 12-2-31B(3)b(2).

(B) The following shall apply only to the following districts: COMMERCIAL TRANSITIONAL, COMMERCIAL, and RESORT DISTRICTS.

1. Town Action:

- a. If Town Staff determines that the application satisfies the requirements of Section 12-2-31B(3)b(2), the Nightly Rental License will be issued.
- b. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the Nightly Rental License Fee shall only be \$165.
- c. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

2. Renewal

- a. If the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License.

(C) The following shall apply only to the following districts: PD and PUD.

- 1. Planned Developments/Planned Unit Developments—Are considered one in the same; PD's that have no underlying zoning or are zoned PD or PUD shall be governed under Section 12-2-31B(3)b(2).

(2) Nightly Rental Conditional Use Permit Regulations - Nightly rentals of such units shall only be authorized if all of the following conditions are met:

- (A) Applicant must provide two copies of a site plan that displays conformance following criteria, an application fee of \$150, for all units listed in 1A, above, and a Nightly Rental License fee of \$400. No person shall rent or advertise for rent their structure, dwelling or dwelling unit unless a Nightly Rental License has been granted by Town Staff. A nightly Rental License must be obtained for each structure, dwelling, or dwelling unit. If an application is subsequently denied, the applicant shall be refunded \$400.
- (B) All fees, dues, debts to the Town of Grand Lake, and taxes must be current before a license will be issued.
- (C) Application can be made for a Nightly Rental License as early as June 1st for the subsequent year and the first Nightly Rental License for any applicant may be valid for a period of up to 19 months (June 1st of current year through December 31st of following year). In instances when a license is issued for a period of time other than 12 months, the fee shall be prorated for the number of months in which it is being issued. Other than the first issued license, all Nightly Rentals shall be issued for 12 months, from January 1st to December 31st.
- (D) No person shall be granted a Nightly Rental License unless a state sales tax number has been received to provide for the collection of state, local sales and lodging taxes. If the structure, dwelling, or dwelling unit is operated by a third party as defined in Section 12-2-31B(2)(D), the third party may use a pre-existing sales tax number for purposes of this paragraph.
- (E) At the time an application for a license is submitted, the licensee shall provide to Town Staff the name, address and telephone number of any current management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. It shall be the duty of the licensee to update such information throughout the term of the license so that Town Staff always has the correct and current information.
- (F) At the time of the application of the license the licensee shall provide to Town Staff the name, address and telephone number of a local contact person who is authorized by the licensee to receive communications from the Town concerning the nightly rental. The local contact person may be a management company, rental agent or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. The local contact person shall maintain a residence or permanent place of business within 15 minutes driving distance to the Town and must be available 24 hours per day, seven days per week, during periods in which the structure is being rented. The designated local contact person may be changed by the licensee from time to time throughout the term of the license. To effect such change, the licensee shall notify Town Staff of the change in writing in advance of the change and shall, at the same time, provide Town Staff with the name, address and telephone number of the licensee's replacement contact person. Any replacement contact person shall meet the requirements of this subparagraph.
- (G) Site Plan Criteria:
 - 1. Adequate parking shall be shown on the site plan, as outlined in Section 12-2-28. Parking requirements for nightly rentals shall be calculated from Group III. The motor vehicles of all occupants of the nightly rentals shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.
 - 2. There is a clearly-defined trash storage area and an adequate number of trash containers provided and the trash company hired for regular pick-up must be identified.

- 3. The dwelling to be used as a nightly rental shall provide on site snow storage equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.
- 4. The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.
- 5. The applicant shall obtain HOA sign-off if the property resides within an HOA.

(H) Additional Criteria:

- 1. While occupying or visiting a nightly rental, no person shall make, cause or permit unreasonable noise to be emitted from the nightly rental that is audible upon private premises in excess of the limits set forth in Sections 25-12-101 through 25-12-109, Colorado Revised Statutes.
- 2. At no time shall a nightly rental qualify for a sign permit. Signs for advertising shall not be permitted at nightly rentals except as outlined in Section 6-2-1(c) and (d), Town of Grand Lake Sign Code.
- 3. If more than one property is accessed by a shared driveway, written permission to access the drive must be obtained from each affected property owner.
- 4. Compliance with the conditions set forth in Section 12-2-31(B)(3)(b) shall be the non-delegable responsibility of the owner of the nightly rental; and each owner of a nightly rental shall be strictly liable for complying with the conditions set forth in this Section or imposed by the Board of Trustees.
- 5. Licensee to Receive Conditions. At the time of the issuance of a license, Town Staff shall provide the licensee with a copy of the special conditions set forth in Section 12-2-31(B)(3)(b) or imposed by the Board of Trustees.
- 6. Licensee to Post License and Conditions. The licensee shall post a copy of the license and the conditions set forth in Section 12-2-31(B)(3)(b) or imposed by the Board of Trustees in a conspicuous location in the nightly rental. The license and the conditions shall remain continuously posted in the nightly rental throughout the term of the license.
- 7. Licensee to Provide Management Company with Conditions. The licensee shall provide any management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental with a copy of the conditions set forth in Section 12-2-31B(3)b or imposed by the Board of Trustees.

(3) Nightly Rental Conditional Use Permit Penalties

- (A) Any person found to be advertising a Nightly Rental without a license to rent that property will be notified by certified mail to cease and desist all advertisements. Upon receipt of that notice, the offending party shall have ten (10) days to remove the offending advertisement. After this grace period has ended, or upon a second or further violation, the offending party shall be determined to be in violation of this Ordinance and shall be ticketed for each offense.
- (B) A violation of any part of Section 12-2-31B(3)b is punishable by a fine of up to \$300 for each occurrence. Each day such violation persists or continues shall constitute a separate and distinct offense.
- (C) The Town may also seek an injunction in addition to all other remedies and penalties provided for by local ordinance or available law.
- (D) All these remedies shall be in addition to all other remedies and penalties provided for by local ordinance or available at law.

18. Section 32 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

Section 12-2-32 - Non-Conforming Uses and Structures

The Regulations set forth in this Section, or set forth elsewhere in this Article, when referred to are the Regulations for Non-Conforming Uses and Buildings.

- b. Expansion or Enlargement - A non-conforming building or use to be extended or enlarged shall conform with the provisions of this Article.
 - 1. A non-conforming structure may be enlarged so long as the non-conformance is not expanded.
 - 2. A non-conforming use may be extended throughout any part of a building which was arranged or designed for such use at the enactment of this Article.

- i. Special Exceptions to Provisions on Expansion of Non-Conforming Uses
 The Planning Commission may authorize, upon appeal in specific cases, an exception permitting an increase in either or both the land use area or the floor area on a building or buildings occupied by a non-conforming use, subject to terms and conditions fixed by the Commission. Every exception authorized hereunder shall be personal to the applicant therefore and shall not be transferable, shall run with the land only after the construction of any authorized building and only for the life of such building. No exception shall be authorized hereunder unless the Commission shall find that all the following conditions exist:

(All other Subsections in this Section will remain the same.)

- 19. Repeal - Existing ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.
- 20. Validity - If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The Town of Grand Lake hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

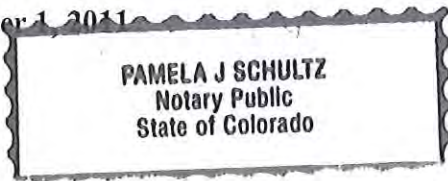

12-2-31A-2c-2(o)

A damage deposit is required and is refundable after determination by Town Staff that no damage to Town Property occurred and no clean-up by Town Staff, billed at an hourly rate as determined by Resolution by the Town Board of Trustees, was necessary at a point of 24 hours after the end of the event.

12-2-31B-2a-(1)A

Included in this narrative should include (but not be limited to: operational hours and functions, management responsibilities, assessed neighborhood compatibility and impact). Written material must be accompanied by supporting documentation, including (if applicable) but not limited to: 1. A site plan depicting the layout of the structure with the proposed use, ingress and egress point, parking and vehicular ingress and egress points, snow storage, trash receptacles, and any other item that may be pertinent to the site plan of the property and proposed use. 2. Landowner or Homeowners Association approval.

12-2-31B-3b

Adequate parking shall be shown on the site plan, as outlined in Section 12-2-28. Parking requirements for nightly rentals shall be calculated from Group II. The motor vehicles of all occupants of the nightly rental shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.

12-2-31B-3b-2G-3

The Single Family Dwelling Unit to be used as a nightly rental shall provide on site snow storage that is equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.

12-2-31B-3b-2G-4

The location of the Single Family Dwelling unit, Accessory Dwelling Unit and all other buildings must be depicted and labeled accordingly. The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.





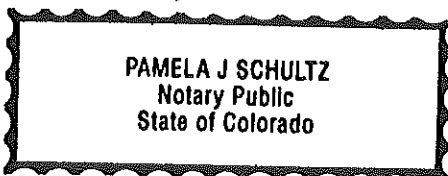

AN ORDINANCE AMENDING THE TOWN OF GRAND LAKE MUNICIPAL CODE CHAPTER 12, ARTICLE 2, SECTION 31, SPECIAL AND CONDITIONAL USE

WHEREAS, the Town of Grand Lake Board of Trustees has the authority to adopt Ordinances; and

WHEREAS, the Town of Grand Lake Board of Trustees desires to have a cohesive and enforceable Municipal Code; and

WHEREAS, the Town Planning Commission held a Public Hearing on the matter on March 16, 2011 and took public testimony on the matter and forwarded a recommendation of approval to the Town Board of Trustees; and

WHEREAS, the Town Board of Trustees held a Public Hearing on the matter on May 9, 2011, and took public testimony on the matter,

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GRAND LAKE, COLORADO THAT:

1. Section 31 of Article 2 of Chapter 12 of the Municipal Code of the Town of Grand Lake, Colorado is hereby amended to read as follows:

- A. ~~Special Use and Special Event Permits~~
 - 1. ~~Special Use and Special Event General Information - The Special Use Permit (SUP) and Special Event Permit review process prescribed herein is intended to assure compatibility and harmony between the proposed special use with both the surrounding properties and the town at large.~~
 - a. ~~The Special Use and Special Event Permit Process shall not be used for the purpose of granting the use of mobile homes for the purpose of temporary living quarters.~~
 - b. ~~The Special Use and Special Event permit process shall not be used for the rental and subsequent use of Town facilities in accordance with Town rental policies.~~
 - c. ~~The Town of Grand Lake shall not review requests of this nature unless the applicant (its constituents or members) are current with the Town and all Town enterprises for all fees, assessments, charges, taxes, or amount due of any type.~~
 - 2. ~~Special Event Permit (SEP): The use of property in the Commercial, Commercial Transitional, or Public Zones or Town right of ways by a non-profit or governmental entity sponsored group for fund-raising efforts or to hold a public event.~~
 - a. ~~The Mayor, or the Mayor's designee, may sign the SEP without referring the matter to the Board of Trustees if the SEP is deemed to be in the best interest of the Town with the following items being taken into consideration:~~
 - (1) ~~The predominant use of the primary facility being used~~
 - (2) ~~The proposed event and the event hours~~
 - (3) ~~Neighborhood compatibility~~
 - (4) ~~Effect of the proposed event on the community~~
 - (5) ~~The Town's anticipated cost in Staff time and equipment use~~
 - (6) ~~Duplication of services or sales items~~
 - (7) ~~Permanent address of the non-profit organization or governmental entity~~
 - (8) ~~First time event~~
 - b. ~~The Mayor, or the Mayor's designee, will refer the matter to the Board of Trustees for approval if the event involves a Special Events Liquor Permit.~~
 - e. ~~Special Event Permit Application and Required Information:~~
 - (1) ~~Applications must be submitted at least thirty (30) days prior to the date(s) of the event~~

- (A) ~~If the event involves a special events liquor permit, the SUP application made at least ninety (90) days prior to the date(s) of the event.~~
- (B) ~~Any significant changes to the application must be made at least thirty (30) days prior to the proposed use unless caused by an emergency, as determined by Town Staff.~~
- (2) The application for this type of SEP shall contain the following information, if applicable:
 - (A) ~~Name and contact information of the sponsoring non-profit or governmental entity.~~
 - (B) ~~Name and contact information of applicant.~~
 - (C) ~~Name and phone number of the contact person for the event.~~
 - (D) ~~Proof of non-profit or governmental entity status.~~
 - (E) ~~Name and address of property owner and the legal description, street address and other identifying data concerning the proposed Special Event site.~~
 - (F) ~~Authorization by the property owner for the proposed use.~~
 - (G) ~~A description of the precise nature of the Special Event.~~
 - (H) ~~A site plan showing its operating characteristics, including, but not limited to: dimensions and locations of specific activities, itinerary for the event and clean-up, trash/dumpster locations, off-street parking, ingress and egress points, traffic circulation, utilities and drainage features, and measures proposed to make the use compatible with other properties in the vicinity.~~
 - (I) ~~List of items or services being requested from the Town, such as sound system, extra trash containers, traffic control devices, street closures, marquee announcement, electricity, and timing of sprinkler systems.~~
 - (J) ~~List of any signage requested including the type, size, and colors, the location of each sign, and the duration the sign will be displayed.~~
 - (K) ~~A copy of the Special Events Liquor Permit application or permit.~~
 - (L) ~~Copy of a current and valid

 - 1. ~~Colorado Sales Tax License,~~
 - 2. ~~Grand Lake Sales Tax License, and/or~~
 - 3. ~~Grand Lake Business License~~~~
 - (M) ~~Any other information deemed by Town Staff to be reasonably necessary to carry out the provisions and the fair administration of this Section.~~
 - (N) ~~An affidavit signed by the applicant stating that the information contained on the application is true and correct to the applicant's knowledge and further stating that knowing submission of false information shall be cause for the SEP to be immediately revoked without notice or hearing.~~
 - (O) ~~A damage deposit is required and is refundable after determination by Town Staff that no damage to Town Property occurred and no clean-up by Town Staff, billed at an hourly rate as determined by Resolution by the Town Board of Trustees, was necessary at a point of 24 hours after the end of the event.

 - 1. ~~The damage deposit shall be One Hundred Dollars (\$100.00).~~~~
 - (P) ~~The applicant shall indemnify the Town of Grand Lake for proposed events involving alcohol, livestock, or events that could cause harm to persons or property, or items of similar nature as determined by the Town.~~

3. General SUP: The use of property, in any zoning district, for a period of six months or less, which use is not listed as a use by right or a conditional use. **A permit for the temporary use (six months or less) of private property.**

- a. **For Residential and Resort-Zoned parcels and neighborhoods, the permit shall be utilized for the approval of proposed uses not listed as a Use-by-Right or a Conditional Use.**
- b. **For Commercial/Mixed Use, the permit shall be utilized for the approval of proposed accessory uses, not incidental to the primary use of the property, or when the**

are two or more businesses present, with at least one business that is proposed located in a non-fixed structure, or a temporary facility; or when the total square footage of the unit/structure does not meet the minimum floor area for the zoning district where it is located.

c. The permit may be utilized for the approval of uses proposed on Public and Open Space-Zoned lands not owned by the Town of Grand Lake.

- d. Application and Required Information for a General SUP:
 - (1) Applications must be submitted at least ninety (90) days prior to the date(s) of the proposed use.
 - (A) Any significant changes to the application must be made at least thirty (30) days prior to the proposed use unless caused by an emergency, as determined by Town Staff.

e. The SUP Application, supporting documentation, and a CD of all supporting documentation in PDF format, shall be submitted to Town Staff in accordance with the above listed schedule. Town staff will have fourteen (14) days to determine whether or not the application is complete. Once determined complete, the request will be placed on the next regularly-scheduled Planning Commission meeting. The application shall be supported by documents, maps, plans and other material containing the following information, if applicable:

- (1) Name and permanent address of applicant.
- (2) Name and address of property owner and the legal description, street address and other identifying data concerning the proposed Special Use site.
- (3) Authorization by the property owner for the proposed use.
- (4) A description of the precise nature of the Special Use and a site plan showing its operating characteristics, including but not limited to: dimensions and locations of specific activities, off-street parking, ingress and egress points, traffic circulation, utilities and drainage features, and measures proposed to make the use compatible with other properties in the vicinity.
- (5) Copy of a current and valid:
 - (A) Colorado Sales Tax License,
 - (B) Grand Lake Sales Tax License,
 - (C) Grand Lake Business License.
- (6) Any other information deemed by Town Staff to be reasonably necessary to carry out the provisions and the fair administration of this Article.
- (7) An affidavit signed by the applicant stating that the information contained on the application is true and correct to the applicant's knowledge and further stating that knowing submission of false information shall be cause for the SUP to be immediately revoked without notice or hearing.

(8) A non-refundable administrative processing fee, set by Resolution, by the Town Board of Trustees.

f. Commission Processing and Review Criteria for a General SUP:

- (1) The Planning Commission shall review the SUP application ~~and determine whether to deny the application or schedule in~~ a Public Hearing to receive testimony and comment of interested citizens, businesses, and adjoining property owners prior to making a recommendation to the Town Board of Trustees.
 - (A) At least fifteen (15) days prior to the scheduled Public Hearing date, ~~the Town Clerk, or her designee,~~ Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP Public Hearing, and Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP Public Hearing.
 - (2) In making this determination of a recommendation of approval or denial of the SUP application, the Commission shall consider the following factors:

- (A) Relationship of the proposed Special Use to the economic development objectives of the Town and the anticipated impact of the SUP on existing businesses.
- (B) Effect upon traffic, with particular reference to congestion, automotive and pedestrian safety and convenience, traffic flow and control, access, maneuverability, and (if applicable) snow removal from the streets and parking areas.
- (C) Effect upon the character of the area in which the proposed Special Use is to be located, including the scale and bulk of the proposed Special Use in relation to surrounding uses and neighborhood.
- (D) Such other factors and criteria as the Commission deems applicable to the proposed Special Use including but not limited to: proposed length of use; specific businesses, land owners or other interested parties to be notified; or proposed conditions of SUP issuance.

(3) At the Public Hearing, after receiving comment and testimony, the Commission shall make a recommendation to the Board of Trustees in the form of a Resolution. Nothing in this Section shall preclude the Commission from tabling or continuing the Public Hearing to another time and place. If the Resolution is to approve the request, it shall contain the following findings:

- (A) That the proposed location of the use is in accord with the purposes of this Chapter and the purposes of the district in which the SUP site is located.
- (B) That the proposed location of the Special Use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety, or welfare, nor will the proposed use be materially injurious to nearby land uses, properties, or improvements.
- (C) That the proposed use will comply with all of the applicable provisions of the Code of Ordinances.
- (D) That the applicant shall comply with such terms and conditions as the Commission determines are necessary to carry out the letter and intent of the Special Use Permit process.
- (E) **That the SUP shall be valid for a specific duration of time, citing specific dates.**

1. **In the case of reoccurring applications, the Planning Commission may make recommendation to the Town Board of Trustees for the Board's approval of an annually-reoccurring Special Use Permit not to exceed three years.**

(4) The applicant may appeal the Commission's decision to deny the SUP request to the Board of Trustees, in accordance with the procedure outlined in part 12-2-31-A(3)(d) below.

~~(5) At least fifteen (15) days prior to the scheduled date, the Town Clerk, or her designee, shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP Public Hearing, and Town Staff shall cause certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP Public Hearing.~~

~~(6) At the Public Hearing, after receiving comment and testimony, the Commission shall make a recommendation to the Board of Trustees in the form of a Resolution. Nothing in this Section shall preclude the Commission from tabling or continuing the Public Hearing to another time and place. If the Resolution is to approve the request, it shall contain the following findings:~~

- ~~(A) That the proposed location of the use is in accord with the purposes of this Chapter and the purposes of the district in which the SUP site is located.~~
- ~~(B) That the proposed location of the Special Use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety, or~~

welfare, nor will the proposed use be materially injurious to nearby land use or improvements.

~~(C) That the proposed use will comply with all of the applicable provisions of the Code of Ordinances.~~

~~(D) That the applicant shall comply with such terms and conditions as the Commission determines are necessary to carry out the letter and intent of the Special Use Permit process.~~

g. Board of Trustees Processing and Review Criteria for a General SUP:

(1) Appeal of Commission Denial:

(A) Applicants appealing the Commission denial of the SUP application shall file with Town Staff a request for hearing. The form of the appeal shall be in the manner as is prescribed by Town Staff. All appeals shall be accompanied by a non-refundable processing fee, set by resolution by the Town Board of Trustees. The matter shall be scheduled for the next regular Board meeting. At that meeting the Board shall determine if the denial is to be sustained or whether a Public Hearing shall be required. The sustaining of the denial is a final decision.

(B) If the Board determines a Public Hearing is appropriate, then at least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP Public Hearing, and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP Public Hearing.

(2) Recommendation of Commission Approval or Conditional Approval:

(A) Upon adoption and transmittal of the Commission's Resolution, Town Staff shall set a date for a Public Hearing on the application before the Board of Trustees. At least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the SUP Public Hearing and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the SUP Public Hearing.

(B) Final action on the Special Use Permit is to be taken by the Board of Trustees at the Public Hearing; except that the Board may continue the Public Hearing to another time before taking final action.

h. Permit Issuance of Approval or Conditional Approval

(1) A Special Use Permit shall not grant variances. Variances shall be granted in accordance with the procedures prescribed in Section 12-2-32.

(2) The SUP shall be valid for a maximum period of six months unless a different time period is authorized by the Board.

(A) **Approved annually-reoccurring permits shall be deemed to be invalid if any provisions of the approval have changed from previous years.**

(3) The SUP applicant shall also be subject to all other procedures, permits and requirements of this and other applicable Ordinances, regulations and agreements of the Town. In the event of any conflict between the provisions of a Special Use Permit and any other permit, requirement, or agreement, the more restrictive provision shall prevail.

(4) Authorization of a change or waiver in any condition previously imposed in the authorization of a special use shall be subject to the same procedures as a new special use.

(5) The SUP applicant shall comply with all such other conditions as are imposed by the Board as a condition of issuance.

(6) Failure to adhere to the General Conditions shall be cause for Town Staff to either suspend or revoke the SUP without notice or hearing.

B. Conditional Use Permits (CUP)

1. **Types of Conditional Use Permits**

a. **General Conditional Use Permits (CUPs) - permitted uses allowed in a district, in addition to the uses by right, where so authorized, are designated by individual zoning districts. Please refer to Sections 12-2-8 through 12-2-25 for individual zone listing.**

b. **Nightly Rental Conditional Use Permits**

2. **General CUP General Information** – Conditional Uses are those uses allowed in a district, in addition to the uses by right, where so authorized, when and if a Conditional Use Permit (CUP) is granted, in accordance with special procedures and requirements. The CUP review process herein is intended to assure compatibility and harmony between the proposed conditional use with both the surrounding properties and the town at large.

a. The Town of Grand Lake shall not review requests of this nature unless the applicant (its constituents or members) are current with the Town and all Town enterprises for all fees, assessments, charges, taxes, or amount due of any type.

3. **Processing and Review Criteria** - Unless identified in Section 12-2-31-B(3)(b), requests for Conditional Use Permits will be processed and reviewed according to the following criteria:

a. Procedure before the Planning Commission

(1) The applicant may propose a Conditional Use Permit request by submitting, to Town Staff, written material outlining the proposed use.

(A) Included in this narrative should include (but not be limited to: operational hours and functions, management responsibilities, assessed neighborhood compatibility and impact). Written material must be accompanied by supporting documentation, including (if applicable) but not limited to:

1. A site plan depicting the layout of the structure with the proposed use, ingress and egress point, parking and vehicular ingress and egress points, snow storage, trash receptacles, and any other item that may be pertinent to the site plan of the property and proposed use.

2. Landowner or Homeowners Association approval.

(B) Application and supporting materials, including a CD of all drawings in PDF format, must be submitted at least twenty-one (21) days prior to the next regular Planning Commission meeting. Within fourteen (14) days, staff will determine if the submitted application, and supplemental materials, are complete and schedule the Conditional Use Permit request for the next Planning Commission. The Planning Commission shall either:

- 1. Formulate a recommendation concerning the Conditional Use including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees, or
- 2. Schedule a Public Hearing for a later date but no sooner than twenty-eight (28) days from receipt of the application. At least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the CUP Public Hearing and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the CUP Public Hearing.

A. After taking evidence in relation to said Condition Use application, the Planning Commission shall formulate a recommendation, including such terms and conditions as it may deem necessary and appropriate. The recommendation shall be placed on the next agenda of the Board of Trustees.

1. The Planning Commission shall take the following factors into consideration prior to making recommendation to the Town Board of Trustees:

- a. Relationship of the proposed Conditional Use to the development objectives of the Town and the anticipated impact of the Conditional Use on existing businesses and neighborhood residences.
- b. Effect upon the character of the area in which the proposed Conditional Use is to be located, including the scale and bulk of the proposed Conditional Use in relation to surrounding uses and neighborhood.
- c. Such other factors and criteria as the Commission deems applicable to the proposed Conditional Use including but not limited to: hours of operation; signage; specific businesses, land owners or other interested parties to be notified; or proposed conditions of CUP issuance.

- b. Procedure before the Board of Trustees
 - (1) The Board of Trustees shall vote to approve, modify or disapprove the recommendation of the Planning Commission by Resolution. The Board of Trustees may also request a Public Hearing. Should the Board of Trustees choose so, ~~the process identified in Section 12-2-31-A(3)(d) shall be followed prior to voting to~~ at least fifteen (15) days prior to the scheduled date, Town Staff shall cause a legal notice to run in a local newspaper of general circulation advertising the time, date, and location of the CUP Public Hearing and certified letters to be mailed to all property owners within two hundred (200') feet of any portion of the property proposed for the SUP indicating the time, date, and location of the CUP Public Hearing.
 - (2) In the Public Hearing, the Town Board of Trustees may move to approve, modify or disapprove the recommendation of the Planning Commission by Resolution.

- c. Submittal of New Materials
 - (1) The applicant may not alter an application or submit additional materials to the Town Board of Trustees for review. Submittal of new materials shall constitute a new application, shall require deposits, and shall be reviewed by the Planning Commission prior to going before the Town Board of Trustees.

4. ~~Types of Conditional Use Permits~~

- a. ~~Conditional Use Permits (CUPs) permitted uses allowed in a district, in addition to the uses by right, where so authorized, are designated by individual zoning districts. Please refer to Sections 12-2-8 through 12-2-25 for individual zone listing.~~

- b. Nightly Rental Conditional Use Permits Nightly Rental Conditional Use Permits depend on the zoning district which the proposed rental is located. In addition to other Town requirements, no person shall rent or advertise to rent a Single Family structure, dwelling, dwelling unit, or lock-off unit for nightly rental purposes, except in accordance with the provisions of this Article. Nightly Rental CUP applications and renewals will be exempt from the Conditional Use Permitting deposit but may be assessed other fees, as defined within the provisions of this Article.

- (1) Nightly Rental Conditional Use Permits by Zone
 - (A) The following shall apply only to the following districts: OPEN, RESIDENTIAL ESTATE, SINGLE FAMILY RESIDENTIAL HIGH DENSITY, SINGLE FAMILY RESIDENTIAL MEDIUM DENSITY, SINGLE FAMILY RESIDENTIAL LOW DENSITY, MULTIPLE FAMILY RESIDENTIAL MEDIUM DENSITY, and MULTIPLE FAMILY RESIDENTIAL HIGH DENSITY.

- 1. Town Action:
 - a. If Town Staff determines that the application satisfies the requirements of Section 12-2-31-B(3)b(2), all adjoining property owners or all owners within 100', whichever includes the largest number of properties, will be notified in writing by the Town of the applicants proposed use. All notified property owners will be given fifteen (15) days to object to the proposed use in writing.

b. If one (1) or more notified property owners object to the pro writing, the application shall be treated as a conditional use as outlined in Section 12-2-31-B(1) and (2). The owner of the subject property shall be given a copy of all written complaints. In consideration of the proposed use, the Planning Commission may hold a Public Meeting to determine its recommendation to the Board of Trustees. The Board of Trustees may hold a Public Hearing on the proposed use to decide whether to approve, modify, or disapprove the Planning Commission's recommendation.

c. If zero notified property owners object to the proposed use, Town Staff shall issue the Nightly Rental License administratively.

d. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the ~~Nightly Rental License Fee shall only be \$165~~ **the owner has the option of purchasing a business license in lieu of the Nightly Rental License.**

e. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

2. Renewal

a. If zero complaints have been filed in the previous 12 months, and the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License. For purposes of Section 12-2-31-B(3)b(2), a complaint must be either an official police citation or a letter signed by the complaining party.

b. If one (1) or more complaints have been filed in the previous 12 months, the applicant must pay an **the appropriate** application fee, **as set by Resolution by the Town Board of Trustee** of \$150 and a Nightly Rental License fee of \$400. The Town shall provide notice to all adjoining property owners or all owners within 100', whichever includes the largest number of properties, and the application shall be treated as a conditional use as outlined Section 12-2-31-B(3)b(2).

(B) The following shall apply only to the following districts: COMMERCIAL TRANSITIONAL, COMMERCIAL, and RESORT DISTRICTS.

1. Town Action:

a. If Town Staff determines that the application satisfies the requirements of Section 12-2-31-B(3)b(2), the Nightly Rental License will be issued.

b. Once approved, the Town shall notify the county in writing that the subject property's use now includes nightly rentals. Should the county elect to assess the property at a commercial rate, the ~~Nightly Rental License Fee shall only be \$165~~ **the owner has the option of purchasing a business license in lieu of the Nightly Rental License.**

c. Once approved, the Town will send notice to all adjoining property owners or all owners within 100', whichever threshold is greater, with the name and 24 hour contact number(s) of the person in charge of the management of the subject property.

2. Renewal

a. If the applicant is current on all taxes, fees and other charges owed the Town, the applicant must only repurchase their Nightly Rental License.

(C) The following shall apply only to the following districts: PD and PUD.

1. Planned Developments/Planned Unit Developments—Are considered same; PD's that have no underlying zoning or are zoned PD or PUD shall be governed under Section 12-2-31-B(3)b(1)(b).

(2) Nightly Rental Conditional Use Permit Regulations - Nightly rentals of such units shall only be authorized if all of the following conditions are met:

(A) Applicant must provide two copies of a site plan that displays conformance with the following criteria, ~~an~~ **the appropriate** application fee of \$150 for all units listed in ~~1A 12-2-31-B(3)b(1)(a), above,~~ and a **the appropriate** Nightly Rental License fee of \$400. No person shall rent or advertise for rent their structure, dwelling or dwelling unit unless a Nightly Rental License has been granted by Town Staff. A nightly Rental License must be obtained for each structure, dwelling, or dwelling unit. If an application is subsequently denied, the applicant shall be refunded \$400 **the Nightly Rental License fee.**

(B) All fees, dues, debts to the Town of Grand Lake, and taxes must be current before a license will be issued.

(C) ~~Application can be made for a Nightly Rental License as early as June 1st for the subsequent year and the first Nightly Rental License for any applicant may be valid for a period of up to 19 months (June 1st of current year through December 31st of following year).~~ **The fee for a Nightly Rental License is set by Resolution.** In instances when a license is issued for a period of time other than 12 months, the fee shall be prorated for the number of months in which it is being issued. Other than the first issued license **to an owner of a unit for that unit,** all Nightly Rentals shall be issued for 12 months, from January 1st to December 31st. **The Nightly Rental License for a unit is transferable to a new owner of that unit upon completion of a complete and approved application.**

(D) No person shall be granted a Nightly Rental License unless a state sales tax number has been received to provide for the collection of state, local sales and lodging taxes. If the structure, dwelling, or dwelling unit is operated by a third party as defined in Section 12-2-31-B(2)(e), the third party may use a pre-existing sales tax number for purposes of this paragraph.

(E) At the time an application for a license is submitted, the licensee shall provide to Town Staff the name, address and telephone number of any current management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. It shall be the duty of the licensee to update such information throughout the term of the license so that Town Staff always has the correct and current information.

(F) At the time of the application of the license the licensee shall provide to Town Staff the name, address and telephone number of a local contact person who is authorized by the licensee to receive communications from the Town concerning the nightly rental. The local contact person may be a management company, rental agent or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental. The local contact person shall maintain a residence or permanent place of business within 15 minutes driving distance to the Town and must be available 24 hours per day, seven days per week, during periods in which the structure is being rented. The designated local contact person may be changed by the licensee from time to time throughout the term of the license. To effect such change, the licensee shall notify Town Staff of the change in writing in advance of the change and shall, at the same time, provide Town Staff with the name, address, and telephone number of the licensee's replacement contact person. Any replacement contact person shall meet the requirements of this subparagraph.

(G) Site Plan Criteria:

1. Adequate parking shall be shown on the site plan, as outlined in Section 7, Item B. Parking requirements for nightly rentals shall be calculated from Group II. The motor vehicles of all occupants of the nightly rentals shall be parked only on the site of the nightly rental, or in a Town-designated parking area located off of the site of the nightly rental. No motor vehicles shall be parked on the lawn or landscaped areas of a nightly rental, or in the public street or right of way adjacent to the nightly rental. No person shall be permitted to stay overnight in any motor vehicle which is parked at a nightly rental.

2. There is a clearly-defined trash storage area and an adequate number of trash containers provided and the trash company hired for regular pick-up must be identified. **The owner or property manager may use the Pay As You Throw (PAYT) trash program in lieu of hiring a trash company for regular pick-up.**

3. The Single Family Dwelling Unit to be used as a nightly rental shall provide on-site snow storage that is equivalent to one-third (1/3) of the designated parking area and shall be in addition to and not part of the required parking area.

4. The location of the Single Family Dwelling unit, Accessory Dwelling Unit, and all other buildings must be depicted and labeled accordingly. The scale, building materials and colors of the building shall be consistent with the neighborhood and shall not be used to draw attention to the structure.

5. The applicant shall obtain HOA sign-off if the property resides within an HOA.

(H) Additional Criteria:

1. While occupying or visiting a nightly rental, no person shall make, cause or permit unreasonable noise to be emitted from the nightly rental that is ~~audible upon private premises in excess of the limits set forth in Sections 25-12-101 through 25-12-109, Colorado Revised Statutes~~ **violation of Grand Lake Municipal Code 7-1-15 Disturbing the Peace or 7-1-16 Unnecessary Noise.**

2. At no time shall a nightly rental qualify for a sign permit. ~~Signs for advertising shall not be permitted at nightly rentals except as outlined in Section 6-2-1(e) and (d), Town of Grand Lake Sign Code.~~

3. If more than one property is accessed by a shared driveway, written permission to access the drive must be obtained from each affected property owner.

4. Compliance with the conditions set forth in Section 12-2-31-B(3)(b) shall be the non-delegable responsibility of the owner of the nightly rental; and each owner of a nightly rental shall be strictly liable for complying with the conditions set forth in this Section or imposed by the Board of Trustees.

5. Licensee to Receive Conditions. At the time of the issuance of a license, Town Staff shall provide the licensee with a copy of the special conditions set forth in Section 12-2-31-B(3)(b) or imposed by the Board of Trustees.

6. Licensee to Post License and Conditions. The licensee shall post a copy of the license and the conditions set forth in Section 12-2-31-B(3)(b) or imposed by the Board of Trustees in a conspicuous location in the nightly rental. The license and the conditions shall remain continuously posted in the nightly rental throughout the term of the license.

7. Licensee to Provide Management Company with Conditions. The licensee shall provide any management company, rental agency or other person employed or engaged by the licensee to manage, rent or supervise the nightly rental with a copy of the conditions set forth in Section 12-2-31-B(3)(b) or imposed by the Board of Trustees.

(3) Nightly Rental Conditional Use Permit Penalties

(A) Any person found to be advertising a Nightly Rental without a license to rent that property will be notified by certified mail to cease and desist all advertisements. Upon receipt of that notice, the offending party shall have ten (10) days to remove the

offending advertisement. After this grace period has ended, or upon a second violation, the offending party shall be determined to be in violation of this Ordinance and shall be ticketed for each offense.

(B) A violation of any part of Section 12-2-31-B(3)(b) is punishable by a fine of up to **not to exceed Three Hundred Dollars (\$300.00)** for each occurrence. Each day such violation persists or continues shall constitute a separate and distinct offense.

(C) The Town may also seek an injunction in addition to all other remedies and penalties provided for by local ordinance or available law.

(D) All these remedies shall be in addition to all other remedies and penalties provided for by local ordinance or available at law.

(All other Subsections in this Section will remain the same.)

- 2. Repeal - Existing ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.
- 3. Validity - If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The Town of Grand Lake hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.



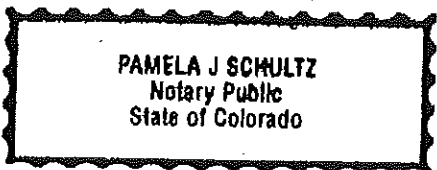
