The first item discussed was regarding a **dog park near City Hall.** Steve Lorenz presented his Dog Park Overview document dated September 6, 2022. The presentation provided information regarding:

- Location and size
- Purpose

- Security Options
- Fiscal Impact Plans
- Fundraising Opportunities

Lisa Fuller of the Grosse Pointe Woods Foundation stated that, through Covid-19 and changes in City Administration, the foundation has remained dormant and is now ready for a wish list of projects from Council. Mrs. Fuller also stated there has been discussion within the Foundation, that there is an interest of a new dog park. In fact, one of the Board Members of the Foundation is Chair of the Citizens' Recreation Commission and an interest of a dog park has been mentioned. She added that, if the city would approach the Foundation for assistance in funding, most likely they would accept.

There is a concern for the size of the proposed dog park being too small. Discussion ensued regarding the possibility of expanding the proposed size. A discussion with the Director of Public Safety is necessary to discuss the department's training programs located near the proposed area and if the proposed dog park would be feasible.

Other topics of discussion ensued regarding landscaping (planting of trees and shrubs), the installation of a water line, and other important items such as benches and trash cans.

The possibility of budget neutrality for the city was discussed and needs to be revisited when more information is gathered and reviewed.

The Council stated this project is at a very preliminary phase and requires more information to effectively move forward.

Prior to COVID-19, the Citizens' Recreation Commission performed a thorough evaluation of the city parks and created a list of priorities needed. Collaborating with the Citizens' Recreation Commission and getting their input will benefit in the progression of this project.

There was a consensus of the Committee-of-the-Whole to refer this item to the Citizens' Recreation commission.

The Mayor recessed the Committee-of-the-Whole at 8:39 p.m. and reconvened at 8:44 p.m.

The next item discussed was regarding **Mack Avenue Holiday Decorations (Snowflakes).** The Director of Public Services, in his memo dated September 8, 2022, stated that he and The Avenue in the Woods had a discussion regarding updating decorations for the 2022 holiday season. After further research, it was discovered that St. Clair Shores and other nearby communities have been installing light up snowflake decorations on their streetlights. Photos of sample snowflakes were provided in the supporting documents.

The intent is to initially, purchase six snowflakes and see how it goes. Four snowflakes are to be placed on the poles at Mack Avenue and Vernier Road, and two in front of the Robert E. Novitke Municipal Center by the porches. Administration believes that the snowflakes will enhance the decorations and prolong the holiday and winter season.

A brief discussion ensued and there was a consensus of the Committee-of-the-Whole to place this on the next Council agenda for approval.

The next item discussed was regarding **Ahee Jewelry's 75<sup>th</sup> Anniversary Donation** – **Parking Meter**. The Assistant City Administrator provided an overview and stated that Ahee Jewelry is celebrating their 75<sup>th</sup> Anniversary and wanted give back to the city, customers, and residents. They are offering to cover all the parking meters with bags from November 1 through December 31, 2022 and incur the cost in the amount of \$27,400.00, which they will donate to the city.

There are some exceptions, which the parking meters are to remain uncovered at the request of some business owners.

There was a suggestion to invite Ahee Jewelry to the Tree Lighting ceremony to acknowledge their generous donation.

On the topic of 75<sup>th</sup> anniversaries, it was also suggested to prepare for the City's upcoming 75<sup>th</sup> anniversary in 2025.

There was a consensus of the Committee-of-the-Whole to place this item on the next Council agenda for approval.

The next item discussed was regarding the **3-year Assessing Contract with Wayne County Appraisal (WCA)**. The City Administrator provided an overview and stated that the contract language remains the same as the expiring contract, with the exception of a 5% increase each year of the contract.

The contract increase amounts by year are as follows:

- 2022-2023 approximately \$82,000.00
- 2023-2024 approximately \$86,000.00
- 2024-2025 approximately \$90,000.00

WCA provides assessing service to all of the Grosse Pointes and has been servicing Grosse Pointe Woods since 2016. They provided exceptional service to the city and works well with administration.

The administration did receive a proposal from an individual assessor, Tom Agrusa, currently with the City of Utica. Although Mr. Agrusa is a qualified assessor and proposed a lower quote than WCA, administration feels, as an individual, there may be serious issues if he has no backup.

There was a consensus of the Committee-of-the-Whole to concur with the City Administrator's recommendation to renew Wayne County Assessing's contract and place this item on the next Council Agenda for approval.

Hearing no objections, the following were heard under New Business:

- Councilmember Granger addressed recent power outages and the lack of power being generated. The City administrator will contact the DTE representative.







Company has policies and procedures for staff in determining true cash value of assessable real and personal property including locating, identifying and inventorying quantity and characteristics of the property for determining the appropriate value and classification. During the term of this agreement, an Advanced Michigan Assessing Officer, or Master Michigan Certified Assessing Officer shall act as the assessor of record and supervise the preparation of the 2023, 2024, and 2025 assessment rolls, utilizing the services and personnel proposed herein.
- 3. Company agrees to respond to inquiries and requests for assessment information from the public. The City agrees to provide office space within the City Hall, or other City owned buildings for the completion of the terms of this contract. The office space shall be made available so as to not impede the performance of the department.. The purpose of office hours are:
  - To meet with City staff to answer questions and give advice;
  - To be available to assist with providing information and answering inquiries of taxpayers/residents/others.

- Serves as a liaison between the City and prospective business and industry investors; acts as a resource for City citizens by responding to inquiries and interpreting State laws.
- To perform certain other functions as described herein.
- 4. Company agrees to oversee maintenance of departmental files including property records/cards, physical data, legal descriptions, splits and combinations of parcels, ownership transfers, and strives to identify new/improved methods for carrying out the responsibilities of the department.
- 5. Company agrees to represent the City in defending assessments appealed to the Michigan Tax Tribunal (MTT) if requested to do so by the City Administrator. The company shall be available to defend all assessments to the MTT as needed during this contract.
- 6. If Company is retained by the City, the City agrees that responses to the Full MTT shall be prepared by the Company's legal staff. City agrees to provide full cooperation with Company's legal staff. Should expert witnesses and/or preparation of respondent's valuations disclosures be necessary, the Company shall notify the City Administrator of such requirement.
- 7. Company agrees throughout the term of this contract to provide field inspections of all properties as necessary; to perform assessment ratio studies to determine true cash value; to perform personal property canvasses to ensure all personal property is equitably assessed; to update property records and ensure notification of annual assessment changes. All assessments completed by Company throughout the term of this contract will be in adherence to State Tax Commission procedures as to the valuation method, assessment manual, personal property multipliers, and general requirements. Company agrees to perform the duties of the certifying assessor for said City including but not limited to;
  - Inspect, revise, and re-evaluate property record cards with new construction, demolition, and property splits.
  - Perform neighborhood market studies and land value analyses throughout the term of this contract.
  - Prepare assessment roll(s), all county and state equalization forms and requirements as determined by the State tax Commission.
  - Provide digital photographs of all properties visited for maintenance purposes.
  - Working with the Building Department to ensure all new property is equitably assessed.

- Prepare all new property record cards in compliance with State tax Commission requirements.
- Attend, prepare, and work with all Boards of Review.
- Assist City in establishment of any IFT, CFT, DDA, TIFA, Brownfield, or other statutory tax incentive program as established by the legislature.
- 8. Company agrees to meet with the City Administrator and/or other designated staff of the City to review progress that the Company has made towards meeting the terms of this proposal/agreement, preparation of assessment rolls, and other matters parties deem necessary to review. In addition the Company will suggest any budgetary information necessary to upgrade and/or improve the City's assessment process.
- City agrees that in addition to the responsibilities provided herein, the staff of the City shall provide full and reasonable cooperation to the Company in completion of the herein-stated services.
- 10. The Company shall be liable to the City, and hereby agrees to indemnify and hold the City (and it's elected and appointed officials) harmless but only to the extent of its insurance coverage set forth below, against all claims covered by said insurance coverage arising out of the performance of the services rendered hereunder caused by any negligent conduct, intentional conduct, or act of the Company or any of its employees in the performance of this contract that are covered by the policies listed in subparagraphs "a" through "c" below.

The Company will carry the following insurance coverage at all times during this agreement:

a. Comprehensive general liability insurance covering the Company and the City in the project with not less than the following limits of liability; bodily injury or death, \$1,000,000 each person and subject to the same limit for each person; \$1,000,000 for two or more persons in any occurrence; property damage, \$1,000,000 each occurrence; \$2,000,000 annual aggregate.

b. Worker's Disability Compensation Insurance, securing compensation for the benefit of the employees of the Company, as required by Worker's Disability Compensation Act of State of Michigan. c. The Company shall also carry professional liability and errors and omissions insurance with not less than \$2,000,000 limit of liability for each claim and in the aggregate including claim expenses. However, the City understands that it cannot be listed an additional insured under this type of policy. Should the City or its officers, directors, employees, and elected or appointed officials ever be held financially liable for any error or omission of the Company and seek indemnification from Company as a result thereof, under no circumstance shall the Company's cumulative liability to the City or its officers, directors, employees and elected or appointed official exceed the coverage of the errors and omissions policy referenced herein.

All required insurance shall be maintained with responsible insurance carriers qualified to do business in the State of Michigan. As soon as practicable upon execution of this contract and upon commencing any performance hereunder, the Company shall deposit with the City the previously mentioned policies of insurance or certificates therefore. During the duration of this contract, a copy of said insurance or certificate shall be given to the City Clerk at the beginning of each year.

- 11. The Company shall not be held liable for any damages caused by strikes, explosions, war, fire or act of nature that might stop or delay the progress of work. In the event of a claim against the City relating to any act or failure to act of the Company that is not covered by the insurance coverage as set forth above, the City has no right to indemnification from Company.
- 12. The City and Company agree that the relationship of the City and Company is that of a client and contractor and not of that of and employer and employee and should not be construed as such.
- 13. In the event that the Company shall not be in substantial compliance with the terms of this agreement, the City shall give the Company written notice of said breach and thirty (30) days to cure the breach. If the Company fails to cure the breach within thirty (30) days after such notice, the City may terminate this Contract immediately without further notice or liability to the Company, other than for permitted fees and expenses accrued through the date of termination.
- 14. The City and Company agree that the Company shall not assign or transfer neither this agreement nor any portion therein without first receiving written approval from the other party.

15. The City agrees to pay the Company as follows;

October 1, 2022 to September 30, 2023.....\$ 82,007 annually October 1, 2023 to September 30, 2024.....\$ 86,107 annually October 1, 2024 to September 30, 2025.....\$ 90,413 annually

Any additional time which may be requested by the City for the basic services outlined by this Agreement shall be billed in an amount equal to the annually rate computed on a pro rata daily basis.

The payments shall be made in twelve (12) equal installments due on the fifteenth  $(15^{th})$  day of each month.

- 19. Michigan Tax Tribunal appraisal services and requested special projects are separate from normal assessment and appraisal functions.

### COMMITTEE-OF-THE-WHOLE MINUTES EXCERPT 09-12-22

The next item discussed was regarding the **3-year Assessing Contract with Wayne County Appraisal (WCA)**. The City Administrator provided an overview and stated that the contract language remains the same as the expiring contract, with the exception of a 5% increase each year of the contract.

The contract increase amounts by year are as follows:

- 2022-2023 approximately \$82,000.00
- 2023-2024 approximately \$86,000.00
- 2024-2025 approximately \$90,000.00

WCA provides assessing service to all of the Grosse Pointes and has been servicing Grosse Pointe Woods since 2016. They provided exceptional service to the city and works well with administration.

The administration did receive a proposal from an individual assessor, Tom Agrusa, currently with the City of Utica. Although Mr. Agrusa is a qualified assessor and proposed a lower quote than WCA, administration feels, as an individual, there may be serious issues if he has no backup.

There was a consensus of the Committee-of-the-Whole to concur with the City Administrator's recommendation to renew Wayne County Assessing's contract and place this item on the next Council Agenda for approval.

I am requesting that the City approve a purchase of one (1) new vehicle as a replacement for a well-used high-mileage vehicle within the department. Our current patrol fleet consists of eight marked vehicles. The department is requesting to purchase one 2023 Ford Police Interceptor Utility AWD vehicle. The same model was purchased in previous years by the department and has worked out well. Ford police vehicles are specifically designed to handle pursuit driving. The vehicle will be purchased through Signature Ford in Owosso at a municipal price with the Macomb County Contract #21-18 bid price. Signature Ford has provided excellent service, quality, and price compared to other quoted vendors from previous purchases.

The included warranty for the new vehicle is 36,000 miles or 36 months factory bumper to bumper and 100,000 miles or 60 months for the powertrain.

In addition to the purchase of vehicle, a vendor has been secured for the vehicle equipment and build-out. The costs include all required equipment and installation. Canfield Equipment in Warren continues to be the chosen vendor for this work due to its workmanship, location, and price.

The graphics for the vehicles will be done by Majik Graphics in Clinton Township, a vendor which provides a lifetime guarantee on their work and has provided excellent service to us in the past.

The new vehicle will be replacing Vehicle 5-5, a 2015 Ford Police Interceptor which no longer runs due to a cracked engine block. This vehicle will be scrapped.

Due to the ongoing pandemic and chip shortage, we estimate a long delivery time for the new vehicle and have been advised by the vendors to order as soon as possible to lock in the prices which continue to rise due to increased costs for labor and materials.

The purchase of the new vehicle is a budgeted item in the 2022/2023 fiscal year in the Vehicle Maintenance – Public Safety fund (640-852-977.349) in the amount of \$50,000.00. The cost of the new vehicle has gone up significantly since our purchase of the same model last year so the amount we are requesting is \$6,900.45 over the budgeted amount.

I am requesting a budget amendment from the General Funds balance account, 101-000-699.000, Transfer from Prior Year Reserves, into the Vehicle Maintenance – Public Safety Vehicle Fund, 640-852-977.349, to cover the difference of \$6,900.45.

Recommend Approval of the above stated purchase in the amount of \$56,900.45 as submitted. I do not believe any further benefit will accrue to the city to seek further competitive bids.

## COMMITTEE-OF-THE-WHOLE MINUTES EXCERPT 09-12-22

The next item discussed was regarding **Mack Avenue Holiday Decorations (Snowflakes).** The Director of Public Services, in his memo dated September 8, 2022, stated that he and The Avenue in the Woods had a discussion regarding updating decorations for the 2022 holiday season. After further research, it was discovered that St. Clair Shores and other nearby communities have been installing light up snowflake decorations on their streetlights. Photos of sample snowflakes were provided in the supporting documents.

The intent is to initially, purchase six snowflakes and see how it goes. Four snowflakes are to be placed on the poles at Mack Avenue and Vernier Road, and two in front of the Robert E. Novitke Municipal Center by the porches. Administration believes that the snowflakes will enhance the decorations and prolong the holiday and winter season.

A brief discussion ensued and there was a consensus of the Committee-of-the-Whole to place this on the next Council agenda for approval.

## COMMITTEE-OF-THE-WHOLE MINUTES EXCERPT 09-12-22

The next item discussed was regarding **Ahee Jewelry's 75<sup>th</sup> Anniversary Donation** – **Parking Meter**. The Assistant City Administrator provided an overview and stated that Ahee Jewelry is celebrating their 75<sup>th</sup> Anniversary and wanted give back to the city, customers, and residents. They are offering to cover all the parking meters with bags from November 1 through December 31, 2022 and incur the cost in the amount of \$27,400.00, which they will donate to the city.

On the topic of 75<sup>th</sup> anniversaries, it was also suggested to prepare for the City's upcoming 75<sup>th</sup> anniversary in 2025.





As we have discussed, recently the City Council had awarded two contracts which were bid through our office. The projects include the 2022 Sidewalk Replacement Program and the 2022 Joint Sealing Program. The contracts include insurance requirements in order to protect the City, AEW, the Contractor and other agencies if affected. Typically, insurance types and levels are based on requirements as provided by the City's attorney several years ago. However, AEW had erroneously included professional liability insurance in the contracts for the aforementioned projects.

In very rare instances, projects may require the contractor to employ a design professional (professional engineer, registered architect, etc.), typically for design-build projects. In such case, professional liability insurance would make sense. These projects require no design elements by the Contractor. Therefore, we are suggesting the City waive the professional liability insurance requirement for the 2022 Sidewalk Replacement Program and the 2022 Joint Sealing Program.

AEW has taken the necessary steps to ensure this does not occur on future projects. We apologize for this inconvenience.
