MINUTES OF THE ELECTION COMMISSION MEETING OF THE CITY OF GROSSE POINTE WOODS HELD ON MONDAY, SEPTEMBER 8, 2025, IN THE CONFERENCE ROOM OF THE MUNICIPAL BUILDING, 20025 MACK PLAZA DR., GROSSE POINTE WOODS, MICHIGAN.

The Chair called the meeting to order at 7:52 P.M.

The Chair provided an overview regarding the printed proof ballots and the Ballot Proof Approval Form. The City Clerk presented the ballot proofs to the Commission for review. Discussion ensued regarding listing the candidates' last names alphabetically on the ballot throughout all precincts. This is due to the number of Full-Term candidate seats being the same as the number of candidates, three (3) for City Council and one (1) for Mayor. Per MCL 168.569a (Promulgated Rule R168.774(9)) and the Michigan Ballot Production Standards, if the number of candidates appearing on the ballot is equal to or less than the number of candidates to be elected to the office, the candidates' names are listed alphabetically. The Commission continued review and proofreading all three (3) precinct ballot proofs in accordance with Ballot Proof Approval standards.

### **Certification of Board of Election Inspectors**

The undersigned, members of the Election Commission of the City of Grosse Pointe Woods, for the *November 4, 2025, Local General Election*, do hereby certify the following:

- 1. The number of members of the Board of Election Inspectors shall be seven (7) in each precinct, seven (7) each in two (2) absent voter counting boards; one (1) of whom shall be designated as Chair, and one (1) of whom shall be designated as Co-Chair. One additional Inspector may be appointed to some precincts as needed.
- 2. The base rate of compensation for all regular precincts and absent voter counting board(s) shall be as follows:

\$183.50	Chair
168.00	Co-Chair
141.75	Inspector
90.00	Intern

- 3. If necessary, the City Clerk is authorized to appoint Election Inspectors to vacancies on the Board of Inspectors due to refusal or failure to serve. There shall be at all times during the times the polls are open a majority of Board of Election Inspectors on duty and there shall be at least one from each major political party: Republican and Democrat.
- 4. The number of members of the three Receiving Boards shall be six (6) total. The flat rate compensation for all receiving board members shall be \$52.50.
- 5. The members of the Board of Election Inspectors and Receiving Board for the above election are listed on the attached summary.
