## Gustavus Vol. Fire Department Quarter 2 Highlights

Not much information has been available for these three months. April had 4 EMS calls; June had 10.

No one was able to find any information on the month of May. There were no fire calls in second quarter.

Jeff Jarvis is currently acting interim fire chief. EMS responders are handling 911 call with Lisa's help when needed which is often. There is currently a need for more dispatchers. Volunteers are trying to get caught up on a backlog of incident reporting.

The city is currently advertising for the fire chief position as well as an interim fire chief. Both positions will have an emphasis on EMS.

Lisa has scheduled Sept. 18-19 for visiting instructors to bring EMS responders current on their certifications.

# Marine Facilities Coordinator (MFC) Quarterly Staff Report Ben Sadler, Marine Facilities Coordinator / Harbormaster Monday, July 19<sup>th</sup>, 2021

My last quarterly report was at the December 14<sup>th</sup> General Meeting, and my next report will be at the September 13<sup>th</sup> General Meeting.

#### **General Day to Day**

As in all my quarterly reports, I will be separating the Harbormaster position from the MFC portion for clarity on specific tasks performed.

#### **Harbormaster**

In my role as harbormaster, I have spent my time monitoring activities at the Dock and Beach. This includes taking back the responsibility of maintaining the restrooms at the Beach and Salmon River Park and opening the trash and recycle containers on April 20th. I worked together with the Dray (Justin Marchbanks and Joe Vanderzanden helped as well) to move the steel float back into place at the Gustavus multi-modal dock facility on April 23<sup>rd</sup>. Joe Vanderzanden and I were able to get the ramp lowered the following Monday (April 26<sup>th</sup>). Fairweather Construction and I were able to get the skiff floats and the wooden float out on May 22<sup>nd</sup> and 23<sup>rd</sup>. All of this went well. There was a problem with the steel float mooring lines being tangled but this is being worked on and will hopefully be resolved in the near future. I have also started removing small debris from the Boat Harbor as part of the Salmon River Boat Harbor Clean-up Project as well as keeping an eye on the toe of the Salmon River boat launch. This area was repaired on January 7<sup>th</sup> of this year and has already started to get washed out. Different ideas of what is causing this have been offered but it is my opinion that landing crafts using the boat launch are not helping the situation. I have also been walking the Salmon River at low tide and removing the log jams that were pushed down in the heavy rainstorms we experienced last year and this winter. On June 30<sup>th,</sup> a charter vessel sank overnight off the east side of the dock. I worked with the owner and USCG to make sure that everything was taken care of and reported properly. At the time of this writing the vessel has not been located.

#### **Marine Facilities Coordinator**

In my role as MFC I was able to maintain communication with the City and the Marine Facilities Advisory Committee (MFAC) over the winter as well as responding to calls and emails from community members and outside inquiries. On May 13<sup>th</sup> I was able to attend a CPR/First aid course put on by GBNP and I am scheduled to attend the Emergency Trauma Tech (ETT) and Basic Life Support (BLS) training put on by MultiMED at the beginning of August. These will hopefully be the first steps in continued education both in First Aid and boater safety. The more I know the more I will have to offer the Community. I have been working to help the City inventory and find new homes for the items located in the old PO building currently being used for storage. I am currently working with Tom and Joe Vanderzanden to rewrite Title 8 to bring it more in line with Gustavus's unique situation. I was also able to put the Gustavus Beach sign back up, reinforce the other signs in the area, and set up doggy potty stations on both sides of the dock. The week ending June 13<sup>th</sup> Western Marine came out and did repairs to the Dock and replaced the ramp between the steel float and the wooden float. So far we have had 85 private vessels and 27 commercial vessels register this year. I have removed 403#'s of trash and 79#'s of recyclables from the Beach receptacles. At the request of the Mayor and City Administrator I have been working on getting a shed for the Marine facilities tools and other items currently being stored in the old PO.

I have also been able to do maintenance work for other departments with direction from the Mayor and City Administrator.

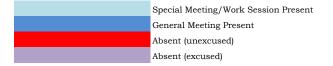

#### SALMON RIVER PARK CLEANUP & MAINTENANCE

Thanks to Mayor Cannamore and Council members Vanderzanden and McLaughlin for the cleanup work for the Park. Also, thanks to the Church of Jesus Christ of Latter-day Saints for getting the Park ready for the Independence Day celebration.

#### **BEACH IMPROVEMENTS**

Thanks to Ben for installing the Doggy Potti stations at the beach and CLEARLY identifying which garbage can to make the deposit. **NICE JOB BEN!** Unfortunately, there have been those who have been putting their household trash in the trash containers, so we are locking them until we install the camera's. We also had someone empty their honey bucket in the restroom – disgusting!



#### **RAC**

The Lynn Canal Icy Strait Resource Advisory Committee Designated Federal Official is calling for project proposals. Funding is available and project proposals are being accepted under the Secure Rural Schools and Community Self Determination Act. Project funds may be used for protection, restoration, and enhancement of fish and wildlife habitat, and other resource objectives consistent

with the purposes of this Act on Federal land and on non-Federal land where projects would be the resources on Federal land – the application deadline is August 6, 2021.

A good project to apply for funding for is the Grandpas Farm Harry Hall Creek culvert replacement. It would be another timber bridge, but about 80' long. The culvert there is getting more perched every year. Fish passage improvements are among the qualifying project types. The proposal would emphasize that Harry Hall Creek and Mountain View stream are significantly important coho-rearing streams benefitting resources on the Tongass. There is an existing completed project scoping document and there is a completed design estimated at \$250,000 and it would be prudent to add 10% for inflation. **There MAY be a match requirement of 20%.** However, the state may cover the match from the new capital funding that is supposed to be available soon.

#### **NEW LIBRARIANS TAKE THE REINS**

A **BIG** welcome to our 2 new librarians. Jessie Soder is the new Administrative Library Director and LeAnn Weikle is the new Library Services Director. Also, Bre Ohlsen has been doing an outstanding job running the library and training up our new Director's – **THANKS** Bre!

#### **GPAC REQUESTS \$10K FOR MONITORING WELLS**

GPAC has received permission from ADOT to install FluxMeters that provide data that would assist in developing a PlumeStop program at the airport. GPAC is requesting \$10,000 (\$2,500 each) for the purchase 4 monitoring wells that would create useful data for the prospective injection of PlumeStop. According to Kelly McLaughlin of GPAC, 2 wells could provide the necessary data but feels 4 would be better. According to Kelly, the Flux Meters measure the speed and direction of the flow of groundwater as well as the saturation and fluctuation of PFAS in the water in order to pinpoint accurate application of PlumeStop. Would the Council like to hear from GPAC on this proposal?

Thank you once again for awarding Tidelines Institute (formerly the Arete Project) a City of Gustavus Endowment Grant in 2020. We are grateful to have the city's support for our work, and we look forward to serving the Gustavus community for many years to come.

A request has been submitted to use the building for a Bike Repair Shop that would be seasonal and work to incorporate a vocational program with Gustavus School. The project could provide a needed service (i.e. bike repair shop) for the community; repair and renovate the building so that it is useful and restored; potentially provide students with practical knowledge about bike repair furthering the use of alternate means of transportation in the community. Regardless of the use, the building needs to be repaired to prevent further dilapidation.

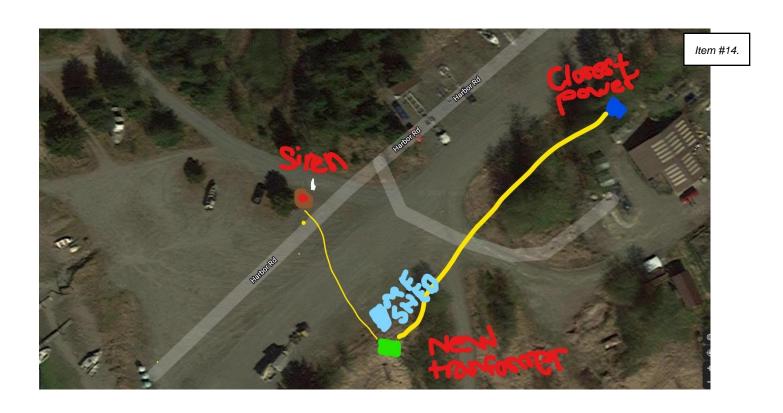

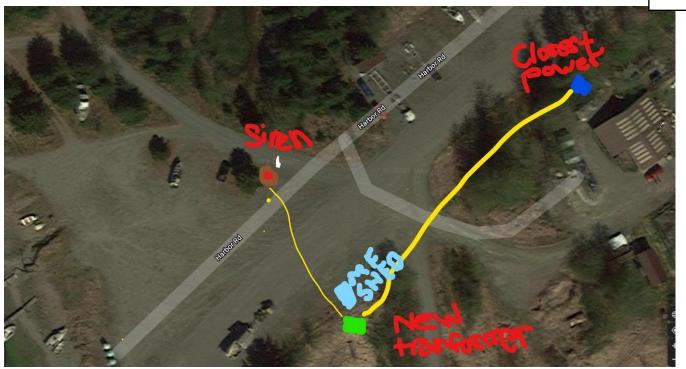
