As discussed with the Town and General Control Systems, Inc. (GCS), the existing radio telemetry system throughout the Town's water distribution system, specifically the radio hardware, is nearing the end of its useful life. Additionally, the existing radios are obsolete and repair parts are becoming increasingly harder to locate in the event a repair is needed. Since the new Button Road water storage tank will be equipped with a new radio telemetry system via CBRI's tank construction contract, it is recommended that the remaining water system radios be upgraded at this time to ensure long-term reliability and compatibility. Accordingly, we have requested that GCS provide a proposal to upgrade the existing radios, as well as install a radio telemetry system at the new pressure reducing valve (PRV) station on Lower Newtown Road for the Town's consideration. The GCS proposal is attached hereto and includes new radios at the Brookwood Tank, Harris Road Pump Station, Werner Tanks, Angle Lane Tank, and the City of Troy metering pit (DeGussa Site). The proposal also includes new redundant pairs of radios at both the water treatment plant and Channel 10 News repeater site, as well as a new radio, enclosure, antenna, and appurtenances at the Lower Newtown Road PRV station. The total cost for the radio upgrades is \$74,910.

We have reviewed the contingency fund balance for CB&I's Button Road Water Storage Tank Contract, and accounting for all additional work performed to date, including the new radio telemetry system for the Button Road tank, there is approximately \$125,000 remaining in the contingency budget. Based on this, we feel there is sufficient budget remaining to cover the costs for the above radio upgrades, while also leaving funds for any additional unforeseen tank-related items. If the Town would like to proceed with the additional radio upgrades at this time, please let me know and we will have CB&I engage GCS for the work. Please note that per the General Conditions, CB&I will be entitled to a 5% markup on the GCS proposal. Including contractor markup, the total amount to be deducted from the contingency allowance would be \$78,656.

Initially, we completed a site visit with the Town and a trail assessment report. The report was submitted to the Town in early April 2024. Per our meeting with the Town after we submitted the report, the Town now wishes for a contractor to complete the needed improvements and we will provide some limited construction phase services.

The existing trail is open to the public, but located on lands owned by the Swatling Falls HOA, Glen Meadows HOA, and the Town of Halfmoon. Based on the preliminary condition assessment, much of the trail is in reasonably good condition and is safe for pedestrians and bicyclists. Two areas of the trail, however, present pavement failures that result in dangerous conditions for trail users. These are the areas to be improved.

Scope of Services
