8. Speed Limit Reduction Request on Cordley Lake Road

9. Freedom River Campground Variance Request

Motion made by Negri, Seconded by Miller, to grant a variance from the Township sewer ordinance requiring connection to the sanitary sewer system when a proposed facility is located within 400-feet of an existing sewer line and allowing the construction of two privy restrooms with septic tanks within that distance of the sewer line located on the property. The request is driven by practical site limitations at the campground. Due to the lack of an on-site water source, constructing a restroom facility with running water and connecting to the sanitary sewer system is not currently feasible. The proposed privy restrooms represent the most reasonable, safe and environmentally responsible resolution to provide necessary sanitation for the campground.

10. Building & Grounds Position

Motion made by Miller, Seconded by Hardesty, to give Randazzo permission to create and post for hiring the new Building and Grounds Maintenance full-time, Grade 3 position, posting the job with the pay scale of that Grade, this person is able to start with hiring and name brought forward for approval of the Board, to approve the job description as well as the understanding that there will be a budget amendment for approximately twelve thousand dollars to finish out the fiscal year 2025/2026, and to amend the organization chart is updated to add this position.
