1. **Item (7 a.) Storage Facilty\_SUP22-001\_SPA22-001** Public Hearing: to consider the remodel of the existing building and construction of 23 new storage buildings totaling 113,180 square foot of indoor area. The project also includes a concrete pad approximately 145,180 square foot in size for additional outdoor storage.
