Resolution for Ballot Question - Consolidation of Residential Trash Collection

Hamburg Township currently has multiple companies collecting trash from residences on a variety of days and times. To minimize road deterioration, improve traffic safety and in an effort to provide residents more economical waste and recyclable collection, should Hamburg Township Board award a residential trash collection contract for the whole township, which includes weekly trash and recyclables pickup, yard waste pick up from April 1st through Dec 10th each year and bulk item pick up.
