THE MATTER OF DISCUSSING THE HARRISBURG REDEVELOPMENT AGENCY FISCAL YEAR 2018-2019 AUDIT REPORT WITH THE AUDITOR, STEVE TUCHSCHERER

STAFF REPORT: Tuchscherer said that the same comments in relation to internal controls apply to the HRA as well. The HRA is really just getting going on the types of uses it was meant to exist for. The biggest challenge with the HRA is with the loans paid out, and grants made to local businesses. There is a spreadsheet going on there, so you need to understand how those spreadsheets balance and relate to the accounting. You also need to make sure you understand what the agreement is for each loan, and make sure that they are being adhered to. The bond details are the biggest challenge for them and requires a second set of books. Mainly, the issue with the HRA loans and grants, and the processes around them, need to be tightly controlled. Otherwise, everything is the same as the City accounting.

 Klemm motioned to approve the HRA's Fiscal Year 2018-2019 Audit Report, as Presented by the Auditor Steve Tuchscherer, and was seconded by Caughey. The HRA Board then voted unanimously to approve the HRA's Fiscal Year 2018-2019 Audit Report.
