CALL TO ORDER AND ROLL CALL BY CHAIRPERSON ROBERT DUNCAN at the hour of 8:46pm.

THE MATTER OF CONSIDERATION OF AN HRA GRANT REQUEST FOR A \$50,000 PROPERTY IMPROVEMENT GRANT FOR THE INTERNATIONAL ORDER OF THE ODDFELLOWS RESTORATION PROJECT

STAFF REPORT: Eldridge stated that the City has \$52,000 left in the HRA Program. The City just closed out the Mainstreet Revitalization Grant and the last HRA Grant for Patrick and Donnell Freeman for the International Oddfellows Building. All investments put into the building including grant funds, total \$700,000. The first grant the Freeman's received went towards repairing the ceiling, the roof, and the parapet on the structure. The second grant went towards re-wiring the building and restoration of masonry, which alone was \$100,000. They have also renovated and created a commercial leased space on the bottom floor of the building. Eldridge stated that windows are an important part of this structure and are part of the National Registry of Historic Places guidelines. The quote is almost \$10,000 per window and a total of 11 windows are needed.

In the past, the Board has discussed whether to divide up how the remaining funds are being spent and if they want all of the funding going into this one structure. Since early spring, Eldridge has had three property owners contact her, but she feels that it is unlikely to go forward due to the high cost of materials currently and the uncertain economy. Eldridge informed Council that we have been trying to create a program, out of the General Fund; Community and Economic Development, with some of the ARP money. This type of program is adequate but it's up to the Council to decide.

- Thomas commented that Council has granted lots of funding so far for this project. Klemm asked how much money has been granted and Thomas replied, \$100,000.
- Duncan commented that the money was very well spent and he's sure the windows are beautiful, but he was concerned with the cost. Boese asked if there were any other bids. Eldridge replied that she thought they did get quotes from other places, and she thinks this is the best one.
- Eldridge thought maybe it was due to being in the Historic Registry and stated that Bess Tweedt submitted it to the registry back in the 1970's.
- Downey asked the Altons, of S 2nd St, if they ever replaced any of the windows in their home. They replied not yet, but they did think the cost of the windows was an absorbent sum.
 - Keaton motioned deny the Property Improvement Grant Application for Patrick and Donnell Freeman and to ask the City Administrator to talk to them about the offer they are receiving on the windows and was seconded by Thomas. BACKGROUND INFORMATION:

The HRA is required to have an "annual meeting of the agency...on the second Tuesday in January immediately following the City Council meeting" An annual meeting is a good opportunity for the Board to discuss the progress and future of the agency and ask questions of staff.

The projected statistics for the grant program are tied to the \$500,000 debt that was allocated during the 5th Substantial Amendment for the loan and grant program. (Please note, the \$550,000 reported in the statistical report is what we were able to finance due to favorable conditions at that time.) The current statistical report is available in **Exhibit A**. The figure is conservative as it does not account for revenue received in loan payments over the last several years. It does reflect the newest grant that was just approved in December.

I have asked Finance Officer, Cathy Nelson, to prepare another Maximum Indebtedness Calculation, which she will bring to the meeting. That document will enable us to know if there are enough funds available to consider additional or revised HRA projects.
