BACKGROUND INFORMATION:

The Crime Comparison by Quarter Report (**Exhibit A**) has been updated by the addition of the 1st Quarter of 2024. *Person Crimes* are at 4, which is higher than the last two quarters. *Person Crimes* are serious crimes, which can include assault, sexual abuse, child or elder abuse, fights, etc. While it's still not at the high of 10 shown in the 2nd Qtr. last year, it is still slightly concerning.

Property crimes show as 10 for the 1st Qtr. of 2024. This is lower than at any point in 2023 and is a good statistic to see. Most of the property crimes are theft, with one person subject to a \$500 scam, 1 burglary on Burton, and a nice arrest on February 5th of two people (from Eugene & Springfield) who were arrested for Burglary II after deputies located them at the scene after they broke into a secure building. (They were taken to the Linn County Jail). *Drug/Alcohol Crimes* are at two in the 1st quarter. *Traffic Offenses* are at 5, which is slightly higher than the 4th quarter, but still far better than the 3rd qtr.

All other offenses have remained the same as the last two quarters. There was a fugitive warrant, some restraining order violations, outstanding warrant arrests, a juvenile who was trespassing, some threats made on Snapchat, and a rather strange series of 911 calls with an intoxicated male. He trespassed at a residence, caused a disturbance at Subway, and laid down in the middle of Territorial in the dark. He was

arrested on two counts of Disorderly Conduct in the 2nd Degree, 1 count of Criminal Trespass in the 2nd Degree, and was lodged in the Linn County Jail. There was also a slightly concerning arrest of a person from Tigard for ASLT IV Domestic, Harassment, Interfering with making a Report, Robbery III, and Criminal Mischief III. There was also a hoax that someone made by reporting injuries caused by a firearm.

In arrests, there were 10 *all other offenses*, which includes 3 DUII's,, and multiple restraining order violations, as well as 5 traffic offense arrests. *Citations* were at 38 for the 1st quarter, with 58 violations, 3 non-injury crashes, and 1 injury crash. 11 of the equipment violations were due to failure to register vehicles.

In the YTD Crimes compared to last year (**Exhibit B**, Page 4), Council can see that *property crimes* are still lower than last year, and *person crimes* are still comparative to last year with 4 assults.

Looking at the Contract Cities Crime Report, (**Exhibit B**, Page 5) at the end of the report, Harrisburg is now at 43 YTD crimes, compared to the other cities in our region; the closest being 37 from Millersburg. Thankfully, we are still well below the 65 crimes we had at this same point last year.

The Council Priorities section has been updated to remove the column with objectives/actions. Staff believes it makes it very clear that the top item is the most important one; but further changes can still be made.



There are four overarching themes in the plan, which bring focus to the mission and vision of the city and organize the long-term goals of the plan. The four themes of the plan are:


- 1. Great Neighborhoods

Each theme includes the City's primary goals under that theme for the foreseeable future. The goals should remain constant over time and only be revised to reflect significant community changes or unanticipated events. A list of measurable objectives with benchmarks helps us track progress towards the goals. Objectives are generally identified to cover the five-year strategic planning period from the date they are adopted. Action items are the steps needed to meet the objective. Many more strategies and action items will be developed throughout the organization to align the entire organization with the goals and objectives identified in this plan.

This Plan is intended as a work in progress. While the mission, vision, values, and goals should remain constant, the objectives and action items will need periodic review and adjustment. We will track progress through regular reporting on the measures, and they will be incorporated into organization and community publications. The annual Budget and Capital Improvement Program will serve as reporting and implementing policy documents, that bear close relationships with the Strategic Plan. Those include the Comprehensive Plan, Transportation System Plan (in progress), Water Master Plan, Parks Master Plan, and in the future, the Wastewater Master Plan, and Storm Drainage Plan, plus related planning documents that also support the Strategic Plan.

The Plan, although adopted near the beginning of the calendar year, depends on the Fiscal Year for its annual progress or implementation. For example, a plan objective identified to be accomplished in 2022 means Fiscal Year 2022-23. (July 1, 2022 – June 30, 2023) The timing of the adoption of the plan allows the City Council to have a mid-year check on how the prior year's plan objectives are progressing and assists City staff with preparing the budget to assist with the Council's priorities adopted in the Plan.

STAFF RECOMMENDATION:

Staff recommends the Council discuss the proposed Eagle Park Sponsorship Program.

BACKGROUND INFORMATION:

Several businesses (some outside) in the City of Harrisburg have asked if the City will allow sponsorships in Eagle Park. Allowing a Sponsorship Program is a fun way to establish pride in our new regional park. Businesses can get involved, and sponsor the improvements and developments in the Park, and in exchange, their business name is posted for all to see, including on the website. Just to get the discussion going, a proposed sponsorship program is shown in **Exhibit A**.

There are several considerations that are important for the City Council to discuss. The first is whether it's considered too early to put up signs. The more we develop the park, the more regular citizens will be using it, which helps to run out those people who might consider vandalism as a sport. If Council is favorable to this suggestion, an on-line sponsorship can be announced and mailed out with the utility bills. Physical signs will only be posted when a development is completed.

1. How much should a business pay to put their name on the Dog Park over the main entrance? Should it be \$25,000? While Staff believes it's worth that kind of a fee, chances are that only the biggest businesses (likely industrial) will be able to afford this. Until that time, it would simply be the Dog Park at Eagle Park.

2. If we allow fence signs, do we want a limitation on the number of signs installed? We want a beautiful park, that is nice to look at, and not a ballfield; but staff does support small signs that are roughly 25' apart on the fence, in uniform sizes.

3. Other signs are similar to those used in other locations in town, and in particular, the picnic table and park benches, which are marked with plaques.

4. The Dog Park sign will be elevated, but other types of signs in the program are within easy reach of people. If a sign is vandalized, especially at a \$1,000 and \$500 level, the sponsors would likely prefer that their sign is replaced. How many times should we allow a sign to be replaced? Should we wait to install fence signs until the dog park has been established for a year?

5. Money raised through the sponsorship program should be used only for development in our Parks programs. 10% of each sign sponsorship could go to the parks maintenance expense fund which is used for sign replacements.

City Council may have their own ideas in relation to a sponsorship program, and discussion/brainstorming at this meeting is encouraged. If the City Council allows Staff to establish a sponsorship program, then Staff will create an attractive and fun flyer that can be mailed with utility bills in the future, as well as being on the website. Staff can return with a final revision of the program at a future City Council meeting.
