Staff recommends normal discussion of any concerns that Council might have in relation to crime issues.

BACKGROUND INFORMATION:

The Crime Comparison by Quarter Report (**Exhibit A**) has been updated by the addition of the 1st Quarter of 2023. *Person Crimes* are up by 1 from the previous quarter, as well as to the 1st Qtr. results in 2022. *Property crimes* are reduced by 1 from the previous Qtr., and by 3 for the 1st qtr. LY. *Drug/Alcohol Crimes* are also increased, and are in fact, higher than any of the previous Qtr. results. *All other offenses* are at 19, which is up by 6, and 5, respectively, from the 4th Qtr., and 1st Qtr. for LY.

Looking at the Contract Cities Crime Report, (**Exhibit B**, Page 4) at the end of the report, *property crimes* are down by 9 compared to overall LY. *All other offenses* are up compared to LY at this time, while d*rug and alcohol offenses* are 5 more than last year. Traffic offenses are down, as well as *person crimes*. Fugitive/Warrant Arrests are also up compared to LY.

Finally, in Year-to-Year Crime comparisons between all cities (**Exhibit B**, Page 5), we are now leading all the other cities in total crimes, although we are under LYTD.

At the work session held in April, the City Council and Deputy Attorney Catherine Pratt had a further discussion on the proposed TPM restrictions in relation to camping. The attached documents should reflect previous discussion and direction that has been supplied by the City Council, City Staff, and the City Council.

At this meeting, the City Council will have a chance to have a final review of the proposed ordinances. Citizens in Harrisburg will also have this opportunity to provide testimony if they

should wish to address the City Council in relation to this subject. Changes may still be made to the draft ordinance, if so desired. **Exhibit A** is the memo from Deputy Attorney Catherine Pratt, with attachments 1 and 2 showing the ORS in relation to this subject. **Exhibit B** shows all the proposed changes being made to HMC 9.55, City Park Regulations. As noted in previous meetings, HMC 9.55 is also being modified to reflect current practices.

Exhibit C is the proposed Ordinance, with the clean (final) versions of HMC 9.45 (Miscellaneous Offenses), HMC 9.55 City Park Regulations, and HMC 9.65 Illegal Camping. The final ordinance will return to the meeting being held on June 13, 2023. This final ordinance will be established as an emergency, as it must be effective as of July 1, 2023.

SUBJECT: Implementing ORS 195.505 and 195.530

ISSUE:

ORS 195.530 (former 2021 HB 3115) states that, **effective July 1, 2023**, City regulations that apply to "the acts of sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to the public must be objectively reasonable as to time, place, and manner with regards to persons experiencing homelessness." This law is Attachment 1 to this Memo. ORS 195.505, requires Cities to implement camp removal policies that meet the requirements set forth in the statute. This is Attachment 2 to this Memo.

The City Attorney Office has recommendation changes or additions to the current Code in order to comply with these new laws. The City Council should adopt the proposed changes to the Municipal Code that clarifies what constitutes illegal camping, institute a policy for the removal of illegal campsites, and delegate authority to the City Administrator to designate areas on public property that are open to the public for people that are experiencing homelessness to sit, sleep, and lay down without criminal sanction.

SUMMARY:

The 2021 Legislative Session saw the passage of several laws related to homelessness and camping on public property in response to the housing crisis and case law in *Martin v. Boise*, and in *Blake v. Grants Pass*. These two cases used the 8th Amendment's prohibition against cruel and unusual punishment as a basis for ordering that the cities in these two lawsuits needed to remove their laws that made it illegal for people to sleep in public when there was no shelter that they could go to.

In response, the State imposed requirements on cities in the following two areas: removal of illegal camps and regulation of the actions of sitting, sleeping, and laying down on public property that is open to the public. The first requirement is that cities are expected to create policies for removing established, illegal camps that allow for 72 hours' notice before the person and property are forcibly removed and policies for the storage of that property for up to 30 days for the person to reclaim their property. This is codified in ORS 195.505. The City will need to implement a policy that meets the standards set forth in this law.

The second requirement focuses on regulating homeless persons' activities on public property. Based on the idea that people are protected from cruel and unusual punishment, a government is not allowed to punish a person for sleeping, sitting, or laying down in public if they have no other place to perform those actions. ORS 195.530 gives municipalities until July 1, 2023, to alter their laws or institute policies so that regulations are either completely removed, or "objectively reasonable" regulations are put into place.

An important note: camping is a different action from sleeping. Camping is something that goes beyond mere sleeping. This is usually something that is performed for more than 24 hours, and/or includes other activities such as cooking, storing property, etc. Cities can still regulate camping and issue citations to people for illegal camping. Cities can also impose restrictions on the time and place that a person sleeps and the "manner" that they sleep. The City Attorney Office has recommended that the City Council delegate authority to the City Administrator to create policies that would regulate the time, place, and manner that a person can sit, sleep, and lay down on Cityowned property that is open to the public. If this delegation occurs, the City Attorney's Office will work with the City Administrator to ensure that these policies do not violate ORS 195.530, and afford as much legal protection as possible to the City.

The changes proposed to the Municipal Code will not reduce the number of persons experiencing homelessness, will not reduce the visibility of persons experiencing homelessness, will not resolve the systemic issues that lead to or contribute to a person's homeless status, will not create a sanctioned camp site on City property, and will not reduce or increase the number of illegal camps.

Several changes to Chapter 9.65 are not made with the specific intention of bringing the City into compliance with ORS 195.505 or ORS 195.530. Rather, some changes are proposed because the City Attorney's Office was already reviewing this Chapter and there has been expressed desire in amending the Park Regulations from citizens, the City Council, and law enforcement agencies over a period of time to include the proposed changes. The proposed changes to add Section 9.45.050 regarding consumption of alcohol in public places is proposed as a means of enforcing the Park's Regulations on the prohibition of alcohol and controlled substances.

RECCOMENDATION:

The City Attorney Office recommends that the City Council adopt the proposed ordinance and proposed changes to the Municipal Code. We recommend that the City Council adopt the changes proposed in Exhibits A and B to the proposed ordinance, so that the City complies with ORS 195.530 and has a valid camp removal policy under ORS 195.505. As needed, the City Council or the City Administrator can implement additional ordinances or park regulations respectively for further refinement of objectively reasonable time, place, and manner regulations regarding measures to stay warm and dry in parks. We recommend express delegation of authority to the City Administrator so that the City can respond to specific concerns in an efficient manner. Should the City Council adopt this delegation of authority, the City Administrator will work with Staff to further amend park regulations to control the manner and place that these actions occur.

195.530. City or county law on homelessness; injunctive or declaratory relief

Effective: June 23, 2021 Currentness

<Section operative July 1, 2023.>

- (1) As used in this section:
 - (a) "City or county law" does not include policies developed pursuant to ORS 195.500 or 195.505.
 - (b)(A) "Keeping warm and dry" means using measures necessary for an individual to survive outdoors given the environmental conditions.
 - (B) "Keeping warm and dry" does not include using any measure that involves fire or flame.
 - (c) "Public property" has the meaning given that term in ORS 131.705.
- (2) Any city or county law that regulates the acts of sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to the public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.
- (3) It is an affirmative defense to a charge of violating a city or county law described in subsection (2) of this section that the law is not objectively reasonable.
- (4) A person experiencing homelessness may bring suit for injunctive or declaratory relief to challenge the objective reasonableness of a city or county law described in subsection (2) of this section. The action must be brought in the circuit court of the county that enacted the law or of the county in which the city that enacted the law is located.
- (5) For purposes of subsections (2) and (3) of this section, reasonableness shall be determined based on the totality of the circumstances, including, but not limited to, the impact of the law on persons experiencing homelessness.

195.505. Required elements of homeless camping policies

Effective: January 1, 2022 Currentness

- (1) A policy developed pursuant to ORS 195.500 shall conform, but is not limited, to the following provisions.
- (2) As used in this section, "personal property" means any item that can reasonably be identified as belonging to an individual and that has apparent value or utility.
- (3) Except as provided in subsection (9) of this section, at least 72 hours before removing homeless individuals from an established camping site, law enforcement officials shall post a written notice, in English and Spanish, at all entrances to the camping site to the extent that the entrances can reasonably be identified.
- (4)(a) When a 72-hour notice is posted, law enforcement officials shall inform the local agency that delivers social services to homeless individuals as to where the notice has been posted.
 - (b) The local agency may arrange for outreach workers to visit the camping site that is subject to the notice to assess the need for social service assistance in arranging shelter and other assistance.
- (5)(a) All personal property at the camping site that remains unclaimed after removal shall be given to a law enforcement official, a local agency that delivers social services to homeless individuals, an outreach worker, a local agency official or a person authorized to issue a citation described in subsection (10) of this section, whether notice is required under subsection (3) of this section or not.
 - (b) The unclaimed personal property must be stored:
 - (A) For property removed from camping sites in counties other than Multnomah County, in a facility located in the same community as the camping site from which it was removed.

- (B) For property removed from camping sites in Multnomah County, in a facility located within six blocks of a public transit station.
- (c) Items that have no apparent value or utility or are in an insanitary condition may be immediately discarded upon removal of the homeless individuals from the camping site.
- (d) Weapons, controlled substances other than prescription medication and items that appear to be either stolen or evidence of a crime shall be given to or retained by law enforcement officials.
- (6) The written notice required under subsection (3) of this section must state, at a minimum:
 - (a) Where unclaimed personal property will be stored;
 - (b) A phone number that individuals may call to find out where the property will be stored; or
 - (c) If a permanent storage location has not yet been determined, the address and phone number of an agency that will have the information when available.
- (7)(a) The unclaimed personal property shall be stored in an orderly fashion, keeping items that belong to an individual together to the extent that ownership can reasonably be determined.
 - (b) The property shall be stored for a minimum of 30 days during which it shall be reasonably available to any individual claiming ownership. Any personal property that remains unclaimed after 30 days may be disposed of or donated to a corporation described in section 501(c)(3) of the Internal Revenue Code as amended and in effect on December 31, 2020.
- (8) Following the removal of homeless individuals from a camping site on public property, the law enforcement officials, local agency officials and outreach workers may meet to assess the notice and removal policy, to discuss whether the removals are occurring in a humane and just manner and to determine if any changes are needed in the policy.
- (9)(a) The 72-hour notice requirement under subsection (3) of this section does not apply:
 - (A) When there are grounds for law enforcement officials to believe that illegal activities other than camping are occurring at an established camping site.
 - (B) In the event of an exceptional emergency at an established camping site, including, but not limited to, possible site contamination by hazardous materials, a public health emergency or other immediate danger to human life or safety.

- (b) If a funeral service is scheduled with less than 72 hours' notice at a cemetery at which there is a camping site, or a camping site is established at the cemetery less than 72 hours before the scheduled service, the written notice required under subsection
- (3) of this section may be posted at least 24 hours before removing homeless individuals from the camping site.
- (10) A person authorized to issue a citation for unlawful camping under state law, administrative rule or city or county ordinance may not issue the citation if the citation would be issued within 200 feet of a notice required under subsection (3) of this section and within two hours before or after the notice was posted.
- (11) Any law or policy of a city or county that is more specific or offers greater protections to homeless individuals subject to removal from an established camping site preempts contrary provisions of this section.

- (6) In any suit brought pursuant to subsection (4) of this section, the court, in its discretion, may award reasonable attorney fees to a prevailing plaintiff if the plaintiff:
 - (a) Was not seeking to vindicate an interest unique to the plaintiff; and

Chapter 9.55 CITY PARK REGULATIONS

9.55.010 Purpose.

The parks of this City are established and maintained as areas of recreation, relaxation and enjoyment for the public. It is intended that they shall-will be regulated and used to permit enjoyment by a maximum number of people engaged in widely diverse interests and activities as may be practical within the limits of space, design and accommodations available in each park unit. While maintaining the aesthetic of the area and promoting the health, welfare, and safety of the public. Limitations may be required to ensure the use of park areas in safety and to protect the rights of others in surrounding areas. [Ord. 679 § 1, 1995.]

9.55.020 Definitions.

As used in this chapter, the term "park" means an area of land owned or controlled by the public, set aside and maintained by the public for the recreation and relaxation of the public, including neighborhood parks and community parks, as well as limited use parks (which includes undeveloped greenways). [Ord. 679 § 2, 1995.]

9.55.030 Vehicles in City parks.

- 1. Vehicles such as autos, trucks, motorcycles, motor scooters, go-carts, bicycles, or other conveyances shall must operate, stop, or park only upon designated roadways or within designated parking areas unless specifically authorized by the City. Parking prohibitions, time limits or other parking restrictions for areas within City parks may be designated by the City with official traffic signs.
- 2. No person shall drive a vehicle upon the City boat landing near the intersection of 1st and Monroe Streets, nor on the adjacent gravel bar, except for the purpose of launching or retrieving a watercraft. No vehicles shall park on the boat landing or adjacent gravel bar.
- 3. No person shall drive a vehicle upon the City boat landing in Eagle Park, or block the boat landing, except for the purpose of launching or retrieving watercraft.
- 4. No vehicle may be parked in any City park while the park is closed to the public.
- 2.5. Any person who violates these prohibitions shall, upon conviction, pay a fine of not more than \$200.00. Any vehicle left parked or standing in violation of this section will be

towed without 24 hour notice. [Ord. 931 § 1 (Exh. A), 2015; Ord. 927 § 1 (Exh. A), 2015; Ord. 880, 2009; Ord. 679 § 3, 1995.]

9.55.040 Animal control.

- 1. The City has reasonable discretion to regulate the presence and activities of animals in City parks.
- 2. No person shall is permitted to ride or lead any horse or pony in a park, except as designated by the City, by permit.
- 3. Also refer to offenses relating to animals in Chapter 6.10 HMC. [Ord. 679 § 4, 1995.]

9.55.050 Fire.

- 1. No person shall is permitted to build or maintain any fire in a park, except in City-created and designated fire rings, fireplaces, or in designated areas. Violation of this Subsection is a Class C Misdemeanor.
- 4.2. No burning materials shall be gathered or used by individuals except as authorized by the City. [Ord. 985 § 2, 2022; Ord. 679 § 5, 1995.]

9.55.060 Commercial activity.

- No person who holds a valid <u>commercial activity permitbusiness license</u> issued by the City under this section <u>shall is permitted to</u> sell merchandise or services within a park in violation of any conditions stated on that <u>permit.license</u>.
- 2. Permitted Prior to receiving an event permitpermit, commercial or special activities events held in City parks shall-must meet or agree to the following conditions:
 - a. Park concession stands, gross sales, expenses and net receipts shall <u>must</u> be certified for accuracy by the authorized agent of the applicant.
 - b.a. The number of persons permitted to stay overnight, if applicable, shall must be authorized by the City.
 - <u>b.</u> Applicant <u>shall must</u> compensate any expenditures for park maintenance, including City lighting, if any.
 - c. Vendors, if present, must supply the City with a certificate of liability in a minimum amount of \$1,000,000 and add the City of Harrisburg as an additional insured.

c.

- 3. A commercial vendor All Business Licenses are will be subject to a fee, as established by a resolution of the City Council; nonprofit organizations will not be subject to a fee. [Ord. 679 § 6, 1995.]
- 3.4.No person shall solicit, sell or offer for sale, peddle, hawk or vend any goods, wares, merchandise, foods, liquids, or services without holding a business license from the City.

9.55.070 Garbage and other refuse.

- 1. No person shall is permitted to discard or dispose of any garbage in a park, except in a receptacle provided for such garbage and other refuse.
- 2. No person shall is permitted to take any garbage or other refuse into a public park for the purpose of discarding or disposing of such garbage or other refuse. [Ord. 679 § 7, 1995.]
- 2.3.Knowingly discarding or dumping of refuse, garbage, or other items outside of a designated waste receptacle is a Class A Violation.

9.55.080 Motor vehicle speed.

The designated speed for motor vehicles upon the roadways within any park is 10 miles per hour unless otherwise posted. No person shall is permitted to operate a motor vehicle upon any roadway in a park at a speed greater than permitted by the basic rule as provided in ORS 811.100. [Ord. 693 § 1, 1995; Ord. 679 § 8, 1995.]

9.55.090 Dangerous equipment and activities.

No person shall is permitted to use or engage in any activity in a City park that the City determines will create an unreasonable interference or danger to other persons. Such activitiesy shall include, but are not be limited to, the use of golf clubs, fireworks, archery equipment, a discus, javelin or shot; any aircraft, rocket, or missile powered by fuel or mechanical means; or any firearm. Such activities will be allowed only as provided in HMC 9.55.100. [Ord. 679 § 9, 1995.]

9.55.100 Special use areas.

The City may set aside, establish, alter, and/or discontinue special use areas in one or more of the parks. These special use areas would include, but not be limited to, activities such as horse or pony riding, Junior Olympics, bicycle riding, camping activities, <u>disc golf</u>, motorcycle riding, <u>mini-boat racing</u>, or any one or more of those activities otherwise prohibited under HMC 9.55.090. Before establishing, altering or discontinuing such a special use area, the City

shall will determine the priority of need for such an area and whether the activity may be carried on without unreasonable interference or danger to other persons.

If the City establishes a special use area, such hours or days of usage may be designated, the particular activity or activities which are permitted, and such conditions as are required for the safety and convenience of persons and property. The City shall-will establish the boundaries of the special use area and post such signs and warnings concerning that special use area as deemed reasonably appropriate. No person shall-is permitted to use or injure any special use area, except for the purposes of one or more of the activities permitted in that special use area under any conditions specified by the City. [Ord. 679 § 10, 1995.]

9.55.110 Sound.

- 1. No person shall is permitted to disturb the peace in any park between the hours of 10:00 p.m. and 8:00 a.m. For purposes of this subsection, "disturbing the peace" is defined as including, but not limited to, the following:
 - a. Playing a musical instrument.
 - b. Playing a radio, tape recorder or television.
 - c. Shouting.
 - d. Engaging in any organized games.
- 2. No person or organization shall is permitted to use any device to amplify sound in any park unless a valid permit has been issued by the City.
- 3. The City may issue a permit authorizing the use of one or more designated devices to amplify sound by one or more designated persons in a designated area of a park on a designated date between specified hours that the number of persons to be entertained or served by the use of sound can be adequately and reasonably served only by the amplification of sound. The City may include conditions in such permit, and the permit may be revoked if the terms of the permit are violated, or a permit may be denied to a person or group of persons who have violated the terms of a permit within the previous year.
- 4. No person who holds a valid permit issued under this section shall is permitted to amplify sound within a park in violation of any conditions stated in that permit. [Ord. 679 § 11, 1995.]

9.55.120 Hours of use – Sleeping and camping – Liquor.

- 1. No person is permitted to enter or use any City-owed or controlled park during posted hours of closure without a permit to do so.
- 2. No person is permitted to camp in any park, except as provided in subsection 3.
- 3. No person is permitted to use any tent, shelter-half, motor home, vehicle, camper, or trailer as a shelter for camping in any park area at any time, except as provided in subsection 4.
- 4. The City Administrator may, in the City Administrator's reasonable discretion, issue permits or designate areas for the use of tents, tarps, canopies, shelter-half, motor homes, vehicles, campers, or trailers as shelters for any recreational camping in parks.
- 1.—No person is permitted to park a vehicle in a Park parking lot during the posted hours of park closure, unless that person has a permit to do so. No person shall sleep in any park between sunset to sunrise, unless previously authorized by the City.

5.__

- 2. No person shall use any tent, shelter-half, vehicle, camper, trailer or RV motor home as a shelter for camping in any park area, unless previously authorized by the City.
- 3.6. No corporation, organization, or person shall is permitted to bring, or permit any person to bring, or to consume any intoxicating liquor on park premises, except that the City Administrator or his/her designee can issue a permit to allow persons to bring and consume alcoholic beverages at City-sponsored outdoor concerts. A permit issued by the City Administrator shall may include conditions and restrictions as determined appropriate by the City Administrator, at least but must including the following conditions:
 - a. No alcohol shall is permitted to be consumed in violation of State statutes or rules of the Oregon Liquor Control Commission;
 - b. Alcohol other than distilled liquor or hard alcohol ean may be consumed on City property, at the site of the concert, beginning no earlier than 30 minutes before the scheduled concert, no later than the end of the concert; and
 - c. The City of Harrisburg reserves the right to cancel the privilege of consuming alcohol at City concerts at any time, for any or all individuals without cause. [Ord. 985 § 2, 2022; Ord. 904, 2012; Ord. 679 § 12, 1995.]

9.55.130 Hours of park closure.

1. No person shall enter or use any park during posted hours of closure without a permit to do so from the City. [Ord. 679 § 13, 1995.]

9.55.140-130 Liability.

All persons to whom an exclusive use permit has been granted must agree in writing to hold the City harmless and indemnify the City from any and all liability for injury to persons or property occurring as a result of the activity sponsored by permittee. Said persons shall will be liable to the City for any and all damages to parks, facilities and buildings owned by the City which that result from the activity of permittee or are caused by anyone who participates in said activity. [Ord. 679 § 14, 1995.]

9.55.150-140 Flora.

No person other than a duly authorized City employee in the performance of his duty or persons participating in City-approved activities shall is permitted to dig, pick, remove, burn, destroy, injure, mutilate or cut any trees, plants, shrubs, blooms or flowers, or any portion thereof, growing in any park. [Ord. 679 § 15, 1995.]

9.55.160-150 Marking, injuring or disturbing any structure.

No person other than a duly authorized City employee in the performance of his or her duties shall is permitted to:

- 1. Cut, break, injure, deface or disturb any rock, building, cage, pen, monument, sign, fence, bench, structure, apparatus, equipment or property in a park.
- 2. Mark or place any mark, writing or printing.
- 3. Attach any sign, card, display or other similar device, except as authorized by permit issued by the City. [Ord. 679 § 16, 1995.]

9.55.170-160 Penalty.

Unless another amount <u>or penalty</u> is stated in this chapter, any person who violates any provision of this chapter <u>shallwill</u>, upon conviction, be punished by a fine of not more than \$500.00, per occurrence, per day. <u>Such penalty may be levied in addition to other administrative charges, civil penalties, or criminal penalties authorized by this Code or by State law.</u> [Ord. 880, 2009; Ord. 679 § 17, 1995.]

9.55.180-170 Rules and regulations.

The Mayor and Council declare these rules and regulations to be necessary in order to have clean, attractive, well-maintained City parks.

You should help to keep this City a pleasant, safe and desirable place to live. The Mayor and Council have established and will enforce the following rules and regulations:

1. General Rules.

- a. The parks are open for public recreation, as designated.
- b. No peddling, soliciting or commercial enterprise is permitted in the park without a permit.
- c. Disorderly conduct, noisy disturbances, or disregard of these rules and regulations will be grounds for your immediate removal from the park by the police, authorized City officials or its designees.
- d. Park participants will be held responsible for the conduct of and any damage to the park or its equipment caused by their children or by children whom they have actual control over.
- e. Children under the age of eight shall must not be left unattended in the parks.
- f. No person shall is permitted to consume or have in their possession any intoxicating beverage, or narcotics narcotic, or controlled substance while in or upon the property of the parks.
- g. Air rifles, BB guns, bows and arrows or other guns and dangerous objects may not be used in parks in the City.
- h. No swimming is allowed on park property because lifeguards and suitable designated swimming areas are not provided.
- i. No overnight camping is allowed on park property without a permit.
- j. Interference with the use of a public facility that has been properly reserved is strictly prohibited.
- i.k. Use of park facilities, structures, or equipment in a manner that does not align with it's intended purpose is strictly prohibited.

- <u>j-l.</u> The Mayor, Council and their employees will not be responsible for accidents, injuries or loss of property by fire, theft, wind, flood or other natural acts which are beyond their control. Equipment furnished on the grounds is solely for your convenience and used at your own risk.
- k.m. The Mayor, Council and their employees are not responsible for any personal injury to children or adults using playground equipment, or enjoying park amenities, such as large boulders or other natural items—such as. Participants use the equipment at their own risk.
- 4.n. You should immediately notify the City Hall or the Police Department of hazardous conditions in the parks or conditions which are in violation of these rules and regulations.

2. Automobiles and Motorized Vehicles.

- a. Vehicles shall must be parked only in the designated areas. Vehicles parked elsewhere or on the grassy area will be removed at the owner's expense without prior notice. No auto repairs are allowed anywhere at any time on park property.
- b. The speed limit in the park is 10 miles per hour and must be observed at all times, and drivers must be alert for children and pedestrians.
- c. Bicycles, roller skates, skateboards, and other types of nonmotorized vehicles must be used safely, without the possibility of injury to others and only in nonrestricted areas.
- d. Disturbing or careless operation of motorcycles, automobiles or other types of motor vehicles will be grounds for removal from the park and/or citation by the police.

3. Park Buildings and Facilities.

- a. Park buildings and facilities are provided for your convenience or pleasure. You have a responsibility to use the facilities with respect for others and to keep them neat and clean. Any irregularities should be reported immediately to the City.
- b. No pets are allowed in the park buildings at any time.

4. Animals.

- a. Except as allowed in HMC <u>9.55.100</u>, no person <u>shall</u> <u>is permitted to</u> ride or lead any horse or pony in the park, except upon a roadway or designated parking area or designated bridle path.
- b. Pets are permitted in City parks (unless otherwise posted) only if they are on a leash that is five feet or less in length with the exception of the dog parks. AN ORDINANCE CONFORMING TO ORS 195.530 RELATED TO KEEPING WARM AND DRY ON PUBLIC PROPERTY

THE CITY OF HARRISBURG ORDAINS AS FOLLOWS:

Section 1. Legislative purpose:

- A. The City Council recognizes that the City has an obligation to ensure that public property is not damaged, and that public property does not pose a danger to the public's safety, health or welfare (including the safety, health and welfare of persons who are experiencing homelessness), and to ensure that public property is available and accessible for utilization by the maximum number of people in the Harrisburg Community.
- B. The cases of *Martin v. Boise*, and *Blake v. Grants Pass*, along with ORS 195.530 (Oregon Laws Ch. 370 § 1 (former H.B. No. 3115), operative July 1, 2023), and ORS 195.550 make it clear that cities can prohibit illegal camping, but cannot impose regulations on the actions of sitting, sleeping, lying down, or keeping warm and dry unless those regulations are objectively reasonable as to time, place, and manner with regard to persons experiencing homelessness.

<u>Section 2</u>. The City Council directs the City Administrator to continue the work required to draft revisions and amendments to the Harrisburg Municipal Code and Harrisburg Administrative Policies to conform to this ordinance and to comply with other requirements of ORS 195.530 regarding imposing only objectively reasonable time, place, and manner regulations of the acts of sitting, sleeping, or lying down in public property.

Section 3. The City Council adopts Municipal Code Section 9.45.050 as set forth in Exhibit A.

Section 4. The City Council amends Municipal Code Chapter 9.55, as set forth in Exhibit B.

Section 5. The City Council adopts Municipal Code Chapter 9.65, as set forth in Exhibit C.

<u>Section 6.</u> The City Council reiterates that nothing in this ordinance is an implied or expressed endorsement for the establishment of campsites on public property.

<u>Section 7.</u> Effective Date. Because prompt compliance with ORS 195.550 is necessary, the City Council establishes an effective date of July 1, 2023, for this ordinance.

EXHIBIT A

Amending Chapter 9.45 Miscellaneous Offenses

9.45.050 Consumption of alcoholic liquor, possession of open container of alcoholic liquor in public places prohibited.

Chapter 9.55 CITY PARK REGULATIONS

9.55.010 Purpose.

The parks of this City are established and maintained as areas of recreation, relaxation and enjoyment for the public. It is intended that they will be regulated and used to permit enjoyment by a maximum number of people engaged in widely diverse interests and activities as may be practical within the limits of space, design and accommodations available in each park unit, While maintaining the aesthetic of the area and promoting the health, welfare, and safety of the public. Limitations may be required to ensure the use of park areas in safety and to protect the rights of others in surrounding areas. [Ord. 679 § 1, 1995.]

9.55.020 Definitions.

As used in this chapter, the term "park" means an area of land owned or controlled by the public, set aside and maintained by the public for the recreation and relaxation of the public, including neighborhood parks and community parks, as well as limited use parks (which includes undeveloped greenways). [Ord. 679 § 2, 1995.]

9.55.030 Vehicles in City parks.

- 1. Vehicles such as autos, trucks, motorcycles, motor scooters, go-carts, bicycles, or other conveyances must operate, stop, or park only upon designated roadways or within designated parking areas unless specifically authorized by the City. Parking prohibitions, time limits or other parking restrictions for areas within City parks may be designated by the City with official traffic signs.
- 2. No person shall drive a vehicle upon the City boat landing near the intersection of 1st and Monroe Streets, nor on the adjacent gravel bar, except for the purpose of launching or retrieving a watercraft. No vehicles shall park on the boat landing or adjacent gravel bar.
- 3. No person shall drive a vehicle upon the City boat landing in Eagle Park, or block the boat landing, except for the purpose of launching or retrieving watercraft.
- 4. No vehicle may be parked in any city park while the park is closed to the public.
- 5. Any person who violates these prohibitions shall, upon conviction, pay a fine of not more than \$200.00. Any vehicle left parked or standing in violation of this section will be

towed without 24 hour notice. [Ord. 931 § 1 (Exh. A), 2015; Ord. 927 § 1 (Exh. A), 2015; Ord. 880, 2009; Ord. 679 § 3, 1995.]

9.55.040 Animal control.

- 1. The City has reasonable discretion to regulate the presence and activities of animals in City parks.
- 2. No person is permitted to ride or lead any horse or pony in a park, except as designated by the City, by permit.
- 3. Also refer to offenses relating to animals in Chapter 6.10 HMC. [Ord. 679 § 4, 1995.]

9.55.050 Fire.

- 1. No person is permitted to build or maintain any fire in a park, except in City-created designated fire rings, fireplaces, or in designated areas. Violation of this Subsection is a Class C Misdemeanor.
- 2. No burning materials shall be gathered or used by individuals except as authorized by the City. [Ord. 985 § 2, 2022; Ord. 679 § 5, 1995.]

9.55.060 Commercial activity.

- 1. No person who holds a valid business license issued by the City under this section is permitted to sell merchandise or services within a park in violation of any conditions stated on that license.
- 2. Prior to receiving an event permit, commercial or special events held in City parks must meet or agree to the following conditions:
 - a. The number of persons permitted to stay overnight, if applicable, must be authorized by the City.
 - b. Applicant must compensate any expenditures for park maintenance, including City lighting, if any.
 - c. Vendors, if present, must supply the City with a certificate of liability in a minimum amount of \$1,000,000 and add the City of Harrisburg as an additional insured.
- 3. All Business Licenses are subject to a fee, as established by a resolution of the City Council; nonprofit organizations will not be subject to a fee. [Ord. 679 § 6, 1995.]

4. No person shall solicit, sell or offer for sale, peddle, hawk or vend any goods, wares, merchandise, foods, liquids, or services without holding a business license from the City.

9.55.070 Garbage and other refuse.

- 1. No person is permitted to discard or dispose of any garbage in a park, except in a receptacle provided for such garbage and other refuse.
- 2. No person is permitted to take any garbage or other refuse into a public park for the purpose of discarding or disposing of such garbage or other refuse. [Ord. 679 § 7, 1995.]
- 3. Knowingly discarding or dumping of refuse, garbage, or other items outside of a designated waste receptacle is a Class A Violation.

9.55.080 Motor vehicle speed.

The designated speed for motor vehicles upon the roadways within any park is 10 miles per hour unless otherwise posted. No person is permitted to operate a motor vehicle upon any roadway in a park at a speed greater than permitted by the basic rule as provided in ORS <u>811.100</u>. [Ord. 693 § 1, 1995; Ord. 679 § 8, 1995.]

9.55.090 Dangerous equipment and activities.

No person is permitted to use or engage in any activity in a City park that the City determines will create an unreasonable interference or danger to other persons. Such activities include, but are not limited to, the use of golf clubs, fireworks, archery equipment, a discus, javelin or shot; any aircraft, rocket, or missile powered by fuel or mechanical means; or any firearm. Such activities will be allowed only as provided in HMC 9.55.100. [Ord. 679 § 9, 1995.]

9.55.100 Special use areas.

The City may set aside, establish, alter, and/or discontinue special use areas in one or more of the parks. These special use areas would include, but not be limited to, activities such as horse or pony riding, Junior Olympics, bicycle riding, camping activities, disc golf, motorcycle riding, mini-boat racing, or any one or more of those activities otherwise prohibited under HMC 9.55.090. Before establishing, altering or discontinuing such a special use area, the City will determine the priority of need for such an area and whether the activity may be carried on without unreasonable interference or danger to other persons.

If the City establishes a special use area, such hours or days of usage may be designated, the particular activity or activities which are permitted, and such conditions as are required for the safety and convenience of persons and property. The City will establish the boundaries of the special use area and post such signs and warnings concerning that special use area as deemed

reasonably appropriate. No person is permitted to use or injure any special use area, except for the purposes of one or more of the activities permitted in that special use area under any conditions specified by the City. [Ord. 679 § 10, 1995.]

9.55.110 Sound.

- 1. No person is permitted to disturb the peace in any park between the hours of 10:00 p.m. and 8:00 a.m. For purposes of this subsection, "disturbing the peace" is defined as including, but not limited to, the following:
 - a. Playing a musical instrument.
 - b. Playing a radio, tape recorder or television.
 - c. Shouting.
 - d. Engaging in any organized games.
- 2. No person or organization is permitted to use any device to amplify sound in any park unless a valid permit has been issued by the City.
- 3. The City may issue a permit authorizing the use of one or more designated devices to amplify sound by one or more designated persons in a designated area of a park on a designated date between specified hours that the number of persons to be entertained or served by the use of sound can be adequately and reasonably served only by the amplification of sound. The City may include conditions in such permit, and the permit may be revoked if the terms of the permit are violated, or a permit may be denied to a person or group of persons who have violated the terms of a permit within the previous year.

9.55.120 Hours of use – Sleeping and camping – Liquor.

- 1. No person is permitted to enter or use any City-owed or controlled park during posted hours of closure without a permit to do so.
- 2. No person is permitted to camp in any park, except as provided in subsection 3.
- 3. No person is permitted to use any tent, shelter-half, motor home, vehicle, camper, or trailer as a shelter for camping in any park area at any time, except as provided in subsection 4.

 - b. Alcohol other than distilled liquor or hard alcohol may be consumed on City property at the site of the concert, beginning no earlier than 30 minutes before the scheduled concert, no later than the end of the concert; and

Said persons will be liable to the City for any and all damages to parks, facilities and buildings owned by the City that result from the activity of permittee or are caused by anyone who participates in said activity. 9.55.150 Marking, injuring or disturbing any structure.

No person other than a duly authorized City employee in the performance of his or her duties is permitted to:

- 2. Mark or place any mark, writing or printing.
- 3. Attach any sign, card, display or other similar device, except as authorized by permit issued by the City. [Ord. 679 § 16, 1995.]

9.55.160 Penalty.

Unless another amount or penalty is stated in this chapter, any person who violates any provision of this chapter will, upon conviction, be punished by a fine of not more than \$500.00, per occurrence, per day. 9.55.170 Rules and regulations.

ORDINANCE No. ____

Chapter 9.65 ILLEGAL CAMPING

Section 9.65.010: Purpose.

It is found and declared that:

- 1. The City has the right to regulate camping on public property.
- 2. Persons experiencing homelessness may need to use public property that is open to the public to sit, sleep, or lay down, but the City may regulate the time, place, and manner that these actions occur.
- 3. The use of the Public Rights-of-Way for sitting, sleeping, or laying down or storage of personal property can impede and obstruct that right-of-way from its intended use, and can create a hazardous situation, and/or imminent threat to life for the person who is using that Public Right-of-Way;
- 4. These regulations are meant strictly to regulate the use of public property, and are not intended to regulate activities on private property; and,

Section 9.65.020: Definitions.

As used in this Ordinance, the following terms and phrases have the meaning set forth in this Section:

- 1. "Camp" or "Camping" means to set up or to remain in or at a campsite, for the purpose of establishing or maintaining a temporary or permanent place to live/residence. Using or maintaining a fire or stove without other evidence of a temporary place to live/residence is considered camping.
- 2. "Campsite" means any place where any indicia of camping is placed, established, or maintained.
- 3. "Disposable Items" means items with no apparent value or utility or that are in an unsanitary condition.
- 4. "Established Campsite" means any campsite that has occupied one location or within a 300-foot radius of that location to the exclusion of the public for any period in excess of 24 hours.
- 5. "Indicia of Camping" Items or activities that may include, but are not limited to: any stove or fire or cooking activity outside of authorized areas; storage of personal belongings; use of tents, lean-tos, shacks, or any other temporary structures or any part thereof for living or storage of personal belongings; designation of an area in a manner to exclude other members of the public by maintaining, using or storing personal belongings or items. Bedding (such as blankets, sleeping bags, or other sleeping matter), by itself, is not indicia of camping.

- 6. "Parks Areas" means publicly owned grounds operated under the supervision of the City of Harrisburg, whether within or outside of the corporate limits of the City of Harrisburg providing outdoor passive and active recreation opportunities.
- 7. "Public Property" means any real property or structure owned, leased, or managed the City of Harrisburg, including public right-of-way and utility easements.
- 8. "Social Service Agency" means a public or private nonprofit organization providing direct assistance, usefulness, or care to individuals experiencing homelessness.
- 9. "Staying Warm and Dry" means using measures necessary for an individual to survive outdoors given the environmental conditions but does not include using any measure that involves fire or flame.
- 10. "Store" or "Storage" means to put aside or accumulate for use when needed, to put for safekeeping, to place or leave in a location.

Section 9.65.030: Illegal Camping

- 1. It is unlawful for any person to camp or create an established campsite in or upon a public right-of-way, park, sidewalk, alley, street, under any bridge, or any properties owned by the City of Harrisburg except as provided in Chapter 9.55, as amended, or by declaration of the City Administrator.
- 2. Measures taken by persons experiencing homelessness to stay warm and dry while sitting, sleeping, or lying down that are not camping in the areas designated by the City Manager for this purpose are not illegal camping.
 - a. Measures taken to stay warm and dry while sleeping or lying down within 100 feet from a riparian area or established wetland are strictly prohibited.
- 3. A violation of this section is a Class C Misdemeanor.

Section 9.65.040: Camping on private property without consent.

- 1. No person is permitted to camp on private property in a vehicle or in places not intended for that purpose, without the permission of the owner or person entitled to the possession thereof.
- 2. A violation of this section is a Class C Misdemeanor.

Section 9.65.050: Removal of Illegal Camps

- 1. Application
 - a. This policy applies to all city-elected officials, employees, volunteers, or contractors engaged in the removal of Unlawful Campsites from City-owned property.
 - b. In cases where an Unlawful Campsite is located within a crime scene, or the Linn County Sheriffs' Office or other law enforcement agency seizes property for reasons outside the scope of the camp cleanup, then standard law enforcement property and evidence control procedures must be followed.
- 2. Posting of Written Notice

- a. The City Administrator, or authorized agents, must post a notice at the location of the Unlawful Campsite no less than seventy-two (72) hours prior to removing persons from an Unlawful Campsite.
- b. The notice must:
 - 1. Be posted at all entrances to the Unlawful Campsite to the extent that the entrances can be reasonably identified;
 - 2. Notify those persons that they are maintaining an Unlawful Campsite and that the City intends to clear the Unlawful Campsite, and remove any persons there, on a specified date;
 - 3. Provide referral information and current contact information for local Social Service Agencies;
 - 4. Inform the persons that any Personal Property retained as a result of the cleanup of the Unlawful Campsite will be stored at a facility located within the same community as the Unlawful Campsite for a period of thirty (30) days;
 - 5. Provide the location where the Personal Property will be stored, the time at which it may be picked up, and a phone number that individuals may call to arrange for pick-up;
 - 6. Confirm that Disposable Items retained as a result of the cleanup will be immediately discarded, and weapons, controlled substances other than prescription drugs, and items that appear to be either stolen or evidence of a crime will be turned over to law enforcement officials; and
 - 7. Be written in English and Spanish.
- 3. Exceptions to the Notice Requirement
 - a. The notification requirements of Municipal Code Section 9.65.050.2.b do not apply:
 - 1. When the City reasonably believes that illegal activities other than Camping are occurring at an Unlawful Campsite; or
 - 2. In the event of an exceptional emergency at an Unlawful Campsite, including, but not limited to, possible site contamination by hazardous materials, a public health emergency, or other immediate danger to human life or safety.
- 4. Communication with Other Agencies
 - a. Prior to posting the 72-hour notice, the City Administrator, or an authorized agent, must notify a local Social Service Agency of the City's intention to remove the Unlawful Campsite. Whenever feasible, the City Administrator will arrange for outreach workers from the local Social Service Agency to visit the Unlawful Campsite to assess the need for additional assistance in arranging shelter or providing additional care as needed.
 - b. The City Administrator may, at their discretion, request assistance from local law enforcement agencies in the removal and cleanup of an Unlawful Campsite.
- 5. Unlawful Campsite Cleanup and Storage Requirements
 - a. All unclaimed Personal Property retained as a result of the cleanup of an Unlawful Campsite will be stored in an orderly fashion, keeping items that belong to an individual together to the extent that ownership can reasonably be

- determined. The City may, at its discretion, inventory, photograph, and bag all Personal Property prior to storing it.
- b. All Disposable Items collected during the cleanup of an Unlawful Campsite must be disposed of in an appropriate manner.
- c. Weapons, controlled substances other than prescription drugs, and items that appear to be either stolen or evidence of a crime must be turned over to law enforcement officials regardless of their condition.
- d. Every effort will be made by the City Administrator to secure the health and welfare of any employee assigned to clear and/or clean an Unlawful Campsite and to utilize properly trained personnel with adequate equipment to manage the potential for exposure to hazardous and infectious materials.
- e. The City employee, agent, or contractor managing the cleanup must store any unclaimed Personal Property at a facility located within the same community as the Unlawful Campsite for a minimum of thirty (30) days, during which time it must be reasonably available to any individual claiming ownership. Any Personal Property that remains unclaimed for at least thirty (30) days may be disposed of or donated to a 501(c)(3) nonprofit corporation.
- f. The City may, at its discretion, seek reimbursement for expenses incurred by the City in relation to the cleanup of an Unlawful Campsite, including expenses incurred in the removal and storage of Personal Property, from a person found to be maintaining an Unlawful Campsite. Any civil action to obtain reimbursement must be filed in the Linn County Circuit Court within twelve (12) months of the date of cleanup.

Section 9.65.060: City Administrator Authority.

The City Administrator is delegated the authority to adopt rules, regulations, and policies to implement reasonably objective time, place, and manner restrictions for sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to the public.

STAFF RECOMMENDATION:

Staff recommends the City Council approve the Parade Permit for the Harrisburg Old-Fashioned 4th of July Parade

BACKGROUND INFORMATION:

The Harrisburg Festival and Events Association has submitted a parade permit application to hold the Old-Fashioned 4th of July Parade in 2023. There is a second parade that will be held during this event, but that does not affect ODOT, and uses only city streets. The Pet Parade will be held on July 3rd, with staging on Schooling St. between 2nd and 1st St., with the parade heading north on 1st St. to the Gazebo.

Because the route incorporates 3rd St., which is also Hwy 99E, we are required to obtain permission from ODOT. As such, the organization has submitted their application (**Exhibit A**) and is asking the City Council for approval of the parade routes. Staging remains the same.

The following is an analysis of the permit application's consistency with Chapter 9.20 of the Harrisburg Municipal Code.

Noise:

Parades generally produce a fair amount of noise. This particular parade occurs during daytime hours and does pass through residential neighborhoods. The levels and type of noise that will likely be created during the parade would not be acceptable per Harrisburg Municipal Code (HMC) 9.20.030 – Unreasonable Noise. However, Subsection (e) of HMC 9.20.030 does allow for the City Council to grant a permit for noise generated from general entertainment, such as a parade. Based on this provision,

and the fact that the applicant will obtain a parade permit, the noise generated from the parade is acceptable.

Traffic:

The parade route includes several public streets, which will be used by those participating in the parade. According to the applicant, the parade is anticipated to last one and a half hours and is scheduled to begin at 11:00 am and end at 12:30 pm. Traffic will be negatively affected during this period. The applicant works with the Linn County Sheriff's Office, and Coburg Police to provide deputies and signage indicating the presence of a parade.

The Parade Route used is the traditional parade route, that also needs approval by ODOT. (**The Parade Permit Packet is Exhibit A**). Staging is at both the schools, with the parade starting at 7th & Smith St. Traffic heads west on Smith to 3rd St., then south on 3rd St., to LaSalle St., then east on LaSalle St to 9th St., and turning north, returning to the staging area. There is also a detour route for traffic traveling on Hwy 99E through 2nd Street. The parade route does impact an ODOT facility, and the applicant will submit the permit for the Route to ODOT. The applicant will be required to obtain the ODOT permit and provide the City with a copy of the approved permit prior to commencing the parade. (**Condition 1**).

Trash and Debris:

Parades will typically generate trash or other debris that may be left on City streets or sidewalks. It shall be the responsibility of the applicant to ensure that no trash or debris generated from the parade is left on any City street, sidewalk, or private property. The City and the HFEA together work on trash removal. (Condition 2).

Time and Duration:

As noted above, the parade is scheduled to begin at 11:00 am on July 4, 2023. It is anticipated that the parade will last no more than one and a half hours. Therefore, the parade permit issued by the City shall be from 10:00 am until 2:00 pm, on July 4, 2023 (Condition 3).

Parade Route and Participation:

The applicant has submitted the traditional route as shown in Exhibit A. The parade shall be limited to the route approved by the City Council (**Condition 4**). The applicant anticipates up to 1,500 parade participants. This number is consistent with prior years. The number of participants and parade route are acceptable.

Pet Parade Route and Participation:

The Pet Parade, which consists of kids (and adults with pets!), any variety of pets, and bicycles, will be staged on Schooling St., between 2nd and 1st St. 10:15am is staging, 10:30 is judging, and the parade is held at 11:30am. 1st St. will be barricaded, up to Smith St. Winners will be announced in the gazebo.

CONDITIONS OF APPROVAL

 Prior to the start of the parade, the applicant shall obtain and provide to the City a copy of the approved parade permit from the Oregon Department of Transportation. The applicant shall comply with all conditions of the ODOT permit.

- 2. The applicant & City shall be responsible to remove any trash or debris on the City street or sidewalks generated by the parade and its participants.
- 3. The Children's Pet Parade will be held on July 3rd, 2023, between the hours of 9:30am and 1:30pm.
- 4. The 4th of July parade shall be held on July 4, 2023, between the hours of 10:00 am and 2:00 pm.
- 5. Both parades shall be limited to the route as approved by the City Council.
- 6. The City will send a letter to the citizens on Schooling St. letting them know about the timing for the staging of the Pet Parade between 2nd and 1st St.

10.05.270 Parade permit.

- 1. Application for a parade permit shall be made to the City Recorder at least 30 days before the date of the parade unless the time limit is waived by the City Council.
- 2. The application shall be signed by the person designated as chairperson of the parade and shall include the following:
- a. The name and address of the person responsible for the parade.
- b. The date of the parade.
- c. The desired route, including assembling and dispersal points.
- d. The number of persons, vehicles and animals that will participate.
- e. The proposed starting and ending time.
- f. The appropriate permit has been received from the State Department of Transportation if the parade crosses or uses Hwy 99E. [Ord. 907 § 4, 2012; Ord. 906 § 1, 2012.]

10.05.280 Issuance or denial of permit.

- 1. The City Recorder shall issue a parade permit conditioned on the applicant's written agreement to comply with terms of the permit unless the City Council finds that:
 - a. The time, route and size of the parade will disrupt the movement of other traffic to an unreasonable extent.
 - b. The parade is of a size or nature that requires the diversion of so great a number of law enforcement officers to properly police the line of movement and contiguous areas that allowing the parade would deny reasonable law enforcement protection to the jurisdiction.
 - c. The parade will interfere with another parade or other activity for which a permit has been issued.
 - d. Information contained in the application is found to be false or a material detail is omitted.
 - e. The applicant refuses to agree to abide by or comply with all conditions of the permit.
- 2. If one or more of the conditions listed in subsection (1) of this section, other than subsection (1)(e) of this section, exists, the City Council may include provisions in the permit that are necessary to alleviate the conditions, including but not limited to:
 - a. Requiring an alternate date.
 - b. Requiring an alternate route.
 - c. Restricting the size of the parade.

3. The City Recorder shall notify the applicant of the decision within five days after receipt of the application. [Ord. $907 \S 4$, 2012; Ord. $906 \S 1$, 2012.]

10.05.290 Parade offenses.

- 1. No person shall unreasonably interfere with a parade or a parade participant.
- 2. No person shall operate a vehicle that is not part of a parade between the vehicles or persons in the parade. [Ord. 907 § 4, 2012; Ord. 906 § 1, 2012.]

10.05.300 Permit revocable.

The City Recorder may revoke a parade permit if circumstances clearly show that the parade no longer can be conducted consistent with public safety. [Ord. 907 § 4, 2012; Ord. 906 § 1, 2012.]

- 8. All grass and small brush within the work area shall be rotary or flail mowed to ground level prior to the beginning of work to facilitate clean up. Disturbed areas shall be reseeded with grass native to the area in an appropriate seeding time.
- √9. The spreading of mud or debris upon any state highway is strictly prohibited and violation shall be cause for immediate cancellation of the permit. Clean up shall be at the applicant's expense. The highway shall be cleaned of all dirt and debris at the end of each work day, or more frequently if so determined by the District Manager or representative.

- 10. Permittee shall replace any landscape vegetation or fences that are destroyed. Any damage that is not fully recovered within 30 days (weather permitting) shall be replaced by ODOT at the expense of the Permittee. A "plant establishment" shall be understood to be part of the planting work to assure satisfactory growth of planted materials. The plant establishment period will begin when the original planting and all landscape construction has been completed and approved. The length of the establishment period will be one calendar year or as defined in the permit Special Provisions.

During construction or maintenance, the work area shall be protected in accordance with the current Manual on Uniform Traffic Control Devices, (MUTCD), Federal Highway Administration, US Department of Transportation, and the Oregon Department of Transportation supplements thereto. Flaggers must have a card or certificate indicating their completion of an approved work zone traffic control course. All traffic control devices shall be maintained according to the American Traffic Safety Services Association (ATSSA), Quality Standards for Work Zone Traffic Control Devices handbook.
- 13. Permittee shall provide a detailed traffic control plan for each phase of the work, showing signs and cones. Plans shall be reviewed and approved by Oregon Department of Transportation in advance of construction or maintenance.
- 14. All damaged or removed highway signs shall be replaced by the permittee. Installation shall be according to MUTCD standards or ODOT specifications, and shall be completed as soon as possible but no later than the end of the work shift.
- 15. No lane restrictions are permitted on the roadway during the hours of darkness, on weekends, or between 6:00 AM and 9:00 AM, or 4:00 PM and 7:00 PM (Monday thru Thursday off by noon on Friday) without prior approval by ODOT.
- 16. Traffic control with lane restrictions are permitted on the roadway with the following guidelines: See attached EXIBIT: DISTRICT 4 LANE RESTRICTIONS, 02/26/2018.

DRAINAGE

- 17. On-site storm drainage shall be controlled within the permitted property. No blind connections to existing state facilities are allowed.
- 18. Excavation shall not be done on ditch slopes. Trench excavation shall either be at ditch bottom or outside ditch area. (Minimum depth at bottom of ditch shall be 36 inches; minimum depth outside of ditch shall be 42 inches).

- 19. Only earth or rock shall be used as fill material and shall slope so as not to change or adversely affect existing drainage. Fine grade and seed the finished fill with native grasses to prevent erosion.
- 20. A storm drainage study stamped by an Oregon Registered Professional Engineer (PE) is required. The study must meet standards of the National Pollution Discharge Elimination Systems (NPDES) when any of the following conditions apply:
 - Whenever a four inch pipe is inadequate to serve the developed area,
 - development site is one quarter acre or larger in size, OR contributes one half cubic feet per second OR directly or indirectly affects state facilities,
 - or as directed by the District Manager or representative.
 - An advance deposit for ODOT hydrology reviews may be required.
- 21. Permittee shall provide on-site retention for storm water runoff that exceeds that of the undeveloped site.
- 22. All water discharged to an ODOT drainage system must be treated prior to discharge. All requests for connection to an ODOT storm system must meet any requirements of the National Pollutant Discharge Elimination System (NPDES). This may include local jurisdiction approval of on-site water quality treatment facilities and/or development of an operation and maintenance plan for any on-site water quality treatment facility, as determined by local jurisdiction

EXCAVATION/CONSTRUCTION

- $\sqrt{23}$. The following ODOT documents and any supplements and subsequent revisions thereto, where applicable and not otherwise superceded by the permit language herein, but only to the extent that they provide standards and performance requirements for work to be performed under the permit, shall be incorporated for use in the permit: "Oregon Standard Specifications for Construction (2018)" and relevant Metric Standard Drawings. ODOT shall have authority over acceptance of all materials and workmanship performed under this permit as stated in Section 00150.00 of the "Oregon Standard Specifications for Construction (2015)." For additional and Special Provisions please refer Supplemental http://www.odot.state.or.us/techserv/roadway/specs/home.htm. Standard Specification books is available on this site.
- 24. Open cutting of pavement is allowed in areas specifically approved by District Manager or representative.
- 25. Trench backfill shall be according to the attached typical drawing, marked as Exhibit _____.
- 26. Open cutting of the highway is allowed with construction in accordance with OAR 734-55-0100. All excavation in paved areas shall be backfilled and the roadway surface patched before the end of each shift. In special cases where steel plates are allowed, said plates shall be pinned and a temporary cold patch applied to the edges. The permittee shall be fully responsible for monitoring and maintenance of temporary patching and steel plating.

- 27. Compaction tests shall be required for each open cut per Oregon Standard Specification for Construction. Compaction tests shall be conducted once for every 300 lineal feet per lift of continuous trench according to the Manual of Field Test Procedures (MFTP), published by ODOT. Percent Compaction shall be 95%. At the discretion of the District Manager or representative, results of compaction test shall be provided to District Manager or representative at applicants' expense.
- 28. Control Density Fill (CDF) shall be used as surface backfill material in place of crushed rock in open trenches that impact the travel portions of the highway. A ¾"-0, or 1"-0 rock will be used for the aggregate. The amount of cement used shall not exceed 3.0% of the total mixture's weight. Maximum compressed strengths must not exceed 250 pounds per square inch (psi).
- 29. Surface restoration shall be a minimum of eight inches of hot asphalt-concrete (AC), compacted in two inch lifts, or match existing pavement depth, whichever is greater. Sand-seal all edges and joints.
- All aggregate shall conform to Oregon Standard Specification for Construction, Section 02630 -Base Aggregate.
- 31. Any area of cut or damaged asphalt shall be restored in accordance with the included attachment "drawing supplied by the applicant. For a period of two years following the patching of paved surface, permittee shall be responsible for the condition of permittee's pavement patches, and during that two year period shall repair to District Manager or representative satisfaction any of the patches which become settled, cracked, broken, or otherwise faulty.
- 32. An overlay to seal an open-cut area shall be completed prior to the end of the construction season, or when minimum temperature allows per "Oregon Standard Specification for Construction" and any subsequent revisions thereto. Typical overlay shall be 1.5 inches deep and cover the affected area from edge of pavement to edge of pavement, and taper longitudinally at a fifty feet to one inch (50': 1") ratio. Taper may be adjusted by the District Manager as required. For a period of two years following this patching of the surface, the permittee shall be responsible for the condition of said pavement patches, and during that time shall repair to the District Manager or representative's satisfaction any of the patches which become settled, cracked, broken or otherwise faulty.
- 33. Highway crossings shall be bored or jacked. Bore pits shall be located behind ditch line or in areas satisfactory to the District Manager. Unattended pits shall either be protected by a six-foot fence, backfilled, or steel plated and pinned.
- 34. Permittee shall install a "tracer wire" or other similar conductive marking tape or device, if installing any non-conductive, unlocatable underground facility, in order to comply with Oregon Utilities Coordination Council (OUCC), per OAR 952-01-0070 (6).
- 35. Trench backfill outside of ditch line or in approved areas can be native soil compacted at optimum moisture in twelve inch layers to 90% or greater of the maximum density.
- 36. Native material that is found to be unsatisfactory for compaction shall be disposed of off the project and granular backfill used.

- 37. Trench backfill in rock slope or shoulder shall be crushed 1"-0 or ¾"-0 size rock compacted at optimum moisture in eight-inch layers. Compaction tests shall be conducted according to the Manual of Field Test Procedures (MFTP), published by ODOT. Percent compaction shall be 95%. At the discretion of the District Manager or representative, results of compaction tests shall be provided to District Manager or representative at applicant's expense.
- 38. Where excavation is on fill slope steeper than a two to one (2:1) ratio, slope protection shall be provided using four-inch size rock laid evenly to a minimum depth of twelve inches.
- 39. No more than 300 feet of trench longitudinally along the highway shall be left open at any one time and no trench shall be left in an open condition overnight (during non work hours).
- 40. Areas of disturbed cut and fill slopes shall be restored to a condition suitable to the District Manager or representative. Areas of erosion to be inlaid with an acceptable riprap material.
- 41. All underground utilities shall be installed with three-foot or more of horizontal clearance from existing or contract plans guardrail posts and attachments. All non-metallic water, sanitary and storm sewer pipe shall have an electrically conductive insulated Number 12-gauge copper tracer wire the full length of the installed pipe using blue wire for water and green for storm and sanitary sewer piping.
- 42. Any area of cut or damaged concrete shall be restored in accordance with the attached Typical Section-Pipe Section under sidewalk.
- 43. Utility markers and pedestals shall be placed as near the highway right-of-way line as practical. In no case shall pedestals and line markers be located within the highway maintenance area.
- 44. No cable plowing is allowed within the lateral support of the highway asphalt (i.e. at six feet lower than the edge of the asphalt, no plowing within nine feet of the edge of the asphalt).
- 45. Review by ODOT Bridge Engineers is required for all proposed bridge and structure attachments and for utility or any facilities to be installed within sixteen feet of bridge foundations, supports, walls or related, or within the influence zone of bridge facilities.

Miscellaneous:

- 46. Permittee shall be responsible and liable for (1) investigating presence/absence of any legally protected or regulated environmental resource(s) in the action area; (2) determining any and all restrictions or requirements that relate to the proposed actions, and complying with such, including but not limited to those relating to hazardous material(s), water quality constraints, wetlands, archeological or historic resources(s) state and federal threatened or endangered species, etc., (3) complying with all federal, state, and local laws, and obtaining all required and necessary permits and approvals.
- √47. If the permittee impacts a legally protected/regulated resource, permittee shall be responsible for all costs associated with such impact, including, but not limited to all costs of mitigation and rehabilitation, and shall indemnify, and hold ODOT harmless for such impacts and be responsible and liable to ODOT for any associated costs or claims that ODOT may have.

- √48. Plans are approved by ODOT in general only and do not relieve the permittee from completing construction improvements in a manner satisfactory to ODOT. The District Manager or representative may require field changes. When revisions are made in the field, permittee is responsible to provide "as built" drawings, within 60 days from completion of highway improvements, and shall submit them to the District Office issuing the permit.
- 49. Permittee shall be responsible for locating and preserving all existing survey monumentation within the work area in accordance with ORS 209.150 and/or 209.155. If monumentation or its accessories are inadvertently or otherwise disturbed or destroyed, applicant shall be responsible for all costs and coordination associated with it's reestablishment by a professional licensed surveyor.
- 50. An advance deposit of \$__0.00______ is required for project associated costs incurred by ODOT. Such costs will be identified and estimated by ODOT, and include, but are not limited to review of studies and calculations involving hydraulics/drainage, geotechnical, traffic and traffic control plans, signal, roadway design, bridge and other engineering support. Excess funds remaining in the account upon completion of billing will be refunded. If ODOT costs exceed the deposit amount, permittee shall be billed for the difference.



STAFF RECOMMENDATION:

Staff recommends the City Council authorize the City Administrator to approve the most awesome event in the region!

BACKGROUND INFORMATION:

Harrisburg Municipal Code (HMC) Chapter 9.52 requires a Public Event Permit for any event that garners more than 100 participants or attendees, or if an event is required to obtain a permit from Linn County. Because this is a regional event that has been in operation for 71 years, the City Administrator has determined that no additional notice of the event needs to be sent in general to citizens. Because there is a Pet Parade this year, being held on July 3rd, citizens on Schooling Street will be informed of staging to be held between 2nd and 1st St.

HMC 9.52 states that it is the City Administrator who authorizes and approves all public event permits. Because the City Administrator is also the Vice-President of the HFEA (Harrisburg Festival and Events Association), the City Council is being asked to authorize the City Administrator to approve the event permit, because there is a slight conflict of interest in the City Administrator approving their own event permit, without someone else in authority reviewing the event permit in its entirety.

The permit process is very involved, and staff feels that the City Council would enjoy seeing the level of planning and complexity involved in operating an event of this size. It's also important that the City follows its own requirements for an event like this. The

criteria below represent the information that the City Administrator must consider when approving the permit. The permit was completed more than 30 days in advance of the event itself, as required by HMC 9.52, and is located in **Exhibit A**.

HMC 9.52.100: Criteria applied to the decision-making process:

(1) Noise that will come from the public event that may impact neighboring properties, including information on any amplified sound.

Findings: Noise will be generated in multiple places during the 4th of July, and for the Pet Parade on July 3rd. The loudest noise is from the parade itself, and the fireworks. In the parade, held between the hours of 11:00 and 12:30, there can be bands, music playing on floats, sirens, and general noise from multiple engines and equipment being operated. The timeframe is during the day, and the event has been held for 71 years, therefore citizens are expectant of the level of noise that is generated.

The fireworks are the loudest of the events that the HFEA holds. Again, this event has been held for 71 years, and only two of those years did not include fireworks. Citizens look forward to the fireworks display on an annual basis. Standard noise requirements, and timeframes for any bands operating are the same throughout the year, typically ending at 11:00pm. Bands will play during the day. Outlaw Shine will be playing at the Gazebo around 1:00 in the afternoon, and somewhere after 5:30, Cornerstone and the Walters will be playing, ending with a presentation of the flag, recitation of the Declaration of Independence, and pledge of allegiance.

The Pet Parade will be relatively low in noise compared to the other parade, but there is still a chance of horns, and pets making noise, including lots of barking. Neighbors on Schooling will be notified about the Pet Parade on July 3rd.

The City Administrator finds that the level of noise from this event is not excessive based upon the 71st year of the event being held in the City of Harrisburg. This criterion has been met.

(2) Whether or not dust may be an issue.

Findings: Dust is already present on the roadways during this event, and a few hundred vehicles will spread that dust somewhat. Otherwise, staging is being held in parking lots, on grass fields, and City streets. **The City Administrator finds that excess dust will not be generated for this event. This criterion has been met.**

(3) Provisions for dealing with trash containment and disposal.

Findings: Trash containment and disposal is directly provided by the City of Harrisburg. Multiple trash barrels and recycling barrels are provided throughout the event and are focused on areas in which more trash is generated, such as near the food vendors. The HFEA also provides volunteers who help the City the day after the event, by going through heavily trafficked areas, and picking up garbage. **The City Administrator finds that provisions for dealing with trash containment and disposal, and therefore this criterion, have been met.**

(4) Other information relative to the impact the event may have on health and safety issues, or the convenience of neighbors near the event or the general public.

Findings: Communication about the event is provided on multiple platforms, including the City Newsletter, website, and Facebook. No parking signs are placed a minimum of three days ahead of the event, as required by traffic law in order to prepare people for vacating the streets along the parade route. The Budget Committee has recommended approval of the budget to the City Council in June, which includes budgeting for contributions to both the 4th of July and the Harvest Festival. The additional officers last year were a great addition to the event, and one that the City will continue to pay for. In addition to 4 LCSO deputies for most of the day, (and attendance exceeding our contract) the City will also have City of Coburg reserve and some regular officers attending and will engage again with the Linn County Posse. This event and the presence of the officers is another great way for them to engage with the community. Their presence helps to control the crowds and prevent problems from arising. It also provides the HFEA and City with more officers to control intersections during dispersal following the parade, and the fireworks.

White lines and cones are set up on the parade route to keep kids behind them, and HFEA always struggles to provide enough safety monitor volunteers to help corral kids during the parade. This is a great low-key way for citizens to help with the event, with fairly little effort. (Please see the City Administrator if you are interested in assisting as a volunteer at this level!) A safety corridor has been added to the corner of LaSalle and 3rd Street, which will help to control pedestrians in an area where large trucks are routed to turn into the detour area during the parade. One bouncy (obstacle course) will be located at BN park, and the kids' games will resume following the parade.

There have been so many positive comments, that the HFEA has decided to keep the larger fireworks, as well as a slightly longer show. Because the fireworks cost an additional \$3,000, on top of material price increases, the HFEA has started a new campaign; "the more money we raise, the bigger the boom!" Fireworks are strictly regulated by the State Fire Marshal, and the location for where they can be fired from is also regulated. Safety regulations around the fireworks is strictly enforced by the Harrisburg Fire/Rescue District, who is the 'sponsor' of the fireworks. They also provide the pyrotechnicians.

A Parade Permit through ODOT has been previously approved by the City Council, and in addition, the HFEA also applies for a Linn County Road Use Permit Application. This is required because the Firecracker 5K uses the Sommerville Loop/Kramer street section that is outside the jurisdictional boundaries of the City of Harrisburg. Facility permits were already filed with the School District as well.

Vendor booths and the Chicken BBQ are expected to take place as normal. The Harrisburg Fire/Rescue Volunteers also will be supplying their ever-popular pancake breakfast on the 4th of July. Because of the huge increase in prices, the HFEA reduced the number of porta-pots in the City; that plan is being adjusted based on usage in different areas of town. Additional washing units are still in place, throughout the event.

A new vendor this year, The Hoggboard Co, d.b.a. Chief's Brew House, will be set up in the City Hall Parking Lot. This will help to contain the area being used for the beer garden. The beer garden must comply with OLCC guidelines. In addition, barriers must

be set up between the beer garden, and the general festival attendees, in order to show a clear demarcation between the area in which liquor is allowed. Attendees will not be allowed to carry alcohol beyond the boundaries, and the vendor must also provide alcohol monitors. An approved OLCC permit must be provided to the City for this vendor permit to operate.

The City Administrator finds that the provisions to follow safety requirements are in place, with the exception of the temporary liquor license. The license must be provided to the City prior to the event. As conditioned, this criterion has been met.

f. An event site plan designating, at a minimum, a traffic plan including emergency access routes, proposed parking areas, setbacks from adjoining properties, location and quantity of proposed sanitary facilities, source(s) of potable water, and any proposed overnight camping areas.

Findings: A traffic plan is designated and shown on several maps. The detail in the event permit includes a complete schedule of when intersections are closed down prior to the parade, and how to route people to staging points prior to the parade. Three different emergency routes to the City are set up, and the HFEA can communicate to volunteers at the three entrance points for allowing EMS service vehicles to enter the parade. The Harrisburg Fire/Rescue District is involved in multiple areas, including in the parade, as well as providing pyro-technicians for the fireworks. An engine is also kept near City Hall in the late afternoon/evening, so that they can easily respond to any problems at or near Riverfront Park. There are two dedicated ADA lots, otherwise, parking is provided throughout the event areas on city streets and in parking lots. Another service group typically provides larger paid parking areas in other areas in town. By barricading the city streets at 2nd Street, the City and HFEA alleviate a lot of congestion and vehicles maneuvering out of tight local streets when vehicles are confronted with a wall of people.

As noted earlier, the Honey Buckets map shows the locations of porta-potties, and wash stations throughout town. Some of the locations are conducive to other events, such as the 5K, and the car hop. Porta-Potties have been adjusted based on feedback from the previous year. Additional maps are created and released to the general public closer to the event, which shows the location of restroom and wash facilities. Potable water is provided by vendors and is otherwise also available in public flushing facilities. Overnight camping is not allowed in City parks, or in any other location inside the city limits of Harrisburg.

The High School plans on holding a regional wrestling event, which occurs on the same Sunday as the Firecracker 5K event. Therefore, the 5K will now be staged from the parking lot at the Middle School/Grade school. In addition, Chief's Brewhouse is planning on having a Beer Garden this year, which will be located at the City Hall Parking Lot. This will require a temporary liquor license permit to be applied for. Chief's Brewhouse will be applying for the temporary liquor license, and evidence of approval by the OLCC is required to be provided to the City prior to the event.

As conditioned, the City Administrator finds that this criterion has been met.

g. An estimate of the total number of persons attending and participating in the event.

Findings: The HFEA typically plans for numbers between 10,000 and 15,000 people for all the events. That includes participants as well as spectators. **The City Administrator therefore finds that this criterion is met.**

h. Plans for signage.

Findings: The City puts out much of the signage required for traffic laws, and to meet requirements in order to tow vehicles that are blocking the parade route. Signage is throughout the event, in strategic places, to direct citizens to different events. **Therefore, the City Administrator finds this criterion has been met.**

Finally, as general information for the City Council, a Son of Liberty, Raymond Brown, will also be present, and this year, hopes to be able to recite the Declaration of Independence, at approximately the same time as the national anthem and the pledge of allegiance.

Overall, and as conditioned, the City Administrator finds that the criteria to hold this public event in Harrisburg has been met. Therefore, the City Council is recommended to authorize the City Administrator to approve the event permit for the 71st Old Fashioned 4th of July Event.

CONDITIONS OF APPROVAL

- 1. A temporary liquor license shall be obtained by Chief's Brew House, along with specific insurance requirements, prior to the 4th of July. Any specific requirements of the OLCC will be met by the owners of the Hoggboard Co, Chief's Brew House.
- 2. A barrier shall be placed around the beer garden area, according to OLCC guidelines, which shall establish a clear demarcation between the areas in which alcohol is allowed, and where it isn't.



Pulblic Event Permit

Public Events in Harrisburg are allowed through Harrisburg Municipal Code (HMC) Chapter 9.52. A public event in Harrisburg is required for any activity below, where there are likely more than 100 participants or attendees. A public event is required for events in which:

- 1. Persons are permitted or invited to attend, and where a fee is charged; or
- 2. A voluntary contribution is paid or solicited for the privilege of attending; or
- 3. Any money is raised or items are sold to defray the expenses of such events, unless exempted under Chapter 9.52; or
- 4. It is an event which is required to obtain a permit from Linn County pursuant to the Linn County Outdoor Assembly Peace, Health, Safety, and Welfare Code, found in Linn County Code Chapter 580.

There are exceptions to the requirement of a public event permit; those are included in HMC Chapter 9.52. Please contact the City of Harrisburg if you feel that your event should fall under the exemptions for obtaining a permit. The Harrisburg Municipal Code can be found by going to our website, at www.ci.harrisburg.or.us.

Permit Application Fee: \$165 for events 500 people or less; \$250 for events with more than 500 people. Permit Fees are set by Council Resolution. This event is Harrisburg's largest, and results in regional tourism for Harrisburg; therefore, a fee has never been charged.

Permits are required to be submitted at least 30 days prior to the first day upon which such public event is to be held.

Trash: City sets garbage cans throughout event area, along with recycling at the riverfront areas. Need additional garbage cans at vendor area, if garbage will not be emptied after a certain time.

HFEA provides volunteers to help with picking up event trash in event areas the day after the event to assist PW crew.

Sanitary: Porta-Pots & Hand Wash Stations from Honey Buckets – See attached map

Public bathrooms at the Museum and by the River open during nearby events

*HFEA reduced the number of units last year, as the prices for these have become extremely expensive. We are now adjusting and adding in units where needed after adjusting last year.

Fireworks: City assists HFEA by digging pits in the field where fireworks will be set off (See the Fireworks Map for area that is cleared for fireworks). The Fire Department provides licensed pyrotechnic operators (Up to 6), as well as providing fire trucks and water tenders in the field being used for setting off fireworks. *Fireworks are strictly licensed by the state and state fire marshal.*

<u>Insurance Requirements</u>: If the decision maker determines that the public event creates a significant potential for injury to persons or property, the applicant shall furnish evidence of liability insurance. If the organizer doesn't file proof of non-cancellable insurance at least 10 days prior to the first day of the event, the City Administrator may void a permit for the public event, and will notify the organizer at the address above.

- The City of Harrisburg and the HFEA have a MOU stating that general insurance requirements are covered under the City's liability umbrella.

Preapplication Conference: A preapplication conference might be required before the application is deemed complete by the City. Any preapplication conference shall take place within 10 working days of receipt of the application by the City.

Application Review: The City Administrator shall review the application for completeness. Each reviewing authority shall review the application, and determines whether the application contains sufficient information to show that the applicant can comply with the requirements of HMC 9.52. (Reviewing authorities means any government official designated by the City Council to review an application for a permit to conduct a public event. It can also include, but is not limited to the City Administrator, the Public Works Director, the Chief of Harrisburg Fire and Rescue, and the Linn County Sheriff or his/her designee).

Upon receipt of the complete application, the City Administrator will mail a notice to property owners within 300 feet of the planned location for the proposed public event. The City Administrator is required to provide property owners with at least ten days from the date of the mailing to comment in writing on the proposal.

The City Administrator may impose any conditions deemed appropriate, regardless of whether they are included in HMC Chapter 9.52. Written notice of conditions and approval shall be provided to the applicant.

The City Administrator can deny the application if:

- 1. The applicant is unable to demonstrate compliance with or the ability to comply with the rules and regulations set forth in this chapter.
- 2. The City Administrator is unable to make any of the findings of fact required in HMC Chapter 9.52.

Any party may appeal a final decision of the City Administrator on a public event application to the City Council by providing written notice to the City Administrator no later than 10 days after the mailing of the notice of decision. Any hearing on the appeal shall be conducted de novo. Notice of the hearing shall be provided to the appellant and to all participating parties, either orally or in writing, at least 10 days prior to the City Council hearing.







DISPLAY AGREEMENT AND PURCHASE ORDER Amendment of Section 5

AS AMENDED THIS AGREEMENT ("Agreement") is entered into on MANCH 13, 2023 , by and between Western Display Fireworks, Ltd., an Oregon corporation, whose address is set forth above, ("Western") and Harrisburg Festival & Event Association/Harrisburg Fire Department, whose address is PO Box 378, Harrisburg, OR 97446 ("Sponsor"). Western and Sponsor are sometimes individually referred to as a "Party" and collectively as the "Parties."

In consideration of the mutual terms and conditions set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. Proposal. Western agrees to supply, and Sponsor agrees to pay for, a fireworks display on the following designated date: July 4, 2023, as detailed in Proposal #23-7198, which is attached hereto and incorporated herein by this reference, (the "Display").
- 2. Price and Payment Terms. Total price of SIXTEEN THOUSAND DOLLARS AND NO/100 (\$16,000,00) is to be paid as follows: 25% of the total price, \$4,000.00 is due by DECEMBER 1, 2022; 25% of the total price, \$4,000.00 is due by JUNE 4, 2023; the remaining balance of the price, \$8,000.00, is due in full on or before July 14, 2023. Interest will accrue at 11/2% per month (an annual percentage rate of 18% per annum) on all unpaid amounts from the date on which the payment was due.
- 3. Western Duties. As part of the total price Western agrees to the following:
 - a. To supply the Display, that is, all shells and other pyrotechnics listed on the Proposal;
 - b. To loan Sponsor the equipment necessary to perform the Display, including mortars, firing equipment and all other required materials necessary; and
 - c. To comply with all federal, state, and local laws, regulations, and ordinances in transferring the Display to the Sponsor; and
 - d. To comply with all local and federal guidelines and obtain any necessary permits to perform the Display, unless otherwise noted in Sponsor Duties.

4. Sponsor Duties.

- a. Sponsor shall comply with all duties as detailed under the Compliance with Laws/Sponsor Responsibilities portion of this Agreement; and
- Sponsor shall obtain all necessary permits necessary to perform the show and comply with all federal, state, and local laws, regulations, and ordinances related to the performance of the Display.
- Insurance. The City of Harrisburg, on behalf of the Sponsor, shall purchase and maintain comprehensive general commercial liability and property damage insurance from a company and in an amount satisfactory to Western. Such policy(ies) shall name Western as an additional insured and shall prohibit cancellation without thirty (30) days notice to Western. The City of Harrisburg, on behalf of the Sponsor will furnish Western with a certificate of insurance confirming that such coverage is in full force and effect prior to June 15. If the City of Harrisburg & Sponsor fails to supply such written verification, Western shall be entitled to refuse to ship or deliver the Display. Western agrees to provide, at its expense, commercial general liability insurance coverage that will cover the conveyance and delivery of the Display to the City of Harrisburg and Event Sponsor.

6. **Indemnification.** Sponsor agrees to indemnify, defend, and hold harmless Western, its agents and employees from and against all claims, costs, judgments, damages and expenses, including reasonable attorney fees that arise from the set-up, performance, and clean-up of the Display to the extent that such are occasioned by any act or omission of Sponsor, its agents and employees.

7. Compliance with Laws.

- a. Sponsor Responsibilities: SPONSOR agrees to perform their requirements in accordance with NFPA 1123 OUTDOOR DISPLAY OF FIREWORKS 2022 Edition (National Fire Protection Association) 8.1 General Requirements. The sponsor of the display shall make provisions for fire protection for the display. 8.1.1 The sponsor shall consult with the AHJ, the local responding fire department (if different from the AHJ) and the operator to determine the level of fire protection required. 8.1.2 The following shall apply to crowd control: (1) Monitors whose sole duty is the enforcement of crowd control shall be located around the display site and at other locations as determined by the sponsor. (2) The AHJ and the operator shall approve the provisions for crowd control. 8.1.2.1 Monitors shall be positioned around the display site to prevent spectators or any other unauthorized persons from entering the discharge site. 8.1.2.2 Where required by the AHJ, approved delineators or barriers shall be used to aid in crowd control. 8.1.2.3 Portions of the display site, other than the discharge site(s), shall be permitted to be open to the public prior to the display as long as the provisions of 4.2.2.2 are maintained. 8.1.2.4 Unescorted public access to the discharge site shall not be permitted where pyrotechnic materials are present during the period before the display. 8.1.2.5 The discharge site shall be restricted throughout the display and until the discharge site has been inspected after the display. Sponsor shall secure and maintain any and all licenses, permits or certificates that may be required by any regulatory body having jurisdiction over the possession and performance of the Display.
- b. <u>Western's Responsibilities:</u> Western shall secure and maintain any and all licenses, permits or certificates that may be required by any regulatory body having jurisdiction over the materials or delivery of the materials herein contemplated.
- 8. Cancellation/Rescheduling by Sponsor. If the Display is cancelled by the Sponsor after receipt of this signed Agreement, Sponsor agrees to pay 25% of the total price (\$4,000.00) for restocking and costs incurred. If the Display is cancelled by the Sponsor within 30 days of the scheduled Display date, Sponsor agrees to pay 50% of the total price (\$8,000.00). If the Display is cancelled by the Sponsor on the date of the Display, Sponsor agrees to pay 100% of the total price (\$16,000.00). By providing notice of not less than 30 days from the original Display date, Sponsor may elect to reschedule the Display to a mutually agreeable date. This date must be within 90 days of the original display date. Western agrees to facilitate this rescheduling and Sponsor agrees to reimburse Western for new permits and other additional costs associated with this change. Sponsor understands that permitting requirements, burn bans and other factors beyond Western's control may prohibit rescheduling of a display. If these factors prohibit the rescheduled Display from taking place then the standard cancellation schedule applies.
- Safety / Weather Forced Cancellation. Sponsor agrees that it shall have responsibility to cancel or delay
 the Display if in the Sponsor's judgment circumstances beyond its control pose a risk to the health and
 safety of any persons or property within the vicinity of the Display.

- 10. **Force Majeure.** Sponsor assumes the risks of weather, strike, civil unrest, terrorism, military action, governmental action, and any other causes beyond the control of Western which may prevent the Display from being safely delivered to Sponsor.
- 11. **Product Performance.** Sponsor recognizes and acknowledges that due to the nature of fireworks, an industry accepted level of 3% of the product used in any display may not function as designed and this level of nonperformance is acceptable as full performance.
- 12. Limitation on Damages. In the event that Sponsor claims that Western has breached this Agreement or was negligent in performing its duties hereunder, Sponsor shall not be entitled to claim or recover monetary damages from Western beyond the amount that Sponsor has paid Western under this Agreement and shall not be entitled to a claim for or recover of consequential damages from Western, including, but not limited to, damages for lost income, business, or profits. Additionally, Western's liability for matters covered by the insurance set forth herein shall be limited to the limits of said insurance.
- 13. Time. Time is of the essence in this agreement. The Parties expressly recognize that in the performance of their respective obligations, each Party is relying on timely performance by the other Party and will schedule operations and incur obligations to third parties in reliance upon timely performances by the other Party and may sustain substantial losses by reason of any failure of timely performance.
- 14. Independent Contractor/No Joint Venture. The Parties agree that Western is an independent contractor, and is not an agent or employee of Sponsor for any purpose. It is further agreed that Western's employees shall be, and remain, the employees of Western and not of Sponsor. Nothing in this Agreement or the actions of Western or Sponsor shall be construed as forming a partnership or joint venture between Sponsor and Western.
- 15. **Attorney Fees.** In the event that either Party to this Agreement shall enforce any of the provisions hereof by any action at law or in equity, the unsuccessful Party to such litigation agrees to pay to the prevailing Party all costs and expenses, including reasonable attorney fees, incurred therein by the prevailing Party.
- 16. **Jurisdiction.** This Agreement shall be governed in all respects, whether as to validity, construction, capacity, performance or otherwise, by the laws of the State of Oregon applicable to contracts.
- 17. Severability. In the event a court of competent jurisdiction determines that any provision of this Agreement is in violation of any statute, law, rule, regulation, ordinance or public policy, then the provisions of this Agreement that violate such statue, law, rule, regulation, ordinance or public policy shall be stricken or modified to the extent that such provision no longer violates such statute, law, rule, regulation, ordinance or public policy. All provisions of this Agreement that do not violate any statute, law, rule, regulation, ordinance or public policy shall continue in full force and effect for all purposes. Furthermore, any court order striking or modifying any provision of this Agreement shall modify or strike the provision in as limited a manner as possible to give as much effect as possible to the intentions of the Parties to this Agreement.
- 18. **Survival.** The terms of paragraphs 6, 12, 15, and 16 shall survive the cancellation or termination of this Agreement.

19. **Entire Agreement.** This Agreement sets forth the entire agreement and understanding between the Parties hereto respecting the matters within its scope and may be modified only in writing signed by both of the Parties hereto.

The pricing and product offered in the Proposal shall remain firm if this Agreement is mutually executed by both Parties on or before December 1, 2022.
