BACKGROUND INFORMATION:

At the start of every fiscal year, the Library Board nominates both a Chairperson and a Vice-Chairperson to serve a one-year term running from June 30, present year, to July 1st of the following year.

- <u>Chairperson</u>: The Chairperson shall preside over all meetings of the Board, set the agenda, and conduct all business through the Board. They will take the lead at all meetings and present the Agenda Bills to the Board and staff. They will inform the Library Supervisor of any items to be included in the agenda at future meetings.
- <u>Vice-Chairperson</u>: The Vice-Chairperson shall serve in the absence of and assume all duties of the chairperson and any other duties that may be assigned by the Chairperson. This person also becomes the Chairperson, if the Chairperson should leave office before the end of their term.

Due to the absence of one board member, the Library Board can choose to table this nomination until the next meeting scheduled for September 5th, 2023 and vote for a protem Chairperson instead.
