## TRC ACCOMPLISHMENTS in 2020:

In case you missed it, 2020 was actually a very successful (although trying at

times) year for TRC. Here are some highlights:

TRC was the recipient of a large donation from One Hundred Women Who Care of Van Buren County. The money is to be used for the Paw Paw River Water Trail in Van Buren County, including the installation of signs on all bridge crossings over the PPR in the county.

TRC applied for and received a grant from the Berrien Community Foundation to fund installation of signs on bridge crossings over the PPR in Berrien County.

Despite COVID-19, TRC and its partner Van Buren Conservation District were able to conduct macroinvertebrate sampling in the two watersheds for a 7th consecutive year. Plans are underway for our Spring macro sampling event tentatively scheduled for Sunday May 2, 2021.

Thanks to a generous donation from Dick and Carol Purdy, TRC was able to conduct it's 4th consecutive year of testing for E. coli in both watersheds. If you would like to see the maps and graphs of our findings now available on our website, please go to: tworiverscoalition.org/ecoli.asp. Also, we are excited to announce that we have applied to EGLE for a grant to do DNA testing as part of our E. coli testing program in 2021.

Paddling with groups was a challenge in 2020, but TRC persevered and held some socially distanced paddling events on both rivers. Also, TRC teamed up with SW x SW CISMA to hold two "Paddle with a Naturalist" events. This was a great opportunity to learn about both invasive species of concern and native species of importance to wetland environments. GOOD NEWS: We will be hosting more "Paddle with a Naturalist" events in 2021! Keep an eye on the "Upcoming Events" section of our website and/or follow us on FaceBook.

TRC super volunteer Dan Burton got us involved in a cool new project to install bird nest boxes in remote areas of the PPR for Prothonatory Warblers. We are currently trying to work out the logistics for some kind of limited group paddle in early to mid June to hopefully view the nest boxes in use.

Finally, the Paw Paw River Water Trail won the prestigious Graham Woodehouse Award for intergovernmental cooperation. TRC is proud to be part of the consortium of governments and organizations who make up the steering committee for PPRWT. But we also give ourselves a little pat on the back for successfully nominating the water trail for the award.



### CITY MANAGER'S REPORT MARCH 22, 2021

### **5 WEST MAIN STREET UPDATE:**

Chuck Moore, the Building Inspector recommended to the County Treasurer to engage the services of a Structural Engineer to conduct a structural inspection on the building before anything is done to it. It is my understanding that the recommendation will be taken to the March 18, 2021 County Land Bank meeting for discussion and possibly approval for the structural Inspection. I hope to bring additional information to the commission as soon as available.

### <u>RECREATIONAL MARIJUANA PAYMENTS: DISTRIBUTIONS TO LOCAL UNITS OF</u> <u>GOVERMENT</u>

Michigan Department of Treasury started distributing more than \$45.7million collected from taxes and fees under the Michigan Regulation and Taxation of Marihuana Act (initiated Law 1 of 2018).

As part of the Act, after funding statutorily defined distributions, disbursements will be as follows:

- 15% to municipalities in which a marihuana retail store or a microbusiness is located, allocated in proportion to the number of marijuana retail stores and marijuana microbusinesses within the municipality.
- 15% to counties in which a marijuana retail store or a marijuana microbusiness is located, allocated in proportion to the number of marijuana retail stores and marijuana microbusinesses within the county.
- 35% to the School Aid Fund to be used for K-12 education.
- 35% to the Michigan Transportation Fund to be used for repair and maintenance of the roads and bridges.

Cities, villages, townships and counties will be receiving nearly \$10 million under the Act. The distribution rate for FY2020 Recreational Marijuana payments is slightly over \$28,000.00 per licensed marijuana retail sore and microbusiness.

The City of Hartford received \$28,001.32. Payment based on the number of licensed retail stores and microbusinesses located within municipalities' jurisdiction.

### **GREAT LAKES CULTIVATION ADVISORS, LLC.**

Mr. Howard Ballard of Great Lakes Cultivation Advisors, LLC presented the Site Plan for his property located on 501 Hillsborough Street, Hartford, MI 49057, for review and approval during the regular meeting held on March 8,2021. After the review, the Planning Commission recommended the approval of the Site Plan to the City Commission at the next meeting on March 22, 2021. The project would start with the existing building with 100 grow plants and an eye on future plan to expand.

### **PROSPECT STREET & WENDELL AVENUE RECONSTRUCTION UPDATE**

These projects continue to move along very well. Michigan Department of Transportation has finally approved and signed the contract with the City. A pre-construction meeting was held on March 15, 2021. The Contractor, Brenner Excavating has elected to start the project sooner around May 10, 2021, instead of the end of the School year with the possibility of completion by the end of June.

The Pre-construction meeting for Wendell Avenue was held on March 19, 2021, the project is not expected to start until the end of the School year, with an estimated completion date by September 30, 2021.

#### STATE REVOLVING LOAN FUND

I mentioned in my last report that it is time to respond to the issues that the SAW Grant exposed within our Sewer System. We have gone through the list of vulnerable areas and prioritized the sections that demand immediate attention.

Unfortunately, this is going to be an expensive undertaking. The list of the projects identified is a little over \$4million dollars, but as a disadvantage community, we could get as much as twenty –five percent grant. The rest could be financed for up to thirty years at a rate of 2.175%. We must be able to justify the resources to pay back the loan before it can be approved. A rate adjustment is definitely necessary to undertake this project.

Chris Cowgill, Wightman's, is moving out of the area March 2021, this will be his last meeting. Ten bids were received for the Wendell Street project and recommends awarding contract to the low bidder Krone Excavating, LLC at a cost of \$309,141.00 contingent on MDOT's approval of the contract. The project construction should begin in early April.

Mike Hnatiuk, West Michigan Railroad, addressed Councils concerns of train cars moving through the train crossing on North Center with the gates deactivated. The gates are disengaged at times when there are a lot of train cars on the spur and parked in areas where it would engage the gates continually blocking the roadway traffic flow on North Center St. A railroad worker always checks to make sure the roadway is clear before they move a train car through the crossing when the gates are disengaged. CSX is parking extra train cars and parking them in the zone which would leave the crossing gates engaged/down and blocking traffic. West Michigan Railroad has extended the spur East behind Meacham Farms on 52<sup>nd.</sup> Most loading and un-loading of train cars is now being done outside of the City limits.

Tim Dibble, Hartford Motor Speedway – came to protest the invoice he received for the water meter on his new building. He does not own it, and cannot remove it as it stays with the building. The City Manager, explained new meters are charged to new customers based on the City's fee schedule.

### Reports of Officers, Boards & Committees; Routine Monthly Reports from Departments:

- A. **Police & Ordinance** City Manager & Mayor had a discussion about blight ordinances, solution is to issue citations to habitual offenders.
- B. **Fire Dept** procedures of the joint agreement were not followed at the February joint meeting. Board pay has to be agreed upon by the City & Township Boards and approved at the joint meeting, as well as the budget. The City Manager has concerns regarding the 10% average yearly growth to the budget and recommends amending the joint agreement to include language that address the level of the departments fund balance, growth of the department, spending down the fund balance before asking for an increase to the budget, and include a remedy if one of the municipalities does not agree to the presented budget.
- C. Ambulance Bill Mears, Pride Care, due to COVID-19 revenue has fallen dramatically and will be taking a loss for the next few years. Expanding or building a building in the area as previously discussed would not be feasible at this time, however they would be open to leasing space if it were to become available. They are building a new facility in Dowagiac to encourage employee retention. Shortage of personnel has been at critical levels; in response they are sending three five people to paramedic school as well as paying their living expenses. COVID-19 has also affected staffing and operations but the organization has still been able to maintain response times below the stated contract time of 12:00 minutes.
- D. Van Buren County Commissioner Mike Chappell, Commissioners approved video meeting rooms for jails & courts, updated five-year recreation plan allowing for communities that do not have a recreation plan to apply for grants, accepted resignation of the road commissioner and hired his replacement.
- E. **Public Works** no discussion
- F. Wastewater Treatment Plant follow-up meetings with Wightman have not been set.
- G. Treasurers, Investment & List of Bills no discussion
- H. City Manager <u>Consolidation & Contamination Risk Reduction (C2R2) Grant; Clean Water &</u> <u>Drinking Water State Revolving Funds & the Strategic Water Quality Initiatives Fund (SWQIF)</u> -Exploring funding options to respond to the high priority issues of the Water & Sewer system, identified through the SAW grant & water reliability study. A rate increase will need to be part of the funding package. <u>Proposed Road Construction Projects Update</u>: Prospect & Wendell streets projects should begin in the spring. <u>Hartford Marathon Station</u> – The company is asking the City to accept the contaminated Right-of-Way as is. The City Manager has sent the request to EGLE for review and recommendation.

Line the west half of the existing 18-inch interceptor sewer on County Road 372 (ssGM-856, ssGM-859, ssGM-853, ssGM-854, ssGM-855, ssGM-857 ssGM-858, ssGM-860, and ssGM-1163, between ssMH-948 and the CR-3/2 Lift Station). Replace the castings on manholes ssMH-950 and ssMH-952.

### **Project Justification/Benefit**

The west half of the interceptor sewer along County Road 372 was noted to be suffering from surface damage with aggregate visible, which is the first step in the degradation of concrete pipe. It was also noted as having multiple "Infiltration" defects of varying significance. Infiltration occurs when sanitary sewer pipes are below the ground water table and clean ground water enters the sewer through defects in the pipe and/or joints. It results in clean water being added to the flow to the WWTP, resulting in additional treatment costs at the plant. Depending on the constituents of the ground water, it can also cause treatment issues at the WWTP. Lining this half of sewer will prevent them from incurring further concrete damage, eliminate the danger of sewer collapse, and eliminate major sources of infiltration along the interceptor sewer lowering flows to the WWTP and reducing treatment costs and may help to alleviate treatment issues being experienced at the WWTP with their UV disinfection system. The manhole castings to be replaced are showing signs of severe corrosion, placing their structural integrity in question.

Replacing these two blocks of sanitary sewer will eliminate the risk of the sewer and road above collapsing and eliminate a segment of concrete sewer of unknown age.

In addition, all of the manholes along these two blocks are brick manholes of unknown age, considered to be among the oldest in the system and likely nearing the end of their useful lives. Replacing these manholes will eliminate six manholes in danger of collapsing.

Replace the parallel 8-inch and 10-inch siphons that cross under the Paw Paw River beside CR-687 near 54th Avenue and line the 15-inch sanitary sewer from the end of the siphon to the CR-687 Lift Station. Replace the casting for manhole ssMH-937 to the northeast of the CR-687 Lift Station.

If left unrepaired, the current void will continue to get larger and the other hole could also begin to form a void, placing the road above in danger of collapsing. The fractures also place the sewer in danger of structural failure. 

**<u>Approval of the Agenda:</u>** Motion made by D. Langston, seconded by N. Spoula, to approve the March 8<sup>th</sup>, 2021 agenda as written. All present in favor, motion carried.

**<u>Approval of the Minutes</u>**: Motion by J. Fuller, seconded by D. Langston, to approve the January 11<sup>th</sup>, 2021 minutes as written. All present in favor, motion carried.

#### Public Comments Not on the Agenda:

\*\*Water / Sewer update – due to PFAS contamination, Wendell & Prospect St., large water project coming up. City has applied fo a 3 Mil grant for the project, and will include connecting the two mobile home parks, Viking & Applewood. J. Fuller asked how far the new line will go – not past the sewer plant.

\*\*5 West Main update – building will need to pass inspection, if not, will be taken down.

\*\*The Catholic church expansion has not started yet.

<u>New Business</u>: Site Plan Review – Great Lakes Cultivation Advisors, LLC. Property located off of Marion Ave. on Hillsborough St. in the City of Hartford – will be a marijuana growing & packaging facility only. T. Kling obtained & reviewed the Site Plan prior to Planning meeting, making sure it met all of the requirements of the Site Plan Check List. Went over & shared with all present.

Howard Ballard, owner of property, presented Site Plan along with Alex Frazier w/Hurley & Stewart engineering firm from Kalamazoo. Mr. Ballard has already purchased the property, owns outright, and has a partner from Oregon. He's working w/Brooks Architecture from Stevensville. Has already been working on property clean up & prep for building. City had already done a good job in the years prior cleaning up the property & removing contamination. There is EPA Brownfields grants & federal funding available to aid in any further cleanup if needed. J. Fuller questioned whether storm water run off would cause extra contamination. Mr. Ballard said no, they will not be doing anything to disturb the current drainage. They're working on getting 100% cleaned up prior to completion & future project. With known contamination – has to be reviewed by state environmental engineer. After thorough review of the Site Plan, and questions answered, ready for motion to be made.

Motion made by D. Langston, seconded by N. Spoula, to recommend the Site Plan Review for the Great Lakes Cultivation Advisors, LLC grow facility to the City Council for final review & approval. Per roll call, 4 in approval, 1 decline by J. Fuller, due to not legal under federal law yet, majority present in favor, motion carried.

**Old Business:** D. Langston inquired whether or not Joe Deckard's carport was approved – the City did approve to let it remain in place.
