and ma sto	e City reserves, for itself and for its successors and assigns, a permanent utility easement on, over, across a under the Vacated Street Segment, for the purpose of constructing, installing, replacing, repairing intaining, and improving utilities, including, without limitation, communication lines, sanitary sewers rm sewers and watermains, along with related appurtenances, together with the right of ingress and egress the purposes above described.

	addition, the City Clerk is authorized and directed to file a copy of this resolution with the Department of tensing and Regulatory Affairs' Office of Land Survey and Renumeration.
