Manager West gave a brief overview of the Mayberry Sewer Assessment situation and the proposed three-year extension for the sewer payment in three installments. Mayberry also requested a water agreement that would hold REU rates for three and a half years until June of 2025. Manager West stated Supervisor Fountain and he discussed the situation with Bob Schroeder of Mayberry Homes to finalize an agreement. He stated that we have just received a wire transfer for the first sewer assessment installment of \$671,000. The second payment would be due one year from now and the third a year after that. Trustee Petrucci inquired as to whether the water agreement will go with the land if the property was to be sold. Manager West stated that we would consider transferring the water agreement to the buyer. Trustee McMullen inquired as to the details of the installment payments. Manager West stated that the payments will be three equal principal payments with interest accruing and due on the second and third payments. Trustee Germane inquired as to whether we would be reimbursed for our legal fees and Manager West stated that we would not be reimbursed. Trustee O'Connell inquired as to the details of the water agreement and Manager West stated that the agreement will hold the pre-approved price of 535 water REU's for three and a half years until June of 2025.
