Commissioner Capossela gave the ARB updates. He shared that the ARB is reviewing a demo permit application on a structure at the corner of St. Paul and Washington Street. He shared the information from the architect on the stability of the home. He shared that the ARB will be visiting the site at their next meeting.

X. TOWN COUNCIL UPDATES

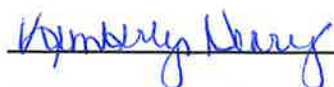

Mr. Baker shared with the Planning Commission the Town Council updates stating that citizens from the Robinson Paradise development address the Town Council on the storm water flooding on their properties. He shared that staff will be meeting the residents on site in the near future. He also shared that the Town recently had a historic walking tour. He also shared that the Council has sent out an RFP to do a compensation study. He continued by sharing that staff is working on an RFP for the Town Park Pavilion. He shared that the Council is also working on updating the Outdoor Event Ordinance. He congratulated that Haymarket Police Department on a successful National Night Out Event. Councilmember Baker shared information on the upcoming Summer Concert scheduled for Saturday, August 16th. Lastly, Councilmember Baker shared that the Town Council and staff will be honoring former late Councilmember Bob Weir at their September 2nd Regular meeting. He shared that staff is working on a proclamation and the Council is inviting the public to come and pay tribute and encouraging them to share memories of Bob. He also shared that Prince William County Board of Supervisors would be doing a proclamation at their next meeting and that a celebration of life event is scheduled for September 27th at Giuseppe's.
