Re: Fiscal Year 2025-2026 Budget Amendment

Virginia Code § 15.2-2507 allows a locality to amend its budget and adjust the aggregate amount to be appropriated during the current fiscal year. However, any amendment that exceeds one percent of the total expenditure shown in the currently adopted budget must be accomplished by advertising a meeting and holding a public hearing prior to acting on the amendment. Since the requested amendment does not exceed that amount, a Public Hearing is not required. The Council may adopt the amendment at the October 27th 2025, Special meeting.

REQUESTED BUDGET AMENDMENT

1. This budget amendment updates the Fiscal Year 2025–2026 budget to include funding for a Town Compensation Study. A total of \$20,000 will be transferred from the Town's Reserve Funds (line item 3500) and added to Professional Services (line item 1211032) to cover the cost of the study. This action follows the direction of Town Council, which will award the contract for the compensation study through the RFP process.
