WHEREAS, the Borough accepted bids on Thursday, July 10, 2025 at 10:00am for the Improvements to Overlook Park and Frank Hall Park Project; and

WHEREAS, a total of five (5) bids were received for the aforesaid project which were reviewed by the Borough Engineer's Office; and

WHEREAS, SDW Construction Inc. was determined to be the lowest bidder for the aforesaid project; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-23.3 the bidder, in writing, requested that the Borough allow for the withdrawal of the bid due to a mistake that was made; and

WHEREAS, the Borough Engineer reviewed the aforesaid request and was in agreement that the request to withdraw the bid met the requirements that are set forth in <u>N.J.S.A.</u> 40A:11-23.3; and

WHEREAS, the Borough Attorney has reviewed the request, as well as the reasons therefor along with the Borough Engineer's recommendation and recommends that the bidder be permitted to withdraw its bid.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Highlands that it hereby accepts the withdrawal of SDW Construction Inc.'s bid for the Improvements to Overlook Park and Frank Hall Park Project.

BE IT FURTHER RESOLVED, that pursuant to <u>N.J.S.A.</u> 40A:11-23.3(f), SDW Construction, Inc. shall be disqualified from future bidding on this project.

RESOLUTION 25-156

REJECTING ALL BIDS FOR THE IMPROVEMENTS TO OVERLOOK PARK AND FRANK HALL PARK PROJECT AND AUTHORIZING RE-BID OF THE PROJECT

WHEREAS, pursuant to a duly advertised notice to bidders, on Thursday, July 10, 2025 at 10:00 a.m., the Borough received five (5) bids for the Improvements to Overlook Park and Frank Hall Park Project; and

WHEREAS, bids were received from the following contractors:

- 1. SDW Construction Inc.
- 2. Twinn Cedars
- 3. Frank Galbraith & Son Excavation & Demolition
- 4. Seacoast Construction, Inc.
- 5. Senco Metals; and

WHEREAS, the aforesaid bids were reviewed by the Borough Engineer's Office; and

WHEREAS, SDW Construction Inc. was determined to be the lowest bidder for the aforesaid project; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-23.3 the low bidder, in writing, requested that the Borough allow for the withdrawal of the bid due to a mistake that was made; and

WHEREAS, pursuant to Resolution No. 155, duly adopted on the same date as the within Resolution, the Borough accepted the withdrawal of SDW Construction, Inc.'s bid for the Improvements to Overlook Park and Frank Hall Park Project; and

WHEREAS, <u>N.J.S.A.</u> 40A:11-13.2(a) authorizes the Borough to reject all bids when the lowest bid substantially exceeds the cost estimates for the goods or services; and

WHEREAS, <u>N.J.S.A.</u> 40A:11-13.2(b) authorizes the Borough to reject all bids when the lowest bid substantially exceeds the contracting unit's appropriation for the goods or services; and

WHEREAS, in light of the aforesaid withdrawal of the lowest bidder, the remaining bids for the project exceed the cost estimate for the services to be provided; and

WHEREAS, in light of the aforesaid withdrawal of the lowest bidder, the remaining bids for the project substantially exceeds the contracting unit's appropriation for the services to be provided; and

WHEREAS, in light of the aforementioned, the Borough Engineer has recommended that the remaining bids be rejected, and the bid security returned to each bidder; and

WHEREAS, the Borough desires to again solicit bids for the Improvements to Overlook Park and Frank Hall Park Project; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Highlands that pursuant to <u>N.J.S.A.</u> 40A:11-13.2, all of the bids that were received for the Improvements to Overlook Park and Frank Hall Park Project be and are hereby rejected.

BE IT FURTHER RESOLVED, that the bid security be returned to each of the bidders for the aforesaid project.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Highlands authorizes the Borough Engineer to prepare the necessary bid specifications for the re-bid of the Improvements to Overlook Park and Frank Hall Park Project.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Highlands further authorizes the Municipal Clerk, once the bid specifications have been prepared, to advertise soliciting bids for the re-bid of the aforesaid project.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to each of the bidders for the aforesaid project.
