	Colony Caretaker Rules and Regulations
agree t	estand that as part of my participation with the Borough of Highlands TNR Program, I hat: I am responsible for keeping the feeding stations for my colony neat and clean, providing fresh food and water for my colony every day, keeping accurate data on all cats in my colony including newcomers and kittens and reporting this data to the MCSPCA on a monthly basis.
2.	I will allow MCSPCA personnel to trap feral cats for sterilization and to check that proper care is given to the colony. I will only trap feral cats if I am given prior approval by the MCSPCA Coordinator in charge of TNR programs.
3.	If I am given approval to trap feral cats, I will not use the trap(s) to knowingly capture any cat with a home; to capture a healthy animal to be euthanized; for any unlawful purpose; or to capture any cat for research/testing purposes whatsoever.
4.	All feral cats in the MCSPCA Trap/Neuter/Return program will receive a spay or neuter, rabies and distemper vaccinations, ear tip and microchip. Any other medical treatment will be done on a case by case need by the veterinarian.
5.	In some cases it may be necessary to euthanize cats and/or kittens whose physical conditions may prevent them from having a quality life and that this decision will be made by the MCSPCA veterinarians. I further agree that I will not hold the MCSPCA or veterinarian(s) liable or responsible for the decision of their actions.

MCSPCA Trap/Neuter/Release Program Trapping Tips

Before You Trap

Familiarize yourself with the Trap-Neuter-Return process and plan your trapping day in advance. Throughout all of your trapping endeavors, plan ahead to ensure the safety and well-being of the cats and reduce your own stress.

- oordinate with other caregivers who may be feeding the cats, and prepare the cats for trapping by feeding on a schedule and in a designated feeding area.
- ssess the colony to see how many cats need to be trapped.
- etermine a safe, temperature-controlled location where you will be able to hold the cats after surgery while they recover.
- ather and prepare all of the appropriate e uipment and understand how it all wor s ahead of time and practice t is important to test all traps, to ensure that the trip plate wor s.
- ithhold food hours before trapping, and you are ready to start trapping.

Trapping

- n the day-of, prepare the traps by lining the bottom with newspaper, tagging with a location description, and baiting.
- et the traps and watch them from afar.
- nce a cat is trapped, cover the trap this will help eep the cat calm.
- head of time, learn how to deal with particularly hard-to-trap cats.
- Never leave a trap unattended
- se stin y cat food such as, wet canned food, tuna fish, sardines or mac erel to bait the trap. entuc y Fried hic en may also be used for tough cats
- lace a sheet over the trap once it is set, the sheet will help calm the cat down once it is trapped.

Post-Surgery

- Transport the cats safely bac to your secure, indoor location where cats will be in a temperature-controlled environment, dry, and away from danger.
- onitor the cats for any illness.
- For your safety and the cats eep them in their covered cages at all times.
- Feed the cats eight hours or so after surgery.
- Return the cats to the e act location where they were trapped.
- lean the traps.

Feeding Stations

- rovide ade uate food and water for the cats on a regular basis, year-round. Feed during daylight hours for your safety and so that you can easily assess the members of the colony. e recommend feeding colony cats at dawn and dus.
- ome colonies find shelter for themselves in a shed or under a building where their safety is uncertain. ou might want to consider building a shelter for the cats. t can eep them safe from the elements and help you control their location and deter them from neighbors properties.

TNR ANNUAL REPORT FOR FY 2024

The Borough of Highlands, working with the MCSPCA and 15 Cat Caregivers, successfully trapped 36 cats during the period of January 2024 through December 2024. Our Memorandum of Understanding with the MCSPCA is renewed each year in January. They provide Animal Control and TNR services to the Borough.

The joint Highlands/MCSPCA TNR Program is discussed during the spring TNR public meeting. Caregivers sign an agreement with the Borough and MCSPCA then provide census of the cats they manage. This flyer outlines where we are with the program. Over the years, several caregivers and others have reached out to MCSPCA to alert them of areas where cats congregate.
